CAREER DEVELOPMENT OF SCHOOL GRADUATES IN THE ASPECT OF CREATION OF INNOVATIVE ECONOMY – POLISH EXPERIENCES

Introduction

Methods and concepts of innovation performance are widely analysed, discussed and evaluated. Economic crisis in Greece, problems in Portugal, Spain and Italy incline towards research on areas of development in Europe. The influence of educational management on the creation of innovative economy is not widely described in scientific literature, however procedures of innovation performance include the measures of educational elements. European Commission analysis the economic innovation on the basis of EIS and IUS reports¹. Scientists are also looking for new tools for measurement of innovations². All

processes in educational area play a great role in preparation of graduates to enter the labour market.

Career development of young people cannot be accidental, especially in difficult economical situation in Europe and should be supported by specialists and experts. Educational research mainly are focused on teaching and behavioural problems. Projecting and modelling of educational processes and activities to make education adjusted to economies needs and requirements. This is connected mainly with school nets planning, structure of vocational and general education, system of vocational advisory and evaluation of educational performance methods.

The research questions in this article³:

How do develop careers of schools graduates and how graduates' decisions influence on innovation indicators of polish economy?

How to improve performance of innovations by performance of education? The article argue research questions on the basis of:

- 1. Analysis of educational indicators in European Innovation Scoreboard (EIS) and Innovation Union Scoreboard (IUS) reports from 2006 till 2010 in the aspects of education.
- Analysis of information given in EIS and IUS reports for educational systems and for economy. Discussion of role and the influence of educational indicators in the creation of innovative economy and for competitiveness of countries.
- 3. Research of graduates' careers of post lower secondary schools and secondary schools in Poland. Methodology and research preparation was divided into following stages: sampling, choose of forms and measurement methods, creation of measurement tools, evaluation of tools. Research population: 649 last year pupils of lower secondary school and All types of secondary schools (basic vocational school BVS, technical and vocational secondary school TVSS, general secondary school GSS and general secondary school with profile GSSP). The research was carried out in three schools of each type between march and may 2011, the measurement tool was a survey. Basic information of population are included in Tab.1.

As a data also were used the results of author's study on educational strategies and vocational education carried out from 2009 to 2010.

Performance of innovations

Methodology of performance of innovation was introduces in 2000 year by European Commission and is constantly evaluated (EIS 2006 – 2009 and IUS 2010). The advanced proposal is based on integrated indicators: Innovation Indicator Scoreboard used and developed since 2000 till 2009 and Innovation Union Scoreboard introduced in 2010 (EUS). In EUS report 2010 indicators are grouped into 3 areas and 8 dimensions (Tab. 2).

Complete and advanced methodology allows to measure innovations, compare particular countries and indicates those elements which are important in the creation of innovative climate.

The article discusses indicators in the educational area. In 2006 and 2007 they were (*EIS 2006 and EIS 2007*):

- New S&E (science and engineering) graduates per 1000 population aged 20-29 (postsecondary education graduates in life sciences, physical sciences, mathematics and statistics, computing, engineering and engineering trades, manufacturing and processing and architecture and building.
- 2. Population with tertiary education per 100 population aged 25-64.
- 3. Participation in lifelong learning per 100 population aged 25-64. Life-long means participation in any type of education or training course during the four weeks prior to the survey.
- 4. Youth education attainment level (percentage of population aged 20-24 having completed at least upper secondary education).

EIS 2008 and EIS 2009:

- S&E and SSH (social sciences and humanities) graduates per 1000 population aged 20-29 (first stage of tertiary education). In comparison with 2006 and 2007 the indicator includes additional information of SSH graduates.
- S&E and SSH doctorate graduates per 1000 population aged 25-34 (second stage of tertiary education). This indicator did not appear in 2006 and 2007 years.
- 3. Population with tertiary education per 100 population aged 25-64.

- 4. Participation in life-long learning per 100 population aged 25-64.
- 5. Youth education attainment level.

Indicators 3, 4 and 5 are repeated from previous reports.

IUS 2010:

- 1. New doctorate graduates per 1000 population aged 25-34 (border definition than EIS 2009).
- 2. Percentage population aged 30-34 having completed tertiary education.
- 3. Percentage youth aged 20-24 having attained at least upper secondary education.

Methods of calculation the EIS and IUS indicators in the area of educational has not evaluated much since 2006. Laforet⁴ presents drivers of innovations and investigates that innovation capacity is determined by resource, collaborative structures and processed, skilled workforce. Especially employers with higher education level and clear growth objectives can create innovation with their knowledge and experience. Accordingly to Murat Ar, Baki⁵ there are 7 drivers of innovation describe creative capability, which is, among others, connected with employment creativity. Zientara⁶ proofs that knowledge based economy requires well-

educated and skill labor. Barro, R.J. and X. Sala-I-Martin⁷ highlight the role of investment of human capital and education on economical growth.

All of educational indicators are quantitative and do not include any information of quality of education. Researchers are agreed that innovation processes and economical growth requires well educated and skilled workforce and they assume that skilled workers are on output of educational system. The measurement system of innovations in Europe includes various economical aspects, allows to observe trends and gives opportunity to improvement for countries and is directed on future educational effects (e.g. number of patents or number of innovative companies). Indicators of number of graduates, population in particular level of education allow to observe trends, educational needs, desires (dreams sometimes) of pupils and their parents. Efficiency of these indicators is presented on the example of Poland.

To the advantages of EIS/IUS system belong:

- Easiness of gathering the data to calculate indicators.
- Objective entrance data for indicators based on public statistics.
- Clear structure of indicators and the measurement system, divided into three complementary areas.
- Ability to compare indicators between countries.
- Ability to observe results in particular country (improvement of innovation in comparison with other countries).
- Easy to use by governments and local authorities.
- Tool for governments and local governments that can support making decisions.

To the disadvantages of the EIS/IUS system belong:

- Containing only easy to gather quantitative data.
- Do not include information of quality of education.
- Do not refer to studies on quality of education.
- Do not present complex methodology of measurement of innovation.
- Provides general information about trends in education worth for making strategic decision on governmental level but will not support making decisions on local government.

Author's research draw a conclusion that despite the indicators have increased, the quality of education decreases: employers states that graduates knowledge, skills, abilities do not meet their requirements and very often graduates plan their careers accidentally (Tab. 5)

Analysis bring new question: How to measure educational area to improve innovation performance?

Methodology of research on graduates careers

Quantitative indicators are useful but not sufficient. There is a necessity to complement them with qualitative indicators. Any indicator of the amount of graduates of particular type of school does not give an exact information. We can observe particular trends connected with career planning of graduates of different types of schools. But we do not receive an accurate knowledge on the subject of decision process and data flows.

Author's research confirms the increasing tendencies of EIS and IUS indicators (Tab. 6)

Educational aspirations of graduates of every type of secondary schools are connected with career paths. Most pupils are going to continue education (Tab. 7).

The tendencies are natural and understood in general secondary schools and general secondary schools with profile. The role of those school is preparation pupils to continue education. Population of 96,39% pupils of GSS and population of 60% pupils of GSSP wish to continue education. A lot of pupils in both types of vocational school graduates' is going to

continue education. Despite the vocational schools are focused on preparation its pupils to enter the labor market, TVSS graduates chooses universities and BVS graduates wish to continue education usually in their occupation in technical vocational schools.

Those processes demand changes. A population of 17,28% basic vocational school graduates and 30,47% of technical and vocational secondary schools graduates is not intend to take up employment (Tab. 8).

Reaching following levels of degree is very important. Well educated graduate has more opportunities on labour market. Employers are searching for qualified workers with particular skills, qualifications, behaviours. Role of school is not only preparation to play role in economy. During many schools years young people learn to exist efficiently in society, to work, to actively participate in social and public life. Population of 17,28% of basic vocational schools and population 30,47% of technical and vocational schools graduates do not want to take up an employment. But, anyway, it is not bad result in the situation on many difficulties with unemployment of young people. Studies pointed out that many interviewed in basic vocational schools work in their occupation in their free time.

To make educational management more effective in local governments there is necessity to analyse not only graduates choices and educational needs but also reasons and determinates of those decisions. They are made mostly independently. From 10% to 33% interviewed pointed out the role of family and friends in those decisions. Educational system help in the area of vocational advisory (tutors, teachers, pedagogues, vocational advisors) is small.

Education quality is impossible to measure only with EIS/IUS quantitative indicators. External examination results seem to be satisfied in Poland (Tab. 9.) and, so far, they are considered as the most important indicator of education quality. But nobody discuss that completion of matriculation exam covers 30% of right answers and, it is just easy to pass matriculation exam on the basic level.

Ministry of Education introduces measurement system of value-added educational indicator, based on comparison of results at the beginning education and at the end of education in particular school. But this is still internal measurement, which do not contain elements of labour market research. On the other hand employers are no satisfied with graduates of secondary schools qualifications, skills and knowledge.

Conclusion and questions do discuss

Educational indicators to improve innovation performance should be very synthetic, but cannot lose important information. Research on career paths of graduates will be carried out in 5 cycles: first internet questionnaire will be send a year after completion the school and repeated 3 times every 5 years. Evaluation of educational process at school will be carried out in particular categories: evaluation of proper preparation to work at your occupation/ evaluation of proper preparation to continue education; recommendation of the school for younger friends or for graduates children; support of creativity, innovation at school; work in accordance with qualifications or below qualifications; level of salary and job satisfaction. Indicators based on answers for above question can supplement innovation performance methodology. The concept can be firstly develop and tested in local governments, responsible for educational management in their areas, however it can be extended in every educational system.
