India

Development Strategy "Made in India"

Two foreign visitors have recently been to India: the German Minister for Economic Cooperation, Dr Erhard Eppler, and the Soviet party chief, Leonid Brezhnev. Politically, the two visits did not carry the same weight, but economically the agreements reached signpost in their various ways the two routes which India wants to pursue — at the same time — on its march into a better future.

Dr Eppler laid the emphasis on his intention to concentrate German development aid for India as far as possible on the agricultural sector; the main outcome of Brezhnev's call on Indira Gandhi, on the other hand, is likely to be greater cooperation and more Soviet aid for the development of India's heavy industry, extension of its petrochemicals industry and of energy production. Dr Eppler had made his motives clear to the Indians before he set off for his visit. He wrote: "Mahatma Gandhi had already understood that not mass production but production by the masses can bring progress to this land." His plea has even more force today when 150 million people in India are unemployed or underemployed and over 70 p.c. of the population are deriving a living from the land.

The returns of India's agriculture however still depend in the main on the monsoon rains. If they fail to break, hard currencies flow out of the country to pay for grain. The vagaries to which India's agriculture is subject create fresh uncertainties each year in the whole economic organism. They explain why India wants to intensify its efforts to establish a competitive industry. Thereby alone can the financial resources needed for purchasing grain be provided. Hence India's avidity for the most modern industrial technologies. To find the right way to balanced progress between a backward agriculture and a supermodern industry seems to be a well-nigh hopeless undertaking when the country has to grapple with such complex contingencies. If nothing else, the visits by Brezhnev and Dr Eppler have thrown new light on the vast range of the development strategy "made in India". bw.

Energy

Playing Poker in the Ec

Nuclear energy is to take the place of oil wherever possible, and external independence is to be achieved alongside internal cooperation. Thus the EC Commission. What hopeful words for a Europe in the grip of an energy crisis! The

debates on the political, economic and technical aspects of the supply of enriched uranium however have so far yielded only a consensus that the rapidly growing requirements of nuclear power stations should and could be covered by Europe's own production while questions concerning the production process and its financing are the subject of an angry poker game of France versus Great Britain, the Netherlands and Germany. For the French gas diffusion process speaks the fact that it has been tried out and fully developed whereas the centrifugal process of the other side offers a more modern technology which apart from lower capital and operating costs and a smaller environmental handicap allows flexible load adjustments.

In this situation the EC Commission has been equivocating. It is urging a "concerted action" on the competitors to avoid that pursuit of both projects results in jointly financed excess capacities. It appears however that the end of the concertation efforts will be a wishy-washy compromise defving economic and technical commonsense: Paris has already announced that it will build an isotope separation plant employing the French design while the British-Dutch-German group has been authorised by an intergovernmental committee to set up separation plants operating the centrifugal process in Great Britain and the Netherlands. When the heads of governments of France and the Federal Republic met in Paris in November, all they could do was to assure one another of mutual participation in and furtherance of the projects.

Ethiopia

Famine Strikes as the Sahara Spreads

About 1,000 people are dying each day in the Sahel zone of Africa which is suffering from a persistent drought. For some seven months the peasants of Wallo and Tegre, two of Ethiopia's most densely populated provinces, have had to bear the brunt of a disastrous famine. Much too late, in early October, the government in Addis Ababa allowed the world public to catch a glimpse of the sufferings of its people. Now it is clamouring for help. Merely to save the people in the two provinces from starvation at least 1.5 mn tons of grains must be provided in 1974.

The problems of the Sahel zone in its entirety will not however have been solved when this, as it were, short-term task has been accomplished. For them a solution must be sought through a long-term development aid scheme for the Sahel countries. The root cause of the disaster is not the famine but the change in the local climate,

which has resulted from inexcusable mistakes in land cultivation. The Sahara could not have spread outwards as it did had not all conceivable ecological rules been violated in the dry savannas and steppes. Overgrazing, overcropping, scorching of the vegetation and deforestation have played havoc with the environment.

There is thus the more reason to welcome the initiatives by several scientists and the UN's agricultural agency, the FAO, in particular to devise strategies for the longer term. Various means are available to prevent the Sahara spreading farther: the herds of animals in the Sahel could be reduced, wells be drilled, new oases created, vegetation regenerated. The good results obtained in this way in Mauretania should encourage the industrialised countries to give more financial and technical aid, for its benefits would be of world-wide significance: drastic atmospheric changes could follow if further large areas of Africa turn into desert.

Spain

Dynamic Expansion

Following the sharp recession of 1970 Spain has for several years experienced a marked expansion, which seems to rule out a relapse into the former economic apathy. With a growth rate of 8 p.c. in 1973 Spain is comparing favourably with other European countries. No wonder then that Spain has become very attractive for foreign investors. In 1972 investments totalling 41.6 bn pesetas were officially sanctioned, compared with 25 bn in 1971 and 1.1 bn in 1967. In the year just ended the trend has continued, thanks to two especially large investment projects. British Leyland will build a new engine factory near Pamplona, and Ford is planning a 400,000 cars a year plant near Valencia.

Substantial revenues are derived from tourism, which by the end of August had yielded about US \$ 1.8 bn — 22 p.c. more than at the corresponding time of the preceding year — and from the remittances of guest workers, which still play a major role in the balance of payments.

With expansion proceeding at such a fast pace it has been impossible to avoid a high rate of inflation — 12 p.c. compared with wage increases of 19 p.c. A relatively steep upsurge of prices will be accepted in the next year or two so as not to retard economic growth. In the past two months however the inflation has been slowed by a — not very strictly enforced — price stop on a number of essential goods including, e.g., the price of petrol which was not allowed to go up before the beginning of 1974 and then only by 20 p.c.

The present crisis situation in the world economy is not causing any immediate anxiety because for the time being oil is not in short supply. Spain is however taking precautious and working vigorously on an extensive nuclear power programme. Atomic stations are to supply one-third of all the electricity required in the early eighties: Iberduero, the leading electricity group, will have over 20 nuclear power stations in operation by then. Foreign investors may find good opportunities in this field too.

Multinational Enterprises

That the multinational corporations are exerting an increasingly strong influence on the economic, social and political life of the countries in which they operate is a fact, that can no longer be ignored in Brussels. Like the United Nations, the World Trade Conference (UNCTAD III), the International Labour Conference and the OECD before it, the EC Commission has had to concern itself with the multinational enterprises.

The multinational corporations have by now grown to such dimensions and spread their activities over such large areas as to arouse doubts about the effectiveness of the measures, which are traditionally applied by public authorities in this field. An aggravating factor is that the trade unions, which would be a counter-weight to the multinational enterprises, have so far been unable to achieve a corresponding degree of cohesion and international integration. As a consequence there is no constraint on these groups to prevent a negative impact of their commercial policies on employment and competition. There is, besides, the problem of tax evasion and currency speculation.

The problems inherent in the existence of multinational enterprises can, as the Commission has correctly observed, only be resolved if the public authorities create counter-weights on a Community level and on an international scale. Needed for this purpose is a plexus of interlinking legal instruments that is sufficiently dense to prevent operations which the Community deems undesirable. As the multinational enterprises are however capable of an useful contribution to the realisation of the Community's economic and social objectives, they should in principle not be subjected to discrimination, but only to stricter control. The Commission has forwarded pertaining recommendations to the Council of Ministers. It is now up to the Council to make speedily suitable decisions so as to lessen the advantages, which the multinational enterprises enjoy over mononational firms and trade unions by virtue of their international status. kw.
