# German Investments Abroad and Foreign Investments in the Federal Republic

The investments of residents of the Federal Republic of Germany in economic areas abroad and of non-residents in the economic area of the Federal Republic are the subject of the following article. Their development over the last fifteen years is analysed in regard to their geographical location and distribution over the various economic sectors. One of the questions to be examined is whether German investments in foreign countries are an alternative to exports from the Federal Republic or a necessary complement to such exports.

nvestments made today are a guarantee of economic growth and job security tomorrow. Data relating to the trend of development and the distribution of recent investments are therefore of great importance for business firms. The present study has the purpose of bringing the development of the nominal direct investments by Germans abroad and of the foreign investments in the Federal Republic of Germany during the 15 years from 1962 to 1976 into focus.

#### **German Investments Abroad**

On December 31, 1976 the German direct investments in foreign countries amounted to DM 47.0 bn<sup>-1</sup>. Europe accounted for 57.3 p.c. of this total, America for 31.9 p.c., Africa for 6.0 p.c., Asia for 4.2 p.c. and Australia for 0.6 p.c. (Table 1). The investments by residents of the Federal Republic in these continents differed widely in the course of the period from 1962 to 1976:

The decline of the German investments in other European countries from DM 3.9 bn in 1973 to DM 2.1 bn in 1976 (i.e. by 46 p.c.) must be viewed in conjunction with the strong advance of German investment activity elsewhere, and especially in America. The German investments increased between 1973 and 1976 by almost 130 p.c.; in the USA and Canada they rose by 111 p.c. and in Latin America by 164 p.c.

A striking feature is the recent lapse of interest of German business firms in investments in other European countries. A modest recovery (by 15 p.c.) in 1975 was followed by a substantial decline (by 24 p.c.) in 1976; the investments in EC countries fell by 16 p.c. and those in EFTA countries by 27 p.c. The Netherlands were the only EC country in which the Federal Republic made greater investments last year than in the preceding year (+ 119 p.c.), and even here the German investments were 72 p.c. lower than in the boom year of 1973.

#### **Focus on Industrialized Countries**

Industrialized countries accounted for 70.6 p.c. of the German foreign investments built up by the end of 1976 and developing countries for 29.4 p.c.<sup>6</sup>. The pattern has changed over the last 15 years:

Although the developing countries were able to raise their share of the total German foreign investment in 1975 and 1976 to 28.3 and 30.4 p.c. respectively (1972: 42.6 p.c.), German enterprises are still concentrating their investment activities on 12 countries only:

These 12 countries accounted for about four-fifths (79 p.c.) of all the German investments abroad on record for December 31, 1976.

Of the total of the German direct investments in other countries as shown for the end of 1976-DM 47.0 bn  $^1-76.8$  p.c. had gone into industry, 20.9 p.c. into the services sector, 1.5 p.c. into private households and 0.8 p.c. into "other" spheres (Table 2). The distribution of the new investments abroad by residents of the Federal Republic in the individual economic sectors varied in the 1962-1976 period.

The slackening of domestic investment activity in the German manufacturing industry since 1970 has had no parallel in the field of foreign investments. In some industries however the investments abroad lagged greatly behind the high figures recorded for 1973; in the iron and steel producing industry for instance the shortfall was 63 p.c.

### Foreign Investments in the Federal Republic

The direct investments of non-residents in the Federal Republic of Germany amounted on December 31, 1976 to DM 45.5 bn <sup>12</sup>. Of this total Europe accounted for 54.3 p.c., America for 42.2 p.c., Asia for 3.3 p.c. and Africa for 0.1 p.c. <sup>3</sup> (Table 3). The continents shared in these invest-

ments in the Federal Republic between 1962 and 1976 as follows:

The investments of other European countries in the Federal Republic declined from close on DM 4 bn in 1973 to not quite DM 2 bn in 1976 (by 51 p.c.). (For purposes of comparison it may be mentioned that the German investments in other European countries decreased over the same period by 46 p.c.). After a marked investment lull in 1975 (-47 p.c.) the new investments by European non-residents increased once more in 1976 (+ 39 p.c.). The EC countries 4 in particular last year invested 48 p.c. more than in 1975 although they did not regain the investment level of previous years; Belgium-Luxembourg and Great Britain alone did not step up their investments. The EFTA states 5 raised their new investments in the Federal Republic in 1976 by 30 p.c.

The pattern of the foreign investments in the Federal Republic resembles the distribution of the German investments abroad in that most of them came from other industrialized nations. The major contributors to the total foreign investment on record for December 31, 1976 were:

Precisely 96 p.c. of all foreign investments in the Federal Republic thus emanated from these 11 countries.

#### **Distribution by Economic Sectors**

Of the total direct investment of non-residents of the Federal Republic on record for the end of 1976 – DM 45.5 bn 12 – industry had attracted 75.1 p.c., the services sector 24.4 p.c. and "others" 0.5 p.c. (Table 4). As in the case of the German investments in foreign countries, the share of industry receded during the 15 years' period under review while that of the services sector grew larger:

Whereas the foreign investments in German industry rose by 4 p.c. in 1976, foreign investors increased their new commitments in the services sector in the same year by nearly 70 p.c. In both sectors however the investment activity showed a decline compared with 1973 — by 44 and 57 p.c. respectively.

Over the 1962—1976 period as a whole the German investments abroad increased at an average of 17.2 p.c. a year and the foreign investments in the Federal Republic of Germany at an average rate of 10.9 p.c. How outward and inward investments have grown at different rates is shown in the following table:

The low average growth of the direct investments by foreign enterprises in the Federal Republic in the 1972–1976 period (1.7 p.c. per annum) is chiefly attributable to the contraction of the capital influx in 1974 (-27 p.c.) and 1975 (-44 p.c.).

The divergent growth trends of the inward and outward investments can also be illustrated by indices using 1962 as the base (1962 = 100). By 1976 the index of the German investments abroad had increased to 598; in 15 years the outward investments had thus risen sixfold or by nearly 500 p.c. The foreign investments in the Federal Republic advanced over the same period to 220; with an overall increase of 120 p.c. they thus more than doubled in the period under review.

In 1976 the German outward investments exceeded the foreign investments in West Germany by approximately DM 2 bn. This was the first surplus since 1973. On December 31, 1976 the total of

the German investments abroad exceeded the total of the non-resident investments in the Federal Republic by DM 1.53 bn.

At the end of 1976 the German investments showed large outward surpluses in the capital exchanges with Brazil (+ DM 3.4 bn), Spain (+ DM 2.8 bn) and Canada (+DM 2.7 bn). The German investment surplus in EC countries 4 stood at DM 471 mn while the exchanges with EFTA states 5 showed an adverse balance of nearly DM 1.5 bn. - On December 31, 1976 the outward investment shortfall with DM 12.5 bn was largest in relation to the USA: German direct investments in the USA of DM 5.4 bn compared with US investments in the West German economy of DM 17.9 bn. The outward investments also fell short of the inward investments in relation to the Netherlands (- DM 2.8 bn), Switzerland (- DM 2.7 bn) and Great Britain (- DM 2.4 bn).

It emerges from the following table of "coverage ratios" that on an average of the years from 1962 to 1966 — selected here as an example — not much more than half the direct investment of non-residents in the Federal Republic was "covered" by comparable German investments in other countries:

The German investments in Africa and Australia/ Oceania are several times larger than the investments in the Federal Republic from these two continents.

#### **Cross Investments**

There is a close correlation between the level of German exports to certain regions and countries and the intensity of the German capital engagement there: exports lead to investments, and these investments regularly result in larger sales of German export goods, as is illustrated by the following table:

In the 15 years under review the EC of the Nine absorbed on average 45 p.c. of all German exports (T 1); in the same period (1962–1976) 37 p.c. of all German investments abroad (C 1) were attracted to this economic area. A similar relationship exists on the import side: other EC countries supplied 48 p.c. of all imports (T 2) and 35 p.c. of the investment inflow (C 2).

An analysis by economic sectors also reveals striking parallels:

There is clear evidence here of a connection between German investments abroad and German exports and similarly between foreign investments in the Federal Republic and German imports.

#### **Motives**

The basic requirement of successful engagement by German firms in any foreign country is a modicum of safety from expropriation, arbitrary interference by the authorities and oppressive restrictions, e.g. on profit transfers. No wonder therefore that — as shown — the German foreign investments have for the most part gone into western industrialized countries with basic political and economic orders corresponding in great measure to that of the Federal Republic of Germany.

This is seen especially clearly in the capital transactions with the USA: More than one-tenth of all German investments in foreign countries went to the USA, and the USA was the source of twofifths of all foreign investments in the Federal Republic. That both are high-wage countries did not impede at all the capital flows in either direction. The fact that the German investments in the USA in 1975 and 1976 for the first time exceeded the US investments in the Federal Republic is due to the considerable changes in the dollardeutschemark cross rate. The consequent worsening of the competitive position of German products in the American market has hastened the decisions of German firms in favour of setting up branch factories in the USA which give them a chance to hold an important market while limiting coincidentally the adverse repercussions of exchange rate variations on the level of employment at the German parent company. Investments by enterprises of the Federal Republic in other industrialized countries are thus certainly a necessary complement to the German export trade.

A large portion of the German investments in developing countries must be viewed against this background. The availability of a favourable source of raw materials is no doubt an important motive for such investments but not necessarily the most common one. The establishment of subsidiaries or acquisition of a capital interest in enterprises in these countries has in many cases a market orientation and not an import orientation. Most of the developing countries are too poor to be able to afford imports of industrial goods in the quantities desirable for speedy development of an efficient economy. This is why the choice for them is often not between internal production or imports but between production by a firm operating in their own country or doing without the goods in question. To give an example: If the subsidiary of a German firm is making trucks in Brazil and selling them in this or other countries of Latin America, it does not thereby diminish German export opportunities or deprive anybody in the Federal Republic of his job; on the contrary, it will create an additional demand for German products because its manufacturing activities depend upon deliveries from Germany for which there would otherwise be no call.

#### Outlook

As regards the discussion about the effects of German direct investments abroad on the labour market situation it may be said that while jobs may be put in jeopardy on the micro-level e.g., in an enterprise with a very narrow production programme - the effect on the macro-level of the particular industry as a whole or the entire German economy will be that a resultant partial export shortfall will be offset or overcompensated by increased exports of other products. The principal motives for German investments in other countries - improved market coverage from a location nearer at hand, cost advantages in production and transportation, avoidance of import restrictions by consumer countries - are likely to retain their stimulating effect in future.

In view of the present changes on the social scene it is open to doubt whether the same is true of the foreign investments in the Federal Republic. Cyclical factors certainly carry some weight in this respect. Similarly the situation will be affected if a saturation point is reached. Of relevance is also probably the fact that administrative regulations (e.g. on the protection of the environment), which are fairly strict in the Federal Republic, and imponderable factors connected with worker participation may deter potential investors from credit commitments in the near future.
