AEO Programmes Worldwide: From MRAs to a General AEO Agreement?!

The Authorized Economic Operator (AEO) status is being introduced around the globe in more and more countries in order to combat terrorism by better security measures in World Trade. This paper gives an overview about existing AEO programmes and new AEO programmes which are about to start in 2015. It describes in detail the Mutual Recognition Agreements (MRAs) which have been concluded to date. And it calls for a General AEO Agreement in order to facilitate the AEO acknowledgement by traders and governments alike in many less developed countries of the world.

I Introduction: AEO-status

The AEO-status has been introduced in World Trade by the World Customs Organization (WCO) and its SAFE Framework (Secure and Facilitate Global Trade¹) as an initiative to combat terrorism.

168 WCO Member States and Taiwan have agreed to introduce the AEO-status,² though Australia has opted to comply with the SAFE recommendation but not to introduce the AEO.³

The AEO-Status had been introduced in the European Union (EU) in January 2008 with the so-called small Customs Code revision (also Security Amendment),⁴ see Article 5a Community Customs Code⁵ and Articles 14a–14x CCIP.⁶

Other AEO programmes are in force in the US (C-TPAT), Canada (PIP), Jordan (Golden List), Argentina,

Brazil, Costa Rica, Guatemala, Mexico, Israel, Norway, Switzerland, Turkey, China, Japan, Korea, Malaysia, Singapore, Taiwan and in New Zealand (SES).

The WCO initiative gets new momentum by the proposed WTO Agreement on Trade Facilitation and its paragraph 7 – Australia has started to rethink its position to the AEO-status since this new development.⁷

2 New AEO programmes in 2015

In 2015, thirteen new countries and Customs Unions are about to start their AEO programmes: Botswana, Chile, Ecuador, El Salvador, Indonesia, Macedonia (FYORM),

4 Conclusion

The WCO has reported more than fifty AEO programmes that are running in 2014.9 The data is not consistent with the press releases of the WCO and an internet research which has been conducted with the national customs services in question.

It has been shown, that there are actually forty-three AEO programmes running in 2015 of which some are only so called compliance programmes which is compliance and benefits at a lower level from AEO programmes.¹⁰

168 AEO Member States and Taiwan have agreed to introduce the AEO (while Taiwan is not a WCO member and the WCO does not name any of its MRAs.¹¹

33 Mutual Recognition Agreements (MRAs) have been concluded to date (of which the EU-Canada MRA is a basic security agreement and the AEO benefits are still under negotiation) (Table 1).

MRAs have been mostly been concluded by major trade nations of the World (Table 3): USA (10), EU/Japan/Korea (7) and Canada (5).

Smaller trading nations have concluded MRAs when they are major trading partners of the mayor economic powers or typical transit countries: Singapore (7), Hong Kong (4), Taiwan (3), Israel (2) and Mexico (2).

It has been repeatedly argued that common AEO Recognition Agreement within the WCO is more likely to be successful in implementing the mutual recognition of AEO standards in the world.¹²

This is of very much importance for the developing countries and least developed countries in order to include them in the global safe network or web of supply chain security.

But the WCO has not taken this view into consideration, yet.

Possibly a global discussion must be sparked in one way or the other.
