Evolving Crisis Management - Current Jobs and Required Employee's Skills and Characteristics Analysis

Abstract

With digitalization transforming the industries, as well as crisis management field, most managers are asking the following questions. What do organizations consider under today's crisis management? Which knowledge, technological capabilities, education and competences do organizations require from their employees in the crisis management field? Considering that fairly large number of organizations do not have adequate crisis management systems in place, and accordingly organizations are not sufficiently prepared for crisis situations, it is necessary to further develop crisis preparedness and response capacities, whereas clear understanding of new methods and crisis management activities can contribute to adequate response to organizational crises. This paper will determine what constitutes the modern crisis management, new job market demands, and further streams of research. Accordingly, the aim of this paper is to identify modern crisis management jobs, organizational needs for jobs, employee's assignments, scope of activities, along with instruments and methods. Analysis was accomplished through qualitative content research of online job ads (vacancies) on online platform LinkedIn, and it identified a mix of skills and characteristics needed for jobs in the crisis management field. In addition, this paper provides an overview and mapping of the contemporary crisis management field (which concepts can be classified under the crisis management field, identifies similarities and differences among the concepts), provides guidelines and basis for further theoretical and empirical research and development of the crisis management field. The contribution of this paper is in identification of guidelines for further research, especially from the aspect of current organizational needs and identifying demand for crisis management employees. The findings can help managers and human resource teams further develop the knowledge on crisis management and crisis management expert's requirements.

1. Introduction

In an era of digitalization and complexity, organizational crisis management and relating activities are of significant importance to managers (Corporate Excellence, 2013). There is a constant need for further development of crisis management and response to challenges of evolving business, technological and social environment (Baubion, 2013). Social media, social practices, technological changes, and smart ICT devices (smartphones, tablets, smart

watches, etc.) are considered simultaneously as both a challenge and an opportunity for crisis management development (Stern, 2017).

Stated developments challenge and significantly affect the traditional organizational crisis management phases of preparedness, response, recovery and feedback (World Bank Group, 2016). In order for contemporary crisis management to be efficient it is necessary to properly understand it, define it and state the actual tasks and assignments, as well as comprehend the development tendencies. Advances in digitalization reduce available time for response to crises. In a multilateral exchange of information through interconnected modes of communication such as social media, instant response to challenges in real time is needed. For instance, shift in modes and approaches in crisis communication are evident from once controlled dissemination of information towards a currently dominant multi directional means of communication via social media (Eriksson, 2012).

Furthermore, in today's economy, employees, i.e. human capital presents a vital organizational asset and driver for attaining sustainable competitive advantage (Becker, 2002). OECD defines human capital as "The knowledge, skills, competencies and attributes embodied in individuals that facilitate the creation of personal, social and economic wellbeing" (OECD, 2001: 18). It is considered a good practice of firms to significantly invest in human capital, their training and growth, as means to have competent and content employees which significantly contribute to firm's success (Siddique, 2004: 227). Accordingly, it is necessary to redefine the roles, assignments, scope of activities, instruments and determine the appropriate contemporary crisis management methods. Job ads help provide the necessary data (Kennan, et al., 2006). Hence, for the purpose of exploring and remodeling the role of crisis management and its interconnected tasks, a primary research was conducted through a content analysis of job demand for employees from crisis management domain through an online platform LinkedIn, serving as a good indicator of employers requirements, with an aim of identifying organizational needs for employees and determining desired sets of specific activities, skills, competencies, knowledge and experience. LinkedIn is both a social networking and job posting platform (Gee, 2016; Lenaerts, Beblavy, Fabo, 2016) significant in todays job search and job matching due to its ease of use and a representative number of employers present- where labor market demand and supply meet. Such stream of research aims to define modern "crisis manager" and what one should possess in order to adequately deal with challenges of turbulent environment.

It is often difficult to pinpoint, even for informed practitioners and academics, where crisis management currently is and in which direction it is advancing. Hence, the aim of this research is to evaluate required demand for crisis management competencies, which consequently enable overview and initial mapping of the crisis management field (which concepts can be categorized under the crisis management, identify the similarities and differences among the concepts), whereas an answer to what organizations consider under today's crisis management, which knowledge, technological capabilities, education and competencies employers demand from their employees dealing with crisis management tasks is determined. Through researching the crisis management profession, the intention of the analysis was to identify inadequately explored areas, evaluate new trends in the practice and new market demands for crisis management, provide more clarity into required crisis management skills and competencies, as well as paths for further development of the field. This research expects to describe the activities of crisis management in its current business context. A list of required knowledge and competencies (e.g. from a technological change

perspective) will be updated, and enable initial overview of the field, as well as provide guidelines for further research of the crisis management field.

The structure of the paper is as follows. After the introduction, section 2 evaluates the field of crisis management and related terms. Section 3 deals with significance of crisis management. Section 4 discusses the job content analysis method and its importance. Section 5 discusses the methods of research and process. Section 6 is analysis section. In part 7 limitations are stated and potential research possibilities, while last part 8 is conclusion section.

2. Positioning of crisis management

Crisis management is a concept and term used in various fields, such as medicine, sociology, psychology, engineering, logistics, political science and communication (Sellnow, Seeger, 2013: 2).

In English language literature there are various terms associated with crisis management: preparedness, prevention, business continuity management, issue management, disaster management, etc. The challenge is not so in proper definition of terms crisis and crisis management, rather in a proper and adequate use of crisis management concepts, both in theory and in practice (Jaques, 2007: 148). Knowledge and possibilities of defining crises characteristics allow a succinct distinction of crisis management from similar terms in literature in order to adequately explore the constructs and relations among the constructs (Kovoor-Misra, Clair, Bettenhausen, 2001: 78). Crisis management and crisis management related activities should be in line with general business strategy. Crisis management presents a significant strategic management function in a sense that it connects numerous activities such as risk management, managing security and safety, environmental scanning, contingency plans, emergency response, etc. in one encompassing activity (Shaw, 2004: 20).

Moreso, business continuity management is a term closely related with crisis management (Parnell, Koseoglu, Spillan 2010: 108). Business continuity refers to a short and long term existence of a firm (Lockwood, 2005: 3). Primary goal of business continuity is to enable business continuation irrespective of various crises and challenges and enable organization to return to a previous initial business path prior to crisis (Light, 2008: 20).

Even though crisis management and contingency management have the same purpose to recover organization from crisis and are complementary activities, crisis management as observed from the perspective of operative set of activities is a broader concept than the business continuity management and includes phases such as crisis preparedness, crisis response, crisis recovery, while business continuity mainly deals with crisis recovery phase. The two stated concepts can be seen as complementary.

Without crisis management and business continuity, activities such as crisis preparedness, crisis identification, crisis response and recovery are impeded. Short of the stated activities and measures, in times of crises, managers are prone to respond instinctively and are likely to make more mistakes, as opposed to in advance prepared strategic responses to crises situations (Sapriel, 2010: 30). The problem is in that a significant number of firms do not spend enough resources for the stated activities, which can result in inadequate responses when necessary. Even though the mentioned activities, as well as other associated concepts demand time, resources and activities before, during and after the crises, the results of the

stated conducted activities can significantly lower inputs and costs, as opposed to a potential damages and harm which crises can incur (PWC, 2009: 9).

Crisis management (CM)

Crisis management developed from the preparedness for emergency situations, and consists of four interrelated main activities: prevention, preparedness, response and revision with an aim of preventing crises emergence and reducing damage caused by crises event (Coombs, 2012: 5).

Crisis management consists of joint employee's activities, together with stakeholders to effectively avoid crises or manage the ones that do happen (Pearson, Clair, 1998: 61).

Crisis management is evolutionary and complex process, which consists of activities based on organizational structure, culture and politics (Carmeli, Schaubroek, 2008: 180).

Crisis management constitutes a part of a good corporate practice (Lockwood, 2005: 3).

Crisis management is important for overcoming threats and minimizing the role of crises on organizations (Sapriel, 2003: 349).

Crisis management considers adequate response to crises and has a significant role in determining firm's success from failure (Spillan, Hough, 2003: 400).

Crisis management assumes that a crisis can be managed before, during and after the crisis event (Parnell, Koseoglu, Spillan, 2010: 111).

Crisis management is a continuous process which consists of three phases: pre crisis phase, crisis phase and post crisis phase (Coombs, 2012: 1-2).

Crisis management is a significant strategic factor of organizational success (Light, 2008: 57).

Crisis management can be viewed as a set of activities which intend to predict or identify potential business crises, improve prevention measures, or minimize the crises consequences (Preble, 1997: 777).

Business continuity management (BCM)

BCM contributes to clearer insight into organization, structure and stakeholder groups through encouraging development of environmental scanning culture, identification and reporting on risks, which consequently contributes to other planning activities and strategy development (PWC, 2009: 5-9).

BCM provides strategic and operative framework for redesign of products and services while simultaneously increasing the resilience for discontinuities. BCM's primary goal is to ensure the business continuation in various circumstances through development of strategies aimed at improving resilience, recovery, and return to "business as usual" mode after the crisis (Shaw, 2004: 21).

Business continuity among other things needs to include plans for swift business recovery, plans of alternative business locations in case of emergency, and provide answers to challenges facing employees in times of crisis. BCM allows organizations to return to initial business path prior to crisis (Light, 2008: 20).

Issue Management

Managing organizational problems which mainly relate to dealing with significant internal or external challenges (Jaques, 2007: 147).

Issue or a trend, which if left unattended can escalate and have significant negative impact on the organizations activities (Coombs, 2012: 4).

Difference between a crisis and issue is in that problems are recurring situations which

Table 1: Overview of crisis management term and concepts related with crisis management negatively impact firms, while crises are often rare and unusual event (James, Wooten, Dushek, 2011: 462).

Contingency plans

Are sort of "B plans" for emergency, unexpected situations caused by crises, which provide guidelines and procedures for quick recovery from crisis to "normal" business (Light, 2008: 20).

Contingency plans should be integrated in and in line with strategic and economic business goals, which if properly implemented, allow sustainable competitive advantage (Shaw, 2004: 26)

Emergency response/emergency management

Emergency response means short term organizational response with an aim of initial stabilization of consequences caused by crisis. The adequate speed of response to a certain situation can be seen as an important element of crisis response within the crisis management (Jaques, 2007: 156).

Organizational resilience

Organizational resilience refers to preparedness for challenging situations, whereas organizations swiftly and efficiently adjust and learn in face of difficulty and change (Vogus, Sutcliffe, 2007: 3418-3419).

Mitroff (2005: 105) differentiates systematic process of crisis management as an umbrella term in relation to other similar terms and supporting disciplines, claiming that crisis management is not risk management, business continuity planning or crisis communication, even though the stated concepts are important, they are merely a part of entire crisis management process. Hence, in this paper, crisis management includes various principles, which constitute specific part of a wider context of managing crises situations.

It is necessary to note that crises management constructs and similar concepts do not necessarily need to diverge. Instead, they can be observed as mutually connected activities (Jaques, 2007: 147). The purpose of all listed activities is to through mutual coordination strengthen the organizational resilience, preparedness, response to crises, and crises recovery.

3. Significance of crisis management

According to Roux-Dufort (2009: 4) crises are results of inadequate organizational culture, as well as managerial unpreparedness, which enables the organizational weaknesses to expand and subsequently develop into crises.

One of the major reasons crises occur are due to inadequately prepared managers, which are inexperienced in preparing for and handling crises. Previous crises experience, as well as education and training, significantly contribute to improvements in organizational crises preparedness. Organizational crises preparedness begins with a perception of top management on taking risks (Rousaki, Alcott, 2007: 28). Furthermore, crisis resilience and organizational crisis preparedness can be successful only if managers at every organizational level support crisis management in all phases, and especially in crisis response phase (Sapriel, 2010: 29). In essence, the role of crisis manager is of a key importance in creating

organizational crisis preparedness, that is in cases of absence of planning and inadequate preparedness crises managers can further escalate the problems.

According to the information provided by FEMA (2011), based on previously conducted research, only 29% of firms in U.S. enable partial or complete training for their employees in business continuity, which indicates a high general level of crises unpreparedness. In accordance with the mentioned, organizations are capable of learning from previous mistakes and avoid the same or similar situations in future through recognizing and correcting the conditions which have led to mistakes at the first place (Rousaki, Alcott, 2007: 30). Previous findings on crises have found that many firms were inadequately prepared for crises and by inappropriately handling of crises have even made the situation worse.

The consequences of crises unpreparedness according to Kahn, Barton and Fellow (2013) can stir negative emotions within certain stakeholder groups, which can blame the firm for the crises, and on the other hand can contribute to a sense of guilt in persons responsible for mistakes in judgment. More so, crises situations can instill a sense of hopelessness in employees during crises times, because sometimes they cannot provide adequate response and properly manage the crises. Therefore, managers should construct the organizational systems which would ensure better crises preparedness (Carmeli, Schaubroek, 2008: 189) and enable firms to adequately assess the potential damages and needed counter measures in order to prevent the escalation of crises. Crisis management is therefore inefficient if the discipline is considered as negative and unproductive in terms of creating value, as a waste of time and as operative instead of a strategic activity (Robert, Lajtha, 2002: 185).

Effective crisis management term is important to understand and distinguish in order for firms to know which options they have available when dealing with crises. Effective crisis management considers avoiding potential crises, reduces duration and effects of crisis (Pearson, Clair, 1998: 61). Effective crisis management is a continuous improvement process, due to volatile, unexpected events which require adjustments in organizational plans (Mitroff, Shrivastava, Udwadia, 1987: 285; Brown, 2002: 21). The crucial point is in a notion that by acting proactively, organizations have better chances of preventing or properly handling crises.

Even though it can be considered that crises cannot be prevented as they often occur spontaneously, that is not entirely right, since the majority of crises are preceded by certain warning signs. For instance, large layoffs are almost always preceded by poor financial results. Recall of products is almost always a result of previous customer's complaints, etc. However, it does still not imply that the organizations would be able to spot and prevent all types of crises if we were to know the crises causes. In a significant number of cases, the inability to communicate in a crisis leads to crises escalation (Parnell, Koseoglu, Spillan, 2010: 111). Considering the complexities of today's crises, successful communication is crucial for overcoming crises problems (Sellnow, Seeger, 2013: 14). Clarity and precision is needed in crises communication. In the firms, the culture of openness and communication is especially important in times of crises (Jaques, 2011: 10). The advantages of effective crises management are reflected in better reputation, improved organizational culture, employee's cooperation and creativity.

4. Job analysis

With the development of the field, dynamic changing environment and advances in technology, it is often necessary to analyze and redefine the job requirements and methods needed for conducting the job. Therefore, job analysis allows for matching of most capable employees with employer's needs, and increasing their retention.

"Job analysis is the procedure firms use to determine the tasks, duties, and responsibilities of each job, and the human attributes (in terms of knowledge, skills, and abilities) required to perform it. Once this information has been gathered, it is used for developing job descriptions (what the job entails) and job specifications (what the human requirements are)" (Dessler, Chhinzer, Cole, 2015:49). "It includes having the skills and techniques to assess the needs and requirements of enterprises as well as the needs and capacities of job seekers" (Heron, 2005: 3). "It is a systematic process in that it follows a step-by-step approach to collect, record, analyse and interpret the information collected" (Heron, 2005: 7).

A number of authors are of belief that job analysis can be of strategic importance for HR practice, especially evident through proper workforce planning and ability to make better decisions (Siddique, 2004: 219). The purpose is in matching employees skills and capabilites with in job ad stated requirements. When jobs are in line with firm's strategy and needs, employee's knowledge and skills can have a positive effect on productivity, overall performance, competitive position, innovativeness, quality and service (Tharenou, Saks, Moore, 2007: 251-252).

Analysis of online job ads is useful in identifying skill sets used in demand for certain groups of jobs. The job description and job specification information as a result of job analysis should be used to decide what sort of person to hire (Dessler, Chhinzer, Cole, 2015:50). Job analysis information is deemed valuable, strategic and basic HR activity, which affects "HR activities of recruitment and selection strategies, training and development, performance appraisal, compensation, and health and safety requirements" (Siddique, 2004: 220).

"For enterprises, job analysis has many general uses including:

- supporting general recruitment and selection processes;
- supporting the job matching process;
- appraising staff performance;
- assisting in staff promotion exercises;
- identifying training needs" (Heron, 2005: 17).

In addition to already stated, job analysis serves as job evaluation tool, for managing labour relations, and helps in job design (Dessler, Chhinzer, Cole, 2015:49)

Second aspect of defining jobs and its requirements relates to attracting competitive employees. Properly defined job roles and specifications/expectations can have several advantages on employees' motivation, matching of employees' expectations and subsequently increased productivity (Siddique, 2004: 223).

5. Methodology

Job content analysis method was used in order to obtain valuable information about job, needed skills and employees characteristic for successfully performing job. The aim was to provide insights into crisis management assignments, as well as preferred employees characteristics and specific job responsibilities in the field of crisis management. Researching online job ads (vacancies)- helps identify mix of skills needed for jobs in the crisis management field.

Based upon the literature and terms reviewed, the crisis management related jobs were searched for on LinkedIn. Qualitative, cross sectional and convenience sample job analysis was conducted on LinkedIn on a date March 18, 2017., using initial classification keyword: crisis management.

Out of a total of 13178 jobs (12521 jobs from USA, and 657 jobs from UK) that matched in LinkedIn search criteria for keyword "crisis management", we have selected in our primary sample 250 job ads, on a basis of being the first 150 job ads that appeared by relevance criteria in USA part of sample, as well as 100 first job ads that appeared by relevance criteria in UK part of sample. We have selected geographically job ads based in US and UK due to the developed practices in crisis management, which could provide latest trends on crisis management, as well as due to the large enough available sample for analysis. Out of initial sample of 250 firms which have contained the keyword "crisis management", 51 job ads were excluded, because even though in their description they have contained the keyword "crisis management", they were not jobs from the business crisis management domain, and for instance referred to medical staff jobs, pharmaceutical jobs, hygiene testers, health and environment, social workers, psychiatrists, job safety and private security firms. Therefore, at this stage sample consisted of 199 firms. In order to gain better insight into most represented specific crisis management jobs, we have analyzed the use of the frequent concepts in crisis management, by using the following keywords: crisis management; preparedness; readiness; crisis prevention; business continuity management; issue management; disaster management; risk/threat management; contingency plans; emergency response; emergency management; business continuity management; resilience; crisis communication; business recovery; safety management.

Through conduced analysis and insight on obtained data through frequencies of ads, we have identified 4 major categories/ streams: crisis management; crisis communication; risk management; business continuity and resilience. In addition, some job ads were excluded on a basis of incomplete information as well as misspecification. Final sample consisted of 127 job ads (comprising of job ads matching descriptions for- crisis management 36 job ads, crisis communication 47 job ads, business continuity and resilience 26 job ads, and risk management 18 job ads).

From the final sample we have accordingly analyzed the following categories: employee assignments, scope of activities, technology, instruments and methods used, knowledge and education, skills and competences, experience.

6. Analysis

The following section analyzed job ads from the final sample classified under 4 major categories: crisis management, crisis communication, risk management, business continuity and resilience. The subsequent job ad categories were analyzed: specified job certificates reqired; specified skills required; specified years of experience required; required degree; job titles, descriptions and skills; as well as propositions of optimal job description for each of the 4 major keywords and its most offered job.

6.1. Crisis management

From the analysis of job ads classified under term "crisis management" the following summary follows: four most wanted job skills in frequency of appearance are interpersonal skills (84%), verbal communication skills (81%), tehnical/computer skills (55%), research, problem solving and analytical skills (48%). Most frequent desirable minimum years of experience is 4 years, however most of ads have described expected experience or do not have specified work experience. Master's degree was required in 8% of job ads. Most of jobs require Bachelor's degree. Only 16,67% of all job ads with key word "crisis management"

have word "crisis" in job title. Jobs with keywords "crisis management" are mainly related to industries such as banking, consulting, recruitment and networking.

From the analysis of job ads classified under term "crisis communication" the following summary follows: four most wanted job skills in frequency of appearance are interpersonal skills (83%), communication skills- verbal (76%), written (71%) and organizational and planning skills (48%). In addition, 81% of job ads contain interpersonal skills as the skills required for a particular job. Most frequent desirable minimum years of experience are 5 and 10 years depending on the seniority of position and industry, but most of ads have described or do not have specified work experience. In a sample, there is no job which require Master's degree. Most jobs do not have a desired degree specification. 48,94% of job ads with word "crisis communication" refers to job title "public affairs manager". Jobs with keywords "crisis communication" are mainly related to companies such as PR/Marketing/Public affair agencies, law firms, telecommunications companies, companies engaged in manufacturing and distributing products.

This analysis provides information that number of years is a relatively important feature when posting a job ad. The most sought-after certificates for Business Continuity are DRI certificates, i.e. Disaster Recovery Institute certificates such as Associate Business Continuity Professional (ABCP), Certified Business Continuity Professional (CBCP), Master Business Continuity Professional (MBCP) etc. The most preffered business continuity skills are interpersonal skills with 22,37% such as the ability to work in a high pressure environment, ability to build strong relationships in a complex business environment, to be self-motivated and work effectively as an individual contributor, to have patience and ability to prioritize, ability to manage multiple tasks successfully, ability to question the status quo. Other most wanted skills are verbal communication and presentation skills with 18,42%, tehnical/computer skills with 15,79% and writing skills with 11,84%. There are 16 out of 26 job ads that require only Bachelor's degree which is exactly 61,54%, while Master's degree was required by only one company in a sample. The largest number of job ads are tied to the IT industry, which dominates job-related business continuity and resilience ads. The most offered job related to the keyword "business continuity" is Business Continuity Analyst.

The keyword "risk management" requires more descriptive years of experience (through skills, competencies etc.) and it counts for 50% of job ads. There were 10 out of 18 job ads that required only Bachelor's degree which is exactly 55,56%, while Master's degree was not required at all. Other job ads either did not specify which degree they are looking for or did

not write it in the ad. The largest number of job ads are tied to financial sevices, which predominates job-related "risk management" ads. The most offered job related to the keyword "Risk Management" is Risk Manager.

7. Limitations and recommendations for further research

Conducted research presents an initial, exploratory effort to analyze crisis management jobs and trends, whereas the conducted research consisted of a relatively small number of analyzed job ads, also narrowed to two analyzed countries, which limits the representativeness and generalizability of results. In our research we have used a convenience sample, and not a random one which has its limitations on making inferential statements and conclusions. Also, a non-exhaustive list of crisis management jobs and activities was used in job analysis LinkedIn search. In addition, since conducted job analysis was qualitative in nature, the results are impacted by researchers' decisions bias. Furthermore, there are also other sources available on employee's skills, competences and knowledge besides the mentioned LinkedIn job ads. They can include recruiting agencies, specialized websites, etc. (Kennan, et al., 2006). Nevertheless, in spite of identified research limitations, conducted initial research provides basic information and could encourage further studies in the field.

Jobs are shifting in their requirements and are ever more interdisciplinary and interconnected. A further research could go in direction of providing an answer whether crisis management jobs will be more specialized or more general in scope of activities? For that purpose, the scope of research could be extended to interviews with experts and practitioners in the field in order to obtain more detailed information.

Further research could also be focused on evaluation of scientific publications in databases in order to find what the academics are focusing on in researching the field, as well as compare the results of academic research to practitioner's demands and see if they are congruent. Also, in future research the aim could be to understand- to what extent are the needed skills delivered by the universities? Another potentially interesting stream of research would be to determine what are the future roles which crisis managers should have and how the crisis management field could develop?

Accordingly, crisis management research, due to its importance and transformation, will most likely be of interest in the upcoming years to many researchers.

8. Conclusion

Professions change and evolve over time. Accordingly, crisis management is going through a transformative stage, and as such there remains a significant amount of research to be conducted and information needed on how to appropriately structure job ads in order to attract skilled and experienced workers. The primary research question was, what is demanded from today's employees in the field of crisis management? In order to answer this question, job advertisements analysis on LinkedIn collected data was conducted. We can infer the following.

Since crisis management is said to be a highly responsible, tactical job where every mistake is costly paid, the required profiles of crisis management employees are most often related to their strong interpersonal skills (such as the ability to work in a high-pressure environment,

strive for self-fulfillment, posses patience and ability to prioritize, have ability to question the status quo, etc.).

In addition, through the required years of experience, employers are looking for potential employees who will bring previous work experience on a new job and therefore be ready for expected challenges. The level of responsibility is high, the level of risk that the employee takes on himself is also particularly high, so employers look in advance for certain skills and competencies that must be met and that is how they immediately reduce the number of registered jobseekers who may, unfortunately, not have enough knowledge or experience.

Crisis management often needs experts from financial services, banking, IT industry, pharmaceutical industry and more. We can conclude that the emphasis is on experience, certain skills and demanding certifications, while expected level of education is usually reduced only to Bachelor's degree.

Skills supply and demand mismatch, requires advancement of new skills through education and training. The curricula itself in today's environment should be flexible and able to adapt to constantly changing trends, firms need and information dissemination channels (Wise, Henninger, Kennan, 2011). Study results comprising of employers' information on required knowledge, skills and competencies can serve as means of improving educational curriculum whereas educational institutions can better adjust in line with new demand for crisis management employees.

Conducted job analysis shed light on crisis management profession, and its demand for expertise. It provides indications of new trends in crisis management and informs on what preferred candidates/employees should possess in terms of skills and qualifications. Such information helps us better understand what employers require from new employees and contributes to HR field as well.
