# Exploring the use of ICTs by measuring the perceived impact of ICTs by users: Analysis of nationally representative data from India, Pakistan, Bangladesh and Cambodia<sup>1</sup>

#### Abstract

The research quantitatively identifies the effect of willingness to use ICT by measuring the perceived impact of ICTs by users in India, Pakistan, Bangladesh and Cambodia. The study attempts to model the relationship between the perceived impacts of access to mobile phones and the adoption of ICT services (including mobiles) using two approaches. First, following the approach used by de Silva et al., and others who find a positive relationship between perceived impacts and adoption, we model mobile phone adoption using a binary logistic approach. Finding that this relationship is not evident in the study countries in our research conducted in 2017, we further investigate the relationship by developing an index to assess ICT adoption and explore its relationship with the perceived impacts of mobile access using a multiple regression model. The multiple regression also shows that perceived impacts have only minimal influence on ICT adoption.

## 1. Introduction

It is well accepted that access to and use of ICTs is a prerequisite to human development. Without connectivity, people, be it as consumers, workers or entrepreneurs, face barriers to participating in the economic and social networks that permeate modern societies (World Bank, 2016). ICT has been defined as a blend of technology and communication (World Bank, 2010). Be it a radio, television, phone, smartphone, computer or the Internet, the adoption of ICTs at the time of the introduction of technology is influenced by the perceived impact of the ICT by the users, or as Davis term it in the Technology Adoption Model (TAM), the perceived usefulness of the technology (1989). Previous studies have found links between mobile phone adoption and economic growth. Mobile phones have improved communication, social inclusion, economic activity and productivity in many sectors.<sup>2</sup> De Silva, Ratnadiwakara and Zainudeen (2009), following the approach taken by Chabossou, Stork, Stork, and Zahonogo (2009), studied the various influences and the interplay of these influences on mobile phone adoption by the poor in a selected set of countries in the emerging Asian region. As ICT contributes to development as a whole, we further study this phenomenon using a 2017 nationally representative dataset in four countries, three of which are also covered by de Silva et al. This research investigates the importance perceived impacts play on individual's adoption of mobile phones and ICTs. We explore the perceived impact of mobiles and ICTs by users and investigate the contribution of perceived impact for the take up of mobiles and ICT for their day-to-day life by studying ICT users and non-users in India, Pakistan, Bangladesh and Cambodia.

## 2. Theoretical background

Adoption literature comes from three schools of thought namely, diffusion, adoption and domestication (Pedersen and Ling, 2002). Based on adoption and domestication school of thought Van Biljon and Kotze (2008) has conceptualized mobile phone usage in technology acceptance model (TAM; Davis, 1989). This model includes perceived usefulness in a multi-dimensional setting looking at factors such as income, socio-cultural factors and gender. TAM includes a number of determining factors that influence mobile phone adoption and use. Specifically, social influence, perceived usefulness and perceived ease of use. The model also consists of mediating factors, such as personal factors, demographic factors and occupation and income. Over time, TAM has been updated and

modified, with the inclusion of additional factors and modification of existing ones. De Silva et el. (2009) incorporate the perceived usefulness through the inclusion of three indices based on how respondents view improvements in various aspects of their lives due to mobile access; namely, emergency, social and economic perceived benefit indices. They used a binary logistic (or Logit) model to identify the effect if perceived had any relationship with mobile phone adoption. Logit modeling uses exponential functions to allow for a dependent variable between 0 and 1 explaining the probability of adoption or discriminant analysis which classifies a set of observations into predefined classes are generally used. We follow this approach. Then, to identify the relationship between the ICT usage index developed and perceived usefulness, we use multiple linear regression analysis (MLR), which is adequate for these purposes and has been used in previous studies.<sup>3</sup> Multiple linear regression analysis is used as the "is a statistical tool for the investigation of relationships between variables" (Sykes, 1993, p. 1). It aims to establish the effect of independent variables on a dependent one (Tabachnick & Fidell, 2007)

# 3. Methodology, Data and Descriptive Statistics

The paper has used data gathered by nationally representative ICT access and use surveys with a margin of error +/- 3% at national level conducted in India, Pakistan, Bangladesh and Cambodia during Q3-4 in 2017. This survey covered 100% of age 15-65 population in these countries. It contained modules of household information, demographic information, income and expenditure, social activities, mobile phone use, no mobile use, Internet, non-Internet use, use of social media, non-use of social media, perceived impact of ICTs, e-Government, e-Commerce and online harassment. This survey has sample size of 11,000 individuals in all study countries. This study has used the module on perceived impact of ICTs.

## 4. Statistical Model for Mobile Phone Adoption

## 4.1 Logistic regression model for mobile adoption

Logit models tie the determining and mediating factors to the latent variable (i.e. mobile adoption) through contributions to the probability of the latent variable taking a value above or below a threshold that would lead to the observable outcome: adoption or not. Therefore, the logit model assigns a probability of adoption of mobile phones based on the various determining and mediating factors postulated in the theoretical model, where the probability of adoption (Y) is given by:

Probability (Y) =

Where Y is mobile adoption and (a dichotomous variable taking the value 1 if the respondent owns a phone and 0 if the respondent does not) and Xi are the factors that impact such adoption (also referred to as determining and mediating factors or influential factors). By values are factor sensitivities of each

influential factor, Xi. Influential factors, Xi, can be quantitative or qualitative variables; dummy variables are used to represent the 'states' in case of qualitative variables. Logistic regression was used to model the mobile phone adoption.

# 4.1 Multiple linear model

The multiple linear model is specified as follows:

Multiple linear regression was used to model the usage and adoption of ICT.

# 5.0 Findings

The influential variables, Xi, used in the study as well as their expected signs are given below in Table 2.

The influential variables are self-explanatory and the expected signs are logical. Country dummies capture the unique characteristics in each country such as culture, perception, different needs etc. de Silva, Ratnadiwakara and Zainudeen (2009) developed a logit model for mobile adoption for the 'bottom of the pyramid' (BOP, the lower income market segment) in Bangladesh, Pakistan, Sri Lanka, Philippines and Thailand using data collected from the BOP in 2008. Emergency, social and economic perceived benefits indices were significant in their model and gave positive coefficients to mobile phone adoption. We ran a similar model to our data set to see whether similar findings were evident in the current context.

The logistic regression model of mobile phone adoption using the same variables as de Silva 2009. The Nagelkerke R Square for this model is .263 which implies a moderate fit of the model.

Starting with the gender variable in the model, odds of female mobile adoption is 46% less than odds of male mobile adoption. When the age increases the odds of mobile phone adoption increases slightly. When the education level of the individuals increase, the odds of mobile adoption increases. If the individuals education level is tertiary the odds of mobile adoption is 4 times than non-educated person. Income increases the probability of adoption, with the natural log of monthly personal income having an odds ratio of 1.371. Odds of adopting a mobile phone increases by 29% when 1 of the closest contacts owns mobile phones.

As per the model, availability of electricity was not significant in the mobile phone adoption. However, other variables related to household access to ICT devices such as fixed line telephone, television and radio show positive coefficients in the mobile phone adoption model. But unlike de Silva et al (2009) all perceived impact variables were not significant in this model. Possible reasons for this might be the target group of the 2009 study was BOP population but in the 2017 study the target group is all economic segments of the population. Alternatively, as the previous study was conducted almost a decade ago, with time the influence of perceived impacts on mobile phone adoption may have become less significant.

To further analyze the question, we included additional variables related to perceived impacts of ICTs. As the previous study captured economic, emergency and social PBI, we introduced knowledge PBI to the model as a perceived benefit. As there were no negative impacts were captured in the previous study, negative impacts were introduced in our study such as, '[Mobiles] cause people to become divided, socially politically, etc.,' 'people get addicted to using them,' 'children are exposed to inappropriate content' and 'private information can be seen by others through the mobile and Internet.'

Adding these five new perceived impact variables did not improved the fit of the model. All the variables related to perceived impacts were not significant in this logistic regression model as well. Nagelkerke R Square for this model is .259. Other coefficients are similar to the previous model.

As perceived impacts does not influence mobile phone adoption, we then explored whether they influence the ICT usage of individuals. Two new variables, "Number of top five contacts having an email account" and "Number of top five contacts have used social media" were considered as predictor variables for ICT usage. Those will represent the social influence on Internet usage and social media usage.

An index was formed to indicate the level of usage of individuals based on following variables Table 6: Variables used to create the ICT usage index

The summation of above variable was divided by the maximum score of the index of each country to derive the index. The index will range from 0 to 1 where 0 will indicate individuals with no ICT usage and 1 will indicate the heaviest users of ICT for the respective countries based on the variables mentioned above.

As per the above table the index shows that the distribution of the index variable is somewhat similar in the South Asian countries but it is relatively high in Cambodia with a larger standard deviation. As the developed index is a scale variable which can be used as an indicator for the ICT usage of

individuals multiple linear regression model was used for the analysis. The derived index will serve as the dependent variable in the multiple linear regression model.

Four multiple linear regression models were developed for each study country. The model fit for these four models are shown in the below table.

The model behaves differently to each country. The coefficients will be explained by variable.

- Gender: Being a female decreases the ICT usage index by 5% in India and Cambodia while for other countries gender variable is not significant index by less than 1% Cambodia, Pakistan and India. Age is not a significant variable in Bangladesh.
- Income: Income is significant in all four countries and it has a positive influence on the ICT usage variable
- Education: Education has the highest coefficient in the model. Only tertiary education
  is significant in Bangladesh. For India primary education is not a significant variable
  as per the model. For Cambodia and Pakistan, all 3 levels of education are significant.
- Number of top 5 contacts have used social media: This is a significant variable for all 4 countries which has a positive influence on the ICT usage variable.
- Number of top 5 contacts having a mobile phone and email: In Pakistan these two variables are significant with positive influence on the dependent variable
- Perceived impact of knowledge: This is positively influenced the ICT usage variable in Bangladesh, Cambodia and India
