





Appendix A Within-cluster Homogeneity

The following graphics present the relative frequency plots of the clustering solution. These figures allow visualizing the within cluster heterogeneity of each cluster while still avoiding over-plotting (Fasang and Liao 2014). We used k=50 sequences to represent the diversity of each cluster. The subsequences are sorted using multidimensional scaling as suggested by Fasang and Liao (2014).









■ Education □ OE (Out of Employment) □ Employment






Figure A2: Subsequences Clusters: Index plots of the subsequences in each cluster departing from a specific state sorted by the observed state at the successive positions starting from the beginning of the sequences. Source: NEPS data.

The subsequences are clustered irrespective of the starting age of the subsequences included in each cluster. Figures A3 present index plots of each cluster ordered by age. As it should be, within cluster heterogeneity seems not to be linked to age. In other words, within each cluster, we do not find different types of subsequences according to ages.







Appendix B Robustness Checks Details

We checked whether each statement made in our interpretation of the SAMM procedure's results holds with different subsequence length ℓ . The following table summarizes these

robustness checks.
