1 Overview

HBRUTTO covers all households, who were successfully interviewed or were contacted for the purpose of being interviewed again.

The data sets provide gross cross-sectional information on all SOEP households' interviews as well as their positions in the panel frame work. Therefore, the variables HID, SAMPLE1, and CID are included in the datasets.
