#### Abstract

This supplemental material has the following content: (1) proofs of all the theoretic results in the main paper; (2) a set of low-level conditions that imply Definition 5.1 (iii) in the main paper; (3) an example where point-identification is achieved with a shape restriction, while one cannot rule out any point in the parameter space without the shape restriction; (4) examples to illustrate that either my method nor CNS dominates the other.


I start with introducing some additional notation used in this supplemental material. Let $\left\{\delta_{n}\right\}_{n=1}^{\infty}$ be a sequence of nonnegative numbers and $X_{n, F}$ be a sequence of random variables indexed by $n$ and $F$. Say $X_{n, F}=O_{\mathbb{P}_{F}}\left(\delta_{n}\right)$ uniformly in $F \in \mathcal{F}$ if and only if (iff) for every $\epsilon>0$, there exists $M<\infty$ such that lim $\sup _{n \rightarrow \infty} \sup _{F \in \mathcal{F}} \mathbb{P}_{F}\left(\left|X_{n, F}\right|>M \delta_{n}\right)<$ $\epsilon$ and $X_{n, F}=o_{\mathbb{P}_{F}}\left(\delta_{n}\right)$ uniformly in $F \in \mathcal{F}$ iff for all $M>0, \lim \sup _{n \rightarrow \infty} \sup _{F \in \mathcal{F}} \mathbb{P}_{F}\left(\left|X_{n, F}\right|>\right.$ $\left.M \delta_{n}\right)=0$. Similarly, $X_{n, F, R}=O_{\mathbb{P}_{F}}\left(\delta_{n}\right)$ uniformly in $(F, R) \in \mathcal{J}$ iff for every $\epsilon>0$, there exists $M<\infty$ such that $\limsup _{n \rightarrow \infty} \sup _{(F, R) \in \mathcal{J}} \mathbb{P}_{F}\left(\left|X_{n, F, R}\right|>M \delta_{n}\right)<\epsilon$ and $X_{n, F, R}=$ $o_{\mathbb{P}_{F}}\left(\delta_{n}\right)$ uniformly in $(F, R) \in \mathcal{J}$ iff for all $M>0, \limsup _{n \rightarrow \infty} \sup _{(F, R) \in \mathcal{J}} \mathbb{P}_{F}\left(\left|X_{n, F, R}\right|>\right.$ $\left.M \delta_{n}\right)=0$. Because $(F, R) \in \mathcal{J}$ implies $F \in \mathcal{F}, X_{n, F}=O_{\mathbb{P}_{F}}\left(\delta_{n}\right)\left(X_{n, F}=o_{\mathbb{P}_{F}}\left(\delta_{n}\right)\right)$ uniformly in $(F, R) \in \mathcal{J}$ if $X_{n, F}=O_{\mathbb{P}_{F}}\left(\delta_{n}\right)\left(X_{n, F}=o_{\mathbb{P}_{F}}\left(\delta_{n}\right)\right)$ uniformly in $F \in \mathcal{F}$. Lastly, $X_{n}$ is $O_{\mathbb{P}^{*}}\left(\delta_{n}\right), \mathbb{P}_{F}$ almost surely iff given any $\epsilon>0$, for almost every sample realization under $\mathbb{P}_{F}$, there exists an $M>0$ such that $\lim _{n \rightarrow \infty} \mathbb{P}_{F_{n}}\left(X_{n}>M \delta_{n}\right)<\epsilon$, where $\mathbb{P}_{F_{n}}$ is induced by the empirical distribution. Similarly, $X_{n}$ is $o_{\mathbb{P}^{*}}\left(\delta_{n}\right), \mathbb{P}_{F}$ almost surely iff for almost every sample realization under $\mathbb{P}_{F}, \lim _{n \rightarrow \infty} \mathbb{P}_{F_{n}}\left(X_{n}>M \delta_{n}\right)=0$ for all $M>0$.

For any function $g: \ell^{\infty}(\boldsymbol{\Theta} \times \mathbf{T}) \rightarrow \mathbb{R}$, let $q(1-\alpha, g, F)$ be the $1-\alpha$ th quantile of $g\left(\mathbb{G}_{F}\right)$ and $q_{n}^{*}(1-\alpha, g)$ be the $1-\alpha$ th quantile of $g\left(\mathbb{G}_{n}^{*}\right)$. And $\mathbf{l}(\cdot)$ is the indicator function which takes value 1 if the event in the bracket is true and value 0 if otherwise.

Other notation can be found in Table S.1, and the text and Appendix A of the main paper. Assumptions B.1-B. 7 can be found in Appendix B of the main paper.

## S.1. Identification power of shape restrictions

It is commonly known that shape restrictions can play an important role for identification in structural models, for example, in BLP estimation and auctions; see Gandhi, Lu, and Shi (2013), Zhu and Grundl (2014), Komarova (2013), and Fan, He, and Li (2015). But

even in the simple non-parametric IV regression model, shape restrictions can greatly help identification. In extreme cases, without shape restrictions, the parameter of interest is not identified at all, that is, one cannot rule out any point from the parameter space. But once a shape restriction is imposed, the parameter of interest is pointidentified. This section provides such an example.

Consider the setup in Example 2.1 in the main paper where the joint distribution of ( $X, Y, Z$ ) is such that

$$
Z \sim \text { Uniform }[0,1], \quad X \mid Z \sim \operatorname{Uniform}[Z, Z+1] .
$$

And $\epsilon$ can be arbitrarily correlated with $X$ but satisfies $\mathbb{E}_{F}(\epsilon \mid Z)=0$. For example, $\epsilon=$ $Z\left(X-Z+\epsilon_{1}-1 / 2\right)$, where $\epsilon_{1}$ is a random variable with mean 0 and independent of both $X$ and $Z$. From this point on, I restrict $\theta_{F}$ to be a bounded continuous function and the parameter of interest is $\theta_{F}\left(x_{0}\right)$ for some $x_{0} \in[0,2]$.

Suppose that one uses the conditional moment restriction

$$
\begin{equation*}
\mathbb{E}_{F}[Y-\theta(X) \mid Z]=0 \tag{S.1}
\end{equation*}
$$

Then the identified set of $\theta_{F}\left(x_{0}\right)$ is $(-\infty, \infty)$. To see this, notice that $\theta=\theta_{F}+\tilde{\theta}$ satisfies equation (S.1) iff $\mathbb{E}_{F}[\tilde{\theta}(X) \mid Z]=0$, which holds iff $\tilde{\theta}$ is a periodic function with period 1 and $\int_{0}^{1} \tilde{\theta}(x) d x=0$. For any real number $a$, there exists such a $\tilde{\theta}$ with $\tilde{\theta}\left(x_{0}\right)=a$. Hence, $\theta_{F}\left(x_{0}\right)$ can take any value in $(-\infty, \infty)$.

Now suppose $\theta_{F}$ is weakly increasing and is constant on $[b, c] \subseteq[0,2]$ with $c-b \geq 1$. After imposing the weakly increasing restriction, $\theta_{F}\left(x_{0}\right)$ is point-identified. To see this, first notice $\tilde{\theta}$ has to be a constant function. Otherwise, $\tilde{\theta}$ must decrease in some region of $[b, c]$ because it has period 1 , which means that $\theta_{F}+\tilde{\theta}$ is not weakly increasing. Then $\int_{0}^{1} \tilde{\theta}(x) d x=0$ suggests that $\tilde{\theta}=0$ and $\theta_{F}$ is point-identified.

## S.2. Choices of $\Theta$ and low-level sufficient conditions for Definition 5.1 (iii)

Define $\Lambda=\left(\Lambda_{1}, \Lambda_{2}, \ldots, \Lambda_{D_{W}}\right)$ to be a $D_{W}$-dimensional vector of nonnegative integers and $w=\left(w_{1}, w_{2}, \ldots, w_{D_{W}}\right) \in \mathcal{W}$ to be a $D_{W}$-dimensional vector of real numbers. Let $|\Lambda|=\sum_{i=1}^{D_{W}} \Lambda_{i}$ and $d^{\Lambda} f=\partial^{|\Lambda|} f(w) / \partial^{\Lambda_{1}} w_{1} \cdots \partial^{\Lambda_{D_{W}}} w_{D_{W}}$ where $f: \mathcal{W} \rightarrow \mathbb{R}$ is a function.

Introduce the norms

$$
\begin{aligned}
\|f\|_{c} & =\max _{|\Lambda| \leq m} \sup _{w \in \mathcal{W}}\left|d^{\Lambda} f(w)\right|\left(1+w w^{\prime}\right)^{\delta / 2}, \\
\|f\|_{\text {sob }}^{2} & =\int \max _{|\Lambda| \leq m+m_{0}}\left|d^{\Lambda} f(w)\right|^{2}\left(1+w w^{\prime}\right)^{\delta_{0}} d w,
\end{aligned}
$$

where $m$ and $m_{0}$ are two integers. Let $\mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W})=\left\{f: \mathcal{W} \rightarrow \mathbb{R}\right.$ s.t. $\left.\|f\|_{\text {sob }} \leq \mathbf{B}\right\}$ where $0<$ $\mathbf{B}<\infty$ is a known constant. Define $\Theta=\Theta^{P} \times \mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W})^{D_{N}}$ where $\Theta^{P}$ is a compact subset of $\mathbb{R}^{D_{P}}$ and $D_{N}$ is a positive integer. In addition, let $\theta=\left(\theta^{P}, \theta^{N}\right)$ where $\theta^{P} \in \Theta^{P}$ and $\theta^{N} \in \mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W})^{D_{N}}$. Define

$$
\begin{aligned}
\|\theta\|_{s} & =\|\theta\|_{\infty}=\max \left\{\left\|\theta^{P}\right\|_{\infty, E}, \sup _{w \in \mathcal{W}}\left\|\theta^{N}(w)\right\|_{\infty, E}\right\} \\
& =\max \left\{\left\|\theta^{P}\right\|_{\infty, E}, \sup _{w \in \mathcal{W}}\left|\theta_{1}^{N}(w)\right|, \sup _{w \in \mathcal{W}}\left|\theta_{2}^{N}(w)\right|, \ldots, \sup _{w \in \mathcal{W}}\left|\theta_{D_{N}}^{N}(w)\right|\right\},
\end{aligned}
$$

where $\|\cdot\|_{\infty, E}$ is the sup norm in the Euclidean space and $\theta_{j}^{N}(w)$ is the $j$ th element of $\theta^{N}(w)$. The following is Assumption 2.1 in Santos (2012).

Assumption S.1. (i) For $\mathcal{W}$ bounded, $\delta_{0}=\delta=0$ and $\min \left\{m_{0}, m\right\}>D_{W} / 2$, while for $\mathcal{W}$ unbounded, $m_{0}>D_{W} / 2$ and $D_{W}(m+\delta) /(m \delta)<2$ and $\delta_{0}>\delta>D_{W} / 2$. (ii) $\mathcal{W}$ satisfies a uniform cone condition.

Santos (2012) showed that under Assumption S.1, $\mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W})$ is compact under $\|\cdot\|_{c}$. Since $\|\cdot\|_{c}$ is stronger than the sup norm, $\mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W})$ is compact under the sup norm. Therefore, $\Theta$ is compact under $\|\cdot\|_{s}$ as it is a product of compact spaces. Moreover, suppose that the shape restriction is

$$
R=\left\{\theta: \partial \theta_{1}^{N}(w) / \partial w_{1} \geq 0, \forall w \in \mathcal{W}\right\} .
$$

Because partial differentiation operators are continuous with respect to $\|\cdot\|_{c}, R$ is closed under $\|\cdot\|_{c}$. This implies that $\Theta \cap R$ is compact under $\|\cdot\|_{c}$, and therefore compact under $\|\cdot\|_{s}$. If $R$ involves higher-order derivatives, one needs to adjust $\Theta$ accordingly to satisfy Assumption B.1(i). Suppose $\mathbf{t} \in \mathbf{T}$ is a $D_{\mathbf{t}^{-}}$-dimensional real vector. Define $\mathbf{N}(\epsilon, \Theta \times \mathbf{T}$, $\|\cdot\|_{s}+\|\cdot\|_{E}$ ) to be the smallest $\epsilon$-covering number of $\Theta \times \mathbf{T}$ under $\|\cdot\|_{s}+\|\cdot\|_{E}$.

Lemma S.1. Under Assumption S.1, if $\mathbf{T}$ is a bounded subset of $\mathbb{R}^{D_{\mathbf{t}}}$, then

$$
\int_{0}^{\infty} \sqrt{\ln \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right)} d \epsilon<\infty .
$$

Proof. Lemma A. 3 in Santos (2012) shows that

$$
\begin{aligned}
& \ln \mathbf{N}\left(\epsilon, \mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W}),\|\cdot\|_{\infty}\right) \leq K_{1}\left(\frac{1}{\epsilon}\right)^{D_{W}(m+\delta) /(\delta m)} \quad \text { if } \mathcal{W} \text { unbounded, } \\
& \ln \mathbf{N}\left(\epsilon, \mathcal{E}_{\mathbf{B}}^{\text {sob }}(\mathcal{W}),\|\cdot\|_{\infty}\right) \leq K_{2}\left(\frac{1}{\epsilon}\right)^{D_{W} / m} \quad \text { if } \mathcal{W} \text { bounded, }
\end{aligned}
$$

where $\mathbf{N}\left(\epsilon, \mathcal{E}_{B}^{\text {sob }}(\mathcal{W}),\|\cdot\|_{\infty}\right)$ is the smallest $\epsilon$-covering number of $\mathcal{E}_{B}^{\text {sob }}(\mathcal{W})$ under $\|\cdot\|_{\infty}$. Notice that

$$
\begin{aligned}
\mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right) & <\mathbf{N}\left(\frac{\epsilon}{2}, \Theta,\|\cdot\|_{s}\right) \mathbf{N}\left(\frac{\epsilon}{2}, \mathbf{T},\|\cdot\|_{E}\right) \\
& \leq \mathbf{N}\left(\frac{\epsilon}{2}, \Theta^{P},\|\cdot\|_{\infty, E}\right) \mathbf{N}\left(\frac{\epsilon}{2}, \mathbf{T},\|\cdot\|_{E}\right) \mathbf{N}\left(\frac{\epsilon}{2}, \mathcal{E}_{\mathbf{B}}^{\mathrm{sob}}(\mathcal{W}),\|\cdot\|_{\infty}\right)^{D_{N}}
\end{aligned}
$$

Therefore, there exists a constant $K$ such that

$$
\begin{aligned}
& \ln \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right) \leq K\left(\frac{1}{\epsilon}\right)^{D_{W}(m+\delta) /(\delta m)} \quad \text { if } \mathcal{W} \text { unbounded, } \\
& \ln \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right) \leq K\left(\frac{1}{\epsilon}\right)^{D_{W} / m} \quad \text { if } \mathcal{W} \text { bounded. }
\end{aligned}
$$

Let $M=\max _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left(\|\theta\|_{s}+\|\mathbf{t}\|_{E}\right)$. Then under Assumption S.1,

$$
\int_{0}^{\infty} \sqrt{\ln \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right)} d \epsilon \leq K \int_{0}^{M}\left(\frac{1}{\epsilon}\right)^{\eta} d \epsilon
$$

where $\eta=D_{W}(m+\delta) /(2 \delta m)$ if $\mathcal{W}$ is unbounded and $\eta=D_{W} / 2 m$ if $\mathcal{W}$ is bounded. Because $\eta<1$ by Assumption S.1, the right-hand side equals $K M^{1-\eta} /(1-\eta)<\infty$.

Assumption S.2. $\rho_{\mathbf{t}}$ and $\mathcal{F}$ satisfy (i) $\rho_{\mathbf{t}}(\cdot, \theta)$ is measurable for all $(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}$. (ii) $\sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\rho_{\mathbf{t}}(\cdot, \theta)\right| \leq \mathbf{F}(\cdot)$ for some function $\mathbf{F}$. (iii) There exists $\mathbf{L}(\cdot)$ such that $\sup _{F \in \mathcal{F}} \mathbb{E}_{F} \mathbf{L}\left(W_{i}\right)^{2}<\infty$ and

$$
\left|\rho_{\mathbf{t}_{1}}\left(\cdot, \theta_{1}\right)-\rho_{\mathbf{t}_{2}}\left(\cdot, \theta_{2}\right)\right| \leq \mathbf{L}(\cdot)\left[\left\|\theta_{1}-\theta_{2}\right\|_{s}+\left\|\mathbf{t}_{1}-\mathbf{t}_{2}\right\|_{E}\right] .
$$

(iv) $\lim \sup _{M \uparrow \infty} \sup _{F \in \mathcal{F}} \mathbb{E}_{F} \mathbf{F}\left(W_{i}\right)^{2} \mathbf{1}\left\{\mathbf{F}\left(W_{i}\right)>M\right\}=0$.

Assumption S.2(iii) is a uniform version of the standard smoothness assumption on the moment functions. Assumption S.2(iv) is a uniform integrability condition, which holds if $\sup _{F \in \mathcal{F}} \mathbb{E}_{F} \mathbf{F}\left(W_{i}\right)^{2+\delta}<\infty$ for some $\delta>0$.

Lemma S.2. Under Assumptions S.1 and S.2, if $\mathbf{T}$ is a bounded subset of $\mathbb{R}^{D_{\mathbf{t}}}, \varrho$ is Donsker and pre-Gaussian uniformly in $F \in \mathcal{F}$.

Proof. By Assumption S.2(iii),

$$
\left\|\rho_{\mathbf{t}_{1}}\left(\cdot, \theta_{1}\right)-\rho_{\mathbf{t}_{2}}\left(\cdot, \theta_{2}\right)\right\|_{2, F}^{2} \leq \mathbb{E}_{F} \mathbf{L}\left(W_{i}\right)^{2}\left[\left\|\theta_{1}-\theta_{2}\right\|_{s}+\left\|\mathbf{t}_{1}-\mathbf{t}_{2}\right\|_{E}\right]^{2}
$$

Let $\mathbf{N}_{[]}$be the bracketing number. By Theorem 2.7.11 in Van Der Vaart and Wellner (1996),

$$
\mathbf{N}_{]}\left(2 \epsilon\left(\|\mathbf{L}\|_{2, F}+1\right), \varrho,\|\cdot\|_{2, F}\right) \leq \mathbf{N}_{[]}\left(2 \epsilon\|\mathbf{L}\|_{2, F}, \varrho,\|\cdot\|_{2, F}\right) \leq \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right) .
$$

Without loss of generality, assume that $\mathbf{F}(\cdot) \geq 1$. This is because one can always redefine the envelope function to be $\max \{\mathbf{F}(\cdot), 1\}$. Then

$$
\begin{aligned}
& \int_{0}^{\infty} \sup _{F \in \mathcal{F}} \sqrt{\ln \mathbf{N}_{[]}\left(\epsilon\|\mathbf{F}\|_{2, F}, \varrho,\|\cdot\|_{2, F}\right)} d \epsilon \\
& \quad \leq \int_{0}^{\infty} \sup _{F \in \mathcal{F}} \sqrt{\ln \mathbf{N}\left(\frac{\epsilon\|\mathbf{F}\|_{2, F}}{2\left(\|\mathbf{L}\|_{2, F}+1\right)}, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right)} d \epsilon \\
& \quad \leq \sup _{F \in \mathcal{F}} \int_{0}^{\infty} \frac{2\left(\|\mathbf{L}\|_{2, F}+1\right)}{\|\mathbf{F}\|_{2, F}} \sqrt{\ln \mathbf{N}\left(\epsilon, \Theta \times \mathbf{T},\|\cdot\|_{s}+\|\cdot\|_{E}\right)} d \epsilon,
\end{aligned}
$$

which is bounded by Lemma S.1. Also by Assumption S.2, $\lim _{M \rightarrow \infty} \sup _{F \in \mathcal{F}} \mathbb{E}_{F} \mathbf{F}^{2} \times$ $\mathbf{1}(\mathbf{F}>M)=0$. Then Theorem 2.8.4 in Van Der Vaart and Wellner (1996) implies that $\varrho$ is Donsker and pre-Gaussian uniformly in $F \in \mathcal{F}$.

## S.3. Asymptotic approximation of the test statistic

Theorem S.1. If Assumptions B. 1 to B. 4 hold, then:
(i) Uniformly in $(F, R) \in \mathcal{J}, T_{n}(R) \leq \Gamma_{\xi_{n}, F, n, R}\left(\mathbb{G}_{n, F}\right)+o_{\mathbb{P}_{F}}(1)$, where the inequality holds as an equality if $\vec{d}_{F}\left(\hat{\Theta}_{n}(R), \Theta_{n, F}(R)\right)=o_{\mathbb{P}_{F}}\left(\xi_{n}\right)$ uniformly in $(F, R) \in \mathcal{J}$.
(ii) If $F \in \mathcal{F}$ and $\Theta_{F} \cap R=\emptyset, T_{n} / n \rightarrow \min _{\theta \in \Theta \cap R} Q_{F}(\theta), \mathbb{P}_{F}$ almost surely.

Theorem S. 1 shows that under the null hypothesis, $\Gamma_{\xi_{n} F, n, R}\left(\mathbb{G}_{n, F}\right)$ is, at least, a conservative approximation to $T_{n}(R)$ regardless how fast $\vec{d}_{F}\left(\hat{\Theta}_{n}(R), \Theta_{n, F}(R)\right)$ vanishes. But if it vanishes fast enough, this approximation is asymptotically exact. For example, if $\left|d^{2} \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \theta_{1}+\tau\left(\theta_{2}-\theta_{1}\right)\right) / d \tau^{2}\right|_{\tau=0} \mid \leq C d_{F}\left(\theta_{1}, \theta_{2}\right)^{2}$, the approximation is asymptotically exact if $\vec{d}_{F}\left(\hat{\Theta}_{n}(R), \Theta_{n, F}(R)\right)=o_{\mathbb{P}_{F}}\left(n^{-1 / 4}\right)$. If $\rho_{\mathbf{t}}$ is linear in $\theta$, the approximation is asymptotically exact if $\vec{d}_{F}\left(\hat{\Theta}_{n}(R), \Theta_{n, F}(R)\right)=o_{\mathbb{P}_{F}}(1)$. Under a fixed alternative, $T_{n}(R)$ diverges to infinity at the rate $n$.

It is worth pointing out that the validity of the approximation does not depend on the shape of the restriction set $R$. In particular, $R$ does not need to be convex. In addition, even if Assumptions B.4(i) and (ii) are not satisfied, one can still obtain a valid uniform asymptotic approximation if one replaces the term $\frac{\sqrt{n} d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)}{d \theta}[\theta-\tilde{\theta}]$ in $\Gamma_{\xi_{n}, F, n, R}\left(\mathbb{G}_{n, F}\right)$ by $\sqrt{n}\left[\mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \theta\right)-\mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)\right]$.

Because $\Theta \cap R$ is compact and $\Theta_{F} \cap R=\emptyset$, $\min _{\theta \in \Theta \cap R} Q_{F}(\theta)>0$ by the continuity of $Q_{F}(\cdot)$. By Theorem S.1, $T_{n}(R)$ diverges to infinity at rate $n$, which is faster than $\kappa_{n}$. Therefore, the second claim holds. If $\left(0, \kappa_{n}\right) \in I_{n}$, then $T_{n}^{*}(R) \leq \int_{\mathbf{T}}\left|\mathbb{G}_{n}^{*}\left(\theta_{n}^{*}, \mathbf{t}\right)\right|^{2} d \mu=O_{\mathbb{P}^{*}}(1), \mathbb{P}_{F}$ almost surely. Hence, under a fixed alternative, the bootstrap critical value does not diverge.

## S.5. Power comparison with CNS: An example

In this section, I show that one can construct examples where for each sequence of rescaling parameters in my test, there exists a sequence of tuning parameters in CNS and a sequence of data generating processes along which the test based on CNS has better size control or power. Similarly, for each sequence of tuning parameters in CNS, one can find a sequence of rescaling parameters and a sequence of data generating processes along which my test has better size control or power.

Example S. 1 (Asymptotic Size). Consider the case where $W_{i}=\left(X_{i}, Y_{i}\right)$ is bivariate normal with the identity covariance matrix and has mean $\theta_{F_{n}}=\left(\theta_{1, n}, \theta_{2, n}\right)$ as $n \rightarrow \infty$. One would like to test $H_{0}: \theta_{F} \geq 0$ against $H_{1}: \theta_{F} \nsupseteq 0$. Then the moment conditions are $\mathbb{E}_{F}\left(W_{i}-\theta\right)=0$, where $\theta=\left(\theta_{1}, \theta_{2}\right)$. The test statistic that gives equal weights to both moment conditions is

\mathbf{V}_{n}\left(\theta_{F_{n}}\right)=\left\{\left(h_{1}, h_{2}\right): h_{1} / \sqrt{n} \geq-\theta_{1, n}, h_{2} / \sqrt{n} \geq-\theta_{2, n}\right\} .

Similarly, the bootstrap statistic with $I_{n}=\left\{\left(\sqrt{\kappa_{n} / n}, 0\right)\right\}$ is
$T_{n}^{*}(R)=\min _{\left(h_{1}, h_{2}\right) \in \mathbf{V}_{n}^{\gamma_{n}\left(\theta_{F_{n}}\right)}} \frac{\left[\frac{1}{\sqrt{n}} \sum_{i=1}^{n}\left(X_{i}^{*}-\bar{X}\right)-h_{1}\right]^{2}+\left[\frac{1}{\sqrt{n}} \sum_{i=1}^{n}\left(Y_{i}^{*}-\bar{Y}\right)-h_{2}\right]^{2}}{2}+o_{\mathbb{P}_{F_{n}}}(1)$,
where $\mathbf{V}_{n}^{\gamma_{n}}\left(\theta_{F_{n}}\right)=\left\{\left(h_{1}, h_{2}\right): h_{1} / \sqrt{n} \geq-\gamma_{n} \theta_{1, n}, h_{2} / \sqrt{n} \geq-\gamma_{n} \theta_{2, n}\right\}$.
If one follows the method proposed in CNS to estimate the local parameter space, one can obtain a bootstrap statistic

where $\hat{\theta}_{n}=\left(\hat{\theta}_{1, n}, \hat{\theta}_{2, n}\right)$ is the minimizer obtained from the minimization problem for $T_{n}(R), r_{n}$ is a sequence of positive numbers that converges to 0 , and

$$

Given $\gamma_{n}=O(\sqrt{1 / \ln n})$, let $r_{n}=1 / \gamma_{n} \sqrt{n}, \theta_{1, n}=0$ and $\theta_{2, n}=c / \gamma_{n} \sqrt{n}$ where $c$ is a constant. And let $Z_{1}$ and $Z_{2}$ be two independent standard normal random variables. Along $F_{n}, T_{n}(R)$ and $T_{n}^{*}(R)$ converge to $\min \left(Z_{1}, 0\right)^{2} / 2$ and $\left[\min \left(Z_{1}, 0\right)^{2}+\min \left(Z_{2}+c, 0\right)^{2}\right] / 2$ in distribution, respectively.

Suppose $c=1.01$. Because $\hat{\theta}_{2, n}=\theta_{2, n}+O_{\mathbb{P}_{F_{n}}}\left(n^{-1 / 2}\right)$,

converges to 1 . This suggests that along $F_{n}, T_{n, \mathrm{CNS}}^{*}(R)$ converges to $\min \left(Z_{1}, 0\right)^{2} / 2$. Therefore, $T_{n, \mathrm{CNS}}^{*}(R)$ leads to a test that has the exact asymptotic size for all $\alpha>0.5$ along $F_{n}$. On the other hand, a $10 \%$ test using $T_{n}^{*}(R)$ has a rejection probability that converges to $8.75 \%$, while a $5 \%$ test has a rejection probability that converges to $4.4 \%$. Therefore, $T_{n, \mathrm{CNS}}^{*}(R)$ has better size control.

Now suppose $c=0.99$. Given any $r_{n}$ such that $\sqrt{\ln n / n}=O\left(r_{n}\right)$, let $\gamma_{n}=1 / r_{n} \sqrt{n}$. Let $\theta_{1, n}$ and $\theta_{2, n}$ be the same as the above. Along $F_{n}, \mathbb{P}_{F_{n}}\left(\hat{\theta}_{2, n}>r_{n}\right) \rightarrow 0$ and $T_{n, \mathrm{CNS}}^{*}(R)$ converges to $\left[\min \left(Z_{1}, 0\right)^{2}+\min \left(Z_{2}, 0\right)^{2}\right] / 2$. Then a $10 \%$ test and a $5 \%$ test based on $T_{n, \mathrm{CNS}}^{*}(R)$ have asymptotic sizes $4.29 \%$ and $1.99 \%$, respectively. The corresponding values based on $T^{*}(R)$ are $8.69 \%$ and $4.37 \%$, respectively. Along this $F_{n}$, my method has better size control.

Example S. 2 (Local Power). Consider the same testing problem as in the previous example. Construct $F_{n}$ in the same way as above except that $\theta_{1, n}=-1 / \sqrt{n}$. Then $F_{n}$ is a sequence of local alternatives. Along $F_{n}$, the limiting distribution of $T_{n}(R)$ is $\min \left(Z_{1}-1,0\right)^{2} / 2$. The limiting distributions of the bootstrap statistics are the same as the ones calculated in the previous example. If $c=1.01$, a $5 \%$ test using $T_{n}^{*}(R)$ rejects with a probability converging to $36.07 \%$, while a $5 \%$ test using $T_{n, \mathrm{CNS}}^{*}(R)$ rejects with a probability converging to $38.91 \%$, which is about $3 \%$ higher. If $c=0.99$, a $5 \%$ test based on $T_{n}^{*}(R)$ has a rejection probability that converges to $35.94 \%$, while a test based on $T_{n, \mathrm{CNS}}^{*}(R)$ has a rejection probability that converges to $23.63 \%$. Now $T_{n}^{*}(R)$ has better power. A similar result holds for a $10 \%$ test.

## S.6. Useful results

The first claim in Theorem S. 2 says that under $\vec{d}_{w, F}$, the convergence rate is parametric even though $\theta$ contains unknown functions. Hong (2017) obtains the same convergence rates in conditional moment equality models with semi/nonparametric unknown parameters. My result is stronger in the sense that the rates are valid uniformly on $\mathcal{J}$. It holds because Definition 5.1 (iii) implicitly restricts the complexity of $\Theta$. With a more complex parameter space, the convergence rate can be lower. The convergence rate under $d_{F}$ is generally slower than the parametric rate because $\zeta_{n} \rightarrow \infty$.

Notice that the convergence rate of $\hat{\Theta}_{n}^{*}\left(\gamma_{n}, \lambda_{n}, R\right)$ has an upper bound that depends only on $\kappa_{n}$, which allows me to freely change $\gamma_{n}$ without significantly changing the imposed identified set. This is possible because of the additional penalty term $\lambda_{n} Q_{n}(\theta)$.

Proposition S.1. Therefore,

\begin{aligned}
& \Gamma_{\kappa, F, m, R}\left(\omega_{1}\right)-\Gamma_{\kappa, F, m, R}\left(\omega_{2}\right) \\
& \leq \int_{\mathbf{T}}\left|\omega_{1}(\tilde{\theta}, \mathbf{t})+\sqrt{m} \frac{d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)}{d \theta}[\theta-\tilde{\theta}]\right|^{2} d \mu(\mathbf{t}) \\
&-\int_{\mathbf{T}}\left|\omega_{2}(\tilde{\theta}, \mathbf{t})+\sqrt{m} \frac{d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)}{d \theta}[\theta-\tilde{\theta}]\right|^{2} d \mu(\mathbf{t})+\epsilon \\
& \leq d_{\infty}\left(\omega_{1}, \omega_{2}\right) \int_{\mathbf{T}}\left|\omega_{1}(\tilde{\theta}, \mathbf{t})+2 \sqrt{m} \frac{d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)}{d \theta}[\theta-\tilde{\theta}]+\omega_{2}(\tilde{\theta}, \mathbf{t})\right| d \mu(\mathbf{t})+\epsilon \\
& \leq 2 d_{\infty}\left(\omega_{1}, \omega_{2}\right) \int_{\mathbf{T}}\left|\omega_{2}(\tilde{\theta}, \mathbf{t})+\sqrt{m} \frac{d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \tilde{\theta}\right)}{d \theta}[\theta-\tilde{\theta}]\right| d \mu(\mathbf{t}) \\
& \quad+d_{\infty}\left(\omega_{1}, \omega_{2}\right) \int_{\mathbf{T}}\left|\omega_{1}(\tilde{\theta}, \mathbf{t})-\omega_{2}(\tilde{\theta}, \mathbf{t})\right| d \mu(\mathbf{t})+\epsilon .

Because $\tilde{\theta} \in R_{m, F}^{\kappa}(\tilde{\theta}), \Gamma_{\kappa, R, F, m}\left(\omega_{2}\right) \leq \int_{\mathbf{T}}\left|\omega_{2}(\tilde{\theta}, \mathbf{t})\right|^{2} d \mu(\mathbf{t}) \leq\left\|\omega_{2}\right\|_{\infty}^{2}$. Therefore, by equation (S.17) and Jensen's inequality,

& \quad \leq \sqrt{\int_{\mathbf{T}}\left|\omega_{2}(\tilde{\theta}, \mathbf{t})+\sqrt{m} \frac{d \mathbb{E}_{F} \rho_{\mathbf{t}}\left(\tilde{\theta}, W_{i}\right)}{d \theta}[\theta-\tilde{\theta}]\right|^{2} d \mu(\mathbf{t})} \\
& \quad \leq \sqrt{\Gamma_{\kappa, R, F, m}\left(\omega_{2}\right)}+\sqrt{\epsilon} \leq\left\|\omega_{2}\right\|_{\infty}+\sqrt{\epsilon} \leq \max \left(\left\|\omega_{1}\right\|_{\infty},\left\|\omega_{2}\right\|_{\infty}\right)+\sqrt{\epsilon} .
\end{aligned}

In addition, $\int_{\mathbf{T}}\left|\omega_{1}(\tilde{\theta}, \mathbf{t})-\omega_{2}(\tilde{\theta}, \mathbf{t})\right| d \mu(\mathbf{t}) \leq 2 \max \left(\left\|\omega_{1}\right\|_{\infty},\left\|\omega_{2}\right\|_{\infty}\right)$. Therefore,

\Gamma_{\kappa, F, m, R}\left(\omega_{1}\right)-\Gamma_{\kappa, F, m, R}\left(\omega_{2}\right) \leq 4 d_{\infty}\left(\omega_{1}, \omega_{2}\right)\left[\max \left(\left\|\omega_{1}\right\|_{\infty},\left\|\omega_{2}\right\|_{\infty}\right)+\sqrt{\epsilon}\right]+\epsilon
$$

Because $\epsilon$ can be any positive number, the lemma follows.

## S.8. Supplemental lemmas

Lemma S.8. Let $f$ be a nonnegative function defined on $\Theta$ and $d$ is a metric such that for some $C>0, d\left(\theta_{1}, \theta_{2}\right) \leq C d_{s}\left(\theta_{1}, \theta_{2}\right)$ for every $\theta_{1}, \theta_{2} \in \Theta$. If $\bar{\Theta}_{n}=\arg \inf _{\theta \in \Theta_{n} \cap R} f(\theta)$, then for any $A \subset \Theta_{n} \cap R$ and $\epsilon>0, \vec{d}\left(\bar{\Theta}_{n}, A\right)=\sup _{\theta \in \bar{\Theta}_{n}} \inf _{\tilde{\theta} \in A} d(\theta, \tilde{\theta})>\epsilon$ only if

\inf _{\theta \in \Theta_{n} \cap R, d(\theta, A)>\epsilon} f(\theta) \leq \inf _{\theta \in \Theta_{n} \cap R} f(\theta) .
$$

Proof. Because $\vec{d}\left(\bar{\Theta}_{n}, A\right)>\epsilon$, there exists $\bar{\theta} \in \bar{\Theta}_{n}$ such that $d(\bar{\theta}, A)>\epsilon+\delta$ for some $\delta>0$. By the definition of arginf, there exists a sequence $\left\{\theta_{k}\right\}_{k=1}^{\infty}$ in $\Theta_{n} \cap R$ such that $d_{s}\left(\bar{\theta}, \theta_{k}\right) \rightarrow 0$ and $\lim _{k \rightarrow \infty} f\left(\theta_{k}\right)=\inf _{\theta \in \Theta_{n} \cap R} f(\theta)$. Therefore, for any sufficiently large $k$,

d\left(\theta_{k}, A\right)>d(\bar{\theta}, A)-d\left(\bar{\theta}, \theta_{k}\right)>\epsilon+\delta-C d_{s}\left(\bar{\theta}, \theta_{k}\right)>\epsilon
$$

As a result,

\inf _{\theta \in \Theta_{n} \cap R, d(\theta, A)>\epsilon} f(\theta) \leq \lim _{k \rightarrow \infty} f\left(\theta_{k}\right)=\inf _{\theta \in \Theta_{n} \cap R} f(\theta) .
$$

Lemma S.9. There exist random variables $A_{n, F}$ and $B_{n, F}$ such that uniformly in $F \in \mathcal{F}$, $A_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1 / 2}\right), B_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1}\right)$, and

\left|Q_{F}(\theta)-Q_{n}(\theta)\right| \leq 2 d_{w, F}\left(\theta, \Theta_{F}\right) A_{n, F}+B_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1 / 2}\right)
$$

Proof. First notice that

\left|Q_{F}(\theta)-Q_{n}(\theta)\right| & =\left|\frac{2 \int_{\mathbf{T}} \mathbb{G}_{n, F}(\theta, \mathbf{t}) \mathbb{E}_{F} \rho_{\mathbf{t}}\left(W_{i}, \theta\right) d \mu(\mathbf{t})}{\sqrt{n}}+\frac{\int_{\mathbf{T}} \mathbb{G}_{n, F}(\theta, \mathbf{t})^{2} d \mu(\mathbf{t})}{n}\right| \\
& \leq \frac{2 d_{w, F}\left(\theta, \Theta_{F}\right) \sqrt{\int_{\mathbf{T}} \mathbb{G}_{n, F}(\theta, \mathbf{t})^{2} d \mu(\mathbf{t})}}{\sqrt{n}}+\frac{\int_{\mathbf{T}} \mathbb{G}_{n, F}(\theta, \mathbf{t})^{2} d \mu(\mathbf{t})}{n}
\end{aligned}
$$

$$
\begin{aligned}
& \leq 2 d_{w, F}\left(\theta, \Theta_{F}\right) \frac{\sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\mathbb{G}_{n, F}(\theta, \mathbf{t})\right|}{\sqrt{n}}+\frac{\sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\mathbb{G}_{n, F}(\theta, \mathbf{t})\right|^{2}}{n} \\
& =2 d_{w, F}\left(\theta, \Theta_{F}\right) A_{n, F}+B_{n, F},
\end{aligned}
$$

where $A_{n, F}=\sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\mathbb{G}_{n, F}(\theta, \mathbf{t})\right| / \sqrt{n}$ and $B_{n, F}=\sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\mathbb{G}_{n, F}(\theta, \mathbf{t})\right|^{2} / n$. By Definition $5.1(\mathrm{iii}), \sup _{(\theta, \mathbf{t}) \in \Theta \times \mathbf{T}}\left|\mathbb{G}_{n, F}(\theta, \mathbf{t})\right|=O_{\mathbb{P}_{F}}(1)$ uniformly in $F \in \mathcal{F}$. Consequently, $A_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1 / 2}\right)$ and $B_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1}\right)$ uniformly in $F \in \mathcal{F}$. Lastly, notice that $d_{w, F}\left(\theta, \Theta_{F}\right)^{2} \leq \sup _{F \in \mathcal{F}} \mathbb{E}_{F} \mathbf{F}\left(W_{i}\right)^{2}<\infty$. Therefore, $2 d_{w, F}\left(\theta, \Theta_{F}\right) A_{n, F}+B_{n, F}=O_{\mathbb{P}_{F}}\left(n^{-1 / 2}\right)$ uniformly in $F \in \mathcal{F}$.

Lemma S.10. $\left\{X_{n, a}\right\}_{n=1}^{\infty}$ and $\left\{Y_{n, a}\right\}_{n=1}^{\infty}$ are sequences of random variables indexed by $a \in \mathcal{A}$ and defined on the same probability space. For every $a \in \mathcal{A}, \mathbb{P}_{a}$ is a probability measure on this probability space. $g$ is a continuous function on the real line. If $\limsup _{n \rightarrow \infty} \sup _{a \in \mathcal{A}} \mathbb{P}_{a}\left(\left|X_{n, a}-Y_{n, a}\right|>\epsilon\right)=0 \forall \epsilon>0$ and $X_{n, a}$ is asymptotically tight uniformly in $a \in \mathcal{A}$, then $\forall \epsilon>0$, limsup $\operatorname{sum}_{n \rightarrow \infty} \sup _{a \in \mathcal{A}} \mathbb{P}_{a}\left(\left|g\left(X_{n, a}\right)-g\left(Y_{n, a}\right)\right|>\epsilon\right)=0$.

Proof. By Assumption, $\forall \eta>0, \exists M>0$ such that $\limsup _{n \rightarrow \infty} \sup _{a \in \mathcal{A}} \mathbb{P}_{a}\left(\left|X_{n, a}\right|>M\right)<$ $\eta$. Because $g$ is continuous, it is absolutely continuous on $[-2 M, 2 M]$. For any $\epsilon>0$, there exists $0<\delta<M$ such that $|g(x)-g(y)| \leq \epsilon$ if $x, y \in[-2 M, 2 M]$ and $|x-y| \leq \delta$,

\mathbb{P}_{a}\left(\left|g\left(X_{n, a}\right)-g\left(Y_{n, a}\right)\right|>\epsilon\right) \leq & \mathbb{P}_{a}\left(\left|X_{n, a}-Y_{n, a}\right|>\delta,\left|X_{n, a}\right| \leq M,\left|Y_{n, a}\right| \leq 2 M\right) \\
& \quad+\mathbb{P}_{a}\left(\left|X_{n, a}\right| \leq M,\left|Y_{n, a}\right|>2 M\right)+\mathbb{P}_{a}\left(\left|X_{n, a}\right|>M\right) \\
\leq & \mathbb{P}_{a}\left(\left|X_{n, a}-Y_{n, a}\right|>\delta\right) \\
& \quad+\mathbb{P}_{a}\left(\left|X_{n, a}-Y_{n, a}\right|>M\right)+\mathbb{P}_{a}\left(\left|X_{n, a}\right|>M\right)
\end{aligned}
$$

The first two terms converge to 0 uniformly in $a \in \mathcal{A}$. Therefore,

$$
\limsup _{n \rightarrow \infty} \sup _{a \in \mathcal{A}} \mathbb{P}_{a}\left(\left|g\left(X_{n, a}\right)-g\left(Y_{n, a}\right)\right|>\epsilon\right) \leq \limsup _{n \rightarrow \infty} \sup _{a \in \mathcal{A}} \mathbb{P}_{a}\left(\left|X_{n, a}\right|>M\right) \leq \eta
$$

This concludes the proof because $\eta$ can be any positive number.
