Valorization of biomass ash in biogas technology: Opportunities and challenges

Abstract

Despite the increasing global focus on replacing fossil fuels with biomass resources, handling the enormous quantity of ash from biomass thermochemical conversion processes into energy remains a serious challenge from both environmental and economic points of view. Therefore, in pursuit of the circular economy, the use of biomass-derived ash in beneficial applications can have a great contribution to address problems related to ash disposal, and at the same time to promote the valorization of wastes. This work attempts to provide a clear insight into the feasibility of the utilization of biomass ash in a valuable field, namely anaerobic digestion and biogas technology, along with a brief statement of possible opportunities and challenges.

1. Introduction

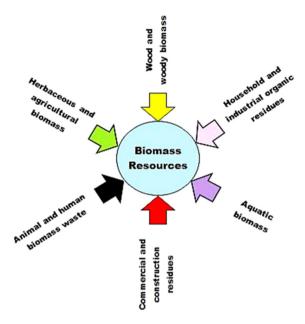


Fig. 1. Categorization of the main biomass types. *Source:* Adapted from [3].

Due to serious energy crises and environmental concerns in recent years, the replacement of a fraction of conventional fossil fuels with biomass, as a plentiful and green source of renewable energy, has attracted a lot of attention worldwide [1]. It is reported that the world's annual production of biomass with potential for conversion to energy is currently around 7 billion tons [2]. As shown in Fig. 1, biomass resources can be categorized within 6 major groups: (i) wood and woody biomass; (ii) herbaceous and agricultural biomass; (iii) animal/ human-derived biomass waste; (iv) commercial and construction biomass residues; (v) aquatic biomass; and (vi) household and industrial organic residues.

Nevertheless, the thermochemical processes (e.g., combustion, gasification, and pyrolysis) applied to convert biomass into energy vectors, generate a huge amount of residual ash. These inorganic residues are mainly buried in

landfills, occupying a large area of applicable land and contaminating the environment [2]. Thus, a proper solution must be adopted to solve the disposal-related issues of biomass ash.

So far, extensive investigations have been done on the utilization of ashes in a wide variety of fields, including construction and ceramic industry, agricultural soil amendment, environmental remediation, and catalytic applications [3]. However, studies on the usage of biomass ash in other promising areas such as biogas technology, based on anaerobic digestion process, are scarce. This aspect provides a proper basis for further research to achieve remarkable innovations that are consistent with the circular economy concept.

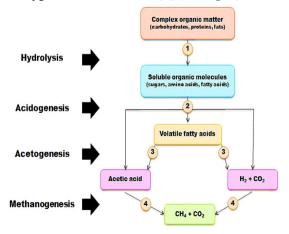


Fig. 2. Schematic diagram of anaerobic digestion process. *Source:* Adapted from [4].

Indeed, the anaerobic digestion process is a collection of sequential biochemical reactions (i.e., hydrolysis, acidogenesis, acetogenesis, and methanogenesis), in which organic substances are transformed into valuable by-products such as biogas, in an oxygen-free environment [4] (see Fig. 2).

In the following sections are outlined the potential opportunities for the application of biomass-derived ashes in anaerobic digestion technology as well as possible challenges that may hinder the valorization of such problematic waste in the aforementioned context.

2. Opportunities

As already mentioned, biogas technology seems to be a very valuable area for the use of selected fractions of biomass ash, especially in two major applications: (i) improving the digestion process performance to enhance biogas formation and, (ii) purification of the produced biogas.

2.1. Improvement of the digestion process for increased biogas formation

Acidification problem and subsequent process instability are of major concerns in commercial biogas plants due to the presence of easily biodegradable substrates. The use of biomass ash as an additive with high buffering ability can not only increase the efficiency of the biogas production process but also significantly reduce the need for commercial alkali reagents as well as continuous regulation of pH in the anaerobic digesters [10]. The other benefit of biomass ash as a fermentation additive is the supplementation of macro- and micro-nutrients required for the activity of anaerobic microorganisms during the digestion process, leading to an overall process improvement in a cost-effective manner [11]. Despite all these advantages, little has been done so far on the study of the effect of adding biomass ash to the anaerobic digestion systems. For instance, in a series of experimental work [5–9], promising results could be achieved in the yield of methane gas from the anaerobic digestion of organic residues using distinct amounts of municipal solid waste incinerator ash. More recently, Novais et al. [10] also observed an enhanced pH buffering capacity and methane production efficiency with the addition of biomass fly ash-based geopolymer spheres to the anaerobic digesters treating high loads of cheese whey. Further details on these studies

are presented in Table 1. These achievements open an interesting route towards future research on the improvement of biogas production from organic residues. Considering the high diversity of biomass-derived ashes and their associated properties [2], distinctive potential impacts can be expected from the use of different types of these valuable wastes either on methane production or on the production of other biogas types such as hydrogen or hythane from the anaerobic digestion process.

2.2. Biogas purification

Raw biogas obtained from an anaerobic fermentation process does not have enough quality for its introduction into the gas grid or vehicles fuel use. The common solution to this barrier is the purification approach by which impurities are absorbed or scrubbed from the biogas stream. The most frequently used biogas purification technologies are water/amine scrubbing, pressure swing adsorption, cryogenic distillation, and membrane separation [12]. However, the application of these processes has several drawbacks, including biogas losses, excessive consumption of energy (e.g., electricity) and chemicals, as well as related atmospheric pollution [13]. In this context, the application of biomass ashes can be advantageous for trapping biogas contaminants, hence reducing costs and environmental impacts in comparison with commercial purification techniques [14].

In recent years, a limited set of studies [13–16] have shown the feasibility of using municipal solid waste incineration bottom ash and wood ash, as sorbents, to remove CO₂ and sulphur compounds (e.g. H₂S, dimethyl sulphide ((CH₃)₂S and methyl mercaptan (CH₃SH)) from biogas in anaerobic reactors or from landfill gas (See Table 2). Nevertheless, the application of biomass ash in the biogas-cleaning process cannot be only restricted to ash residues from incineration of municipal solid waste or wood, since ashes from other biomass resources or other thermochemical conversion processes may be more effective to reduce biogas contaminants. Even when using a specific type of biomass ash, different purification capacities may be observed depending on the effect of potential factors that contribute to the variation in the biomass composition and properties [3]. Hence, these knowledge gaps provide a good opportunity for researchers who are interested in working in this economically attractive and challenging field.

3. Challenges

Although there seem to exist many potential benefits of using biomass ash in biogas industry, encountering multiple barriers is unavoidable. Some of these challenging obstacles can be summarized as follows [17]:

- (a) Scarcity and inaccessibility of data on the key parameters necessary for the technical verification of biomass ash utilization in biogas technology such as availability of ash and its characteristics, commercial validation, user needs, and relevant specifications and standards;
- (b) Possible economic barriers and lack of adequate financial incentives to encourage investments and, ultimately, the widespread use of ash in this valuable area;
- (c) Lack of institutional and legal guidelines as well as insufficient or strict industry and environment legislation for the use of biomass ash in biogas technology.

4. Conclusion

The growing trend of biomass ash production on recent years, resulting from an increased biomass to energy applications, has encouraged researchers to find innovative ash applications in an economic and sustainable way. It is believed that the utilization of biomass ash in anaerobic digestion technology, either as an additive for optimizing the biogas production process or as an adsorbent for biogas purification is a promising solution to the valorization of such abundant by-product from biomass to energy applications. Thus, further research in this relatively unexplored approach is highly recommended, taking into account the potential challenges and constraints.
