Disruption by design? Classification framework for the archetypes of disruptive business models

The current scholarly debates highlight the role of business models for understanding the dynamics inherent to disruptive innovations. Additionally, research on business models argues for similarities between business models, as they are shared by multiple competitors and across industries. Despite the recent advancements in both debate streams, a consolidation of the research on the underlying similarities of disruptive business models is lacking. Such a consolidation would allow learning from previous waves of disruption, ultimately informing theory and practice to cope with the increasing pace and impact of disruptive innovations. Consequently, this study systematically identifies 122 disruptive business models that have been discussed in the literature during 2006–2019. Based on qualitative content analysis, we then develop a classification framework and propose five archetypes of disruptive business models: (1) matchmakers, (2) standardizers, (3) service providers, (4) open collaborators, and (5) performance reducers. We make a twofold contribution to the discussions around the hitherto tentatively specified business models underlying disruptive innovations, thus emphasizing the contingency of the phenomenon. First, we discuss how the identified archetypes are inducing disruptive dynamics. Second, we elaborate on how the archetypes are constituting paths towards disruption.

1. Introduction

There is a debate around the characterization of business models, which underlie disruptive innovation. Disruptive innovation captures how new entrants challenge established organizations (henceforth, incumbents) by introducing new offerings, which develop along an alternative performance

trajectory (Christensen, 1997). Christensen et al. (2018, p. 1050) states that ‘no innovation is inherently disruptive. Firms make strategic choices to position an innovation in a disruptive way – most often by targeting non-customers in new markets.’ Recent scholarly contributions theorize business models as the decisive disruption mechanisms (Cozzolino et al., 2018; Hopp et al., 2018; Snihur et al., 2018).

However, the available knowledge about the characteristics of disruptive business models is limited. Based on empirical observations, there exist communalities of disruptions across industries. Airbnb's platform model is changing the logic of the hotel industry (Guttentag, 2015), while Spotify's disrupted the established model of the music industry (Trabucchi et al., 2019), and low-cost models such as the frequently-cited steel minimill disrupted the business logics of integrated steel mills (Christensen, 1997). Similarly, low-cost carriers are disrupting full-service incumbent airlines (Serio et al., 2018).

Despite these observations, Christensen et al. (2018) conclude that business models underlying disruptive innovation have only been '*tentatively specified*'. This is because available studies are in-depth in nature and focus on the particularities of selected disruptive innovation processes (Cozzolino et al., 2018; Snihur et al., 2018), focus on selected disruptive technologies (Amshoff et al., 2015), or discuss characteristics of selected sub-types of disruptive innovation (Trabucchi et al., 2019). We argue for revisiting previous waves of disruption to overcome this tentative characterization. A comprehensive classification of disruptive business models would back a 'common language and theoretical platform' (Hopp et al., 2018, p. 476), thereby advancing the scholarly discussion.

Consequently, the objective of our study is to distill typical business models ('archetypes') of disruptive innovation. We approach this by reviewing and synthesizing the current state of research from a business model perspective and contributing evidence that there is no 'one size fit all' approach to disruption (Christensen et al., 2018; Hopp et al., 2018). We contribute to the following research question: *what archetypes of business models underlying disruptive innovation can be developed on the basis of the present research base?*

This paper presents five archetypes of business models underlying disruptive innovation. For conceptualization, we understand business models as a construct to capture companies' strategic choices regarding value proposition, value creation, and value capture (Teece, 2010; Clauss, 2017; Spieth et al., 2021). We stress that the presented archetypes are no success formulas for disruption. The involved strategic actors need to perform disruptive innovation through continuous business model innovation, while maneuvering along the disruptive path (Kumaraswamy et al., 2018; Schmidt and Scaringella, 2020).

To deliver our contributions, we first present the systematic selection of disruptive business models in the academic literature during 2006–2019.

Subsequently, we describe the qualitative content analysis for developing a classification framework, which ultimately led to identifying the archetypes. Finally, we draw conclusions and present avenues for further research.

2. Theoretical background

2.1. Disruptive innovations as a business model phenomenon

Disruptive innovation describes the process by which an entrant with fewer resources challenges established incumbents in the mainstream market (Christensen et al., 2018). The concept, initially understood as a technological problem, shows how technologies with relatively lower performances compared to existing mainstream alternatives can be increasingly valued by emerging customer segments (Bower and Christensen, 1995). This technology-focused understanding of disruptive innovation was revised in 2006, when researchers have started to acknowledge that the reason market incumbents are disrupted is a lack of business model innovation (not technology innovation) (Christensen, 2006; Markides, 2006). Recently, scholars argued for widening the disruption understanding to a 'market outcome in which new offerings successfully challenge established ones in the given market' (Ritala et al., 2021, p. 2). Reviews of the Christensenian conceptualization highlight that companies make strategic choices to position an innovation disruptively in relation to existing mainstream alternatives (Christensen et al., 2018; Petzold et al., 2019). Thus, the latest empirical contributions take a business model perspective.

Cozzolino et al.'s (2018) in-depth study on the newspaper industry emphasizes that it is a disruptive business model that spurs the disruptiveness of an innovation. We build on this understanding and refer to evidence that disruptive business models do not require disruptive technologies per se. For instance, both Airbnb's and Spotify's models were initially built on the already established Internet technology (Guttentag, 2015; Trabucchi et al., 2019). In conclusion, disruptive business models are not coherent with the established ways of doing business, thereby creating substantial challenges for industry incumbents (Christensen, 2006; Cozzolino et al., 2018).

Altered business models in the context of disruption were the focus of previous studies on how disruptive business models emerge and dynamically develop (Ansari et al., 2016; Cozzolino et al., 2018; Snihur et al., 2018). Consequently, the existent research predominately adopts an in-depth view of

the dynamic evolution of disruptive business models and distils the respective generative mechanisms, thereby contributing to the complexity of this phenomenon (Petzold et al., 2019).

We build on Christensen's conceptualization of disruption (Christensen et al., 2018) and follow Hopp et al.'s (2018) call for abstracting and generalizing to advance the disruptive innovation theory. Due to the limited consolidation of the findings of the previous waves of disruption, knowledge can only hardly be transferred to provide a deeper understanding (Christensen et al., 2018; Hopp et al., 2018). Consequently, a synthesis from the business model perspective would add to our understanding of disruptive innovation.

2.2. Understanding the model character of business models

Business models have received considerable interest, especially since the emergence of the Internet in the mid-1990s, which enabled value creation beyond physical products and services (Amit and Zott, 2001; Zott et al., 2011; Schneider and Spieth, 2013; Foss and Saebi, 2017). Hence, scholars have built on the business model concept to develop a deeper understanding of how companies do business, which processes are performed, and how these processes are interlinked (Schneider and Spieth, 2013; Spieth et al., 2014; Foss and Saebi, 2017).

Despite ongoing debates, there is still no common definition of a business model (Spieth et al., 2014; Wirtz et al., 2016). For our study, we conceptualize business models along the key dimensions of value propositions, value creation, and value delivery (Teece, 2010; Spieth et al., 2014; Clauss, 2017). Particularly, a business model depicts which value propositions are delivered to the market. Value creation defines the activities from input factors to customers that result in new market offerings that eventually add value (Chesbrough, 2006). Value capture refers to how revenue sources and pricing capture the created value (Teece, 2018). The reader is referred to Foss and Saebi (2017), Schneider and Spieth (2013), and Wirtz and colleagues (2016), who provide comprehensive reviews of current debates related to the concept of business model (innovation).

Underlining the model character of business models, Teece (2010) argues that business models are to a certain degree “*“shared” by multiple competitors*” (p. 179). Moreover, Baden-Fuller and Morgan (2010) understand business models as recipes. Building on these arguments, the research engages

in discussing business model archetypes (Bocken et al., 2014; Fielt, 2014; Gassmann et al., 2014; Ritter & Lettl, 2018). Particularly, Ritter and Lettl (2018, p. 2) describe these archetypes as ‘*generic logics of how firms do business*’ (p. 2). Examples of business model archetypes are the ‘razor and blade’ model of Gillette or the ‘low-cost carrier model’ of Southwest Airlines (Fielt, 2014). Furthermore, Gassmann et al. (2014) review business models across industries and propose ‘business model patterns’ with underlying generative mechanisms.

In the context of disruptive innovation, Amshoff et al. (2015) made a first contribution by presenting business model archetypes based on the particular technology of condition monitoring. Recently, Garbuio and Lin (2019) extended this discussion and proposed business model archetypes based on artificial intelligence technologies within the health-care industry. A further contribution to the discussion about similarities of disruptive business models is made by Trabucchi et al. (2019), who study the business models of big-bang disruptors – a sub-type of disruption characterized by a zero marginal cost structure (Downes and Nunes, 2014).

Consequently, a more complete synthesis is needed to advance theory building. This study considers business models beyond a particular technology or industry, thereby abstracting case-specificities. We respond to the calls for research regarding (1) a systematic consolidation of existing research findings on disruptive innovation (Hopp et al., 2018), (2) the development of a better understanding of business models that cause a change in performance trajectories (Christensen et al., 2018), and (3) guidelines for business model innovation to pursue disruptive opportunities using business models as blueprints (Teece, 2010; Hopp et al., 2018).

3. Methodology

A methodological approach based on qualitative analysis is used to explore our research question. Two independent researchers were involved to ensure reliability.

We systematically collected data on disruptive business models using a highly transparent, systematic and replicable methodological approach to minimize bias (Tranfield et al., 2003). Hence, we follow previous studies, arguing for the quality control underlying academic journal publications and build on systematically collected secondary data from these sources (Hopp et al., 2018; Petzold et al., 2019).

3.1. Constructing the data base

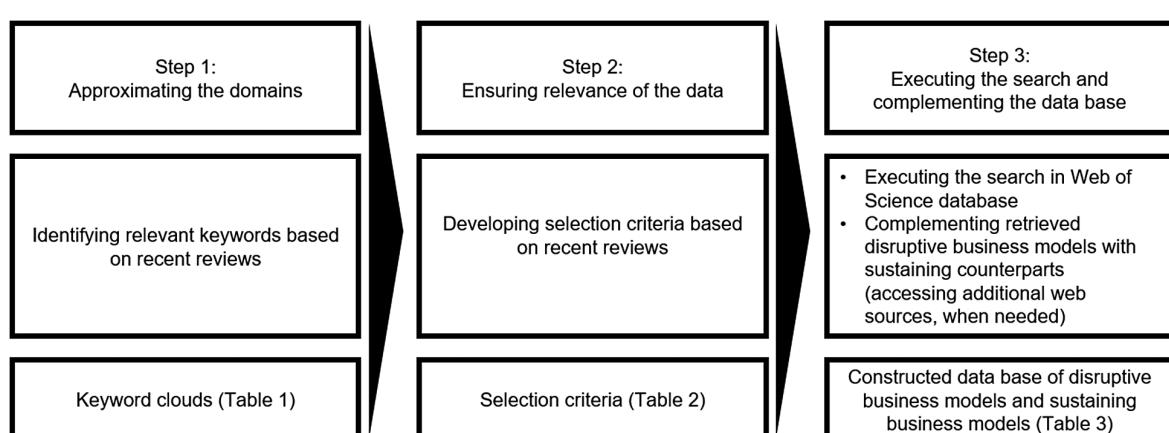
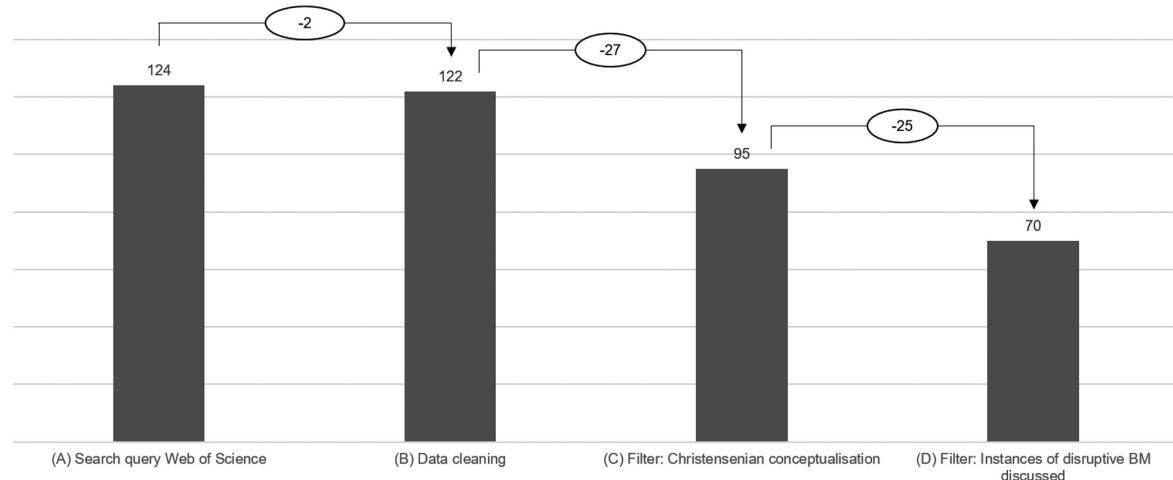


Figure 1. Three-step process for data base construction.

We followed three steps for selecting scientific articles from the Web of Science ([Figure 1](#)) as a basis for identifying disruptive business models in academic literature.

In a first step, we approximated the domains of ‘disruptive innovation’ and ‘business model’. We revisited recent reviews (Schneider & Spieth, [2013](#); Foss & Saebi, [2017](#); Christensen et al., [2018](#); Hopp et al., [2018](#); Petzold et al., [2019](#)) to identify relevant search keywords ([Table 1](#)). For operationalization, we applied Web of Science’s topic search: the search keywords had to be present in either the papers’ title, abstract, or associated keywords.

In a second step, we defined inclusion criteria ([Table 2](#)). We included peer-reviewed articles and leading practitioner-oriented articles (Harvard Business Review, MIT Sloan Management Review) to ensure the scientific rigor of the data base. We defined the timeframe from 01.01.2006 – 31.12.2019 to only include articles that have been published after the guiding argument that disruptive innovation is a business model problem (Christensen, [2006](#)).

In a third step, we executed the search and followed sub-steps (A) to (D) ([Figure 2](#)). (A) The keyword string led to 124 articles. (B) We cleaned the retrieved list and removed one duplicate and one non-English article. (C) To reduce the conceptual noise regarding the terminology ‘disruptive innovation’, articles had to be anchored in the Christensenian conceptualization of disruptive innovation. We examined the abstracts and bodies of the articles and present key quotes to underpin our filtering decision (see [Table 3](#)). (D) Finally, we filtered whether the articles discuss instances of disruptive business models. We considered the full ‘spectrum of maturity’ (Christensen, [2006](#), p. 45) and included instances of disruptive business models from niche to mainstream market entry.

Consequently, we selected 70 articles, in which we identified 122 disruptive business models. We complemented our data base with the corresponding sustaining business models ([Table 3](#)).

3.2. Qualitative content analysis

Subsequently, we conducted a qualitative content analysis for an in-depth investigation of the disruptive business models. Two independent researchers performed the analysis using MAXQDA18. We controlled for inter-coder reliability and used upcoming coding divergence for enhancing reliability. The analysis followed an abductive approach, from data to theory and vice versa (Saldaña, [2016](#)).

In a first analysis step, we developed a coding strategy aligned with our research question based on the theoretical framework and developed initial coding criteria to identify relevant data segments (Creswell, [2013](#)). In the first coding cycle, we coded segments according to the three dimensions ascribed to a business model: (1) value proposition: how are products/services, customer segments, and customer relationships described; (2) value creation: how are key activities, required resources, partners, and underlying technologies described; (3) value capture: how are revenue and cost structures described.

Through further abstraction, the involved researchers independently engaged in pairwise comparisons of the coded business models to classify them while accounting for similarities and differences. In this step, the assignment of business model characteristics to the three business model dimensions facilitated the classification. We followed previous studies on business model archetypes in different contexts and applied the following criteria to guide the classification process (e.g., Bocken et al., 2014). Hence, archetypes needed to be, (a) representative of underlying mechanisms propelling the disruptive innovation, (b) explanatory, (c) mutually exclusive.

In the second coding cycle, we sorted the data into smaller segments and inductively coded them for each classified business model archetype. We departed by taking the in-vivo coding from the first coding cycle. We abstracted the data to the first-order concept and second-order themes to aid the sense-making and identify the underlying generative mechanisms. We mainly used process coding to grasp the actions intertwined with the disruptive innovation dynamics underlying the respective business models (Miles et al., 2014).

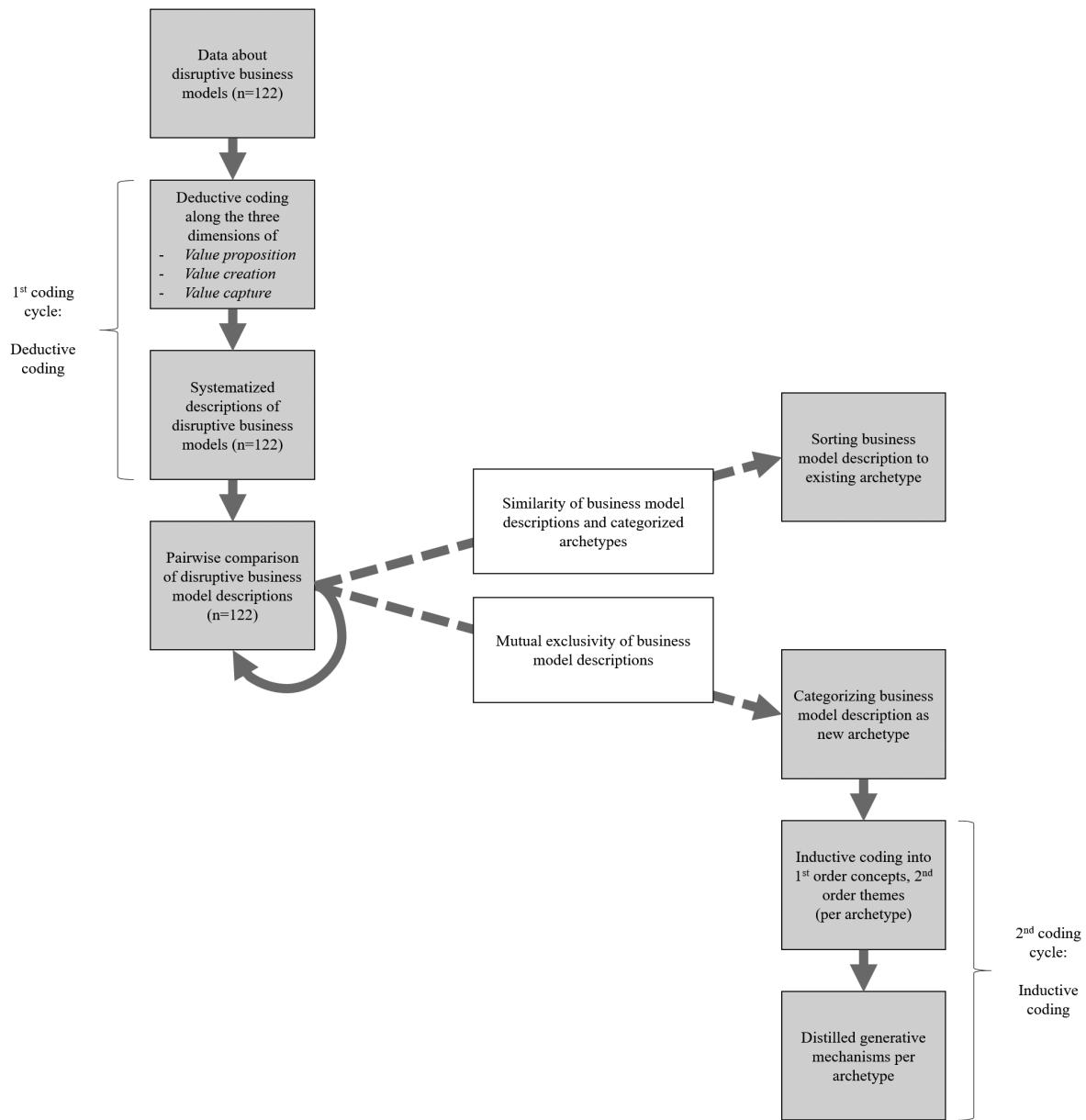


Figure 3. Coding cycles and classification procedure.

We iteratively and independently cycled between the data, concepts, and archetypes to check whether we identified new and sufficiently different

archetypes. [Figure 3](#) provides an overview of the coding cycles and the classification into archetypes.

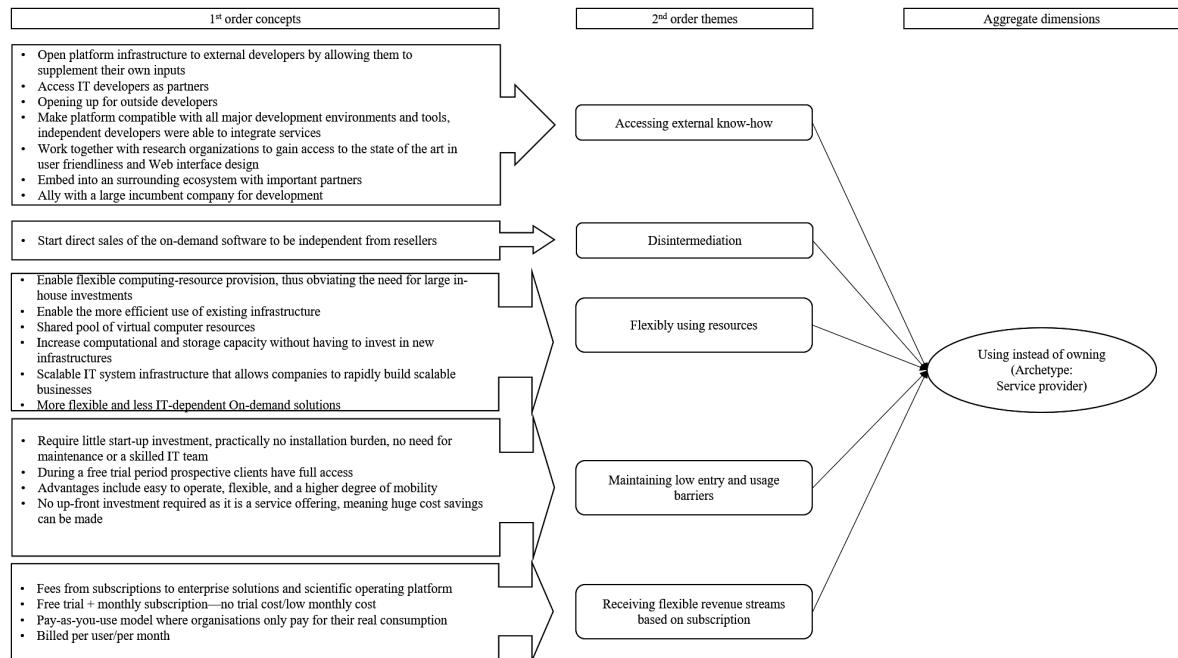


Figure 4. Part of the data structure.

We discussed our coding results until we reached consensus. This iterative analysis procedure culminated in the data structure, of which we present a part in [Figure 4](#).

4. Findings

4.1. Overview of data

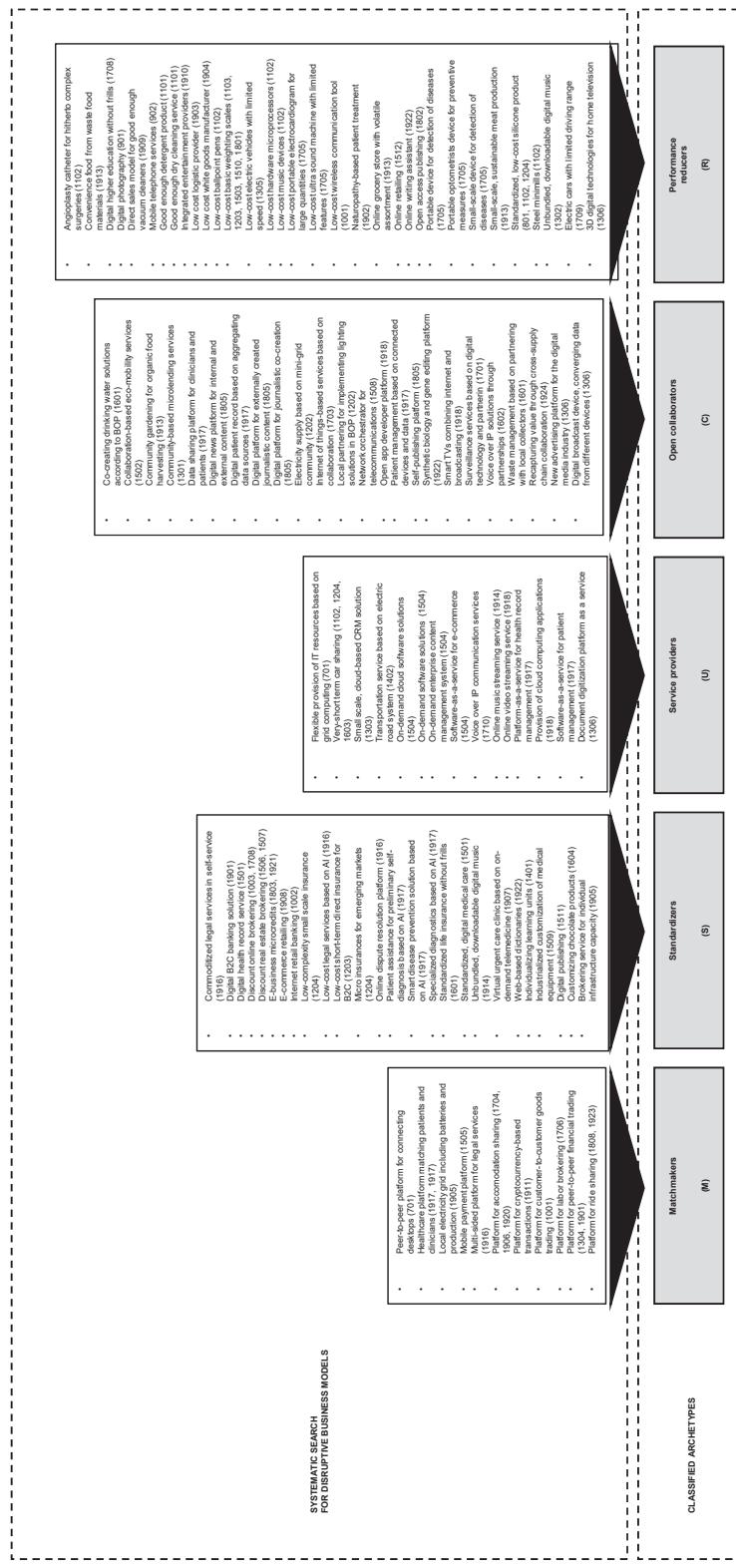


Figure 5. Overview of archetypes and classified business models.

[Figure 5](#) provides an overview of the archetypes along with the classified disruptive business models. We present our findings based on the developed coding structure and the characteristics of the archetype and its underlying generative mechanisms. When we refer to in-vivo codes from the systematically retrieved business models, we use the following label: “document ID (see [Table 3](#)) _ archetype character (see [Figure 5](#)) and code ID.”

4.2. Matchmakers

This archetype includes business models that match market sides. These business models range mobile payment platforms, which enable users to complete peer-to-peer transactions, to platforms matching

Furthermore, matchmaking models could be characterized by joint resource use among users and '*focus on access and services that utilize the resources of others*' [1706_M093], which means that it is not a single company that owns resources and provides services to a base of users. In fact, the users of matchmaking models own the required resources and share them according to the individual needs of the matched peers. Thereby, '*companies involved in the sharing economy act as avenues ("labor brokers") that connect people in need of certain services with sellers of those services*' [1706_M077]. To make this happen and create trust among its users, matchmakers frequently implement a social rating system. Thereby,

[matchmakers] rely on user-based rating systems for quality control, ensuring a level of trust between consumers and service providers who have not previously met. [1704_M061]

Moreover, efficient processes are essential within the value creation logic of these business models and pave the way for relatively low-cost transactions. Consequently, matchmakers create automated processes to match market sides.

Given the flexibility of transaction-based value creation, value capture mechanisms are also flexible. As such, the use of underlying technologies allows the automation of transactions and ensures low operational costs. This is particularly important as matchmaking models generate relatively lower margins per transaction. Therefore, matchmaking models are subscription-based or charge a fee per transaction, which is sometimes linked to the result of a particular transaction. In fact, companies operate on a variable costs structure, resulting in flexible revenue streams. Subsequently, users benefit from relatively low upfront investments and high convenience, which supports acceptance in lower tiers of the market. Furthermore, matchmakers are not involved in the actual value creation. The service provision is performed among the matched peers. Matchmakers are technically not involved in the transaction themselves.

From the user perspective, this disintermediation can be evaluated as beneficial because customers

perceive a higher value compared to models with intermediaries. Regarding value capture, users no longer pay surcharges for having intermediaries in the process. Users of matchmaking models ‘only’ pay a transaction fee for the matchmaking:

Enabling direct trading between investors provides better value for our clients as it reduces their commission costs considerably and, just as importantly, they feel that they are not paying unnecessarily for the services of an intermediary. [1304_M031]

Matchmakers can be considered as a *facilitator* between the involved users while aligning demand with supply. Thereby, the over- or underserving of

customers is avoided and ‘*fewer products are needed when one can pay a fee and have access to cars, clothing, lodging, or tools.*’ [1706_M089] Hence, in comparison to owning resources, matchmakers facilitate the exploitation of existing resources through sharing them among a user base. By connecting peers from similar locations, matchmakers frequently benefit from shorter distribution channels, which makes their models relatively efficient.

Ultimately, matchmaking models ‘*can be thought of as a vertical disintegration where activities are unbundled*’ [1808_M123], which allows for more flexible and nuanced services that better fit user demand. The combination of the efficient exploitation

of overall resource bases and the disintegration of value creation activities enables matchmaker models to approach low-end customers.

4.3. Standardizers

Standardizers offer customized value propositions based on modularized value creation. Exemplary business models include the delivery of commoditized legal services via digital channels or standardized digital healthcare solutions.

Core to standardizers is the reduction of complexity in value propositions. By making the value propositions easy to understand, standardizers can offer scaled-down solutions to hitherto unaddressed customer segments. Indeed, for small-scale insurances and financial services, '*the success [...] is based on the significant reduction of the complexity of the product*' [1204_S034]. Furthermore, the reduction of performance leads to relatively lower access and usage barriers for (potential) customers. Thereby, standardizers achieve a reasonable market acceptance, especially in the lower tiers of the market. For standardized life insurances, the reduction of complexity leads to a '*purchasing decision [of] low-risk and low-involvement, even for a low-income customer*' [1601_S089]. Consequently, standardizers frequently target small, price-sensitive customers.

Because standardizers frequently build on existing digital technologies, it is possible to establish

relatively cost-efficient direct customer relationships. For instance, for micro-credits, '*pushing direct marketing messages to target these customers, and thus, enhancing a harmonious relationship with customers*' [1803_S114] was identified. Targeting customers via a digital channel makes hitherto dominant intermediaries in value networks redundant, which in turn positively affects the cost effectiveness.

Regarding value creation, standardizers predominantly focus on efficiency. Thus, the automation of value creation activities is key to realize relatively slim cost structures. The deployment of suitable technologies such as robo-advisors (e.g., financial services), internet platforms (e.g., digital insurances), or artificial intelligence (e.g., digital healthcare services) is relevant, too. Consequently, the value creation logic of standardizers follows a '*highly industrialized approach*' [1509_S073] based on rules and norms, resulting in faster completion of value creation activities.

This automation focus allows standardizers to increasingly integrate customers into value creation activities, which has two benefits. First, customer integration allows lowering operation costs because part of the service is outsourced to the customer (usually free of charge). Second, customers can better steer the actual creation of value when integrated in the process. In fact, '*manufacturers [engage] consumers in a way that they can co-create products and re-configure production supply chains*'

[1604_S101] to meet particular customer requirements. Consequently, customers' experiences with standardizers positively increase.

Furthermore, the modularization of value creation processes is a key theme for standardizers. This modularization allows customers to efficiently select from a '*wider choice of [additional] incremental features*' [1509_S075]. Standardizers '*chunk down*' [1401_S044] information (i.e., bite-sized or modular pieces), enabling customers to branch out. Business models for the production of physical goods rely on '*semi-finished inventory*' [1604_S094], which enables a standardized customization of the final value proposition delivered to the customer.

In line with the focus on value creation automation and value proposition standardization, the value capture mechanisms of standardizers are flexibly designed. Revenue streams are generated either on a per-transaction-basis (i.e., '*every dollar spent by the company [is] linked to marginal revenue*' [1601_S090]) or are based on an automated individual calculation.

4.4. Service providers

In contrast to delivering a value proposition via the sale of goods, the actual use of products and services is the core of service providers. The majority of identified business models are software-as-service solutions that challenge on-premise alternatives. Very short-term car rental models are another example, as users flexibly benefit from the service but never own value creation assets (i.e., automobiles) to realize value creation independently.

Essential to this archetype is the flexible use of resources. Whereas conventional business models are often based on the sale of goods, service providers design a value proposition that allows customers to make use of the companies' resources. In cloud computing, such a mechanism '*enables flexible computing-resource provision, thus obviating the need for large investments in in-house servers*' [701_U004].

Use based-models realize value creation through standardized processes so that the basic value propositions are uniform. Nevertheless, the value creation logic of these models allows adaptation according to specific customer needs. Hence, use based-models frequently build upon collaboration and partnerships with externals. These external knowledge providers can flexibly build upon available value creation logic for further development. Thereby, service providers can overcome limited internal capabilities and develop and grow the technology side of value creation. For the

technology platform of the CRM solution Salesforce, this collaboration is realized as follows:

By making Force.com compatible with all major development environments and tools (i.e., .NET, Java, PHP, Ruby on Rails, among others), independent developers (i.e., those outside Salesforce.com) were able to integrate services ranging from simple email to Facebook and Twitter within the platform. [1303_U033]

Hence, customers benefit from a relatively flexible value proposition that better fits their individual needs and preferences. Customers can relatively flexibly up- and downscale their usage behaviors. In addition, service providers more efficiently exploit existing infrastructure. For grid computing, this '*enables the more efficient use of existing computing infrastructure*' [701_U007].

The flexibility is reflected in the value capture logic, which is based on flexible revenue streams. Customers '*only pay for their real consumption*' [1303_U024]. Hence, value capture follows a pay-per-use logic, realized through subscription fees (i.e., customers are '*billed per user/per month*' [1303_U030]).

This flexibility gives customers the freedom to quit easily, making use based-models attractive in uncertain or volatile environments. Customers can, for instance, benefit from '*practically no installation burdens, no need for maintenance or a skilled IT team, no requirement to purchase additional hardware*' [1303_U026]. Customers require less specific knowledge, allowing them to benefit from the value proposition ad hoc.

Our analysis suggests that relatively non-technology-savvy customers are likely to prefer this model. These customers are more interested in the outcome of the value proposition than in the underlying technological functionalities. For software-as-a-service solutions, this means:

The traditional buyers of software products were being replaced with non-experts. Thus, preferences changed from comprehensive on-premises solutions to more flexible and less IT-dependent on-demand solutions. [1504_U094]

Furthermore, a free trial period is frequently included, which eases customers' first access by lowering entry barriers. This is particularly relevant for first-time customers having relatively little (technological) experience with the offered value proposition. This can be illustrated by referring to Salesforce:

During the trial period, prospective clients have full access to the Salesforce.com suite of products and user support. [1303_U034]

This free trial period attracts customers because they are not confronted with considerable entry barriers, as is the case with purchasable value propositions (i.e., entry barriers through high upfront investments).

Finally, use based-models deliver the value proposition directly to the customer. This disintermediation circumvents additional players in the value chain, which enables capturing a larger share of the created value. Direct sales make service providers more independent from resellers, thereby increasing flexibility in strategic development and margin calculations. Thus, use based-models offer value propositions to be used by customers according to their specific demands.

4.5. Open collaborators

Collaboration models focus on opening a business model to facilitate access to and for externals (e.g., customers, suppliers, incumbents, media) instead of internalizing knowledge and capabilities. Thereby, collaboration-based business models are dependent on externals for realizing value proposition, value creation, and value capture. Examples are co-creation models for journalistic content or a focused partnering with stakeholders already embedded in low-end target market to launch and grow offerings in base-of-pyramid (BoP) markets.

Collaboration models frequently target the lowest end of the market. Value propositions of these business models are designed to '*target base-of-the-pyramid customers and improve their lives through innovative solutions and inclusive business models*' [1202_C016]. Target customers are those who cannot afford already existing solutions. Hence, collaboration models target non-customers rather than over-served ones. New market segments are addressed, increasing the 'economic pie' and allowing more people to benefit from a certain value proposition. Subsequently:

market development at the base of the pyramid creates an opportunity to enhance the economic situation of deprived people on one hand and to expand the consumer market of companies on the other hand. [1202_C018]

Furthermore, access to external knowledge is a fundamental element in value creation. Digital technologies favor the emergence of externalities and give '*opportunities to create value by massively exploiting external knowledge*' [1805_C142].

Thereby, a certain share of value creation activities is performed outside the company. Customers can perform particular activities through self-service

mechanisms. This increases flexibility on the customer side (e.g., when to use/access the value proposition), whilst reducing related costs and creating relatively low-cost alternatives. Here, participatory journalism can be taken as an example, when companies '*mix [...] many bottom-up bloggers' contributions and less top-down journalistic content*' [1805_C143]. Thus, value is created by orchestrating external sources of knowledge rather than using internal capabilities. Consequently, collaboration models offer value propositions that democratize centralized offerings, enabling more people to actively benefit from a certain value proposition.

Collaboration models also attract (financial) resources from unaffected externals. The financial investors or governmental institutions, not directly affected by the market impact of the disruptive business models, provide resources, thereby nurturing value creation activities. Moreover, collaboration models aid partnering with incumbents to get access to relevant infrastructure or customers. For Voice-over-IP business models, '*by far the most influential of actors [...] are the [incumbent] cellular network providers*' [1602_C095]. Especially in systemic industries with complex (technological) infrastructure, collaboration business models rely on cooperation with infrastructure providers for value creation and value proposition delivery. Furthermore, companies do '*not sell directly to end users [but] work together with many different partners, who integrate systems, act as distributors*' [1701_C107]. The interplay between companies with collaboration models and their incumbent counterparts is a crucial aspect of understanding the development and growth of these models.

Allying with embedded partners represents another approach of collaboration models. These business models follow '*bottom-up approaches*' [1202_C004] to create value in collaboration with partners already embedded in the market. Value creation activities are more closely connected to the specific needs of customers (e.g., regional communities), which potentially increases the market acceptance of the value propositions. Subsequently, open collaborators harness the knowledge and expertise (e.g., regional, social specificities of the target market) of their partners to design value creation activities more adequately. For instance, open collaborators use:

Co-creation with the BoP to tailor distribution and commercialization to community needs [as] part of [their] regular value-chain. [1601_C076]

This close interaction with embedded partners also affects the value capture dimension. Hence,

collaboration models remunerate their partners based on a flexible cost structure (e.g., realized on a commission basis). Additionally, the generated revenue streams are shared among the involved partners. Hence, the collaboration model is based on jointly generating and capturing value in an interplay with externals.

4.6. Performance reducers

Business models that focus on the reduction of performance varieties realize good enough value propositions. These are designed without frills and are attractive for new or hitherto unreachd customer segments. Examples include low-cost airlines or portable medical devices with limited features.

A key aspect of these no-frill models is the drastic reduction of performance variety related to value propositions to attract low-end customers and realize relatively lower prices. Value propositions focus on the core offering, thereby reducing additional services through simplification. For low-cost carriers, this implies, for example, '*no frequent flyer programs, limitations to the served routes/destinations*' [1510_R140]. Performance reducers realize the fundamental form of low-end disruptive innovations. For instance, the '*angioplasty catheter [...] replaced the need for open-heart surgery to treat moderate cardiac disease*' [1102_R045]. Thus, even complex value propositions are scaled down to an absolute minimum, which allows targeting fringe customers.

Performance reducers deliver their value propositions directly to customers, thereby eliminating intermediaries and distributors. Through standardized processes, performance reducers are able to build direct and efficient customer relationships based on '*web-based discount channel[s]*' [1102_R050]. Because of the reduction of performance variety and automation of value delivery, customers benefit from relatively low access and use barriers, which propels the adoption of these disruptive value propositions.

To succeed '*in aggressively pursuing manufacturing efficiencies*' [1102_R057], performance reducers design value creation along the automation of activities. This allows for high transaction throughputs. Value creation processes are built on existing technological bases rather than radical technologies. Moreover, available resources are well exploited. For low-cost carriers, this can be illustrated by referring to '*fast-turn-arounds and a maximization of flying time*' [1510_R146]. Relative to expensive mainstream business models, performance reducers transfer their value proposition to the digital world

in a just good enough manner, thereby reducing costs significantly.

Ultimately, performance reducers flexibilize their value capture mechanisms, focusing on the reduction of fixed costs. Non-core value creation processes for the business models are outsourced to externals. Therefore, performance reducers are able to concentrate on core activities, whilst keeping a '*low overhead to accommodate lower margins*' [801_R005], which is typical for no-frill value propositions.

5. Discussion and contributions

We started this paper by asking which archetypes of business models underlie disruptive innovation. Based on the qualitative content analysis of 122 systematically retrieved disruptive business models, we identified five typical business models ('archetypes').

We discuss how the classified archetypes a) are inducing disruptive dynamics, and b) are constituting paths towards disruption.

5.1. Archetypes as inducers of disruptive dynamics

We abstract from the complexity inherent in disruptive innovation and develop an understanding of the inducing forces of disruptive dynamics (Kumaraswamy et al., 2018). While there are studies on how particular business models evolve over time (e.g., Cozzolino et al., 2018; Snihur et al., 2018), the literature still lacks a consolidation of these findings (Hopp et al., 2018). Christensen et al. (2018) conclude that business models underlying disruptive innovation have only been '*tentatively specified*'. We join the ongoing debate by identifying five archetypes inducing disruptive dynamics.

First, *matchmakers* offer platforms and act as agents of labor and assets, allowing small-scale transactions amongst peers. Whereas previous discussions have highlighted the relevance of platform models for disruptive innovations, the inherent zero marginal cost structure is particularly supportive for realizing big-bang disruption models and target fringe customers (Hopp et al., 2018; Trabucchi et al., 2019). Matchmaking platforms are better connectors of demand and supply than established businesses (Van Alstyne et al., 2016). Additionally, platforms enable leveraging network effects, thus accelerating business growth (Katz and Shapiro, 1985). Our analysis shows that the risk of *matchmakers* in overserving customer segments is considerably lower compared to traditional unidirectional

customer relationships. Hence, flexibility allows *matchmakers* to synchronously match demand and supply. This matching is realized individually, on a per-transaction basis, ultimately increasing the relevance of individual transactions for the involved stakeholders. Consequently, *matchmakers* gradually grow their model along the disruptive trajectory. *Matchmakers* exploit existing assets and do not ask for high upfront investments, thereby allowing more people to make use of a particular offering compared to established ‘ownership’ models. This flexible and individualized matching of supply and demand fuels disruptive dynamics.

Second, *standardizers* focus on the efficient design of value creation, focusing on transaction standardization while also customizing value propositions. Our findings show how the modularization of value creation activities allows standardizers to simultaneously serve multiple customer demands. In fact, standardizers generate enhanced customer experience because the performance attributes of value propositions can be designed according to specific customer demands while keeping the value creation logic lean and highly efficient. Consequently, standardizers significantly reduce the costs of their offering while offering a higher level of customer experience. Technology integration (e.g., 3D-printing technologies) can continuously integrate customer feedback into the value creation logic. This industrialized customization results in relative efficiency compared to established business models and allows for the quick and flexible scaling up along the disruptive trajectory.

Third, *service providers* offer value propositions that can be used by customers for a limited time. Customers can complete a particular job-to-be-done without accessing the required physical assets. We complement argumentations on how business models make services more convenient and cheaper to access compared to established models (Govindarajan and Kopalle, 2006), as use based-models provide quick access to a technological service. Combined with relatively low initial investments, entry hurdles are considerably limited compared to asset-intensive alternatives. Moreover, use based-models usually start with a standardized basic functionality. Service providers actively target customer segments overserved by more advanced alternatives. Thereby, service providers have relatively little risk to overserve (potential) customers in the early stages of the disruptive innovation process. Furthermore, financial burdens are lowered, which makes the access to the offering more flexible. No (little) upfront investments combined with relatively low subscription fees make cost streams plannable for customers. In turn,

customers can use the value proposition only for the period of time they need that particular service.

Fourth, *open collaborators* open their business model to external knowledge and assets. By proposing this archetype, we relate to Ansari et al. (2016), who focus on how disruptors in systemic industries need to access complementary assets. Their study shows how incumbents ultimately included the potential disruptor’s technology in the sustaining business model, thereby eliminating disruptive dynamics. Moreover, Snihur et al. (2018) discuss how a back-end platform was opened up to externals to further develop the value creation with external IT capabilities, and ultimately disrupting an established competitor. Against this background, open collaborators is a complex archetype because it involves the strategic management of a multitude of interfaces with externals. Open collaborators need to possess adequate capabilities, which allows them to strategically drive the business model in collaboration with externals while also following the disruptive trajectory.

Nevertheless, collaboration models offer the opportunity to access external knowledge and complementary assets, ultimately realizing value creation activities and overcoming internal limitations. Moreover, collaboration models enable co-creation with stakeholders and potential customers to better fit needs, thereby avoiding potential overshooting such as when customers’ demands are not fed back into value creation. The integration of customers and stakeholders allows value creation activities to be externalized. In turn, value can be captured more efficiently and the corresponding costs can be lowered.

Finally, *performance reducers* focus on no-frills value propositions. The concept of low-end disruptive innovations has been core to many scholarly discussions (Bower and Christensen, 1995; Govindarajan and Kopalle, 2006). Performance reducers target low-end, price-sensitive customers consistently using just good enough value propositions compared to the hitherto available alternatives. Efficiency-oriented mechanisms that result in low operational costs lead to relatively lower per-transaction margins compared with sustaining alternatives. These relatively slim margins allow targeting low-profit customer segments to gain a foothold in a low-end market niche. Moreover, performance reducers can realize both relatively low operational costs and customized value propositions. In sum, performance reducers can enter the market from the bottom by considerably lowering access and usage barriers, which constitutes a promising starting position to induce disruptive dynamics. Consequently, we confirm the characteristics of no-frill disruptive business models

while positing that these business models represent “only” one alternative to perform disruptive innovation.

5.2. Archetypes as paths towards disruption

Recent debates discuss the merits of consolidating available research to advance the theory of disruptive innovation (Christensen et al., 2018; Hopp et al., 2018). Research is increasingly diverging, thereby limiting the impact of previous academic achievements (Hopp et al., 2018). Hence, we systematically consolidate waves of disruption in the scientific debates from 2006 to 2019. The proposed archetypes present paths towards disruption and update the accepted criteria of the phenomenon (Govindarajan and Kopalle, 2006).

Departing from the understanding of disruptive innovations as new business models relative to established (i.e., sustaining) ones, we extend the current scientific debates by proposing a classification of disruptive innovations beyond the criterion of just good enough innovations (e.g., Govindarajan and Kopalle, 2006). Specifically, we build on the recent arguments highlighting the contingency related to disruptive innovation (Christensen et al., 2018).

We extend the discussion on ‘*business models as models*’ (Baden-Fuller and Morgan, 2010) and how business models can be seen as blueprints of how organizations do business (Teece, 2010; Gassmann et al., 2014; Spieth et al., 2014). We complement recent attempts to characterize disruptive business models (Amshoff et al., 2015; Trabucchi et al., 2019) and provide a more complete and robust approach to classifying business models and how the underlying mechanisms spur the disruptiveness of innovation (Spieth et al., 2016; Christensen et al., 2018). We emphasize that the proposed archetypes are a form of abstraction and do not represent a particular business “en detail.”

Although the classification might infer predictability (Klenner et al., 2013), we follow Kumaraswamy et al. (2018) in that disruptive innovation is a performative phenomenon. We present paths towards disruption, and argue that every ‘disruption journey’ is shaped by a complex set of (contextual) factors and multiple actors. Additionally, we agree that disruptive innovation is a phenomenon that evolves over time (Ansari et al., 2016; Petzold et al., 2019). Therefore, we argue that our archetypes contribute by providing orientation frameworks for (potentially) disruptive innovations as the involved actors perform activities and strategic maneuvers contingent on the respective archetype. While we strengthen the

argument on the relativity of disruption (Christensen et al., 2018), there is the need to investigate the relationships between disruptors and incumbents (and even other actors beyond this dyadic setting) to better grasp the complexity of the evolving business model of a particular archetype.

6. Conclusions, implications, and limitations

We are joining debates, which argue that disruptive innovation is a question of competitive positioning rather than a matter of technological innovation. We propose typical business models (‘archetypes’) of disruptive innovation, which are summarized in Table 4. From a theoretical perspective, we make a twofold contribution.

First, the identification of five archetypes contributes to further understanding the inducers of disruptive innovation. Our consolidation of academic findings present a suitable means to learn from previous waves of disruption (Hopp et al., 2018), while developing the theory of disruption. Second, we extend the scientific debate on the criteriabased understanding of disruptive innovation (e.g., Govindarajan and Kopalle, 2006; Hopp et al., 2018). The proposed archetypes present paths towards disruption, thereby underlining the contingency of the phenomenon. We complement the discussion on business models as blueprints in the context of disruption (Amshoff et al., 2015; Trabucchi et al., 2019).

Our findings have implications for the managers of incumbent organizations, as well as entrepreneurs striving to launch their businesses. The proposed archetypes can assist both groups in guiding strategic decisions in the face of disruption. Practitioners may refer to the archetypes when seeking potential paths to commercialize (disruptive) technologies by designing adequate business models. By linking the archetypes to familiar disruptive business model examples, we support the theoretical relevance of the classification and provide reference points for business strategies. From a practitioner’s perspective, the archetypes may be used as guiding principles in performing disruptive innovation instead of predicting the phenomenon (Kumaraswamy et al., 2018); hence, they can help with brainstorming for new business model design or creating response strategies for potentially disruptive dynamics.

This study is not without limitations: it relies on systematically collected data from academic sources, thereby limiting the access to historical data. Our classification needs to be revisited

on a continuous basis, especially because current debates emphasize an ‘era of continual disruption’ (Kumaraswamy et al., 2018) bringing about new business model archetypes with potentially new inducers. Referring to current debates about widening the concept of disruption (Ritala et al., 2021), future research could include a broader data base. However, we argue that the focal study represents a cornerstone in the discussion. We aimed to reduce the conceptual noise through transparently constructing a data base, which is anchored in the Christensenian understanding.

Future studies should join debates about the multiple levels of disruption. For instance, longitudinal inter- and intra-industry studies could discuss how far the distilled archetypes enable waves of disruption over time. While we acknowledge Snihur et al.’s (2018) concerns regarding the difficulty of tracking disruptive business models in real time, we encourage scholars in R&D management to accept this challenge and contribute to the performative perspective.
