Particulate Matter Pollution Remains a Threat for Cardiovascular Health: Findings From the Global Burden of Disease 2019

BACKGROUND: Particulate matter (PM) pollution is a significant risk factor for cardiovascular diseases, causing substantial disease burden and deaths worldwide. This study aimed to investigate the global burden of cardiovascular diseases attributed to PM from 1990 to 2019.

METHODS AND RESULTS: We used the GBD (Global Burden of Disease) study 2019 to investigate disability-adjusted life-years (DALYs), years of life lost (YLLs), years lived with disability (YLDs), and deaths attributed to PM as well as its subgroups. It was shown that all burden measures' age-standardized rates for PM were in the same decreasing trend, with the highest decline recorded for deaths (–36.7%). However, the all-age DALYs increased by 31%, reaching 8.9million in 2019, to which YLLs contributed the most (8.2 million [95% uncertainty interval, 7.3 million–9.2 million]). Men had higher deaths, DALYs, and YLLs despite lower years lived with disability in 2019 compared with women. There was an 8.1% increase in the age-standardized rate of DALYs for ambient PM; however, household air pollution from solid fuels decreased by 65.4% in the assessed period. Although higher in men, the low and high sociodemographic index regions had the highest and lowest attributed YLLs/ YLDs ratio for PM pollution in 2019, respectively.

CONCLUSIONS: Although the total age-standardized rate of DALYs for PM-attributed cardiovascular diseases diminished from 1990 to 2019, the global burden of PM on cardiovascular diseases has increased. The differences between men and women and between regions have clinical and policy implications in global health planning toward more exact funding and resource allocation, in addition to addressing inequity in health care access.

nvironmental pollution is among the most significant reversible causes of premature death and disability worldwide.¹ Among environmental risk factors, air pollution, particularly particulate matter (PM) pollution, is a leading contributor to the global burden of disease (GBD) associated with increased morbidity and mortality.^{1–3} After hypertension, smoking, and high fasting plasma glucose, air pollution is the fourth most important risk factor considering all-cause death rates, whereas it is the second most important risk factor for global disability-adjusted life-years (DALYs).⁴ Moreover, 91% of the world's population lives in places where the

CLINICAL PERSPECTIVE

What Is New?

- Age-standardized rate of the cardiovascular disease burden attributable to particulate matter pollution had a decreasing trend from 1990 to 2019; also, all-age disability-adjusted lifeyears (DALYs) increased by 31% from 1990 to 2019, in which men contributed more.
- The age-standardized rate of DALYs for ambient particulate matter as a subtype of particulate matter increased from 1990 to 2019, whereas during the same period, there was a two-thirds decrease in this index for household air pollution from solid fuels.
- The differences in the burden of cardiovascular diseases attributable to particulate matter pollution among regions and between sexes can guide policy making to reduce the negative impacts of this environmental issue.

What Are the Clinical Implications?

- The findings of the current study showed that although there was a decrease in agestandardized rate of all burden measures, the all-age numbers for them increased.
- These differences highlight the inequity in access to health care in different global burden of disease regions and countries. Sex differences, including higher years of life lost (YLLs), deaths, and DALYs in men, can have clinical and policy implications.
- The higher YLLs/years lived with disability ratio in low and low-middle sociodemographic index regions can lead to better air pollution control strategies.

air quality index exceeds the limits of the World Health Organization guidelines. $^{\rm 5}$

As one of the well-established outcomes of air pollution, cardiovascular diseases (CVDs) contribute to about one-third of global deaths.⁶ For CVDs, ambient PM pollution and household air pollution (HAP) from solid fuels are 2 major risk factors.^{4,7,8} PM is classified into 3 main categories based on its aerodynamic diameter: coarse (PM₁₀, 2.5–10 μ m), fine (PM_{2.5}, <2.5 μ m), and ultrafine (PM_{0.1}, <0.1 μ m) PM.^{5,7} PM₁₀ and PM_{2.5} are the most common pollutants responsible for hospitalization and mortality.⁷

PM_{2.5} is the most influential environmental risk factor contributing to global CVD mortality and disability.^{1,5} The CVD burden continues its decades-long increase in almost all countries other than high-income countries.⁴ Although PM pollution-attributed deaths caused by CVDs have decreased in several regions, it is still a significant concern, especially in low-income countries.⁹ Notably, climate change has already affected air quality; for instance, an increase of up to 112% was reported in mean annual PM_{2.5} concentration from 2000 to 2020.¹⁰

Thus, there is an urgent need for more extensive investigations and studies toward understanding the trends, spatial and temporal changes, and their relationship with policies and strategies on global, regional, and national scales. The GBD studies are systematic approaches evaluating global changes in health situations.¹¹ In this way, DALY is a complementary tool to assess health impacts (morbidity and mortality) that might be attributed to environmental risk factors (eg, PM pollution).¹² To compare the overall health and life expectancy of different populations, DALY is applied, taking into account the years of life lost (YLLs) and years lived with disability (YLDs).¹²

In this study, the global burden of CVD attributed to PM pollution and its subcategories was investigated using GBD data retrieved from the Institute for Health Metrics and Evaluation from 1990 to 2019. For this purpose, YLLs, YLDs, DALYs, and deaths were considered in 204 countries, 21 GBD regions, and sociodemographic index (SDI) quintiles.

METHODS

The data underlying this article were derived from sources in public domain: Institute for Health Metrics and Evaluation, at http://ghdx.healthdata.org/gbd-results-tool.

Overview

The study was based on the Guidelines for Accurate and Transparent Health Estimates Reporting.¹³ As GBD 2019 study only assessed PM-attributed burden in 2 of the 11 CVDs (ischemic heart disease [IHD] and stroke), we only used the *International Classification of Diseases (ICD-10)* codes for these 2 for mapping. The GBD 2019 study could provide all estimates along with their uncertainty intervals (UIs) for all regions in all years in between, even in case of sparse or missing data. The data obtained were age-standardized rate (ASR) and all-age number of deaths, DALYs, YLLs, and YLDs attributed to ambient PM and HAP from solid fuels for all 204 countries, 21 GBD regions, and SDI quintiles by age groups and sex from 1990 to 2019.

Data Source

Data on the global burden of CVDs attributed to PM pollution were obtained from the GBD Results tool on the Institute for Health Metrics and Evaluation (http://ghdx.healthdata.org/gbd-results-tool) website in addition to GBD studies.¹⁴ The systematic evaluation of 369 diseases and injuries along with 87 risk factors in 204 countries and territories from 1990 to 2019 is available on the website.¹⁴

Detailed description of methods for estimation of CVD burden attributed to PM has been explained by GBD studies.^{4,15} Total PM, composed of ambient PM pollution and HAP from solid fuels data, was incorporated from various sources, such as satellite observations of aerosols, the atmosphere, chemical transport model simulations, population estimates, and land-use data (http://ghdx.healthdata.org/gbd-2019/data-inputsources). Ambient PM exposures were assessed using satellite, ground-level monitoring, and chemical transport models in grids that were subsequently transformed into national exposures by estimated population weights.^{16,17} HAP from solid fuels was also defined as the PM from wood, drug, agricultural residues, coal, and charcoal used for cooking and heating, which were estimated from observational surveys and census reporting.^{18,19}

CVD Burden

Estimation of mortality was done by using vital registration data coded to the ICD-10 system or household mortality surveys known as verbal autopsy (IHD death: I20-I25.9¹⁴; and stroke death: G45-G46.8, I60-163.9, 165-166.9, 167.0-167.3, 167.5-167.6, 168.1-168.2, and I69.0-I69.3¹⁴). Statistical methods were used to increase the comparability of mortality data sources. They include the reclassification of codes that are nonspecific or unspecified, noise reduction algorithms, and Bayesian geospatial regression software (the Cause of Death Ensemble model) that used locationspecific covariates to create smoothed time trends for 204 countries and territories by borrowing strength over age, space, and time. Selected covariates for Cause of Death Ensemble model of CVD included cholesterol (total, mean per capita) (+1 direction), smoking prevalence (+1 direction), systolic blood pressure (mmHg) (+1 direction), mean body mass index (+1 direction), elevation >1500 m (proportion) (-1 direction),

fasting plasma glucose (mmol/L) (+1 direction), outdoor pollution (PM_{2.5}) (+1 direction), indoor air pollution (all fuel types) (+1 direction), health care access and quality index (-1 direction), lag distributed income per capita (-1 direction), summary exposure value for ω -3 fatty acids (+1 direction), fruits (+1 direction), vegetables (+1 direction), nuts and seeds (+1 direction), polyunsaturated fatty acids adjusted (percentage) (+1 direction), pulses/legumes (kcal/capita, unadjusted) (-1 direction), alcohol (liters per capita) (+1 direction), and trans fatty acid (+1 direction).

For incidence and prevalence of disease data, they were produced by a broad range of population-representative data sources identified through literature review and with study collaborations, including scientific reports of cohorts and registries, population surveys, microdata from registry and cohort studies, and health system administrative data (*ICD-10* codes: IHD new cases: I20–I21.6, I21.9–I25.9, and Z82.4–Z82.49²⁰; stroke new cases: G45–G46.8, I60–I62, I62.9–I64, I64.1, I65–I69.998, and Z82.3²⁰). Epidemiologic state-transition disease modeling software, DisMod-MR, and Bayesian meta-regression software, MR-BRT, which adjusted for study-level differences in measurement methods and case definitions, were used for the production of consistent disease estimates.⁴

PM-Attributed CVD Burden

Population-representative survey and surveillance data and geospatial Gaussian process regression models that borrowed strength across time and geography were used to estimate risk factor exposures.⁴ The attributable burden was defined by the reduction in the current CVD burden if population exposure was altered to a counterfactual distribution of PM. Estimating attributable burden followed the 6 key steps of comparative risk assessment framework,⁴ comprehensively described in the GBD articles^{21,22} and composed of the following: (1) including the risk-outcome pairs into the analysis; (2) estimating relative risk as a function of exposure based on published systematic reviews and meta-regression; (3) using spatiotemporal Gaussian process regression, DisMod-MR 2.1, a Bayesian meta-regression method, or alternative methods to estimate exposure levels; (4) computing the theoretical minimum risk exposure level as the counterfactual level of exposure based on the published trials or cohort studies; (5) calculating the population-attributable fractions and computing attributable burden (deaths, YLLs, YLDs, or DALYs) by the relevant outcome quantity; and (6) considering the mediating effects of various risk factors on each other to determine the attributed burden of a combination of risk factors.¹⁵ The final estimates of attributable burden include uncertainty in each step of the analysis.

Statistical Analysis

Standard epidemiologic measures, such as YLLs, YLDs, deaths, and DALYs, were considered caused by CVD burden attributable to PM, ambient PM, and HAP from solid fuels pollution risk factors. YLLs were calculated as the number of cause-specific deaths multiplied by a loss function that demonstrates the years lost for death calculated from the year at which death occurs. YLDs were also calculated as the number of years of healthy life lost attributable to disability or ill health. DALYs were obtained by the sum of YLLs based on maximum observed life expectancy, and YLDs based on standardized disability weights. Disability weights are scored on a scale of 0 to 1, where 0 is the state of full health, and 1 is regarded as dead. DALY is a summary measure quantifying all burdens of the disease, as it could take into account the effect of a disease with high morbidity and disability but low mortality and vice versa, resulting in the fact that each 1 year of DALY is regarded as 1 year of full health loss.²³ In summary, 1 DALY represents the loss of the equivalent of 1 year of full health. All mentioned measures were reported as the metrics of ASR per 100000 or number with percentage change along with 95% UIs. In addition, the age group, sex, year, and location of all of them were extracted for stratification. The ASR was calculated through standardization to the global age structure; also, when comparing populations from different locations or a sample population over time, this standardization was considered to be necessary.²⁴ The 1000 draw-level estimates for each parameter were used for the calculation of UIs for each parameter, and 95% UIs were defined by the 25th and 975th values of the ordered 1000 times. YLLs/YLDs ratio was used as an epidemiologically meaningful combination of fatal and nonfatal estimates of CVDs.²⁵ This ratio can reflect the quality of health care provided in a region and poorer health quality, and living less than life expectancy in a certain region would lead to a higher YLLs/YLDs ratio.²⁶ In addition, the relation between development status reflected as SDI and YLLs/YLDs ratio was considered. SDI is the geometric mean of 0 to 1 index of total fertility rate for those aged <25 years, mean education for those aged \geq 15 years, and lag distributed income per capita.^{27,28} The range of each SDI class is as follows: low SDI (<0.455), lowmiddle-SDI (0.455-0.608), middle SDI (0.608-0.690), high-middle-SDI (0.690–0.805), and high SDI (>0.805). The considered age category of CVD burden attributed to PM pollution was \geq 25 years, by 5-year intervals. Graphs and world maps were designed to illustrate the distribution in addition to the changes in global and national CVD burden attributable to PM pollution. All statistical analyses were performed by R version 4.0.4 (R Core Team [2020]; R: a language and environment for statistical computing; R Foundation for Statistical Computing, Vienna, Austria) and STATA software version 14.0 (Stata Corp).

Funding Source Role

There was no role of the funder in any of the study design, data collection, data analysis, data interpretation, or drafting of the manuscript. All the responsibility for the decision of the manuscript was on the corresponding author, who had full access to the study data.

Ethical Approval and Consent to Participate

No individual data were reported in this article, and the information is based on aggregated preexisting online data. All the data included in this study are publicly available on the GBD Compare tool (https://gbd.healt hdata.org/gbd-compare). Therefore, the need for ethical approval was waived in this study. Also, as there are no individual data reported in this study, participant consent was waived.

RESULTS

Overview

Generally, in 2019, there were 3.5 million (95% UI, 3.1 million–4.0 million) deaths from CVDs attributed to PM, among which male individuals contributed 56.5%. For ASR of death also, 44 (95% UI, 38.9–49.4) deaths were reported per 100000. Moreover, 8.9 million (95% UI, 7.9 million–9.9 million) DALYs were reported globally, among which men had a 40.6% contribution. Two subtypes of PM, ambient PM and HAP from solid fuels, had 2.5 million (95% UI, 2.0 million–2.9 million) and 1.1 million (95% UI, 0.7 million–1.5 million) CVD-attributed deaths, respectively. All-age numbers, ASRs, and crude rates of all burden measures for PM-attributed CVDs are shown in the Table and Table S1.

Time Trends

Between 1990 and 2019, total deaths and DALYs attributable to PM pollution increased by about one-third. Although the all-age deaths increase from 2.6 million (95% UI, 2.3 million–2.9 million) in 1990 to 3.5 million (95% UI, 3.1 million–4.0 million) in 2019, a particularly higher increase was observed in men, 43.0% (95% UI, 25.3%–61.5%), compared with 28.2% (95% UI, 10.7%–48.0%) in women. The same increasing pattern was witnessed for DALYs, 6.8 million (95% UI, 6.1 million–7.5 million) in 1990 to 8.9 million (95% UI, 7.9 million–9.9 million) in 2019, and YLLs with an increase of 6.4 million (95% UI, 5.7 million–7.1 million) to 8.2 million (95% UI, 7.3 million–9.2 million). Particulate Matter Pollution Cardiovascular Burden

was a 73.1% (95% UI, 62.3%–83.6%) increase in YLDs, which was almost similar in both sexes. In terms of the ASR for each of the measures, a similar decrease of \approx 35% was observed for deaths, DALYs, and YLLs. However, age-standardized YLDs of CVDs attributable to PM pollution decreased less dramatically (12.6% [95% UI, 7.1%–18.3%]) (Table).

From 1990 to 2019, deaths related to ambient PM pollution increased by 121.9% (95% UI, 82.1%–181.2%). Also, DALYs and YLLs had more than doubled in this period. YLDs increase was also \approx 200.9% (95% UI, 146.4%–282.1%), with nearly the same increase among women and men. Despite this increase in all measures, there was a more moderate increase in the ASRs, being 0.3%, 8.1%, 5.8%, and 49.6% for deaths, DALYs, YLLs, and YLDs, respectively (Table).

All crude numbers and ASRs attributed to HAP from solid fuels decreased from 1990 to 2019. These include a change in death from 1.5 million (95% UI, 1.1 million–1.8 million) to 1.1 million (95% UI, 0.7 million–1.5 million) with an ASR decrease of 66.1% (95% UI, 57.3%–74.0%) (Table).

The risk-time trend figures for PM pollution attributed to CVD burden imply that YLLs, deaths, and DALYs for PM pollution, especially HAP from solid fuels, ASR had decreasing trends for men and women from 1990 to 2019 (Figure 1). In the case of ambient PM, the 3 measures mentioned above had marginal fluctuations, whereas YLDs had an increasing trend from 1990 to 2019. For PM, ambient PM, and especially HAP from solid fuels, higher YLDs were allocated to the women, in contrast with the other 3 measures.

For PM pollution, ASR for all the studied measures had declining trends, particularly for YLLs, deaths, and DALYs; however, for the all-ages numbers, the measures had increasing trends from 1990 to 2019 (Figure S1). For ambient PM pollution, rates of YLLs, deaths, and DALYs had almost steady-state trends from 1990 to 2019. However, YLDs had an increasing trend from 1990 to 2019. The number of attributed all ages for all 4 measures had an increasing trend from 1990 to 2019. On the contrary, for HAP from solid fuels, decreasing trends were observed for all the considered measures.

Burden Among GBD Regions *PM Pollution*

Changes in the ranking of deaths ASR from 1990 to 2019 for both sexes in 21 GBD regions were considered (Figure 2). North Africa and the Middle East exhibited the highest ranking in 1990, whereas it substantially decreased to the seventh rank in 2019. In the case of DALYs, the first rank was allocated to Oceania from 1990 to 2019. ASR of DALYs in North Africa and

the Middle East decreased by 36.5% from 2586.5 (95% UI, 2255.2–2951.5) to 1641.8 (95% UI, 1377.9–1925.6) per 100000, and their rank decreased from the second to the sixth within the category. ASRs of deaths and DALYs for all GBD regions were declining; however, some areas, such as Southern and Central Asia, Eastern, Southern, and Western sub-Saharan Africa, the Caribbean, Central Latin America, and high-income Asia Pacific regions, increased ranking among the considered regions.

PM Pollution Subtypes

For ambient PM, death and DALY ASRs of women and men exhibited similar rankings for the studied reajons. For men, the highest ASR of deaths (87.9: 95% UI, 48.9-128.5 per 100000) was allocated to Central Europe in 1990, whereas it remarkably moved down to the seventh position with 39 (95% UI, 31.4-47.2) in 2019 (Figure S2). In 2019, Central Asia exhibited the highest ranking (103.3 ASR of deaths per 100000; 95% UI, 74.3-135.2) among the considered regions climbing from the fourth position to the first. North Africa and Middle East and East Asia underwent a marginal increase in ranking from the third and fifth positions in 1990 to the second and third places, respectively. North Africa and the Middle East had the highest ranking, with deaths of 55.45 per 100000 (95% UI, 43.1-68.1) in 1990. Although the total death rate increased by 1.5% to 56.3 per 100000 (95% UI, 46.6-65.8), its ranking decreased to the second position in 2019. Similar to the corresponding data for men, Central Asia reached the first position for ambient PM-attributed deaths caused by CVD for women in 2019, with 63.3 deaths per 100000 (95% UI, 44.7-83.7). Central, East, and Southeast Asia had increasing trends from 1990 to 2019.

For HAP from solid fuels, Oceania has been on top since 1990, with a death ASR change of 101.1 (95% UI, 78.6–129.2) to 85.04 (95% UI, 62.4–110.0) in 2019. Central, Eastern, and Western sub-Saharan Africa have changed their positions between the second and the fourth positions; however, Western sub-Saharan Africa has had a steady-state trend (Figure S2).

Burden Among GBD Countries




Figure 3. Global age-standardized DALY rate (per 100000) caused by cardiovascular disease attributed to particulate matter pollution for both sexes in 1990 and 2019. DALY indicates disability-adjusted life-year.

The country-level burden of PM pollution on CVDs was investigated. From 1990 to 2019, CVD's ASR of DALYs attributed to PM pollution decreased in most countries (Figure 3). In 2019, Solomon Islands, Vanuatu, and Afghanistan had the highest PM pollution-attributed CVD ASR of DALYs of 7171.4 (95% UI, 5684.0–8759.2), 4345.2 (95% UI, 3289.2–5798.7), and 3961.3 (95% UI, 3046.3–5042.0) with percentage




Figure 1. Global time trend of age-standardized rate for YLLs, YLDs, deaths, and DALYs caused by cardiovascular disease attributed to PM pollution (A), ambient PM pollution (B), and household air pollution from solid fuels (C) by sex from 1990 to 2019. DALY indicates disability-adjusted life-year; PM, particulate matter; YLDs, years lived with disability; and YLLs, years of life lost.

changes of -7.1%, -0.03%, and 35.8% from 1990 to 2019, respectively.

Determinants of CVD Attributable to PM Pollution Sex and Age




Figure 4. Global YLLs, YLDs, deaths, and DALYs caused by cardiovascular disease attributed to PM pollution (A), ambient PM pollution (B), and household air pollution from solid fuels (C) for both sexes, men and women, in 1990 and 2019.

The burden measures exhibited a higher attributed rate for men than women. In the case of YLDs, the attributed rate was almost unchanged between 1990 and 2019, and it was higher for women than for men. For the ambient PM, higher attributed rates of YLLs, DALYs, and deaths were depicted for men, whereas the attributed rate for YLDs was more for women, and it increased in 2019 compared with 1990 (Figure 4). In 2019, for PM pollution, the highest YLLs and DALY rates were both observed in the age range of 80 to 84 years; however, the highest YLDs were at the age of 75 to 79 years for both men and women. In the case of ambient PM and HAP from solid fuels, the highest rates for both YLLs and DALYs were in the age ranges of 85 to 89 and 75 to 79 years, respectively. The HAP from solid fuels attributed rates of YLLs. YLDs. deaths. and DALYs caused by CVD significantly decreased from 1990 to 2019. Similar to the results obtained for PM and ambient PM, the attributed YLDs were notably higher for women versus men. In contrast to the attributed YLDs rate for the ambient PM, this measure remarkably decreased from 1990 to 2019 for both men and women.




Figure 5. Global age-standardized YLLs/YLDs ratio of cardiovascular disease attributed to particulate matter pollution for both sexes (A) and men vs women (B) in 1990 and 2019.

The PM-attributed CVD age-standardized YLLs/ YLDs ratio for both men and women remarkably changed from 1990 to 2019 (Figure 5). The YLLs/YLDs ratio for both sexes was 18.1 in 1990, decreasing to 13.2 in 2019 (Table). Also, for men and women, YLLs/ YLDs ratio decreased from 23.7 and 13.7 in 1990 to 17.9 and 9.3 in 2019, respectively. Significantly higher YLLs/YLDs ratios were observed for men than women.

The ASR of deaths per 100000 attributed to ambient PM pollution was investigated for each sex, and in the case of women, it was generally less than that for men. The global deaths for women slightly decreased




Figure 2. Ranking of 21 global burden of disease regions (1990–2019) for age-standardized rate of deaths and DALYs attributed to PM pollution, both sexes (A); and deaths and DALYs attributed to PM pollution for men versus women (B). DALY indicates disability-adjusted life-year; and PM, particulate matter.

from 24.6 (95% UI, 17.7–31.8) in 1990 to 23.2 (95% UI, 18.7–27.7) in 2019. HAP from solid fuels had higher death ASR for men compared with women, whereas both decreased from 1990 to 2019, with a percentage change of -67.9% (95% UI, -76.2% to -58.3%) and -64.5% (95% UI, -72.7% to -55.9%) for men and women, respectively.

Sociodemographic Index




Figure 6. Age-standardized YLLs/YLDs ratio of cardiovascular disease attributed to particulate matter pollution for both sexes, men and women, within the 5 SDI locations in 1990 and 2019.

In the third ranking, PM pollution was a significant risk factor for the global attributed burden of DALYs ASR caused by CVDs for both sexes in 2019 (Figure S3). The low, lowmiddle, and middle SDI quintiles had the second ranking in 2019, whereas high-middle and high SDI quintiles had the sixth and eighth rankings, respectively. In terms of deaths, although being the fourth globally, these were second for low and low-middle, third for middle, sixth for high-middle, and 10th for high SDI countries (Figure S3). The low-middle SDI region had the highest burden of YLLs/YLDs ratio caused by CVD attributed to PM pollution for both men and women in 1990 and 2019 (Figure 6 and Table S2). As previously mentioned, YLLs/YLDs ratio was higher for men than women; and for women, the low SDI region had slightly higher values of YLLs/YLDs ratio in 2019, with a decrease compared with 1990.

IHD and Stroke Global Burden

Stroke and IHD were investigated separately for all measures. Similar to total trend of CVDs attributed to PM, all measures, including deaths, DALYs, YLLs, and YLDs, for IHD attributed to PM pollution showed decreasing trends in terms of ASR, with percentage changes of -30.3%, -28.5%, -28.9%, and -12.4%, respectively. However, all-ages number for all of them increased from 1990 to 2019 (46.2%, 44.1%, 43.3%, and 81.3%,

respectively). This increase was mostly attributable to increase in ambient PM pollution, whereas ASR and allage numbers of HAP from solid fuels decreased for all the measures during the investigated period (Table S3).

In terms of stroke burden, DALYs increased from 36.3 million (95% UI, 32.4 million–40.3 million) in 1990 to 43.5 million (95% UI, 38.4 million–48.7 million) in 2019. Conversely, ASR of DALYs decreased from 888.0 (95% UI, 789.9–989.8) to 525.6 (95% UI, 463.9–589.9) per 100000. Ambient PM pollution and HAP from solid fuels had similar trends to the whole CVD group burden, with moderate DALY increase of 9.0% (95% UI, –14.3% to 43.3%) in ambient PM pollution ASR and decrease of –68.8% (95% UI, –76.2% to –60.7%) in HAP from solid fuels (Table S3).

DISCUSSION

Globally, all-age deaths, DALYs, YLLs, and YLDs of CVDs attributable to PM increased from 1990 to 2019; however, the ASR for all of them showed a downward trend. This opposite trend can be partially explained by aging and population growth. Men had a higher attributable rate for deaths, DALYs, and YLLs but not for YLDs. All burden measures and their ASR for ambient PM have also increased, whereas there was an inverse trend for HAP from solid fuels. In 2019, the highest CVD death rate was for the ages of 85 to 89 years, whereas this was 80 to 84 years for DALYs. This ranking was significantly different for SDI quintiles, with its highest ranking in low and low-middle SDI quintiles in 2019.

PM pollution is the most important environmental risk factor for global CVD mortality and disability. The epidemiologic studies conducted in Europe, Canada, and the United States suggest an association between exposure to fine PM pollution and mortality attributable to CVD.²⁹⁻³¹ The underlying mechanisms by which PM can affect the cardiovascular system are broad and elusive to determine; however, inflammation, oxidative stress, metabolic dysfunction, atherosclerosis, hypertension, and autonomic dysfunction are suggested to play a role in this regard.³²

Several factors contribute to PM, ambient PM, and HAP from solid fuels, which, in turn, may result in CVD burden. In the African region, HAP from solid

DALY indicates disability-adjusted life-year; PM, particulate matter; YLDs, years lived with disability; and YLLs, years of life lost.

fuels was an influential risk factor for CVD, ranking third for the attributed YLLs caused by CVD. This is hypothesized to be related to biomass consumption as a primary source of domestic energy and coal burning for heating, cooking, and lighting. This consumption has been estimated to be as much as 80% in Africa.^{33,34} Likewise, it has been well established that indoor cooking is significantly harmful, especially in the absence of proper ventilation, which is common in African countries.³⁵ HAP affects \approx 2.45 billion people in low- and middle-income countries. Additionally, 2.8

to 4.3 million premature deaths are attributed to HAP annually, equivalent to 7.7% of the global mortality. 36,37

The ASR of YLDs increased for men and women, with higher ambient PM and HAP from solid fuel levels. In our study, YLLs, deaths, and DALYs were higher for men, whereas higher YLDs were noticed for women. Sex disparities related to CVD can have clinical and policy implications in global health planning toward more exact funding and resource allocation.³⁸ It has been suggested that women might be more susceptible to PM-induced health effects. The Women's

Health Initiative Observational Study found that with each 10-µg/cm³ increase in PM_{2.5}, fatal cardiovascular events in women increased by 76%.³⁰ Also, according to the NHS (Nurses' Health Study), the same increase in PM25 concentration could lead to an increase of 43% in fatal coronary heart disease.³⁹ This could be attributed to exposure disparities that increase the risk for women. For instance, the use of biomass fuels for cooking in sub-Saharan Africa and South Asia disproportionately exposes high levels of indoor air pollution.⁴⁰ In most of the regions, YLLs/YLDs ratio decreased. YLLs/YLDs ratio was generally higher for men than women, especially in the Russian Federation and African countries. In addition, it has been found that the IHD burden attributed to PM pollution is higher in men than women because of the higher all-cause mortality rates in men.⁴¹ On the basis of the results investigated in this current study, it was also endorsed that PM pollution has brought about higher YLLs for men and higher YLDs for women caused by CVD from 1990 to 2019. Policies should be designed to address these sex differences with the aim of reducing men's exposure to ambient air pollution and women's exposure to HAP from solid fuels. A great burden of HAP exposure has been suggested to be among women of childbearing age and children aged <5 years because of their disproportionate time spent in the house.⁴² These interventions include the ones that improve access and take-up to cleaner fuels (such as refined biomass, ethanol, liquefied petroleum gas, solar fuels, and electricity), structural interventions, such as improved cookstoves and inbuilt stoves, fuel policy, and behavioral interventions.⁴³

Air pollution and its cardiovascular effects are becoming an emergency in communities in recent years. It has been suggested that short-term PM25 can increase cardiovascular events by 1% to 3%, whereas longer exposure can lead to an ≈10% increase.¹ The Lancet commission on pollution and health has prepared the "pollutome" framework as a subset of "exposome," which is defined by the total influences of pollution on human health.⁴⁰ The health effects of air pollution on all-cause mortality and cardiovascular mortality are only the tip of the iceberg, whereas the remaining complications, such as diabetes, nonfatal myocardial infarction, and heart failure with emerging evidence, should not be neglected. IHD and stroke were assessed as subcategories of CVDs for which the same trend was observed. The effect of PM pollution on IHD was attributed to several complications of atherosclerosis, including plaque vulnerability, thrombosis, and acute ischemic events.44 In terms of stroke burden, a study by Zhang et al reported the association of PM_{2.5} with both ischemic and hemorrhagic stroke, whereas the case for PM_{10} was only significant with ischemic stroke, which, stratifying by age and sex, could not affect this result.⁴⁵ Future projections of air pollution's effect on premature mortality have shown that although future $PM_{2.5}$ will be reduced in most regions, the increase in population may lead to higher mortality attributed to PM.⁴⁶ All of these highlight the importance of pollution control all over the world.

Having the first ranking among the 21 GBD regions, North Africa and the Middle East exhibited the highest PM-attributed ASR of deaths in 1990. In this region, the highest disease burden attributable to air pollution was from the PM pollution.⁴⁷ Moreover, it has been reported that countries in North Africa and the Middle East had a high burden of IHD attributable to PM₂₅⁴¹ Nevertheless, in 2019, its rank dramatically decreased from first to seventh. These countries are rich in terms of fossil fuels, and thereby, the main source of climate change is the energy sector; however, it seems hard to address this problem in preventive programs because energy is needed for the development of these countries.⁴⁸ Oceania held the first position for DALYs from 1990 to 2019. Indeed, in some low- and middleincome countries, particularly in Asia, Oceania, and Africa, there have been concerns about notable exposure to PM_{2.5}-attributed DALYs caused by IHD.⁴¹ Preventive measures with a special focus on PM_{2.5} are highly warranted to further reduce the attributable burden in these countries.

On the contrary, death and DALY rates underwent declining rankings in Europe, probably because of less exposure to PM through promoting air pollution control measures and technologies along with higher-guality and access to health care facilities and services. According to the literature, population aging has increased the total number of deaths and DALYs caused by IHD attributed to PM pollution in Europe, whereas in Asia and Africa, population growth has played this role since 1990.⁴¹ In Western Europe, the ranking of deaths caused by CVD attributed to ambient PM substantially decreased among the 21 GBD regions. In 2019, Central Asia exhibited the first ranking for ambient PM, for both men and women. Africa and Oceania also had increasing rankings from 1990 to 2019. Deaths per 100000 were generally less for women than men. From 1990 to 2019, the ASR of HAP from solid fuels-attributable stroke burden decreased in most countries.⁴¹ Oceania has been on top of the death rate caused by CVD attributed to HAP from solid fuels.

Investigating at the country level, Afghanistan had the highest PM pollution-attributed DALYs ASR in 1990 and 2019, although its DALYs number decreased. The ASR of DALYs attributable to CVD attributed to PM pollution was the highest in South Asia, Central Asia, South-East Asia, North Africa and Middle East, and East–sub-Saharan Africa in 1990. In 2019, the CVD ASR of DALYs attributed to PM pollution decreased in most regions. The highest levels were allocated to some parts of South Asia, Central Asia, and Eastern sub-Saharan Africa. These differences in ASR of DALYs around the globe supposedly indicate differences or inequity in access to health care and primary and secondary prevention strategies, especially in lowand middle-income countries.^{4,49}

More importantly, the share of older people is supposed to double in the mentioned regions between 2019 and 2050.^{4,50} Indeed, these global patterns present significant findings for clinical practice and public health policy development. Likewise, it has been well established that long-term exposure to PM, especially PM_{2.5}, is associated with an increased risk of CVD in adults aged 35 to 70 years.⁹ In this way, attention should be paid to promoting air pollution control systems and, more importantly, preventive policies and measures related to decreasing PM emissions.

The YLLs/YLDs ratio in high SDI, high-middle SDI, and middle SDI was lower than that in low SDI and low-middle SDI in both 1990 and 2019, but this difference was widened in 2019. The YLLs/YLDs ratio was higher in low and low-middle SDI than in global SDI. This global difference can be attributed to opposing trends in low and low-middle SDI countries and high and high-middle SDI countries. It can show the inequities in access to health care systems and air pollution control strategies. Widespread use of statins and low doses of aspirin have supposedly led to a lower burden of IHD in high SDI countries.⁴¹ Likewise, air pollution prevention and control strategies have resulted in less exposure to PM in high SDI countries.^{41,51} These results show that low-middle and low SDI countries cry out for urgent planning and implementation of preventive and control strategies to increase the access and quality of the health care system and enhance air pollution control with the main focus on PM control.

Strengths and Limitations

The present study provides the policy makers and stakeholders at national and international levels with valuable information about the burden of CVDs attributed to PM. However, there are several limitations to address. First, the data for some countries may be from samples not representative of the whole population of the region. Second, PM composition may vary over time and place,⁵² which can affect the spatial homogeneity assumption in these studies. Third, cause-specific mortalities from different countries are heterogeneous,^{53–55} affecting the GBD study results. Third, the GBD 2019 study only assessed IHD and stroke among CVDs in association with the PM that, although contributing to most CVDs, may have

an impact on our results and further consideration of other CVDs in future GBD studies may be helpful in this regard. Fourth, our findings from the GBD study 2019 showed an association between PM pollution and cardiovascular health, and no causal relationship can be deduced from these findings. Fifth, inherent limitations of GBD studies should be taken into consideration, the most important of which is the fact that data presented here are only estimates from the models, which may not necessarily represent true numbers. Finally, especially in low- and middle-income countries, there may be limited access to clinical care and a lack of effective case-finding methods, resulting in low-quality epidemiologic data sets.

CONCLUSIONS

Despite a decrease in ASR of deaths, DALYs, YLLs, and YLDs of CVD attributed to PM pollution from 1990 to 2019, the all-age numbers for them increased, primarily attributable to aging in higher SDI countries and population growth in lower SDI ones. The differences in ASR of DALYs around the globe supposedly indicated differences or inequity in access to health care and primary and secondary prevention strategies. It is worth considering that YLLs, deaths, and DALYs were higher for men, whereas higher YLDs were noticed for women, which can have clinical and policy implications in global health planning toward more exact funding and resource allocation. The YLLs/YLDs ratio was higher in low and low-middle SDI than global SDI. This global difference can show the inequities in access to health care systems and air pollution control strategies. Air pollution prevention and control strategies have resulted in less exposure to PM in many countries. These results showed that low-middle and low SDI countries cry out for urgent planning and implementation of preventive and control strategies to increase the access and quality of the health care system and enhance air pollution control with the main focus on PM control.




