Asymmetric volatility spillover between crude oil and other asset markets

Abstract

This study uses the Multiplicative Error Model (MEM) to explore asymmetric volatility spillovers between crude oil and other major asset markets. We have extended the MEM of Engle et al. (2012) and ddd to include asymmetric volatility spillovers and developed the spillover balance as well as asymmetric spillover indexes. We have then allowed these indexes to vary over time. Our results reveal that the stock market is the dominant contributor to volatility spillover, while the crude oil is mostly the volatility spillover recipient. The asymmetric spillover effects are predominantly negative in the stock and crude oil markets and positive in the bond market. We further show that the spillover indexes are dynamic and influenced by specific events, such as the global financial crisis and the COVID-19 pandemic, as well as varying economic conditions.

1. Introduction

Stocks, bonds, gold, and crude oil represent the main investment vehicles in the world markets. Understanding the interactions and interdependences among these assets is of significant interest to investors and policymakers alike. Comprehending the spillover of risks among these assets can provide investors with useful trading signals and greater hedging opportunities (Asadi et al., 2022). It can also help policymakers decide when and how to intervene in response to adverse shocks to achieve greater economic stability.

The spillover of risks, which is commonly known as the volatility spillover effects, characterize how shocks and risks propagate and spread among different asset markets (Diebold and Yilmaz, 2012; Diebold and Yilmaz, 2015). To analyze these effects, it is important to understand the characteristics of the volatility itself. For instance, several studies document asymmetries in volatility, which imply that past returns are negatively correlated with present volatility (Bekaert and Wu, 2000). Such asymmetries may also be important when investigating the volatility transmission across markets (Segal et al., 2015). Thus, because of their relevance for risk valuation and portfolio diversification strategies (Garcia and Tsafack, 2011), both volatility and its spillover asymmetries need to be properly quantified.

The realm of volatility spillover effects in financial markets has been thoroughly charted, with seminal works, like Gallo and Otranto (2008); Diebold and Yilmaz (2012); Diebold and Yilmaz (2015); Engle et al. (2012), leading the way. Typically, these studies are anchored in the Vector Auto-regression (VAR) models or the multivariate GARCH model, often integrating the volatility spillover index as highlighted by Diebold and Yilmaz (2009). However, the domain of asymmetries in volatility spillovers remains less traversed. While there are studies that focus on asymmetric spillovers in the U.S. stocks (Baruník et al., 2016), foreign exchange markets (Baruník et al., 2016), Australian electricity markets (Chanatásig-Niza et al., 2022), and between the crude oil and stock markets (Wang and Wu, 2018; Xu et al., 2019), a comprehensive exploration in this direction is sparse.

27 This study furthers the literature by providing new evidence on the asymmetric volatility
28 spillover dynamics among major global investment vehicles. Our main contribution to the lit-
29 erature stems from the use of a novel approach for analyzing the asymmetric spillover effects.
30 Specifically, we employ a modified version of the Multiplicative Error Model (MEM) of Engle
31 et al. (2012) to incorporate the dynamic nature of the spillover asymmetry. As highlighted by En-
32 gle et al. (2012), the MEM is favored for its ability to overcome the shortcomings of the widely
33 used VAR model (i.e, Diebold and Yilmaz (2009); Baruník et al. (2016); Baruník et al. (2017)),
34 especially in resolving issues of zero and non-negative predictions of volatility. The MEM is
35 also shown to be better suited for spillover modeling than the multivariate GARCH model (i.e.,
36 Bauwens et al. (2006); Wang and Li (2021)), which imposes restrictions on the number of as-
37 set markets that can be investigated. Our proposed approach allows the MEM to incorporate the
38 asymmetric volatility spillovers. This development has given rise to a new spillover balance index
39 and asymmetric spillover indexes, which enable us to effectively analyze the spillovers of both
40 negative and positive news. We have also evolved the spillover and asymmetric indexes from their
41 static versions to time-varying forms, marking a significant stride in examining the dynamic links
42 and spillover effects over time. This contribution is significant, especially considering the scarce
43 literature on the intricate subject of time-varying analysis, a fact supported by Apergis et al. (2017).

44 The closest work to ours is that of Wang and Wu (2018) and Xu et al. (2019), who investi-
45 gated asymmetric spillovers between oil and stock markets, focusing primarily on the Chinese and
46 U.S markets. These studies have used VAR and Multivariate GARCH models and found that the
47 negative spillovers are stronger than their positive counterparts. In a similar vein, Wang and Li
48 (2021) examined asymmetric volatility spillovers between the crude oil and other financial mar-
49 kets in China. Other pertinent works in this context include those by Arouri et al. (2012); Li et al.
50 (2016); Siddiqui et al. (2020); Reboredo et al. (2014); Turhan et al. (2013) and Zhang and Wang
51 (2014). Departing from these studies, our research explores the global interplay between crude oil,
52 stock, bond, and gold markets, broadening the scope beyond the common context of the Chinese

53 financial markets. More importantly, we advance the literature by introducing a novel approach,
54 which incorporates the time-varying nature of asymmetric spillovers in the modelling of both the
55 dynamic links and spillover effects of positive and negative news in the global asset markets.

56 Our dataset comprises S&P 500 futures (ES: CME GROUP), Treasury bond futures (US:
57 CCBOT/CME GROUP), gold futures (GC: COMEX/CME GROUP), and crude oil futures (CL:
58 NYMEX/CME GROUP), spanning from July 1, 2003 to August 5, 2022. We use futures rather
59 than spot prices for two reasons. Firstly, futures contracts are traded for 23 hours during the sam-
60 ple periods, offering a near whole-day variance, thereby enhancing the precision of the realized
61 variances and semi-variances. Secondly, the fact that all four futures are traded on the same ex-
62 change negates the necessity for time zone adjustments. In accordance with Barndorff-Nielsen
63 et al. (2010); Baruník et al. (2016); Baruník et al. (2017); Chanasig-Niza et al. (2022), we com-
64 pute the realized variance and semi-variance from five-minute intraday returns, capturing the clos-
65 ing times from day $t - 1$ to day t . These realized semi-variances are then used to estimate the
66 asymmetric volatility spillover indexes.

67 Our empirical analysis yields several interesting results. First, we document strong evidence
68 that the bad volatility in the stock market spillover into other markets. We also show that the
69 stock market is the main provider, whereas the oil market is the primary recipient of the volatility
70 spillover. This finding is, economically, reasonable due to the considerable size of the stock mar-
71 ket, which leads to the propagation of its crashes and the potential dissemination of information
72 to other asset markets. Second, we uncover evidence that the total asymmetric volatility spillover
73 effects across different asset markets tend to be negative and significant. Specifically, we find neg-
74 ative spillover asymmetries in the stock, gold, and oil markets, but their magnitudes are larger in
75 the stock market. This finding is consistent with prior studies, which show that negative spillovers
76 are more prevalent than their positive counterparts (Baruník et al., 2016; Baruník et al., 2017; Xu
77 et al., 2019). It also lends support to loss aversion and the disposition effect, which predicts that
78 investors tend to hold on to losers and sell winners (Frazzini, 2006). Third, unlike other markets,

79 bonds exhibit significantly positive asymmetric spillover effects, implying that positive news from
80 the bond market engenders more substantial spillover to other markets than negative news. This
81 highlights the bond market’s quintessential role as a safe-haven during bad times. Such behav-
82 ior underscores the efficacy of bonds in dampening spillover effects and their utility as valuable
83 hedging vehicles during turbulent market conditions. Finally, we uncover evidence that volatility
84 spillover effects across different asset markets vary considerably over time, implying that the de-
85 gree and direction of spillovers are influenced by major events and economic conditions that vary
86 across time. Finally, we show that the 2009 Global Financial Crisis has had a more significant and
87 enduring influence on the volatility spillovers than the COVID-19 pandemic, presumably because
88 the Covid-19 is a health pandemic that did not originate from the financial markets.

89 The remainder of the study proceeds as follows. Section 2 introduces the concept of realized
90 semi-variance and the multiplicative error model for their dynamics. Section 3 proposes the volatil-
91 ity spillover balance and asymmetric volatility spillovers index. Section 4 presents the dataset.
92 Section 5 discusses the empirical results and Section 6 concludes.

93 **2. The Methodology Framework**

94 Andersen et al. (2001) introduced a natural estimator for the quadratic variation of a process,
95 known as the realized variance (RV), defined as the sum of frequently sampled squared returns.
96 To simplify, let us assume that prices p_0, \dots, p_n are observed at $n + 1$ intervals, evenly distributed
97 over the interval $[0, t]$. Using these returns, the n -sample realized variance, RV , can be defined as
98 follows:

99 where $r_j = p_j - p_{j-1}$ is the realized variance (RV), which converges in probability to the quadratic
100 variation of log prices as the number of intraday observations increases, i.e., as $n \rightarrow \infty$. Barndorff-
101 Nielsen et al. (2010) and Patton and Sheppard (2015) further introduce a measure that decomposes

102 RV into components that are due to positive and those that are attributable to negative returns,
 103 terming this measure "realized semi-variance" (RS). These estimators are defined as follows:

104 where $I\{\}$ is the indicator function that returns a value of 1 if the condition in $\{\}$ is met. These esti-
 105 mators provide a complete decomposition of RV , in that $RV = RS^+ + RS^-$. This decomposition
 106 holds exactly for any n , as well as in the limit.

107 2.1. Multiplicative Error Models

108 Since the RV is non-negatively valued and highly persistent over time, we follow the work
 109 of Engle and Gallo (2006), Shephard and Sheppard (2010), Engle et al. (2012), and Xu et al.
 110 (2018) and use the MEM to model the dynamics of RV . The MEM was initially proposed by Engle
 111 (2002) and has been widely used for modeling the dynamics of non-negative, highly persistent
 112 financial time series, such as absolute return, daily range, realized volatility, trading duration,
 113 trading volume, and bid-ask spread. Instead of modeling the RV directly, we extend the MEM to
 114 incorporate RS^+ and RS^- in its modeling process.

115 Given the information set I_{t-1} , the realized semi-variance in market i , denoted as $RS_{i,t}^+$ and
 116 $RS_{i,t}^-$, is modeled as follows:

117 where $i = 1, 2, \dots, k$, the innovation term $\epsilon_{i,t}^+$ and $\epsilon_{i,t}^-$ is a unit mean random variables, such that
 118 $\epsilon_{i,t}^+ | I_{t-1} \sim \text{i.i.d}(1, \sigma_i^+)$ and $\epsilon_{i,t}^- | I_{t-1} \sim \text{i.i.d}(1, \sigma_i^-)$. The conditional expectation $\mu_{i,t}^+$ and $\mu_{i,t}^-$, can

119 be specified as a base MEM(1,1):

120 Furthermore, the heterogeneous autoregressive (HAR) model of Corsi (2009) has emerged as a
 121 simple and powerful way to include the long-memory feature of realized volatilities. Adding HAR
 122 terms to the realized semi-variance equations, results in richer dynamic equations:

123 where $RS_{i,t}^{w+} = \frac{1}{5} \sum_{l=1}^5 RS_{i,t-l}^+$, $RS_{i,t}^{m+} = \frac{1}{22} \sum_{l=1}^{22} RS_{i,t-l}^+$, $RS_{i,t}^{w-} = \frac{1}{5} \sum_{l=1}^5 RS_{i,t-l}^-$, $RS_{i,t}^{m-} =$
 124 $\frac{1}{22} \sum_{l=1}^{22} RS_{i,t-l}^-$. In the HAR model, $RS_{i,t}^{w+}$ and $RS_{i,t}^{w-}$ represents the medium-term weekly re-
 125 alized semi-variance, whereas $RS_{i,t}^{m+}$ and $RS_{i,t}^{m-}$ denote the long-term monthly realized semi-
 126 variance.

127 To study the semi-variance spillover effects, we incorporate the lagged daily semi-variance
 128 observed in other markets into the specification and allow for the interactions between posi-
 129 tive/negative semi-variance spillover effects among different markets. This yields the following
 130 general semi-variance volatility spillover model:

131 Following Engle et al. (2012) and Xu et al. (2018), the semi-variance models in (8) and (9) can
 132 be estimated using quasi-maximum likelihood estimation. This is under the assumption that the
 133 innovation terms $\epsilon_{i,t}^+ | I_{t-1}$ and $\epsilon_{i,t}^- | I_{t-1}$ follow exponential distributions.

134 3. Spillover Analysis

135 Engle et al. (2012) and Xu et al. (2018) propose a quantitative measure for the volatility
 136 spillover effects across multiple markets, premised on the measure of spillovers as responses to
 137 shocks. Following their methodology, we derive analogous measures for our semi-variance mod-
 138 els.

139 Let $RS_t^+ = (RS_{1,t}^+, RS_{2,t}^+, \dots, RS_{k,t}^+)'$, $\mu_t^+ = (\mu_{1,t}^+, \mu_{2,t}^+, \dots, \mu_{k,t}^+)'$, $RS_t^{w+} = (RS_{1,t}^{w+}, RS_{2,t}^{w+}, \dots$

 141 $(RS_{1,t}^-, RS_{2,t}^-, \dots, RS_{k,t}^-)'$, $\mu_t^- = (\mu_{1,t}^-, \mu_{2,t}^-, \dots, \mu_{k,t}^-)'$, $RS_t^{w-} = (RS_{1,t}^{w-}, RS_{2,t}^{w-}, \dots, RS_{k,t}^{w-})'$,
 142 $RS_t^{m-} = (RS_{1,t}^{m-}, RS_{2,t}^{m-}, \dots, RS_{k,t}^{m-})'$ and $\epsilon_t^- = (\epsilon_{1,t}^-, \epsilon_{2,t}^-, \dots, \epsilon_{k,t}^-)'$. Conditional on the in-
 143 formation available at time t , (8) and (9) can be stacked in a compact matrix form as

144 If further assuming $\mathbf{x}_t = (RS_t^{+'}, RS_t^{-'})'$, $\boldsymbol{\mu}_t = (\mu_t^{+'}, \mu_t^{-'})'$, $\mathbf{x}_t^w = (RS_t^{w+'}, RS_t^{w-'})'$, $\mathbf{x}_t^m =$

145 $(RS_t^{m+'}, RS_t^{m-}')'$ and $\epsilon_t = (\epsilon_t^{+'}, \epsilon_t^{-}')'$, (3) and (10) can be expressed as:

146 where \odot denotes the Hadmard (element by element) product. The innovation vector $\boldsymbol{\epsilon}_t$ has support
 147 over $[0, +\infty)$, with a unit mean vector $\mathbf{1}$ and general variance-covariance matrix $\boldsymbol{\Sigma}$. The first two
 148 moment conditions of the vector MEM are given by $E(\mathbf{x}_t | \Omega_t) = \boldsymbol{\mu}_t$ and $\text{var}(\mathbf{x}_t | \Omega_t) = \boldsymbol{\mu}_t \boldsymbol{\mu}_t' \odot \boldsymbol{\Sigma}$,
 149 with the latter being a positive definite matrix by construction.

150 By defining appropriate error term, the above process (i.e., equation (11)) can be written as
 151 VARMA(1,1). Given this representation, the covariance stationarity condition requires that the
 152 largest eigenvalue of $\mathbf{A} + \mathbf{B} + \mathbf{A}^w + \mathbf{A}^m$ to be less than unity. Consequently, the unconditional
 153 first moment can be obtained as $E(\mathbf{x}_t) = (I_{2k} - \mathbf{A} + \mathbf{B} + \mathbf{A}^w + \mathbf{A}^m)^{-1} \boldsymbol{\omega}$.

154 Next, we derive a multiple-step ahead forecasting $\mathbf{x}_{t+\tau}$ (where $\tau > 0$). The forecast is com-
 155 puted at date t , but since it is not known, it needs to be substituted with its corresponding condi-
 156 tional expectation $\boldsymbol{\mu}_{t+\tau|t}$. Hence:

$$\boldsymbol{\mu}_{t+\tau|t} = \boldsymbol{\omega} + (\mathbf{A} + \mathbf{B} + \mathbf{A}^w + \mathbf{A}^m)\boldsymbol{\mu}_{t+\tau-1}, \quad (14)$$

160 which can be solved recursively for any horizon τ .

161 The terms $\mu_{t+\tau}^+$ and $\mu_{t+\tau}^-$ can then be extracted from $\boldsymbol{\mu}_{t+\tau|t}$. Once $\mu_{t+\tau}^+$ and $\mu_{t+\tau}^-$ are obtained,
 162 the multiple-step ahead forecasts of $RV_{t+\tau|t}$ can be directly derived as follows:

$$E(RV_{t+\tau|t}) = \mu_{t+\tau|t}^+ + \mu_{t+\tau|t}^-, \quad (15)$$

163 where $RV_t = (RV_{1,t}, RV_{2,t}, \dots, RV_{k,t})'$.

164 Next, we derive a spillover balance index and spillover asymmetry measure. Let us recall that
 165 the MEM in a system,

$$\mathbf{x}_t = \boldsymbol{\mu}_t \odot \boldsymbol{\epsilon}_t, \quad \boldsymbol{\epsilon}_t \sim D(\mathbf{1}, \boldsymbol{\Sigma}). \quad (16)$$

166 The innovation vector $\boldsymbol{\epsilon}_t$ has a mean vector $\mathbf{1}$ with all components unity and general variance-
 167 covariance matrix $\boldsymbol{\Sigma}$. We can interpret $\boldsymbol{\mu}_{t+\tau} = E(\mathbf{x}_{t+\tau}|I_t, \boldsymbol{\epsilon}_t) = \mathbf{1}$, that is, the expectation of
 168 $\mathbf{x}_{t+\tau}$ conditional on $\boldsymbol{\epsilon}_t$ being equal to the unit vector $\mathbf{1}$: this is the basis for the dynamic forecast
 169 obtained before. Let us now derive a different dynamic solution, $\boldsymbol{\mu}_{t+\tau}^{(i)} = E(\mathbf{x}_{t+\tau}|I_t, \boldsymbol{\epsilon}_t = \mathbf{1} + \mathbf{s}^{(i)})$
 170 , for a generic i th element $\mathbf{s}^{(i)}$, where $i = 1, 2, \dots, 2k$. The i th element equal to the unconditional
 171 standard deviation of $\epsilon_{i,t}$ and the other terms $j \neq i$ equal to the linear projection $E(\epsilon_{j,t}|\epsilon_{i,t} =$
 172 $1 + \sigma_i) = 1 + \sigma_i \frac{\sigma_{i,j}}{\sigma_i^2}$. The element-by-element division (\oslash) of the two vectors,

$$\rho_{t,\tau}^{(i)} = \boldsymbol{\mu}_{t+\tau}^{(i)} \oslash \boldsymbol{\mu}_{t+\tau} - \mathbf{1}. \quad (17)$$

173 Given the multiplicative nature of the model, $\rho_{t,\tau}^{(i)}$ gives us the set of responses (relative changes)
 174 in the forecast profile starting at time t for a horizon τ brought about a 1 standard deviation shock
 175 in the i th market. The cumulated impact of the shock from market i to market j is:

$$\Phi_t^{j,i} = \sum_{\tau=1}^K \rho_{t,\tau}^{(i)}. \quad (18)$$

176 The total spillover effect (TSI) as:

$$TSI = \sum_{i \neq j} \sum_{t=1}^T \Phi_t^{j,i} \quad (19)$$

177 which measures the overall contribution of volatility spillover shocks across markets.

178 This is also a way to assess the total change induced by the shock of different markets. Follow-
 179 ing Engle et al. (2012), we express the spillover balance as the ratio of the average responses “to”
 180 to the average response “from” (excluding one’s own):

$$Balance_i = \frac{\sum_{j \neq i} \sum_{t=1}^T \Phi_t^{j,i}}{\sum_{j \neq i} \sum_{t=1}^T \Phi_t^{i,j}}. \quad (20)$$

181 A value bigger than unity signals that the market is a net creator of volatility spillover.

182 The use of semi-variances in the model estimation allows us to distinguish between the spillovers
 183 from positive and those from negative returns. This, in turn, enables us to quantify the asymme-
 184 tries in the volatility spillovers over time. Following Baruník et al. (2015), we define directional
 185 spillover from an asset i to (ST) all other assets (excluding one’s own) as:

$$ST_i^- = \sum_{j \neq i} \sum_{t=1}^T \Phi_t^{j,i} \quad (21)$$

186 for $i = 1, 2, \dots, k$ and for $j = 1, 2, \dots, 2k$, and

$$ST_i^+ = \sum_{j \neq i} \sum_{t=1}^T \Phi_t^{j,i} \quad (22)$$

187 for $i = k + 1, k + 2, \dots, 2k$ and for $j = 1, 2, \dots, 2k$.

188 We compute the spillover asymmetry measure (ASM) index as

$$ASM_i = ST_i^+ - ST_i^-, i = 1, 2, \dots, k \quad (23)$$

189 A positive ASM indicates that spillovers from positive realized semi-variances are larger than those

190 from negative realized semi-variances, and the opposite is true for a negative ASM. By contrast, if
191 ASM takes a value of zero, the volatility spillover measures are symmetric. The total asymmetric
192 spillover effect (TASM) is computed as:

$$TASM = \sum_i ASM_i \quad (24)$$

193 To test the significance of ASM_i and $TASM$, we use the bootstrapped standard error (see
194 Appendix A)

195 **4. Dataset**

196 Our data comprises four futures contracts: S&P 500 futures (ES: CME GROUP), Treasury
197 bond futures (US: CCBOT/CME GROUP), gold futures (GC: COMEX/CME GROUP), and crude
198 oil futures (CL: NYMEX/CME GROUP). The first three contracts were studied by Fleming et al.
199 (2001, 2003). Our sample period spans from July 1, 2003 to August 5, 2022, over a total of
200 4,864 trading days. The data are obtained from TickData, Inc. We selected July 1, 2003, as
201 our starting date because it encompasses both daytime and evening, ensuring that our estimated
202 realized variance represents a reasonable proxy for the whole-day variance.

203 There are two benefits to using futures rather than spot prices in our analysis. First, the futures
204 contracts are traded for 23 hours during the sample periods, which closely approximates the whole-
205 day variance, enhancing the accuracy of the realized variance estimates. Second, the four futures
206 contracts used in our analysis are traded on the same exchange, eliminating the need for time zone
207 adjustments. Thus, the use of futures contracts does not only simplifies the analysis, but also allows
208 us to make more accurate comparisons across the different markets.

209 Our portfolios are rebalanced at specific times each day during different periods, i.e., at 13:30
210 each day between 07/01/2003 and 01/31/2007, at 15:15 each day between 02/01/2007 and 11/17/2012,
211 and at 16:00 each day between 11/18/2012 and 08/05/2022. We calculate the realized variance and

212 semi-variance using all intraday returns between day t and $t - 1$ and use the last transaction prices
213 before the chosen close times as the close prices. This procedure is consistent with Fleming et al.
214 (2001, 2003). Table 1 presents the trading close times and date ranges for the four assets.

216 Table 2 summarizes the descriptive statistics for the realized variance and semi-variances.
217 Crude oil displays the highest volatility, while bonds exhibit the lowest mean of realized variance
218 and semi-variance. This implies that crude oil is riskier than the other markets, possibly due to its
219 lower liquidity, susceptibility to natural disasters, and sensitivity to geopolitical risks. This finding
220 is consistent with Xu et al. (2019), who reported a risk ratio of oil to stock that is notably similar
221 to ours. The negative semi-variance contributes slightly more than its positive counterpart to the
222 total realized variances of the asset markets. The Ljung Box statistic shows strong serial autocor-
223 relations in both the realized variance and semi-variance. The overdispersion, which is the ratio of
224 standard deviation to mean, ranges from 1.1 to 2.1. This large overdispersion requires a high value
225 of α (ARCH coefficient) in GARCH/MEM models. Additionally, the positive skewedness and
226 high leptokurtic together with overdispersion, indicates that a more flexible distribution is required
227 for modeling the realized variance.

229 Figure 1 shows that asset volatility increases considerably during global financial crisis. Sub-
230 sequently, the realized variance declines significantly and jumps occasionally. At the start of the
231 COVID-19 pandemic, there was a sharp increase in volatility, but this was not as persistent as in the
232 case of global financial crisis. The graph also shows that the realized variance and semi-variance
233 are highly persistent over time, suggesting that the effects of the information transmitted by positive
234 and negative returns cannot be eradicated completely over a short period of time. These features,
235 along with the Ljung Box statistics in Table 2, suggest that MEM-type models are well-suited for

236 modeling the dynamics of the realized semi-variances. Additionally, the semi-variances associated
237 with two of the four assets in our sample tend to move in tandem with their corresponding realized
238 variances. Notably, the common volatility spikes across the various markets occurred during the
239 2008 Global Financial Crisis and the 2019 Coronavirus outbreak.

241 **5. Empirical Results**

242 Based on the equation-by-equation estimation results, we proceed to select a more parsimo-
243 nious specification, based on the significance of the zero restrictions. The large number of coef-
244 ficients in the general specification of equations (8) and (9) yields inefficient parameter estimates
245 and, therefore, less precise spillover forecasts analysis (Engle et al., 2012). We report only the co-
246 efficients estimates that are significant at 5 percent level or better in Table 3. The model diagnostics
247 are summarized in the lower panel of Table 3. where the values of the log-likelihood functions,
248 Bayesian Information Criteria (BIC) and Ljung box (LB) statistics for residuals are reported.

250 We find significant interactions between good and bad volatility within each of the four markets
251 included in the analysis. For example, bad volatility of bonds has significantly positive effect on
252 the good volatility of bonds, and vice versa. Similar patterns are observed in the cases of gold and
253 crude oil. However, the stock market appears to be an exception, with only bad volatility exerting
254 a significantly positive influence on the good volatility. Across the four markets, we also show that
255 the magnitude of the effect of bad volatility on good volatility is larger than that of good volatility
256 on bad volatility¹, indicating that the bad volatility dominates the semi-variance dynamics. We also
257 notice that the bad volatility of the stock market exerts significant influences on both the good and

258 bad volatility of the other three markets (see the row of $RS_{j,t-1}^{-1}$). Finally, the two HAR parameters,
259 α_w and α_m , are significant in all cases, implying a high level of persistence in the semi-variances.
260 The LB statistics are small and insignificant, suggesting that our model successfully captures the
261 dynamics of the semi-variance processes.

262 5.1. Volatility spillover effects

263 In this section, we quantify the volatility spillover effect with the aim to answer the following
264 questions: (1) Which markets, if any, serve as the primary net provider or receiver of spillovers?
265 (2) How is good and bad volatility transmitted within each market? And (3) are volatility spillovers
266 symmetric or asymmetric? To explore these questions, we employ the spillover balance index and
267 asymmetric spillover measure derived in Section 3. A value of a spillover balance index that is
268 greater (smaller) than unity indicates that the asset is a net provider (receiver) of spillover. A
269 significantly negative asymmetric measure implies that the spillovers from negative news cause
270 more shocks to other markets than their counterparts from positive news, and vice versa. The
271 results are presented in Table 4.

273 For the ease of exposition, hereafter we refer to spillovers from bad and good volatility as
274 negative and positive spillovers, respectively. Firstly, the spillover balance indexes in the second-
275 to-last of Table 4 indicate that stock volatility is the primary provider of spillovers, with spillover
276 balances of 3.43 and 2.13 from bad and good volatility, respectively. Gold and oil, on the other
277 hand, are spillover recipients, as their spillover balance indexes are less than unity. The observed
278 imbalance is largely attributed to the significant transmission of negative shocks from the stock
279 market, impacting both the good and bad volatility in the oil market. This observation aligns with
280 the findings presented in Table 3, suggesting that the stock market is the primary conduit of volatil-
281 ity spillovers. The bond market seems to be more balanced, with spillover balances from the bad
282 and good volatility being 1.08 and 1.24, respectively. The prevalent influence of the stock market

283 is presumably rooted in its extensive size and renown for dispersing risks (Yang and Zhou, 2017),
284 coupled with the oil market's illiquidity, which is often susceptible to natural disasters and geopo-
285 litical uncertainties, making it a "recipient" of risks. Intriguingly, this conclusion contrasts with the
286 results of Wang and Li (2021), who found that crude oil instigates volatility in the Shanghai stock
287 index. A plausible explanation for this divergence lies in the contextual differences. Specifically,
288 unlike our study, which focuses on the global context, Wang and Li (2021) examined the inter-play
289 between WTI crude oil and the Chinese stock market. Since the Chinese stock market is relatively
290 local and less accessible to international investors, its ability to induce volatility in the crude oil
291 market is potentially limited.

292 The last row of Table 4 reports the asymmetric measures of the volatility spillover. The TASM
293 of the four assets is negative and significant (-24.39), indicating the presence of asymmetric volatil-
294 ity spillover among these assets. The stock market has the largest significantly negative asymmetry
295 index (ASM = -24.62), suggesting that the stock market creates more negative than positive shocks
296 for other markets. For the gold and oil markets, the asymmetry index is negative and insignificant,
297 suggesting no asymmetric volatility spillover effects between these two assets. Interestingly, the
298 bond market has the significantly positive asymmetry index (ASM=7.18), implying that the bond
299 market creates more positive than negative shocks to other market. The unfavorable news in the
300 stock and crude oil markets can have a beneficial impact on the bond market, as investors tend to
301 seek refuge in safe-haven assets during stock market crashes to mitigate risk. Further support for
302 the negative relationship between stocks and bonds can be found in Chiang et al. (2015), while
303 evidence of the negative relationship between oil and bond markets is provided by Ciner et al.
304 (2013). This elucidated the crucial role bonds as safe haven instruments during bad times. In
305 other words, this evidence indicates that bonds can effectively mitigate spillover effects and offer
306 valuable hedging opportunities for investors.

307 Overall, we document a complex interconnectedness among the four asset markets, with the
308 stock market playing a central role in transmitting volatility spillovers. The oil market appears to

309 be the primary recipient of these spillovers, while contributing minimally to the volatility in other
310 markets. Furthermore, we find evidence of asymmetric spillover effects, particularly in the stock
311 and bond markets. In the bond market, the spillover balance of good volatility is larger than of
312 bad volatility, and the ASM index is significantly greater than zero. This suggests that spillover of
313 shocks from good news are more prevalent than that from bad news. This direction of asymmetry
314 differs significantly from those in other markets.

315 *5.2. Dynamics Analysis*

316 To better understand the time series evolution of volatility spillovers, we estimate equations (8)
317 and (9) using a rolling window of 500 days to allow for the spillovers to change over time. This
318 approach enables us to derive time-varying spillover balance indexes and asymmetric spillovers.
319 This dynamic analysis also enables us to investigate the impact other events, such as the global
320 financial crisis, Eurozone debt crisis, and the recent COVID-19 pandemic, on spillovers across
321 markets.

322 *5.2.1. Dynamics of Total Spillovers*

323 The plot in Figure 2 indicates that the volatility spillover effects increase sharply during the
324 global financial crisis (i.e., between 2008 and 2009). The timing of the spikes identified in the
325 total volatility spillovers during the year 2009 and at the end of 2010 in the stock market are
326 remarkably similar those reported in Fengler and Gisler (2015). After the financial crisis, the total
327 volatility spillover remained stable and low until 2014, followed by several jumps between 2015
328 and 2016. These timings correspond to the stock market selloff, in which the Dow Jones Industrial
329 Average fell by 530.94 (3.1%) on August 21, 2015. The total spillover effects in 2015/16 may
330 have possibly originated from the big selloffs and two flash crashes in the stock market. There
331 were also some increments of volatility spillover effects during the recent COVID-19 pandemic,
332 i.e., between 2020 and 2022. However, the fluctuations of total volatility spillover effects were not
333 as significant as those observed during the global financial crisis, plausibly because the Covid-19

334 is a health pandemic that did not originate from the financial market. Overall, the cyclical behavior
335 observed in our Figure 2 aligns closely with findings in Wang and Li (2021) and Xu et al. (2019)².

337 Figure 3 presents the time-varying TASM index. The total asymmetric index is negative for
338 most of the sample periods, indicating that volatility spillovers caused by negative news are greater
339 than those resulted from the positive news. However, during a few periods, such as the period pre-
340 ceding the subprime mortgage (i.e., 2006-2007), the asymmetry approaches zero or even becomes
341 positive. These periods suggest that the negative and positive return shocks led to similar sizes
342 of volatility spillovers across asset markets. The period between 2007 and 2009 had the largest
343 asymmetry, with the spillover index bottoming out around February 2009. This is expected, as
344 the spillovers were widespread during the global financial crisis. The COVID-19 pandemic period
345 also displays a clear negative asymmetry in volatility spillovers, although the magnitude of the
346 asymmetry is not quite as substantial as that of the global financial crisis. The volatility spillovers
347 were more significant during the financial crisis and exacerbated by the European Sovereign Debt
348 crisis. These negative spillovers lasted over seven years and then began to diminish gradually.
349 This indicates the effect of global financial crisis is long lasting. Xu et al. (2019) reported similar
350 results for the total asymmetric spillover of volatility between the oil and stock markets. They also
351 observed dips around the years 2009, 2010, and 2015 and corroborate the prevalence of negative
352 volatility.

354 5.2.2. Dynamics of Spillover Balance Index

355 Figures 4 and 5 present the dynamics of the spillover balance index for each asset market. Fig-
356 ure 4 shows that the spillover balance of the stock market's bad volatility of stocks is greater than

357 unity for most of the sample period, indicating that this market is a net provider of bad volatility
358 spillover. Similarly, in Figure 5, the spillover balance indexes of the good volatility associated
359 with each of the four asset markets are mostly greater than unity, albeit their magnitudes are much
360 smaller than spillover indexes of the bad volatility. These findings are consistent with Table 4,
361 which indicates the dominance of negative asymmetric spillovers. Interestingly, during the period
362 2009-2013, the bad volatility spillover index of the stock market is close to unity, suggesting that
363 the volatility spillover has been dissipated to other markets. Overall, we find that the stock market
364 is a net provider of spillover, especially during significant events, such as the 2008 Global Financial
365 Crisis, massive stock market selloffs, and the two major flash crashes in 2015.

366 Our results also show that the bond market is generally a provider of bad volatility spillover,
367 especially during the period 2015-2017 as well as during and after the Covid-19 pandemic. How-
368 ever, the good news from the bond market has also provided large spillover effects during the period
369 from 2006 to 2008, i.e., before the global financial crisis. This may be due to investors flocking to
370 safety and buying bonds during the financial crisis, signaling the spillover of good news. It is diffi-
371 cult to conclude whether the bond market is a net spillover provider or a net spillover receiver, as its
372 spillover balance index remains above and below unity for almost equal proportions of time. The
373 bond market was relatively a spillover provider for good volatility during the 2008 global financial
374 crisis and the massive stock market selloff of 2015, while it was relatively a spillover provider of
375 bad volatility during the period from 2014 to 2015, when a massive stock market selloff and flash
376 crash took place.

377 The gold market behaved rather differently, as it is neither a net spillover provider nor a net
378 spillover receiver of news. Both its good and bad spillover balance indexes are above unity during
379 the period 2009-2017, reaching their peaks between 2014 and 2015. This timing coincides with the
380 massive stock market selloffs and flash crashes. The results also indicate that the gold market was
381 dissipating positive and negative risks between 2009 and 2017. At the end of the sample window,
382 i.e., around 2022, there have been steep increases in good and bad volatility spillovers transmitted

383 from the bond to the other markets.

384 Since around mid-2007, the crude oil market mostly served as a spillover receiver, with spillover
385 balance indexes fluctuating evenly between zero and two. Combined with the results in Table 3,
386 the bad volatility spillover to the oil market is transmitted from both the stock market and within
387 the crude oil market itself. Interestingly, the bad volatility of the oil market exhibited mild cyclical
388 behavior around the cutoff point, with a spillover balance index of one, peaks during the years
389 2007, 2012, 2018, and 2022, and troughs in 2006 as well as over the period 2014-2017. However,
390 the good volatility of the oil market was transmitted to other markets only in 2005-2007, which
391 could be the calm prelude before the crash in the stock market. Subsequently, the crude oil began
392 to receive spillovers from the other markets, except for the years 2014 and 2022, where there was
393 a brief temporary balance between the spillover balance indexes.

395 5.2.3. Dynamics of Asymmetric spillover index

396 Figure 6 displays the dynamics of the ASM spillover index of each asset market. For the stock
397 market, the ASM index is mostly negative, with a large negative asymmetric effect reported during
398 and after the global financial crisis (i.e., the period 2008-2011). The negative spillovers intensi-
399 fied following the collapse of Lehman Brothers in September 2008 and were further exacerbated
400 during the Eurozone crisis. However, the net spillover effect of the stock market was dampened
401 during subsequent events, such as the debt ceiling debate in 2011, fiscal cliff in 2012, government
402 shutdown in 2013, and the stock market selloff in 2015. The net spillover effect dipped more dur-
403 ing the Global Financial Crisis than other periods. Asadi et al. (2022) suggest that stock market
404 crashes significantly impact profitability, overhead cost, and competitiveness in raw material mar-
405 kets, which may explain how shocks of bad volatility of the stock market contributed to spreading
406 the spillover effects to other markets. Ghosh et al. (2021) also argue that technological inefficiency
407 and a weak outlook may affect other markets, supporting the argument that the negative spillover

408 effect caused by the flash crash in 2015 was transmitted to other markets. Overall, this implies
409 that the stock market is the main driver of bad volatility, which spreads negative shocks to other
410 markets.

411 Interestingly, the ASM index in the bond market is positive most of the time, suggesting that
412 the positive news from the bond market exerts more influence on other markets than negative
413 news. As bonds provide investors with relatively stable incomes during crises, they are regarded as
414 useful hedging instruments during periods of market turmoil. This, in turn, explains why economic
415 downturns may bring good news to the bond market, which is then transmitted to other markets.
416 However, the period near 2015-2016 experienced a negative spillover shock for a few months,
417 indicating a shift in negative shocks from the stock to the bond market. But shortly after, investors
418 fled to safety and, consequently, causing the bond market to spillover the good volatility. Near the
419 end of 2018, a drop in the ASM to zero corresponded to rising tariffs and trade policy tensions,
420 particularly between the US and China, and the impact of the Covid-19 health pandemic on the
421 global economy.

422 As for gold, the first half of the sample was positively asymmetric, while the second half ex-
423 hibited a negative asymmetry. Interestingly, we observe several similarities in the movement of the
424 net volatility spillover between the bond and gold markets. This may be due to the hedging benefits
425 of these two instruments, as gold and bond markets are typically considered safe haven assets (see,
426 e.g., Agyei-Ampomah et al. (2014)). However, the range of the gold market's ASM fluctuations
427 are not as wide as those of the bond market, indicating a relatively more stable volatility spillover
428 effect of the gold market.

429 The negative returns in the crude oil caused spillover shocks in all markets, with the ASM
430 index being negative most of the time. The dominance of negative asymmetries is also reported
431 by Xu et al. (2019), who investigated the asymmetric volatility transmission between the crude
432 oil and stock market, and by Pham et al. (2022) in the context of cryptocurrency and thermal coal
433 futures. The volatility spillover effect of the crude oil market displays similar behavior patterns

434 to that of the stock market, but with a narrower range of fluctuations, possibly due to relative size
435 difference between the two markets. The asymmetric measure in the oil market moves in the same
436 direction as its counterpart in the stock market, except for the period around 2015, when a spike in
437 the positive volatility was observed in the crude oil, but not in the stock market.

439 *5.3. Robustness check*

440 We have also conducted several checks to verify the sensitivity of our results to the choice of
441 forecasting horizons and rolling windows. The results from these tests are largely consistent with
442 our primary analysis and our conclusions remain largely unchanged. Details of these additional
443 tests and their associated results are provided in Appendix B.

444 *5.4. Discussion and policy implications*

445 Overall, our TASM results indicate that the negative volatility spillovers are more prevalent
446 than positive volatility spillovers at the aggregate level. This is consistent with the theory of loss
447 aversion in behavioral finance, where investors are emotionally attached to negative news than
448 positive news. Our finding that the TASM is mostly negative and takes a long time to become
449 positive is also in line with the disposition effect of Frazzini (2006), which suggests that investors
450 tend to hold on to losers and sell winners. Furthermore, our evidence that the spillover from bad to
451 good volatility is stronger than that from good to bad volatility is supported by Bollen and Whaley
452 (2004)'s view that the buying pressure from investors tends to increase during episodes of high
453 volatility.

454 Another interesting finding is that the stock market is the main provider, whereas the oil market
455 is the main receiver, of volatility spillover and that the oil market has a limited spillover effect on
456 other markets. This may be attributed to the stock market's considerable size, causing its crashes to
457 spread to other markets. In addition, due to potential information transmission across asset markets

458 (related to market efficiency), negative shocks in the stock market may be immediately transmitted
459 to the oil market. The bond and gold markets behave differently, as they are generally viewed as
460 safe haven (Bredin et al., 2015), where investors seek safety during times of market stress.

461 Finally, we find that for the bond market, the overall spillover balance of good volatility is
462 greater than that of bad volatility. This may be because investors, who seek safety from bonds,
463 interpret stock market crashes as buying signals in the bond market.

464 In terms of policy implications, researchers have been consistently calling for more efforts on
465 the part of regulator authorities to better measure and monitor the risks and uncertainties in differ-
466 ent asset markets (Fengler and Gisler, 2015; Chiang et al., 2015). Our methodological innovation
467 should serve as a useful tool for policymakers, who are interested in understanding and monitoring
468 volatility transmission among different markets. The finding that stock market is the main trans-
469 mitter of negative shocks also supports the need for the stock market to be more heavily regulated
470 (Ghosh et al., 2021). Regulatory policies, such as the circuit breaker, can prevent asset bubbles
471 (Turhan et al., 2013), restrict the volatility spillovers within the stock market, and minimize the
472 spread of negative volatility from the stock market to the other markets (Li et al., 2016). Further-
473 more, this study shows that the bond market spills over good volatility during the financial crisis.
474 Policies need to be implemented to keep a moderate amount of good volatility in the bond market.
475 In addition, as there is significant awareness of the speculative fluctuations in the cryptocurrency
476 market (Pham et al., 2022), policies can be made to minimize the impact of cryptocurrency on
477 other markets. When policies are announced, policymakers need to assess their full impact (Ciner
478 et al., 2013) and ability to mitigate financial distresses (Jiang et al., 2019). Furthermore, consider-
479 ing the potential amplification of the volatility caused by the releases of negative news, regulators
480 should work with media to ensure responsible reporting. A more accurate and balanced informa-
481 tion dissemination can mitigate panic and overreaction in the markets. Moreover, as suggested by
482 Baruník et al. (2015) in the context of petroleum markets, introduction of regulations for institu-
483 tions can similarly be made across the four markets to reduce spillover effects. As a preventive

484 measure, macroeconomic policies can also be designed to control the impact of global crude oil
485 industry and encourage the development of alternative sustainable energy resources (Jiang et al.,
486 2019), Finally, given the susceptibility of oil markets to geopolitical and other global events, di-
487 versifying the energy portfolio and increasing investments in sustainable energy can mitigate the
488 risks associated with oil market volatility.

489 **6. Conclusion**

490 This study uses a Multiplicative Error Model (MEM) to investigate the asymmetric volatility
491 spillovers across four major global asset markets, namely stocks, bonds, gold, and crude oil. This
492 approach overcomes some important shortcomings of other popular models, including VAR and
493 multivariate GARCH models. The asymmetric volatility spillover index derived from the MEM
494 enables us to capture more accurately the impact of positive and negative news on different markets
495 as well as the interdependence of the volatility transmission across these markets. We have also
496 expanded the scope of the volatility spillover balance and asymmetric spillover indexes to reflect
497 their time-varying features.

498 Our novel empirical model offers new insights into volatility spillovers between different asset
499 markets. Firstly, we find that the volatility spillovers are time varying, and both the degree and the
500 direction of the spillovers are influenced by changes in economic conditions. Secondly, we identify
501 the net providers and the net receivers of volatility spillovers. Specifically, we find that the stock
502 market is the provider, the bond and gold markets are largely balanced, while the crude oil market
503 mostly serves as a receiver of volatility spillovers. Thirdly, we show that the asymmetric spillover
504 effects are mostly negative in the cases of the stock and crude oil markets and positive in the bond
505 market. Fourthly, we investigate the impact of the variation in economic conditions, such as the
506 global financial crisis, the Eurozone crisis, and the COVID-19 pandemic, on volatility spillovers
507 among asset markets. We provide evidence that such events exert a significant influence on both
508 the magnitude and direction of spillovers and that the spillover effects are amplified during times

509 of economic stress. Finally, we shed light on the role of safe-haven assets, namely gold and bonds,
510 in times of market volatility. We find that these assets help mitigate spillover effects and provide
511 hedging opportunities for investors.

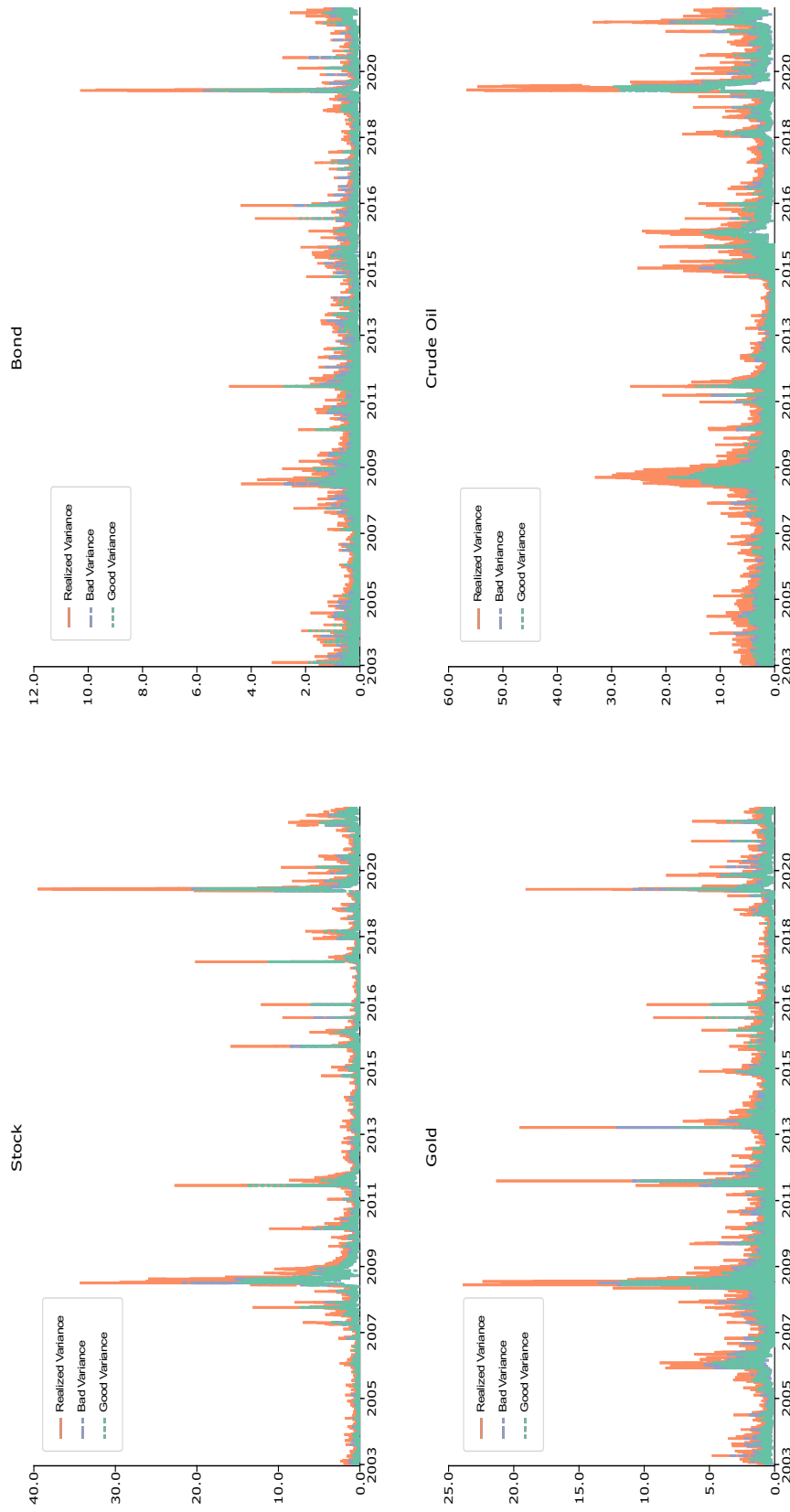


Figure 1 – Realized Volatility, Bad Volatility and Good Volatility for all markets.

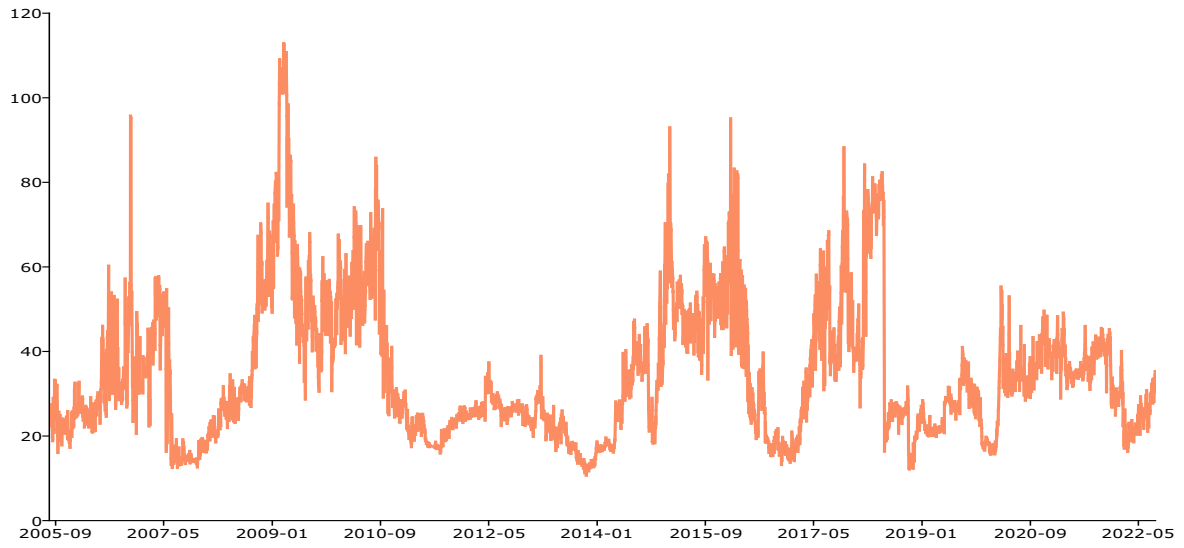


Figure 2 – Total Volatility Spillovers

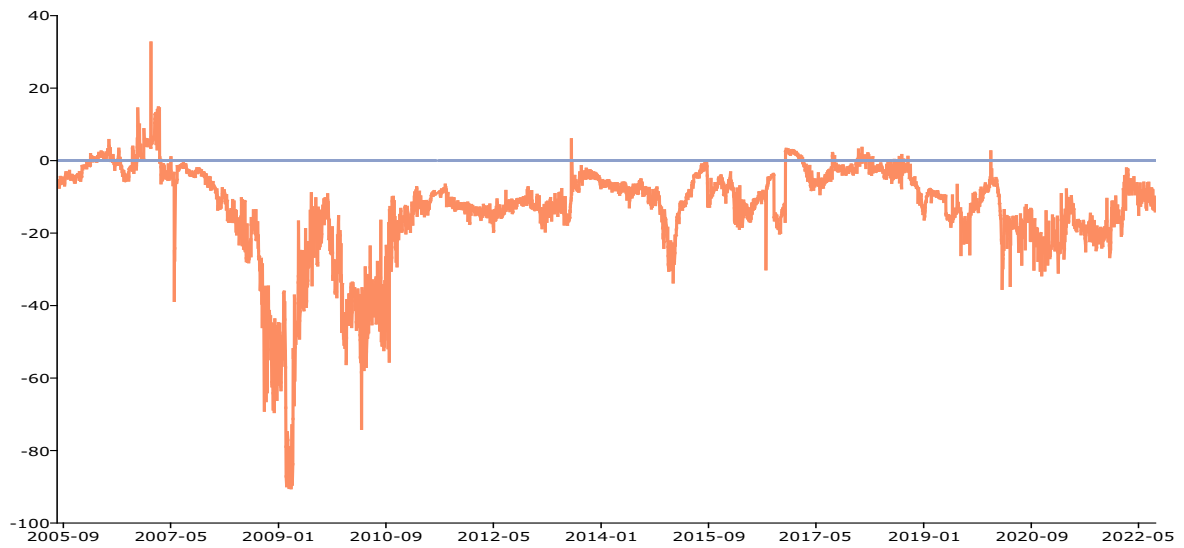


Figure 3 – Total Asymmetric Spillovers (*TASM*)

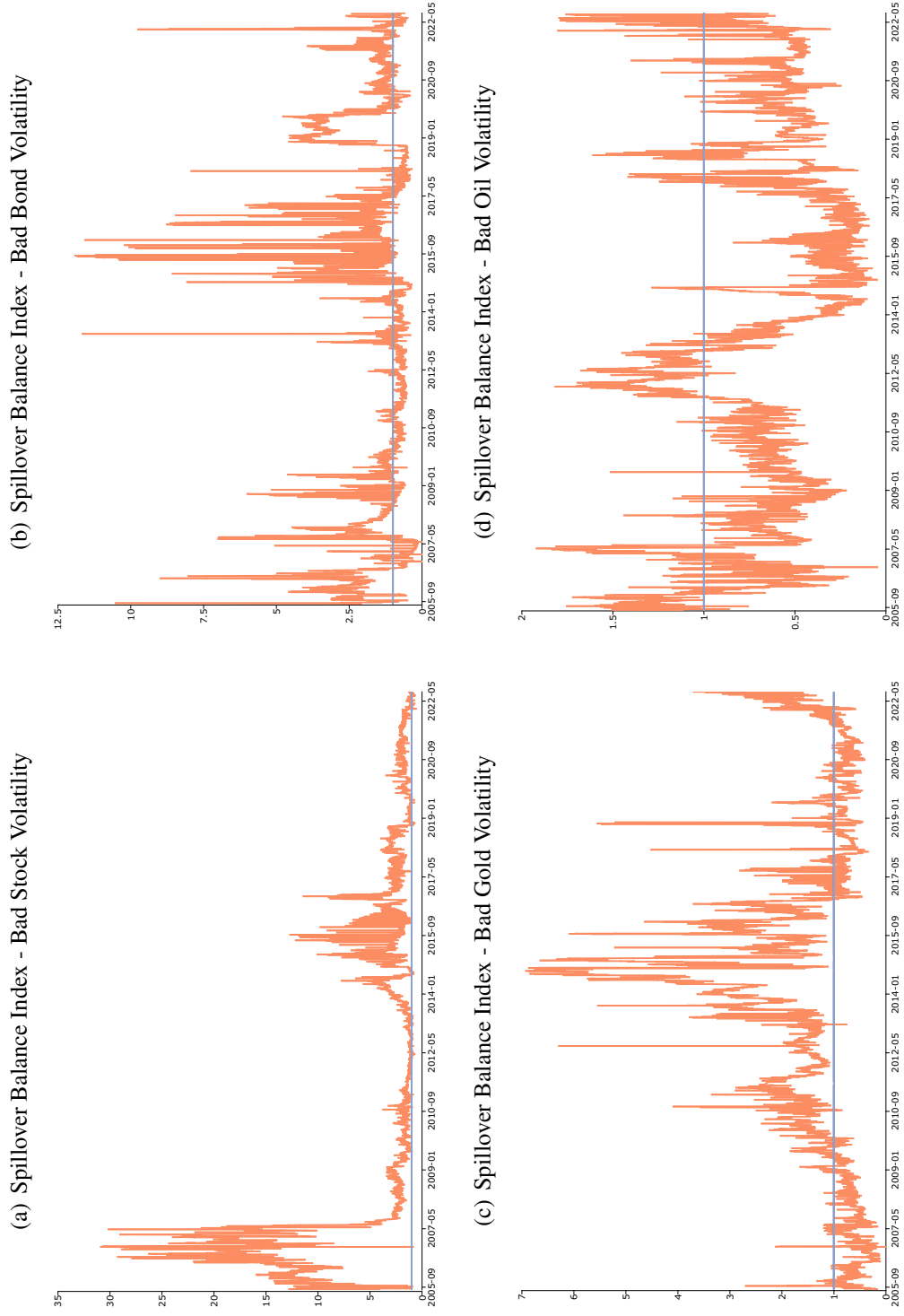


Figure 4 – Spillover Balance Index - Bad Volatility.

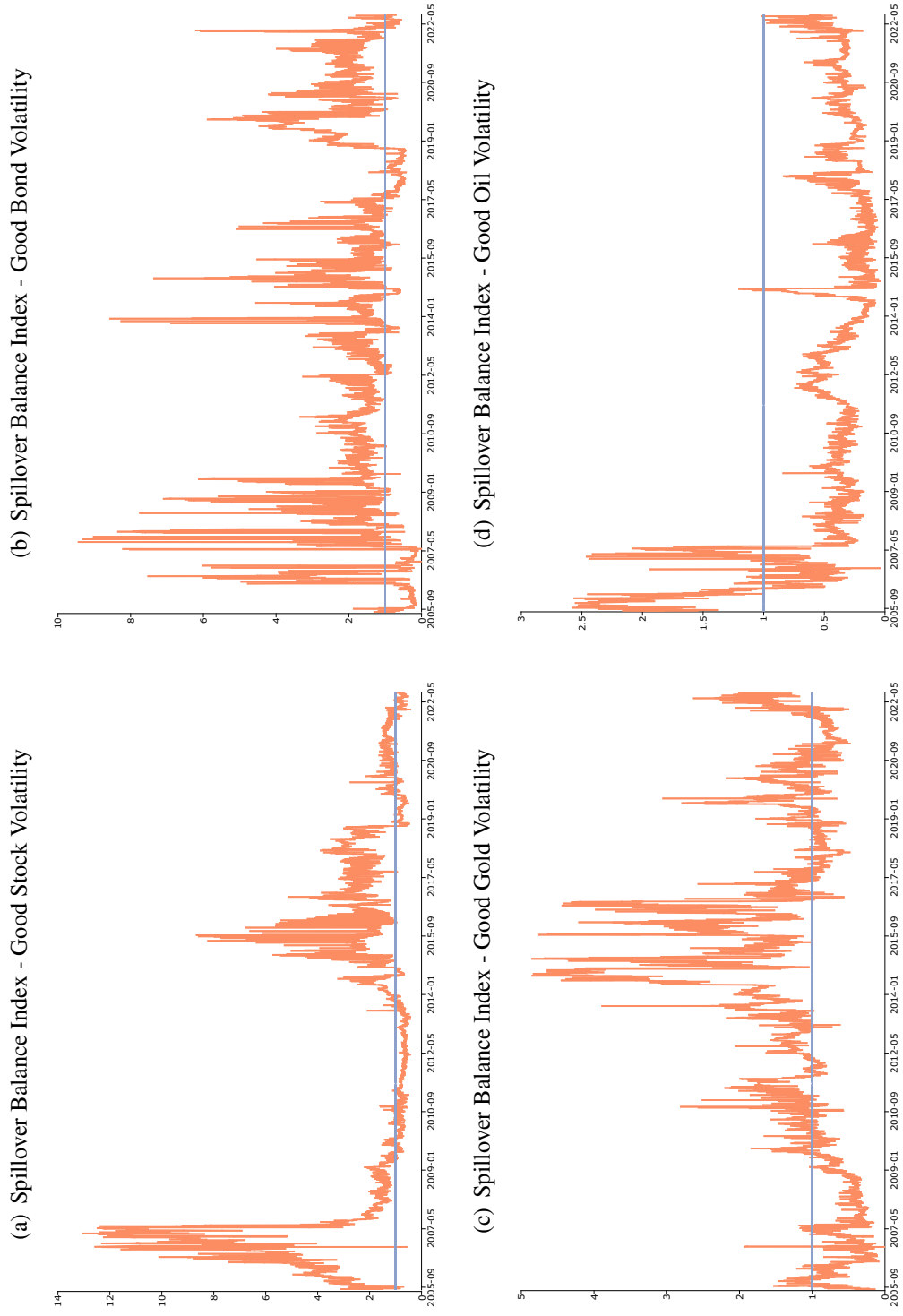


Figure 5 – Spillover Balance Index - Good Volatility.

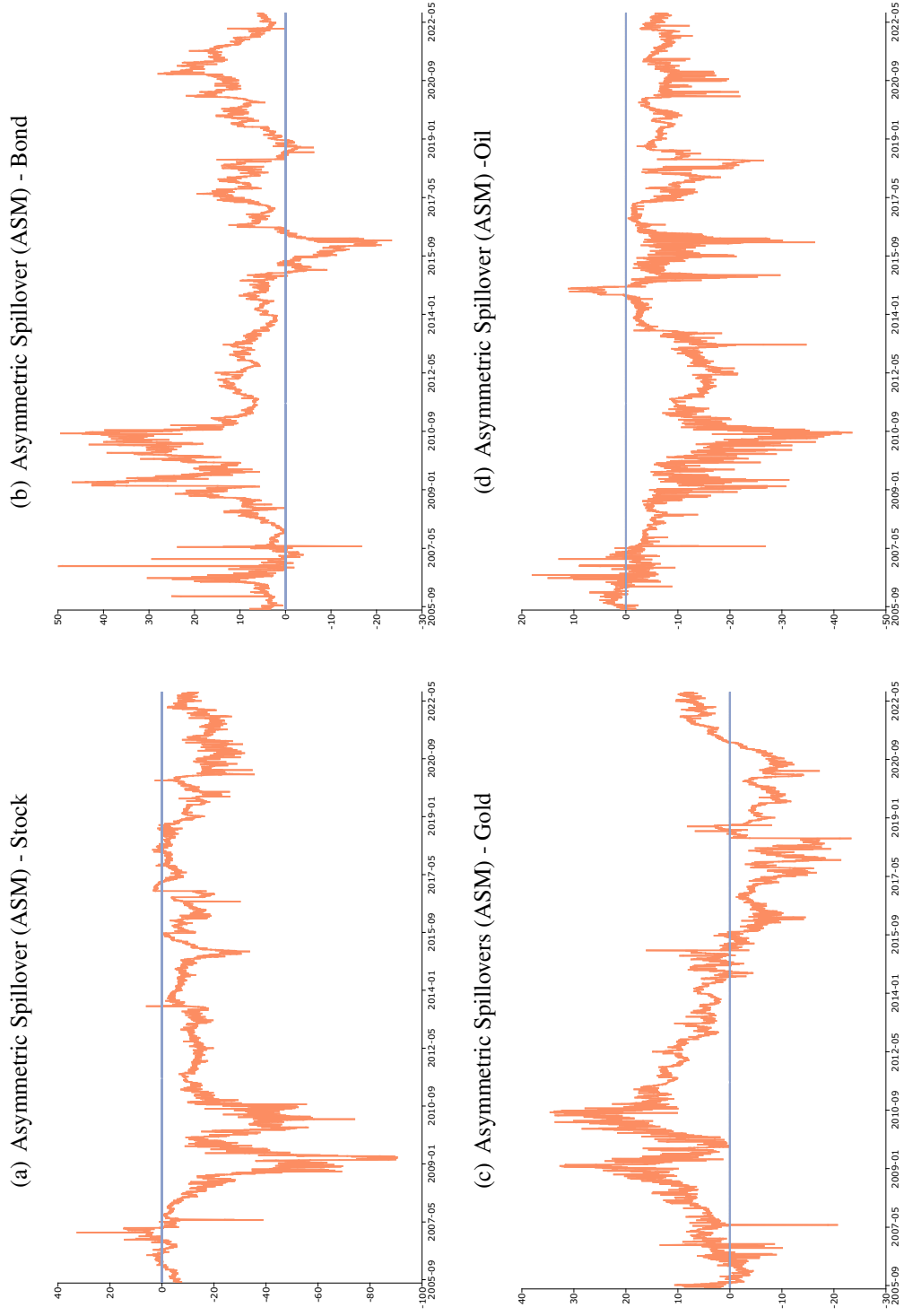


Figure 6 – Asymmetric Spillovers (*ASM*)

512 **Appendix A: Bootstrap standard error**

513 The definitions of $TASM$ and ASM_i aid in testing our initial hypotheses concerning the sym-
 514 metry of spillovers. When utilizing these spillover asymmetry measures, the two hypotheses are
 515 redefined as follows:

$$\begin{aligned} \mathcal{H}_0^1 : TASM = 0 \quad \text{against} \quad \mathcal{H}_A^1 : TASM \neq 0 \\ \mathcal{H}_0^2 : ASM_i = 0 \quad \text{against} \quad \mathcal{H}_A^2 : ASM_i \neq 0, \quad \text{for } i = 1, 2, \dots, k. \end{aligned} \quad (25)$$

516 To test the hypotheses about the symmetry of volatility spillovers, we opt to bootstrap the
 517 measures. It's crucial to ensure that the empirical results are not attributable to estimation errors
 518 from the MEM or discretization errors from realized semi-variances. The latter, in particular, could
 519 be significant due to the limited number of observations during the day in the real data used for the
 520 computation of realized semi-variance.

521 We bootstrap the two realized semicovariance data directly from (11). The LB statistics, as
 522 shown in the last column of Table 3, suggest that the estimated residuals do not exhibit autocorre-
 523 lation, thus we can bootstrap the data from these residuals. The bootstrap procedure is as follows:

- 524 • After estimation, acquire the fitted residual $\hat{\epsilon}_t$.
- 525 • Bootstrap new residuals from $\hat{\epsilon}_t$, denoted as ϵ_t^b , where $b = 1, 2, \dots, 1000$. The residuals are
 526 bootstrapped 1,000 times.
- 527 • Then, the realized semi-variance data X_i can be simulated from the vector MEM model as
 528 follows:

$$\begin{aligned} \mathbf{x}_t^b &= \boldsymbol{\mu}_t^b \odot \boldsymbol{\epsilon}_t^b, \\ \boldsymbol{\mu}_t^b &= \hat{\boldsymbol{\omega}} + \hat{\mathbf{A}}\mathbf{x}_{t-1}^b + \hat{\mathbf{b}}\boldsymbol{\mu}_{t-1}^b + \hat{\mathbf{A}}^w\mathbf{x}_{t-1}^{w,b} + \hat{\mathbf{A}}^m\mathbf{x}_{t-1}^{m,b}. \end{aligned} \quad (26)$$

529 where $\mathbf{x}_{t-1}^{w,b} = \frac{1}{5} \sum_{l=1}^5 \mathbf{x}_{t-l}^b$, $\mathbf{x}_{t-1}^{m,b} = \frac{1}{22} \sum_{l=1}^{22} \mathbf{x}_{t-l}^b$,

530 • For each set of simulated data, we estimate the model and calculate $TASM$ and ASM_i .

531 Using 1,000 bootstrapped processes, we obtain the bootstrapped standard errors of $TASM$ and
532 ASM_i . We then test the significance of the two null hypotheses.

533 **Appendix B: Robustness checks**

534 To assess robustness, we first re-evaluate the volatility spillover effects in Table 4 using differ-
535 ent forecast horizons of $\tau = 100$, $\tau = 30$, and $\tau = 10$. Secondly, we present both the spillover
536 index and the asymmetric spillover index using a shorter 200-day rolling window.

537 Table 5 displays the bad and good volatility spillover effects when a forecasting horizon of $\tau =$
538 10 is employed³. From Table 5, the spillover effects, including the spillover balance and TASM
539 results, are qualitatively consistent with Table 4. Stocks exhibit the largest negative volatility
540 spillover, while the TASM spillover is both negative and significant. The only difference is that
541 the values in Table 4 are larger than those in Table 5. This is expected, as our volatility spillover is
542 calculated as the sum of shock effects across all future forecasting horizons.

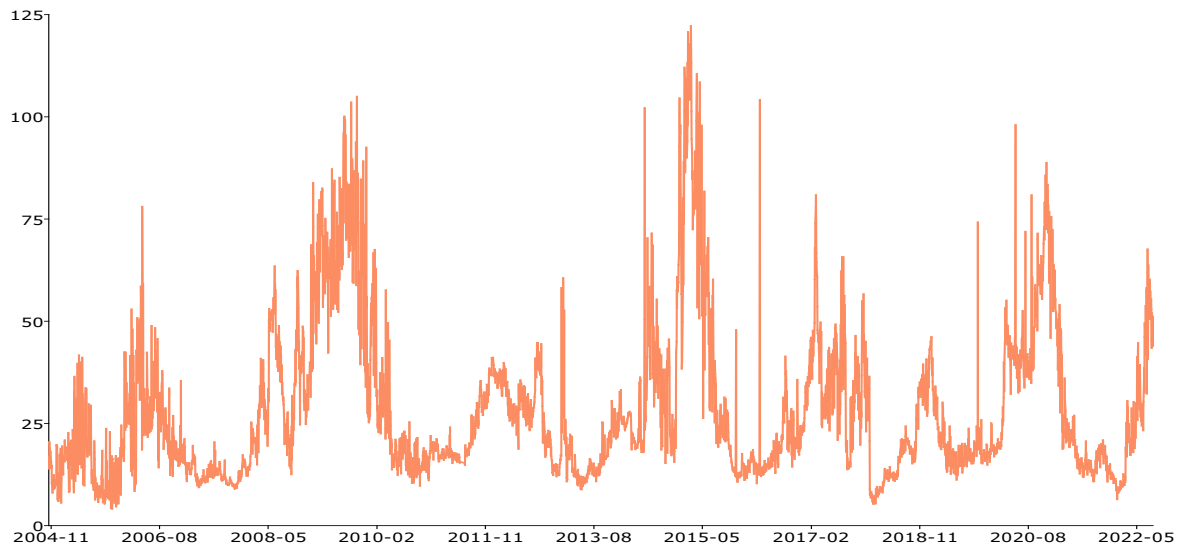


Figure 7 – Total Volatility Spillovers

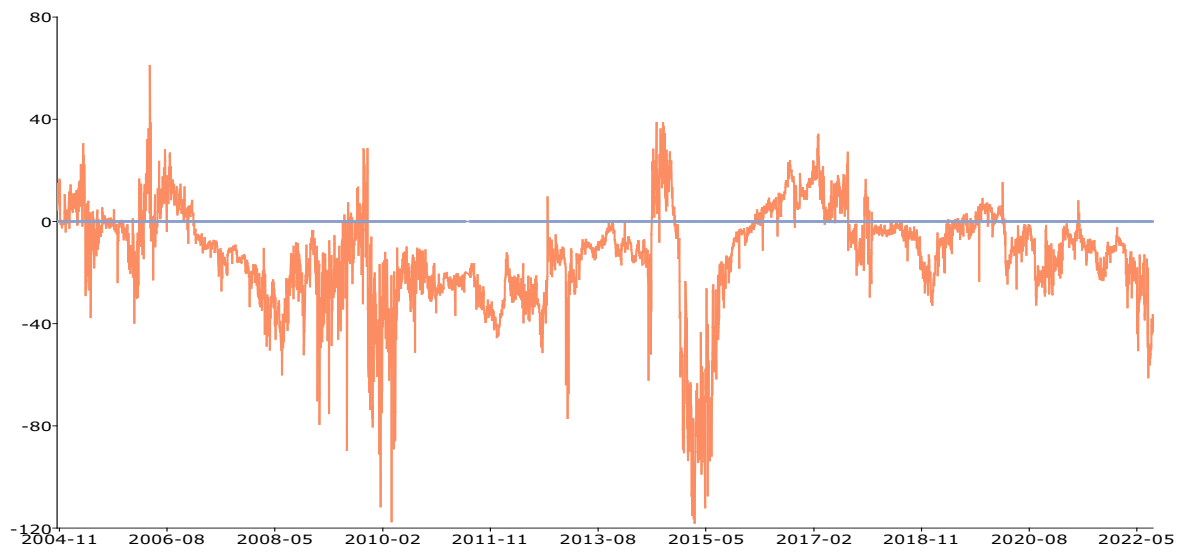


Figure 8 – Total Asymmetric Spillovers (*TASM*)

544 Figure 7 and 8 present the dynamics of total volatility and asymmetric spillovers using a 200-
545 day rolling window⁴. Our core findings remain consistent. The global financial crisis greatly
546 affected market interconnectedness. While the COVID-19 pandemic increased volatility spillovers,
547 its impact was less pronounced than the financial crisis. The asymmetric spillover index was mostly
548 negative. The most significant asymmetry occurred during 2007-2009, with the COVID-19 period
549 showing lesser negative asymmetry. The difference observed from Figure 7 and 8 is that 2015/16
550 exhibited pronounced high total volatility spillover effects and larger negative asymmetric effects.

551 This might be attributed to our use of a shorter rolling window. The 2015/16 stock market sell-off
552 had a significant but relatively short-lived impact on volatility. When a shorter rolling window is
553 employed, this effect appears more pronounced.
