Title: Artificial Intelligence in Natural Resources Management: Selected Case Studies from Africa.

Abstract

This paper explores Artificial Intelligence (AI) 's transformative role in digital transformation and its implications for Africa's socio-economic development. We examine how AI's advanced analytics, machine learning algorithms, and predictive modeling capabilities reshape operational strategies. Case studies elucidate the diverse applications of AI in Africa, including natural resource management such as mining, wildlife conservation, precision agriculture, and water resource management. Examples such as copper deposit discovery in Zambia (Mitimingi & Hill, 2024) and AI-powered wildlife monitoring in Burkina Faso (Vermeulen et al., 2013) illustrate its potential to drive growth, competitiveness, and sustainability across the continent.

Background information on AI and its significance

Al technologies have become a strategic approach to tackle challenges spanning mining, wildlife conservation, precision agriculture, forest monitoring, water resource management, and community-based natural resources management (CBNRM). Molossi and Pipan (2023) state that in mineral exploration, AI algorithms analyze geological and geophysical data to identify potential mineral deposits, leading to cost reductions and time savings. In water resource management, AI-based models assess groundwater availability, monitor water quality, and predict risks such as droughts and floods, enabling informed decision-making for conservation and sustainable management (Umer et al., 2022; Gxokwe et al., 2022).

Al-powered systems track changes in forest cover, biodiversity, and illegal logging activities in forestry. In wildlife conservation, Al-driven technologies monitor animal movements, prevent poaching, and mitigate human-wildlife conflicts. Additionally, Al applications optimize crop production, improve soil fertility, and enhance agricultural pest management through data-driven recommendations. These advancements underscore the transformative potential of Al in various natural resource management sectors.

Key examples include the recent discovery of immense copper deposits in Zambia (Mitimingi & Hill, 2024), the deployment of AI-powered drones for wildlife monitoring and antipoaching efforts in Burkina Faso (Vermeulen et al., 2013), precision agriculture techniques. Additionally, AI analytics are employed in water resource management strategies to predict and manage water availability and quality while empowering local communities through CBNRM initiatives. These case studies highlight the assorted applications of AI in Africa, underscoring its potential to enhance decision-making, conservation efforts, and sustainable natural resources management across the continent.

Furthermore, AI plays a crucial role in digital transformation efforts within organizations by helping to integrate digital technologies to reshape operational strategies and customer engagement approaches. Nevertheless, he lamented that robotics is one of many things that come to mind when considering Africa, given its high unemployment and rapid population growth. However, some African countries recognize robotics' potential for economic development. This paper demonstrates how Africa is leveraging intelligent automation and robotics.

Literature Review

In recent years, artificial intelligence (AI) has garnered increasing attention as a transformative technology with the potential to drive socio-economic development and address pressing challenges across various sectors. While AI has been widely studied and implemented in many parts of the world, its adoption and impact in Africa have gained prominence. With its diverse and rapidly evolving digital landscape, Africa presents a unique context for exploring the role of AI in addressing societal needs, fostering innovation, and driving inclusive growth.

As interest in AI applications grows across Africa, a burgeoning body of literature has emerged examining the opportunities, challenges, and implications of AI adoption in the region. This section seeks to identify gaps, opportunities, and areas for further research by critically analyzing the literature. It will contribute to our understanding of the evolving AI landscape in Africa and its potential impact on the continent's development trajectory.

The use of AI in mining and exploration has garnered much interest from businesses, academics, and policymakers. The research by Molossi and Pipan (2023) focused on utilizing image logs to mitigate drilling hazards through an innovative AI methodology, mainly applied in East Africa. The study aimed to address challenges related to regional drilling operations, explicitly targeting borehole stability issues encountered during drilling activities. By leveraging AI techniques and image logs, the researchers developed a novel methodology to automate data analysis and interpretation to reduce drilling risks associated with borehole stability. The study contributes to geophysics and drilling engineering by introducing an advanced approach to enhance operational safety and efficiency in East African drilling projects.

The article delves into the critical role of image logs in characterizing formations during drilling operations, explicitly focusing on logging while drilling (LWD) for real-time assessment. Highlighting a case study from East Africa, where unexpected borehole stability issues disrupted operational efficiency, the article underscores the importance of structural interpretation in

guiding drilling decisions. The article proposes an innovative approach to automate LWD data analysis, incorporating various AI methodologies like computer vision, numerical series analysis, and machine learning. This automated framework aims to mitigate drilling risks associated with borehole stability by offering a swift and precise interpretation of image logs. Evaluation against manual interpretation by geologists focuses on prediction accuracy and confidence levels, revealing a positive correlation between apparent dip and model error. Surfaces with lower dipping angles notably exhibit higher confidence. These findings underscore the significance of accurate interpretation, particularly for high-dipping surfaces, in averting borehole stability issues and optimizing operational measures during drilling activities. (Molossi and Pipan, 2023).

Molossi and Pipan's (2023) data and methods section outlines the development of a workflow utilizing logging while drilling (LWD) image logs from two wells. They emphasize manually interpreting sharp density contrasts to establish a baseline. This manual interpretation is instrumental in determining apparent dip magnitude and dip azimuth, derived directly from the amplitude and phase of sinusoids representing geological features. However, obtaining true values necessitates additional measurements from while drilling (MWD) data, such as magnetometer and inclinometer data acquired during drilling. P. 944 The methods used in the above example are further elaborated in the section on the primer in AI for mineral exploration.

Automation of repetitive tasks caught the attention of Vernon (2019), who discusses the role of robotics and artificial intelligence (AI) in Africa, highlighting their potential for social and economic empowerment. The article explores the adoption of robotics in African countries and strategies to capitalize on intelligent automation opportunities while mitigating global threats like premature deindustrialization.

Kondo and Diwani (2023) provide a comprehensive overview of AI, portraying it as a transformative technology gaining widespread attention and interest across various sectors. It emphasizes AI's significant role in enhancing human capabilities and addressing societal challenges in healthcare, infrastructure, digital economy, environmental conservation, and agriculture. The portrayal of AI as a tool for improving all aspects of life underscores its potential to drive positive impacts and societal advancement in the twenty-first century. The article also delves into the various research fields within AI, including machine learning, natural language processing, robotics, and deep learning, highlighting the interdisciplinary nature of AI and its wide-ranging methodologies.

Furthermore, the article explains key concepts within AI, such as supervised, unsupervised, reinforcement, and deep learning, providing insights into how machines learn from data and make decisions. The discussion on deep learning elucidates its ability to analyze complex patterns in various forms of data, mimicking the human brain's cognitive processes. Additionally, the article touches upon the significance of natural language processing (NLP) in enabling computers to understand and process human languages, facilitating communication between humans and machines.

Moreover, the article explores the potential of AI to drive economic growth and competitiveness in African countries across various industries, including agriculture, transportation, finance, energy, and healthcare. By employing bibliometric analysis and

visualization, the study aims to provide insights into the current state of AI research in Africa, facilitating future research endeavors in the region.

The text underscores the significant role of ADM systems in making critical decisions with potential impacts on financial, health, and liberty outcomes, thereby emphasizing their far-reaching implications for individuals, organizations, and society.

A critical analysis of their research reveals several strengths and limitations. Firstly, the authors effectively convey the importance of ADM systems in contemporary decision-making processes, particularly within governmental and organizational contexts. The discussion on the potential impacts of ADM systems on various aspects of society, including vulnerable populations, adds depth to the analysis and underscores the ethical considerations associated with their implementation.

Technology companies have started investing in human capital. For example, Cisse (2018) explained how Google established the first AI Research Lab in Accra, Ghana, signaling a significant step towards advancing AI research and development in Africa. This initiative will employ numerous engineers and scientists, demonstrating a solid commitment to fostering AI expertise on the continent. Additionally, recent efforts such as the African Masters of Machine Intelligence degree program, sponsored by tech giants like Facebook and Google, are already underway, with renowned global experts joining to teach at the African Institute of Mathematical Sciences in Kigali, Rwanda. This program boasts a curriculum led by top-notch lecturers, making it one of the premier AI educational initiatives globally. (Cisse, 2018).

The crucial dependency lies in policy development, ensuring responsible AI adoption in Africa. African governments must establish standardized legal frameworks and values prioritizing AI technology's ethical and beneficial use. Globally, there is increasing concern over the potential misuse of AI, prompting initiatives to address these issues. For instance, the European Commission has outlined ethical guidelines for AI in the public sector. At the same time, Google has introduced standards to govern its AI research and product development in the private sector. These efforts underscore the importance of ensuring that AI serves the greater good of humanity while mitigating potential risks associated with its deployment. Some African countries have drafted AI policies. For example, the Zambian government has completed drafting a comprehensive Artificial Intelligence (AI) strategy, poised to harness the latest technological advancements for national development. Copperbelt Katanga Mining.(May, 2024).

According to Manson et al. (2023), Africa's readiness for implementing artificial intelligence (AI) in clinical radiotherapy delivery, with a focus on the pivotal role of medical physicists in leading this transition. It addresses the current status of AI adoption in radiotherapy within the African context, potential challenges and opportunities, and the importance of medical physicists in driving the integration of AI technologies in clinical practice. Additionally, the article explores strategies for enhancing AI readiness in radiotherapy and the implications of AI implementation for improving patient outcomes and healthcare delivery in Africa. AI has gained prominence in radiotherapy practice due to its ability to automate various tasks involved in the radiotherapy chain, including medical image processing, calculation, and hardware control. With advancements in big data processing and high-performance computing, Al technology can effectively streamline the entire workflow of radiotherapy. Manson et al. (2023) explain that tasks ranging from selecting the most suitable radiation method, such as a proton or photon radiation, to treatment planning, plan evaluation, quality assurance, dose delivery, and patient care are easily handled using AI. Research indicates that deep learning algorithms, trained on extensive clinical data from cancer patients, can assist healthcare professionals in identifying optimal treatment options and improving cancer patient treatment plans.

Methodology

The research paper uses secondary data analysis, which involves examining and interpreting existing data that others have previously collected. The data came from various sources such as official statistics, survey data, administrative records, research studies, or publicly available datasets. The advantage of secondary data analysis is that it offers an opportunity to explore research questions or test hypotheses using pre-existing data without the need to collect new data through primary research methods. For this study, the researcher will access secondary data from archives, databases, or repositories and then apply various analytical techniques to analyze the data and draw conclusions relevant to the current research objectives. This approach provided valuable insights and enhanced the efficiency of research efforts. However, the researcher is aware of the limitations of secondary data to ensure the validity and reliability of their findings.

A primer on AI in mineral exploration

This section briefly outlines how AI can be utilized in mineral exploration. It is understood that AI algorithms can process and interpret vast amounts of data much faster and more accurately than traditional methods. These algorithms analyze various data types, including geological maps, geochemical samples, and geophysical survey results. Training models to identify mineral deposits is the first activity, which can be done by recognizing patterns and correlations in the data to identify areas with high potential for mineral deposits. The second part involves data processing, analysis, and integration. (Ueki et al. , 2018). Welltrained AI systems benefit from a feedback loop mechanism, whereby they continuously learn from new data and exploration outcomes, progressively enhancing their predictive accuracy. This iterative process involves successful discoveries feeding back into the AI model, refining its comprehension of mineralization patterns. Additionally, using adaptive algorithms enables AI systems to adapt to new data and evolving geological insights, rendering them more robust and dependable in predicting mineral deposits over time.

Al plays a crucial role in geological mapping. It analyzes satellite imagery and remote sensing data to create detailed maps that highlight potential mineral-rich zones.

Al interprets **geophysical** data from magnetic, gravity, and seismic surveys to detect anomalies indicative of mineral presence, using machine learning models trained to recognize signals associated with various types of mineral deposits. (Melo & Li (2021). Geophysical data provides information on the physical properties of the earth's surface and subsurface. As a result, geophysical data can help locate hydrocarbons, minerals, aggregate, and other natural resources. Geophysical data can also be used for geologic mapping, hydrology, environmental monitoring, slope stability assessment, infrastructure planning, and monitoring and to study permafrost (Ganguli et al., 2022; *Uses for Geophysical Data*. 2024).

Geochemistry studies the chemicals, rocks, and minerals that form and shape the earth. Al assists in **geochemical** analysis by analyzing data from soil, rock, and water samples and identifying chemical signatures that correlate with specific minerals to guide exploration efforts more accurately. Using accurate geochemical data, scientists are helping pinpoint locations that may host copper, gold, or other earth resources. Therefore, explorers can target regions with mineral potential with access to geochemistry data (Victorian Government, 2024).

Al algorithms analyze geological maps, rock samples, and historical exploration data. This data provides insights into the geological formations and structures conducive to mineralization. Amvrazis et al. 2022, stated that mapping and classifying geological rock mass features like discontinuities and block sizes are crucial for understanding and predicting rock mass behavior under various load conditions. This information is essential for assessing rock slope stability, evaluating geological hazards, and designing mitigation measures. Manual data acquisition is time-consuming and risky, especially in remote areas post-hazard events, and challenging for large, inaccessible areas. (Gohil & Shah, 2022, pp. 77–84).

The last data point is **remote sensing**, which is acquiring information about an object or phenomenon without physically contacting it (NASA Earthdata, 2024). In remote sensing, satellite imagery and aerial photographs provide large-scale terrain views. All uses this data to detect surface features and alterations indicative of mineralization.

The benefits of AI in mineral exploration include reducing the costs of traditional mineral exploration methods, which are often expensive and time-consuming due to extensive fieldwork and drilling. Industry leaders such as Rio Tinto, Goldcorp, and BHP are adopting AI technologies to enhance their exploration strategies and reporting significant improvements in outcomes (NRI Digital, 2023).

Data processing, analysis, and integration are crucial components of mineral exploration, encompassing pattern recognition, predictive modeling, and clustering and classification techniques. Pattern recognition involves training machine learning algorithms to identify correlations between collected data and known mineral deposits, including geological formations, geophysical anomalies, or geochemical signatures. By integrating various data sources, predictive modeling utilizes AI to develop models that estimate the likelihood of discovering mineral deposits in different locations. These models undergo continuous refinement and validation with new data and exploration findings. Clustering and classification algorithms are employed to categorize data points into clusters based on similarities in their characteristics, aiding in identifying regions with geological, geophysical, or geochemical properties akin to known mineral-rich areas.

Selected Case Studies

Diagnostics

Al in healthcare takes many forms, including diagnosis, logistics, and patient care. For example, an Al developer, Qure.ai, utilizes deep learning technology to automate radiology interpretation, improving imaging accuracy and healthcare outcomes. This innovation enables faster diagnosis and treatment, making healthcare more accessible and affordable globally.

The Centre for Infectious Disease Research in Zambia (CIDRZ) has partnered with Qure.ai, a leading health-tech company specializing in artificial intelligence (AI)-powered medical imaging diagnostics solutions, to implement a comprehensive tuberculosis (TB) screening program in Zambia. This initiative will utilize Qure.ai's AI-enabled computer-assisted detection software and lung health management platform to evaluate chest X-rays and identify presumptive TB patients. Supported by the U.S. Centers for Disease Control and Prevention (CDC) through a cooperative agreement with CRDF Global, Qure.ai, in collaboration with CIDRZ, will integrate its lung health suite, including qXR and qTrack, across seven hospitals in Zambia. These AI-powered solutions aim to enhance TB case detection, alleviate pressure on healthcare workers, and optimize radiology workflows. Qure.ai's CE-approved chest X-ray software, qXR, can rapidly detect 30 critical lung markers, facilitating the identification of various lung diseases beyond TB, such as pneumonia, COPD, COVID-19, and silicosis. (Qure.ai. 2024).

Drones

Drones have revolutionized how medicines and products are transported in healthcare services. For example, Zipline partnered with the Rwandan government to deliver more than 50 types of blood products to rural hospitals and clinics using custom-designed drones (Duan, 2018). The Zipline drones have a range of more than 100 km; as of 2018, 12,000 units of blood had been delivered on 6,000-plus flights. The company has more than 100 Rwandese employees.

Drones in wildlife management are a game changer. For example, drones survey elephants in the 940 km² Nazinga Game Ranch (NGR) located in southern Burkina Faso along the international border with Ghana. In the wide open and challenging terrain of the Savannah, survey operations are expensive, which is a huge task for most African countries. Pre-programmed UAS (Unmanned Aircraft Systems) have replaced traditional foot and aerial surveys of elephants. (Vermeulen et. Al., 2013).

During the impact of Cyclones Idai and Kenneth in Mozambique in 2019, the WFP utilized drones for the initial time in emergency response, collaborating with Mozambique's National Institute of Disaster Management (INGC) to manage and guarantee operational safety.

Drones facilitated swift post-disaster evaluations and meticulous mapping, offering a plethora of data to assist 20 humanitarian organizations on-site in reaching affected populations. (World Food Programme, 2019).

The use of drones for precision agriculture is increasing. Charis Unmanned Aerial Solutions in Rwanda and FutureWater in Kenya provide farmers with precise information about their crops using drone technology. The data collected helps farmers make informed decisions about fertilization, irrigation, and pest management, thereby reducing costs and increasing yields. Farmers use drones for targeted interventions by applying the proper treatment in the right place at the right time to optimize available resources, increase the profitability and sustainability of agricultural operations, reduce negative environmental impacts, and improve the quality of the work environment. Drones equipped with advanced sensors enable precision farming by providing high-resolution images of crops, allowing farmers to detect diseases and optimize resource usage. (africanDRONE, 2024).

For instance, healthcare providers in Zambia utilize Qure.ai's AIpowered medical imaging diagnostics solutions for tuberculosis (TB) screening, enhancing TB case detection and optimizing radiology workflows. Drones are employed in healthcare services to transport medical supplies and in wildlife management to survey elephants. Additionally, drones are increasingly used in precision agriculture, providing farmers with precise information about their crops to optimize resource usage and increase yields.

The literature provided offers a comprehensive exploration of the multifaceted role of artificial intelligence (AI) in Africa, spanning various sectors and domains. Firstly, they underscore the evolving landscape of AI adoption on the continent, emphasizing its potential to drive socio-economic development and address pressing societal challenges. Specifically, the application of AI in mineral exploration emerges as a prominent theme, with discussions focusing on its ability to process geological, geochemical, and geophysical data to identify mineral deposits and enhance operational safety in drilling projects. These themes collectively reflect the diverse applications and implications of AI across different sectors in Africa, highlighting both opportunities and challenges associated with its integration into various aspects of society and economy.

Conclusion
