## A comment on "Se Habla Español: Spanish-Language Appeals and Candidate Evaluations in the United States"

#### **Abstract**

Zárate, Quezada-Llanes, and Armenta (2024) examine whether Hispanic and Anglo voters change voting behavior if a political candidate speaks to them in Spanish and whether it matters how proficient in Spanish the candidate sounds. They find that Hispanic support for the Anglo and Hispanic candidates is higher in the native-like Spanish condition compared with the English-only condition. Relative to the English condition, non-native Spanish does not increase support for the Anglo candidate, but it decreases support for the Hispanic candidate. They find mixed effects for the Anglo participants. We conducted computational and robustness reproductions. First, we successfully computationally reproduced all the main results. Second, we constrained the analysis to participants that passed the manipulation checks (this was not done by the authors). We find the same results hold. Notice we constrained ourselves to study 1, which is based on data by Prolific.

## 1. Introduction

Zárate, Quezada-Llanes, and Armenta (2024) (hereinafter, the authors) conducted two studies. For study 1, they obtained a national sample of 503 Hispanic and 506 Anglo respondents through the survey firm Prolific. The survey was fielded from October 26-31, 2020. Overall, their Hispanic and Anglo samples were younger, had higher levels of education, were more liberal, and were more likely to identify as Democrat compared with estimates of the United States population. For study 2, they obtained a sample of 1000 Hispanic and 1000 Anglo respondents through Lucid. The survey was fielded from December 28, 2021 to January 11, 2022. The partisan composition of the sample corresponds to the two-party 2020 presidential vote share.

The authors use a between-subjects survey experiment. Prior to beginning both experiments, all participants were told that they were being asked to participate in a research study examining how people evaluate state legislature candidate campaign speeches. At the beginning of the survey, they asked several demographic questions including age, gender, ideology, and partisanship. In study 1, participants were randomly assigned to one of six conditions where they were instructed to listen to a short audio clip from a campaign speech of a candidate running for a seat in a state legislature. They varied whether they candidate is Hispanic or Anglo, and whether part of the campaign speech is spoken in non-native Spanish, native-like Spanish, or fully in English. To vary the ethnicity of the candidate, they gave a Hispanic- or Anglo-sounding name to the hypothetical candidate (Josué Martínez or Josh Martin) and explicitly stated the candidate's ethnicity or race. For the language treatment, respondents were assigned to one of three different audio recordings, all of which shared the same substantive content. The only differences between these audio files was in the language, English or Spanish, used in two sentences and the candidate's accent when speaking Spanish. For Study 2, they also vary whether the candidate is running in a nonpartisan or partisan primary election for a total of 12 treatment conditions. Participants in Study 2 either did not know the candidate's partisanship or were told that the candidate was running in their selfidentified political party primary. After receiving the treatment, they included four questions to measure their outcome of interest: evaluations of the candidate. They

measure candidate evaluations by asking respondents how likely they are to vote for the candidate, whether they trust the candidate, how much they like or dislike the candidate, and if they would feel represented with the candidate in office. All items are measured on a 5-point scale. For their dependent variable, they construct an index of candidate evaluations by summing scores of these four variables. Following the candidate evaluation measures, they collected other relevant social and demographic information. In Study 2, they asked for racial identification information at the beginning of the survey and randomly assigned participants to receive the group strength questions either before or after the treatment.

In study 1, they "find that Hispanics prefer candidates who use Spanish-language appeals but only when the candidate speaks with native-like proficiency. This is true for both of the Anglo and Hispanic candidates in [their] experiment. [...] Spanish-language appeals do not have a consistent impact, positive or negative, on Anglos' candidate evaluations [...]" (p. 364). Study 2 "successfully replicate[s] these findings" (p. 364).

For our reproduction, we obtained the data from the American Political Science Review Dataverse. We did not contact the authors for further data or clarifications.

We conducted computational and robustness reproductions. First, we successfully computationally reproduced all the main results (i.e., Tables 1 and 2 and Figures 1, 2, 3, and 4 of the paper) from the raw data and code provided. A small coding error was found, and is discussed below. Second we reproduced the results of hypotheses 2 and 3 for Study 1 (that Hispanic voters give higher evaluations to Hispanic candidates, and that relative to the Anglo candidate speaking English, they will punish Hispanic candidates speaking non-native Spanish) purely from the raw data, without looking at their code. Finally, we enforced manipulation checks on participants and discarded those who answered incorrectly (they indicated the incorrect candidate ethnicity or language), and additionally also enforced match between ethnicity self-identification and Prolific's classification.

## 2. Computational Reproducibility

The replication package includes a script for all analyses. The authors conducted supplementary analyses with additional datasets that were not available in the replication package. One of those datasets was proprietary. We successfully computationally reproduced all the main results (i.e., Tables 1 and 2 and Figures 1, 2, 3, and 4 of the paper) from the raw data. Our code is available here: <a href="https://osf.io/s4uhg/">https://osf.io/s4uhg/</a>. We found one coding error, which could have been impactful but by fortune wasn't: when the authors encode the candidate's ethnicity under the "treatment" field, they incorrectly assign Q10 to the Anglo-English condition. The correct question to use is Q10.1. Fortunately, this was the first encoded condition, and the following ones overwrote the "mistake", except for the cases for which it actually applied. Hence the error had no consequence. However, it could have resulted in different outcomes had the list not been exhausting. Also, notice that if they thought the candidate was identified as biracial, the order of encoding matters, since posterior encodings overwrite previous ones. We did not investigate this further, but we looked into a similar issue when it comes to participant's self-identification of ethnicity. See Section 4.1 for further details.

Our results, compared with those of the original paper, can be seen in Figures 1-4.

### 2.1 Discrepancies Between Pre-analysis Plan and Article

The authors pre-registered both studies (study 1: <a href="https://osf.io/6ebav">https://osf.io/6ebav</a>; study 2: <a href="https://osf.io/g36q9">https://osf.io/g36q9</a>), including the analysis plans. The table below contrasts the pre-registrations with the published paper.

In addition to the information provided in table above, it is worth mentioning that the authors did not specify any data wrangling decisions in the pre-registration. This includes issues such as recoding variables and handling missing data. Also, the published paper did not report everything exactly as specified in the pre-registration. However, the authors mention this in footnote 8 and provide extensive supplementary materials. The supplementary materials also include additional analyses not specified in the pre-registration.

## 3. Recreate Reproduction

We conducted recreate reproducibility using the replication package. We focused on replicating the findings of Study 1. To achieve recreate reproducibility, one of us attempted to replicate the findings starting with the raw data without having looked at the code from the authors. We used the same linear regression models as the authors.

We followed the steps outlined in the "Experimental Design" section of the original article to create appropriate dependent and independent variables. The survey instruments in the replication package provided enough information to guide data processing. <u>Table A3</u> in the Appendix below shows the regression output using the data from Study 1. The first and second columns show the results from the original paper, while columns 3 and 4 are the result of our recreate reproduction. Both the direction and statistical significance of the effect remain the same, and the magnitudes are similar.

#### 4 Robustness

Furthermore, we conducted robustness reproducibility tests. We did two independent analyses based on the two branches of our code: one from the code taken from the authors (used for computational reproduction) and one from the code we wrote from scratch (used for recreate reproduction). We made independent decisions during data processing, which resulted in our final dataset having different sample size and covariates. We used the same linear regression models as the authors. For the first branch, based on the computational reproduction code, we chose only the participants whose ethnic self-identification matched the one provided by prolific. This is discussed in Section 4.1. For the second branch, based on the recreate reproduction code, we 1) enforced manipulation checks, and 2) jointly enforced manipulation checks and restricted analysis to those whose ethnicity self-identification matched Prolific's. This is discussed in Section 4.2.

# 4.1 Self-Identification for Race/Ethnicity – Based on Computational Reproducibility

During data processing, we noticed that a series of questions were asked to report their ethnicity in multiple-choice questions Q53\_1, Q53\_2, Q53\_3, Q53\_4, Q53\_5, Q53\_6. The provided code used a unique strategy for coding race, based on exclusive self-nomination, where the last option overwrites all previous choices. For example, if a participant self-reported to be Black and White race column would reflect only white Race/Ethnicity. At the same time, if a participant self-reported to be Black, White and Latino then the Latino option will overwrite all previous ones. We consider it a mistake, since running the provided code in a different order will result in a different definition of race. To demonstrate the possible ambiguity of this choice we compared White and Latino samples by Race/Ethnicity distributions by running code in the original and reversed orders.

While the authors do not use the self-reported Race/Ethnicity to split the sample from Study 1 into Latino and White and rely on Race/Ethnicity that was assigned to participants by Prolific. Given the complexity of the concept of Race/Ethnicity and the possibility of mixed or combined identity, we decided to conduct a robustness check, where Latino and White groups will be identified based on a survey response only. For the simplicity of the study, we will assign participants who have exclusively self-identified as White in the survey as White, and participants who exclusively identified as Latino in the survey. If participants have reported more than one Race/Ethnicity or if they reported a Race/Ethnicity that is not exclusively Latino or not exclusively White, then we removed them from this robustness check. The difference in demographic characteristics is summarized in the table below.

We are happy to report that all reported results remained consistent with the original study. The direction and significance level of the results remained the same, given the alpha value at 0.1 and the same effect size. The only difference was found in Table 2 of

the paper "Effects of Language and Ethnicity on Candidate Evaluations among Anglos", where interaction Hispanic x Spanish was not significant at level 0.1 (b = -0.065, SE = 0.043, **Table A2**) in the original study, but became significant (b = -0.076, SE = 0.041, **Table A2**) at level 0.1 in the robustness check analysis. A table comparing this table with our robustness scenario is found <u>Table A2</u>. However, we decided not to interpret the interactive effect, as the direction of the effect was consistent with the original study and the uncertainty intervals overlap. We have included a comparison of the figures and tables reported in the paper for study 1 with those from the robustness check in Appendix A. See Figures <u>A1</u>, <u>A2</u>, and <u>A3</u>, and <u>Table A1</u> and <u>Table A2</u>.

# 4.2 Removing Participants that Failed Manipulation Checks, and Matching Ethnicity Self-identification with Prolific's classification – Based on Recreate Reproducibility

A series of questions were asked to evaluate participants' attention (manipulation checks) in the survey. Participants were told the name and ethnicity (White or Latino) of their assigned candidate in the survey vignette. After listening to the recording, participants were asked to answer the race of the candidate and the language spoken in the recording. In study 1, for the Hispanic participants dataset, we found that only 418 of 501 participants correctly identified the candidate's ethnicity.

We remove the participants that did not pass the manipulation checks from the analyses. The candidate's race is hypothesized to influence a participant's evaluation of the candidate; therefore it is questionable if the effect of candidate's race is truly reflected by those unable to correctly identify the candidate's race. Our result is shown in <a href="Table A4">Table A4</a>. Our results match the original results, with the effect directions remaining the same as well as almost all significant levels. The one difference is for hypothesis 2, non-fluent Spanish, in which the effect ceased to be significant.

It is worth pointing out that our analysis removing participants that did not pass the manipulation checks is not free of potential problems. As pointed out by the original authors in our communication with them, removing participants based on manipulation checks can lead to cherry picking and to non-randomness of the samples. This decision can subsequently lead to an increase in Type I and Type II errors (Kotzian, Stoeber, and

Weissenberger 2020). Despite this possibility, it is reassuring that the original findings remain nearly the same both removing and not removing participants who did not pass the manipulation checks.

A few words regarding those who did not pass the manipulation checks are in order. We noticed misidentification mostly happened from Latino to white and vice versa. Upon further investigation, restricting ourselves only to those participants who misidentified the Latino candidate as white and the white candidate as Latino, we found the following: for misidentifications of the Latino candidate, 60% happened when he spoke non-fluent Spanish, compared to 33% expected from random chance (vs fluent Spanish and English). Similarly, for misidentifications of the white candidate, 54% happened when he spoke fluent Spanish, again deviating from the 33% expected by chance. We did not pursue this further, but it may be due to participants encountering unexpected situations: a Latino candidate speaking non-fluent Spanish, and a white candidate speaking fluent Spanish.

We further added the self-identification constraint. That is, besides passing the manipulation checks, participants were restricted to also match their ethnicity self-identification to that indicated by Prolific (see the discussion in <u>Section 4.1</u>). Only 383 of the original 501 remained. Our results are presented in <u>Table A5</u>. We are happy to report that even after this constraint the effect direction and significance remains the same, except again for hypothesis 2, non-native Spanish, for which significance ceased.

### 5. Conclusion

To reproduce the results of the paper, we took two different paths, one based on the code provided by the authors (computational reproduction) and one based on code created from scratch (recreate reproduction). In the computational reproduction branch, we perfectly reproduced the figures and tables from the paper. See Figures 1-4 and Tables 1-2. Notice these involve both the Prolific and the Lucid datasets. We used this as basis to add a robustness check on the Prolific dataset: using only the data for which ethnicity self-identification matched Prolific's identification. The results are in Figures A1-A3 and Tables A1-A2. We happily report the general results hold. In the recreate reproduction branch, we limited ourselves to study 1 (the Prolific dataset). Our recreate reproduction is available in Table A3, where we happily inform the same direction and significance was found. We further built on this to add two constraints, the first one was subsetting participants to only those who passed manipulation checks, this is shown in Table A4. The second one further enforces participant's match between ethnicity self-identification and Prolific's identification. The results are shown in **Table A5**. We are happy to report that for both these scenarios the directions remain the same, and with one exception the significance levels also remain the same.

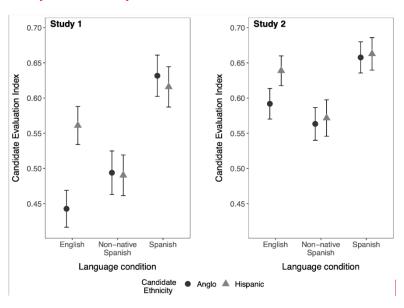

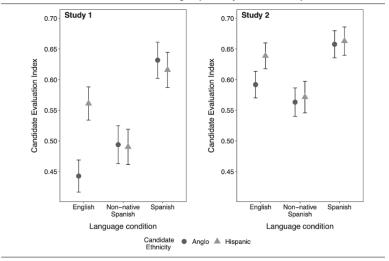

#### **Computational Reproduction**



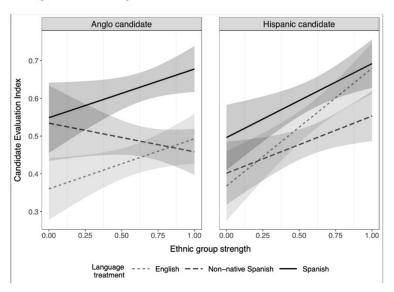

FIGURE 1. Mean Candidate Evaluation among Hispanics by Treatment Group

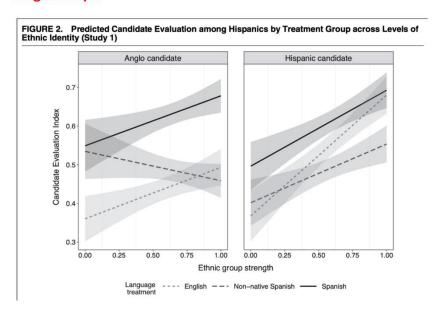

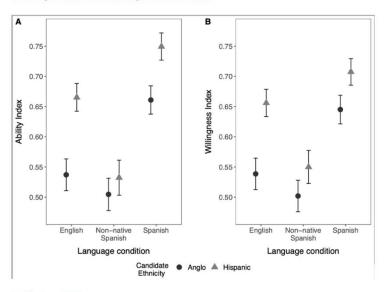

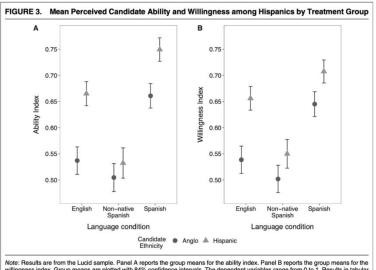

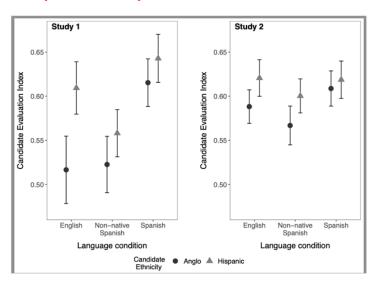

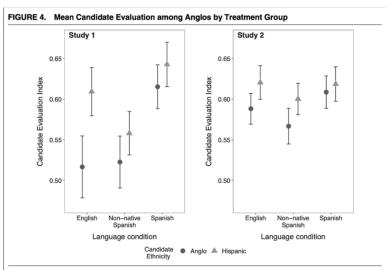

Comparison of Figure 1 between original study and modified version based on definition of Latino and White groups.

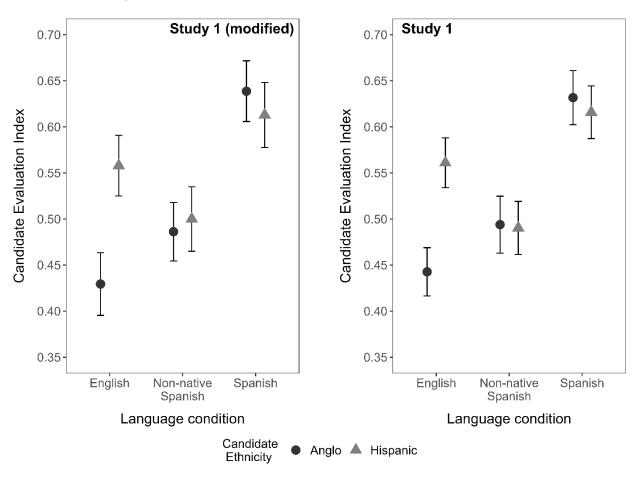
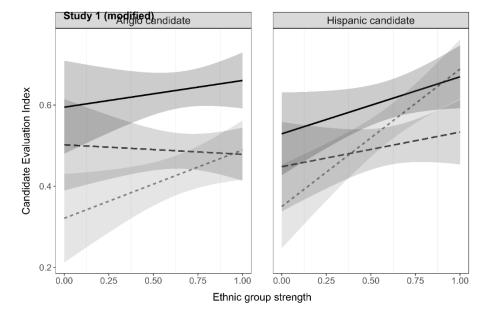

Comparison between Figure 2 in original paper and modification based on definition of Latino and White groups.



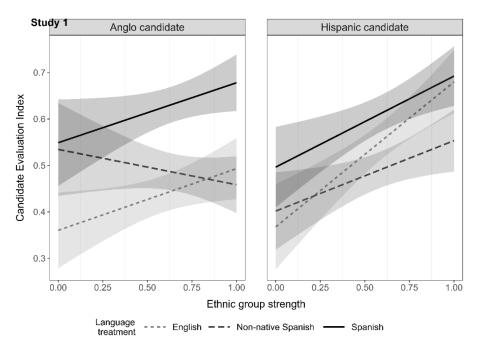
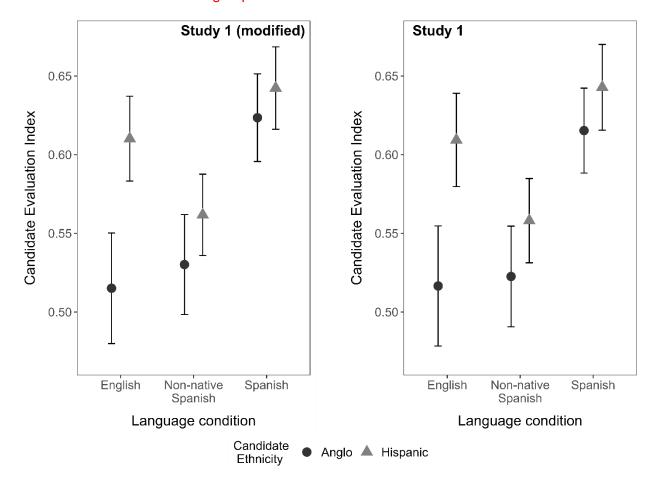
