#### **OVERVIEW**

The objective of this research project is to understand the mechanisms by which the institutional framework governing the naturalization process influences the intentions of various immigrant groups in Germany to pursue citizenship. To achieve this, we implement an experimental design across three distinct data sources: the German Socioeconomic Panel, the IAB-SOEP Migration Sample, and the IAB-BAMF-SOEP Sample of Refugees. Within this framework, we systematically manipulate the prerequisites and conditions for naturalization. Subsequently, we assess the immigrants' hypothetical intentions to naturalize by soliciting their responses to these varied scenarios. This approach allows us to capture the potential impacts of institutional settings on naturalization decisions across diverse immigrant groups.

#### State of research

Research addressing the conditions within destination countries highlights a negative correlation between restrictive legal frameworks and naturalization rates (Dronkers and Vink 2012). This association is notably more pronounced among non-citizens from less developed nations (Jensen et al. 2021; Vink, Prokic-Breuer, and Dronkers 2013). Although these studies underscore the significance of destination country conditions on naturalization frequencies, they are limited in their ability to infer causal mechanisms due to their empirical design constraints.

In contrast, our study enhances the field by employing an experimental design to causally examine the effects of the destination country's legal requirements on naturalization. Our approach builds upon a limited number of studies that have employed causal analysis to explore how institutional contexts affect non-citizens' decisions to naturalize. Notable topics in this realm include acceptance of dual citizenship (Peters and Vink 2023; Vink et al. 2021), the implementation of fee waivers (Yasenov et al. 2019), the effectiveness of informational nudges (Hotard et al. 2019), discretionary decision-making procedures (Hainmueller, Hangartner, and Ward 2019), and the provision of voting rights (Slotwinski, Stutzer, and Bevelander 2020). These studies utilize natural experiments – specific changes in legal requirements – to draw causal conclusions, typically focusing on the impact of individual legal modifications in isolation. Our research extends this inquiry by systematically varying multiple aspects of legal frameworks to more comprehensively understand their influence on naturalization decisions.

#### **Hypotheses**

We propose that immigrants are more inclined to pursue citizenship under certain conditions: shorter required residency duration (H1), absence of a formal language test (H2), and no mandatory naturalization test (H3). Additionally, the likelihood of immigrants investing in citizenship increases if the process duration is shorter (H4), the citizenship certificate is ceremonially handed over in person (H5), and if there is an option for a family-based application (H6). Conversely, the requirement to renounce previous citizenship (H7) and the imposition of a naturalization fee (H8) are expected to deter immigrants from seeking citizenship.

Moreover, we hypothesize that the institutional framework of the naturalization process presents greater challenges for refugees in Germany, compared to other groups such as economic and family migrants, due to their typically more complex migration histories. However, refugees generally exhibit a longer-term intent to reside in the host country, which may increase their likelihood to naturalize. Therefore, the impact of the institutional framework on naturalization intentions might be comparatively less significant for refugees than for other immigrant groups in Germany.

#### Data

We implement a standardized vignette study across three distinct data sources: the German Socioeconomic Panel (SOEP-CORE), the IAB-SOEP Migration Sample (IAB-SOEP-MIG), and wave six of the IAB-BAMF-SOEP Sample of Refugees in Germany (IAB-BAMF-SOEP-REF).

SOEP-CORE is a representative, annual panel survey of private households in Germany that commenced in 1984 in West Germany and expanded to include East Germany after 1990. Initially, it oversampled immigrants from Turkey, Greece, Italy, Spain, and former Yugoslavia (Sample B in 1984) and later included immigrants arriving post-1984 mainly from Eastern Europe and other developing countries (Sample D in 1994-1995) (SOEP Group 2023).

The IAB-SOEP-MIG, a collaboration between the Institute for Employment Research (IAB) and SOEP, initiated in 2013, is conducted annually using the Integrated Employment Biographies register data from the Federal Employment Agency as the sampling frame. This sample is representative of the population that immigrated to Germany between 1995 and 2013, including second-generation immigrants born after 1976 and their household members. Refreshment samples in 2020 and 2021 included recent migrants from the EU (arrived 2016-

2018) and third-country nationals (arrived 2019-2020) following the skilled worker migration law (SOEP Group 2023).

The IAB-BAMF-SOEP-REF, established in 2016 through a partnership between the IAB, the research center of the Federal Office for Migration and Refugees (BAMDPF), and the SOEP, surveys annually. Anchor persons for this survey are selected from the Central Register of Foreigners (Ausländerzentralregister, AZR), a comprehensive registry of all foreign nationals in Germany. The sample represents asylum seekers and refugees who have arrived in Germany since 2013 and their household members (Brücker, Rother, and Schupp 2017; Kroh et al. 2017).

### **Description of sample**

The vignette experiment was incorporated into the surveys conducted in 2021 and 2022.<sup>1</sup> In 2021, it was specifically directed at panel respondents from the IAB-BAMF-SOEP-REF who did not hold German citizenship, representing approximately 80.5% of that cohort (own calculation). The fieldwork for this segment was carried out in the latter half of the year. In 2022, the experiment expanded to include respondents from the SOEP-CORE, the IAB-SOEP-MIG, and non-refugee participants of the IAB-BAMF-SOEP-REF<sup>2</sup> who also did not have German citizenship and were engaged through computer-assisted methods such as CAPI, CATI, CASI, and CAWI. This group constituted 3.8% of the SOEP-CORE, 77.8% of the IAB-SOEP-MIG, and 10.4% of the IAB-BAMF-SOEP-REF participants (own calculation). The main phase of data collection for this expanded scope occurred in the first half of 2022.

To accommodate potential language barriers, the survey instruments and related materials were provided in various languages spoken by the major immigrant groups, in addition to German (SOEP Group 2023).

### **Construction of the vignette experiment**

In this vignette experiment, we describe the institutional context for naturalization in Germany, detailing the various dimensions that vary across the vignettes. These dimensions are outlined in Table 1 and include factors such as (1) dual citizenship, (2) the waiting period length, (3) requirements for language and (4) citizenship tests, (5) the duration of bureaucratic procedures, (6) fees associated with naturalization, (7) options for family applications, and the methods for

delivering the citizenship certificate. Following our theoretical considerations, dimensions (1) to (4) address legal requirements and dimensions (5) to (8) address implementation of naturalization laws.

In Table 1, each dimension is presented with a base level that represents the current legal and procedural norms, and a liberalized level, which shows more permissive and inclusive options. This arrangement facilitates a comparative analysis between the current and liberalized conditions, helping to illustrate the potential impact of making the naturalization process more inclusive and less restrictive. This structured comparison aims to provide insight into how changes in these dimensions could affect immigrants' intentions to naturalize, offering a realistic view of how liberalization could influence decision-making in this area.

First, regarding the dimension dual citizenship, one must either renounce the old citizenship or be allowed to keep it. Second, we distinguish whether the length of the waiting period is eight or four years. Third, the applicant must be able to express and communicate himself/herself very well linguistically both orally and in writing (corresponds to language level B1) and a formal language test proves applicants' skills. In the liberalized level, a formal language test is not necessary, and the applicant only need to be able to express himself/herself orally and in writing in simple sentences. Fourth, we vary whether or not a successful naturalization test is required that proves the knowledge of the German legal and social system. Fifth, we distinguish whether the duration of the bureaucratic procedure is twelve or three months. Sixth, we describe the cost of the procedure as 255 euros or that no costs are incurred. Seven, naturalization applications apply only to the applicant, not to the entire family. We formulate the possibility that family members are automatically entitled to naturalize as well if the applicant has successfully completed the naturalization procedure. Eighth, we vary a procedural dimension that expresses the welcoming culture of the destination country. The government delivers the naturalization certificate either with or without an official naturalization ceremony.

The experiment employs a 2<sup>8</sup> factorial design, leading to a total of 256 unique vignette scenarios. Each respondent is randomly assigned one vignette to evaluate, a method that simplifies the decision-making process compared to experiments where multiple vignettes are rated. This focused approach is particularly useful in handling the complex nature of the decision to naturalize.<sup>3</sup>

Table 2 provides an example of one such vignette, while the introduction to the experiment gives respondents a foundational understanding of the naturalization process in Germany. This background information includes the benefits of naturalization, such as voting rights and freedom of movement, alongside essential requirements like adherence to the democratic order, financial independence, and a clean criminal record. This preparatory information ensures that all respondents have a uniform base of knowledge from which to consider their vignette, facilitating a clearer assessment of how varying institutional settings influence their willingness to apply for German citizenship.

Following the introduction, each respondent is presented with one vignette describing a hypothetical institutional context, followed by a question on the respondents' intention to apply for German citizenship under these conditions (yes, definitely; yes, probably; rather unlikely; definitely not).

#### Introduction

In the following part of the survey, we would like to learn more about your naturalization intentions. Naturalization in Germany offers you a number of advantages, such as the general right to vote, legal equality and protection, as well as other opportunities to participate in society. You can choose your profession freely and have access to civil servant status. In addition, you benefit from freedom of movement and travel in Europe and can also travel outside Europe to many countries without a visa to many countries.

However, naturalization is subject to conditions. You need an unlimited or permanent right of residence at the time of naturalization, and you must be committed to the free democratic basic order of the Basic Law. In addition, you must be able to support yourself dependents and must not have been convicted of a criminal offense.

In addition, there are further requirements, but also exceptions and exemptions. In the following, we will show you a hypothetical situation, i.e., that is, one way in which naturalization could be legally structured. This does not mean that the naturalization requirements in Germany are actually as described here and we cannot offer you naturalization in the context of this interview.

Please consider whether you would apply for naturalization under these conditions.

#### Vignette description

To become a naturalized citizen, you must have lived in Germany for at least four years.

<u>No formal language test</u> is required, you just need to be able to express yourself orally and in writing in simple sentences.

You <u>do not have to take a naturalization test</u> to prove your knowledge of the German legal and social system. You <u>do not have to give up</u> your previous <u>citizenship</u>.

After you submit all the documents, the procedure takes an average of <u>three months</u> and there are <u>no costs</u>. You will receive the naturalization certificate <u>in person</u>, at an <u>official naturalization ceremony</u>.

If you have successfully completed the naturalization procedure, your <u>family members</u> are automatically entitled to naturalize as well. Your family members then <u>do not have</u> to complete <u>any further naturalization</u> <u>procedures</u>.

#### Decision

Would you apply for German citizenship under these conditions?

- Yes, definitely
- Yes, probably
- Rather unlikely
- Definitely not

In scenarios where respondents indicate a disinclination to apply for citizenship, noted by the choices "rather unlikely" and "definitely not," they are further asked to specify their reasons for not pursuing naturalization. Additionally, they are required to rank these reasons according to their perceived importance. The reasons included in the survey for not applying are designed to uncover the underlying factors that may deter individuals from naturalization, such as economic, social, or procedural barriers. Following reasons were included:

- (1) The naturalization procedure is too expensive for me
- (2) The naturalization procedure is too expensive for me
- (3) The naturalization procedure takes too long for me
- (4) I generally do not see any benefit for me in naturalization
- (5) I do not meet the formal requirements

- (6) I do not feel connected to Germany
- (7) I plan to return to my home country soon
- (8) I do not want to give up my previous citizenship
- (9) Other or not applicable
- (10) No answer

#### **RESULTS FROM THE VIGNETTE EXPERIMENT**

First results from the vignette experiment were published in Kosyakova & Damelang (2024) and Kosyakova & Damelang (in press). In their study, the authors differentiate among various immigrant groups, including refugees, European Union (EU) citizens, and non-EU citizens. Using the vignette method, they empirically analyzed the impact of liberalizing legal requirements and implementing more inclusive naturalization procedures on the intentions to acquire German citizenship. This analysis compared current versus liberalized requirements and less versus more inclusive naturalization procedures, providing a realistic scenario of how such changes affect naturalization intentions.

The findings indicate that liberalizing legal requirements, particularly enabling dual citizenship and reducing the waiting period, positively influences naturalization intentions. However, the extent of these effects varies among the different immigrant groups, largely due to divergent perceptions of the benefits of naturalization. Conversely, making the naturalization procedure more inclusive did not significantly influence immigrants' intentions to naturalize. These results underline the importance of citizenship policy for the naturalization intentions of noncitizens. However, the results also show nuanced reactions to liberalized requirements stressing the importance of group-specific cost-benefit considerations.

#### **APPENDIX A: PRETEST**

Initially, we crafted the experimental framework by delineating various dimensions derived from theoretical frameworks, leading to the construction of 16 specific statements representing each of the eight identified dimensions. Following a preliminary review by factorial survey specialists, we refined the phrasing of these statements. Notably, we consolidated two dimensions—procedure duration and naturalization fee—into a single statement, reducing the total to 14 statements to enhance readability and shorten the survey length.

Subsequently, we adapted this expert-reviewed version for deployment in an online survey format. The survey served dual purposes: it functionally tested the instrument and elicited direct feedback on the individual dimensions and specifications through open-ended responses. Conducted in late May and early June, the survey garnered participation from 15 individuals, comprising both seasoned migration experts and individuals with personal migration and naturalization experiences.

Feedback from this phase prompted four substantive revisions to our design. First, we refined the temporal dimension of the procedure to more distinctly contrast durations of twelve and three months. Second, we altered the phrasing in the certificate handover dimension to better differentiate between impersonal pickup and official handover treatments. Third, we eliminated a dimension deemed irrelevant to the naturalization decision-making process, which initially aimed to evaluate the impact of having a designated contact person within the naturalization authority. Lastly, we introduced a new dimension regarding family application policies to reflect the inclusiveness of national policies, recognizing its significant theoretical and policy relevance.
