



1 General Information

As part of the SOEP-LEE2 project, the SOEP-LEE2-Compare study collects establishment data in several waves. The 2022 wave data are included in the ESTAB2022 dataset and are presented in this codebook. For data privacy reasons, some variables are only available in the onsite edition of the dataset, as indicated in each variable's description below. In the international edition, i.e. the scientific use file, a categorized version of these variables is included as a replacement. These are identified by the suffixes _cat or _cat2. While the ES-TAB2022 dataset contains the survey data, additional information from fieldwork is provided in the dataset BRUTTO2022. In both datasets, establishments are uniquely identified by the establishment identifier, EID.

In SOEP-LEE2-Compare, establishments were asked the same survey questions as those establishments in the linkable SOEP-Core employer survey of the SOEP-LEE2 project (see the documentation of SOEP-Core's LEE2ESTAB dataset for a reference). The two studies use the same variable names and encodings, allowing researchers to compare the respective datasets. Note that the same EIDs may appear in both studies, however, they do not refer to the same establishments.
