1 General Information

The LEE2ESTAB dataset contains establishment data of the SOEP-LEE2 study. The data were collected from establishments employing SOEP-Core respondents. Currently, the dataset comprises one survey wave, which was primarily collected in 2022. Observations are uniquely identified by the establishment identifier, EID, and the survey year variable, SYEAR. If an establishment was surveyed in several survey waves, its EID remains the same. To facilitate the linkage with SOEP-Core, SYEAR is set to 2021 in the first wave and to 2023 in the second wave, which are the survey years in which employer contact information was collected in the SOEP-Core person questionnaire. For linkage with SOEP-Core, the linkage file LEE2PERSON is required. The data can be linked in Stata as follows:

LEE2ESTAB contains some variables that are only available in the SOEP-Core onsite edition, as indicated in each variable's description below. Other editions contain a categorized version of some of these variables as a replacement. They are identified by the suffixes _cat or _cat2. Additional information about all establishments that were contacted for the survey is provided in the dataset LEE2BRUTTO.

The SOEP-LEE2 study was a follow-up to the SOEP-LEE study of 2012. Data from the latter are provided in separate datasets, SLEE_ESTAB and SLEE_SAMPLE. It is generally not possible to use the establishment data from the two studies as a panel of establishments because the identity of the 2012 establishments was no longer known when SOEP-LEE2 was conceived. Although the two datasets partially use a similar set of EIDs, these do not identify the same establishments.
