

# The EU economy's dependency on nature\*

#### Abstract

While the importance of nature for economic production is undisputed, nature's contribution is still underrepresented in economic modelling. Following previous studies, this work produces a "high-level" estimate of the dependencies of all EU economic sectors on ecosystem services by applying the ENCORE (Exploring Natural Capital Opportunities, Risks and Exposure) framework to an input-output model. Depending on the version of ENCORE used and on some other assumptions, between 19% and 36% of the EU economy's gross value added (GVA) is found to be highly dependent on ecosystem services. International extensions of the analysis show that the economies of EU and China appear to be more dependent on nature than that of the United States. The analysis also reveals that the entire economy is vulnerable to nature degradation, as all sectors are interlinked through supply and customer connections, potentially leading to cascading effects along value chains.

# 1 Introduction

Ongoing nature degradation and biodiversity loss (see IPBES, 2019), and the possible adverse effects on societies, economies and their financial systems have increasingly caught the attention of policymakers, leading to ambitious commitments to nature protection and restoration, including significant financial investments. In Europe, these commitments are reflected in the European Green Deal, specifically the EU Biodiversity Strategy for 2030<sup>1</sup>, and at the international level, in the Kunming-Montreal Global Biodiversity Framework (see CBD, 2022). Concurrently, academia and policy institutions try to advance economic frameworks to integrate natural capital and ecosystem services to enhance the information available for policy and decision-making.

Although the connection between nature and economic activities is indisputable, the specific relationships between ecosystem services and the production process are not necessarily immediately apparent. Furthermore, in many cases, these relationships are locationspecific and context-dependent, giving rise to substantial data and modelling challenges. To begin our analysis, we define ecosystems and their contribution to economic production. According to Article 2 of the Convention on Biological Diversity<sup>2</sup>, an ecosystem is defined as a dynamic complex of plant, animal and micro-organism communities and their non-living environment interacting as a functional unit. According to the United Nations (UN) System of Environmental-Economic Accounting - Ecosystem Accounting (SEEA EA) definition, ecosystem services are the contributions of ecosystems to the benefits that are used in economic and other human activity. They can be biotic and abiotic. These services can mitigate or regulate other natural phenomena, such as flood protection that softens the damage of a flood, or they can be **direct inputs** to production, such as biomass, timber or water. Similar to climate, a double-materiality perspective applies. Ecosystems can enter a firm's production function - a so-called **dependency** on ecosystems, and a firm's production can have negative externalities that can adversely **impact** ecosystems - so-called pressures.

Approaches focusing on analysing the dependencies of economic sectors on ecosystem services can help identify the sectors potentially most exposed to nature degradation, both directly and indirectly, and assess the importance of these sectors for the economy. However, rather than focusing on flows of specific ecosystem services and the dependencies of individual sectors, we aggregate contributions from all ecosystems to all sectors of the economy. Applying a similar approach to that described in WEF (2020) and Evison et al. (2023), the paper uses ad-hoc structural analysis using an Input-output (IO) framework and a set of assumptions on modelling sectoral dependence on nature, with the latter being approximated with ENCORE (2024) (Exploring Natural Capital Opportunities, Risks and Exposure). Doing this makes it possible to run a high-level economic analysis to understand to what extent economies rely on nature. To this end, the study provides insights into the share of the EU's gross value added (GVA) that may be directly and/or indirectly affected by nature degradation and the disruption of ecosystem services.<sup>3</sup> In particular, it looks at the share of GVA generated by economic activities for which failure to maintain the capacity of ecosystems to deliver services could entail significant costs, or even stop production. In this context, this paper aims to make two main contributions. First, it intends to provide a set of model-based figures describing the EU economy's dependence on nature. Secondly, it aims to outline the assumptions and methodological choices necessary to replicate this type of analysis, and it conducts a sensitivity analysis around key data sources and assumptions. The underlying methodology may also open an avenue for more advanced economic analysis.

The remainder of the paper is structured as follows. Section 2 provides insight into the data, methods and assumptions used. Section 3 discusses the results and provides sensitivity analysis. Finally, section 4 concludes and highlights potential for further research.

# 2 Data and methodology

The starting point for our analysis is ENCORE (2024), a holistic framework that links ecosystem services and economic activities. By linking this data on ecosystem dependencies of economic sectors with EXIOBASE input-output tables (see Stadler et al., 2018), it is possible to calculate the share of gross value-added that is dependent on nature to different degrees. This section describes the data, methodology and additional modelling assumptions.

#### 2.1 ENCORE: dependencies of economic sectors on ecosystem services

ENCORE is a holistic mapping that provides information on dependency linkages between individual economic sub-sectors and ecosystem services. The latest version of ENCORE of July 2024<sup>4</sup> follows the SEEA EA categorisation of ecosystem services (25 services) and the UN Industrial Classification of All Economic Activities (ISIC) sector classification (271 sub-sectors). Compared to the previous version of ENCORE, the change in the classification of economic sectors used in ENCORE 2024 has the advantage, for EU-level analyses, of being reported in International Standard Industrial Classification (ISIC) that is consistent with the NACE classification (Nomenclature statistique des Activités économiques dans la Communauté Européenne).

As regards the ecosystem services covered in ENCORE, each of the 25 SEEA EA services belongs to one of the broad categories of provisioning, regulating and maintenance, and cultural services (see Table 1 and ENCORE (2024) for a more detailed description of each service). The first two categories have an essential meaning from an economic production perspective. **Provisioning** services can be understood as a direct input to production, e.g. biomass or water supply. In contrast, **regulating and maintenance** services can be understood as components that protect economic capital against disruption or enhance Total Factor Productivity. Ecosystems that protect against disruption are, for instance, flood mitigation services that reduce damages caused by floods or soil and sediment retention services that decrease soil erosion, preventing nutrients from being washed from the top-soil

layer and requiring farmers to lower the amount of fertilizer.

The dependencies of sectors on individual ecosystem services are provided as "materiality ratings". Based on literature reviews complemented by expert assessment (including the use of quantitative indicators when available), the ratings range on a 5-level scale from "Very Low" to "Very High" dependency (in addition to "No link", see Table 2).<sup>5</sup> "High" and "Very High" materiality ratings indicate a high potential exposure to nature-related shocks or deteriorating trends, which means that the disruption of an ecosystem service

could cause production failure and severe financial loss. These six qualitative ratings are transformed into a 0-5 score scale to perform a quantitative evaluation. This is a common choice in the literature (see Evison et al., 2023; EC FISMA et al., 2024), underlined by implicit assumptions about the relationship between the ratings.

# 2.2 EXIOBASE: harmonized interregional input-output tables

These materiality ratings reflect the direct nature dependencies of sectors based on their own operations, but not those that occur through value chains, both within countries and across international value chains. To have a complete picture of how the contributions from ecosystem services diffuse via inputs to other sectors, ENCORE needs to be combined with information on the structure of the economy provided by a set of Input-Output (IO) tables. IO tables provide a detailed description of the sale and purchase relationships between different production sectors, and between producers and consumers within an economy or a set of economies linked by trade relationships. In this analysis, we employ EXIOBASE multi-regional IO dataset (Version 3.7) for 2022 at basic prices reports 163 sectors for 49 countries (including all EU-27 countries) (see Stadler et al. (2018)).<sup>6</sup> The EXIOBASE research dataset is updated yearly with a two-year lag by the academic community. The

choice of using EXIOBASE is motivated by its completeness in terms of countries, its granularity in terms of sectors and its widespread use in macroeconomic environmental analysis literature (e.g. see Wood et al., 2014; Bleischwitz et al., 2018; Sun et al., 2022; Zhong et al., 2024).


#### 2.3 Data aggregation choices

In line with existing literature, the framework makes three major aggregation choices, which may impact the results. These choices are presented in detail in the following subsections.

### 2.3.1 ENCORE-EXIOBASE sector mapping

Figure 1 displays materiality ratings for ecosystem dependencies for different EXIOBASE sectors as provided by ENCORE 2024. Many primary sectors are highly reliant (e.g. materiality rating of 5) on ecosystem services, while mining and manufacturing are only highly dependent on a few ecosystem services. When applying ENCORE to other sector classifications, some choices need to be made. For instance, some sectors in EXIOBASE are a mix of different ISIC sectors (e.g. hotels and restaurants). Further, discrepancies between previous versions of ENCORE and the latest one may emerge because some sectors (e.g. agriculture) were more differentiated, such as small- and large-scale farming (e.g. crops, livestock) and forestry, usually assuming that small-scale counterparts have higher materiality scores. Moreover, materiality ratings may have been revised. The EXIOBASE sectoral classification does not completely coincide with the ISIC and other classifications used by ENCORE, and requires the introduction of a mapping via a crosswalk table. Table A.8 provides the unique mapping of ecosystem services with economic sectors as proposed by ENCORE (2024) used in this analysis.

#### 2.3.2 Ecosystem service aggregation

Finally, another important assumption relates to constructing a single nature-dependency score for each sector based on the dependency ratings for the 25 ecosystem services. As implemented in other studies (see e.g. Evison et al., 2023; EC FISMA et al., 2024), the consolidated dependency score of a sector is defined to reflect three components: a) the number of ecosystem services on which this sector depends, b) the average rating across these ecosystem services, and c) the maximum dependency rating. The latter component assumes limited substitutability between ecosystem services. In addition, this study normalises the

first component using a normalisation factor, which is necessary due to changes (mostly increases) in the materiality ratings and the increasing number of ecosystem services across versions of ENCORE. The three components are given an equal weighting to create an overall dependency score (see Equation 1). Table A.9 displays the dependency scores for all sectors for ENCORE (2024) and ENCORE (2022), and Figure A.1 provides information on the distribution within the scores.

Taking into account the increases in materiality ratings compared to ENCORE 2022, the following thresholds have been defined for ENCORE 2024 materiality ratings: consolidated dependency scores below 2.25 are considered "Low Dependency", scores between 2.25 and 3.25 "Medium Dependency" and scores above 3.25 "High Dependency". A sensitivity analysis was carried out on different thresholds. Table 3 and 4 explain this procedure using a minimum example with 25 ecosystem services and one sector.

# 2.3.3 Aggregating sectors by industry groups

We reduce the dimensionality of the calculated results by grouping the 136 EXIOBASE sectors into 23 industry groups (see Table 5), similar to what is done in Evison et al. (2023). This is done for purely illustrative reasons when *ex post* processing the results.

#### 2.4 Structure of input-output tables

Figure 2 presents a simplified example of an input-output table. In this table, outputs flow from sectors/countries listed in rows to sectors/countries and final demand components listed in columns. Key elements are: (1) the intermediate **input-output table** matrix **Z**, which contains information on the supply and demand of intermediate inputs. Each row represents the **intermediate output** of a specific region/sector, exported to all other regions/sectors (columns). Conversely, each column shows the **intermediate inputs** required by a certain region/sector, imported from the respective regions/sectors indicated in the rows; (2) the final demand table matrix Y, which contains information on goods and services used for final consumption by all sectors of the economy. In EXIOBASE, there are seven final demand components stored in the final demand matrix Y: (1) private consumption, (2) consumption by non-profit organisations, (3) public consumption, (4) gross fixed capital formation/investment, (5) changes in inventories, (6) changes in valuables and (7) total exports.

The sum of intermediate uses and final demand for each row constitutes the total output of each sector/country, represented in vector X. The sum of elements X at the country or world level gives GDP. Total output is equal to total input by construction. Subtracting intermediate inputs (sum of Z elements across columns) from total output (X vector) results in gross value added, reported in vector/matrix V. Value added can be obtained by subtracting taxes. As highlighted by Aslam et al. (2017), the V matrix from the IO table

should not be confused with Domestic Value Added (DVA). Depending on the input-output table, the V matrix provides accounting measures of value added, including up to six components, for instance, (1) compensation of employees; (2) taxes on production; (3) subsidies on production; (4) net operating surplus; (5) net mixed income, and (6) consumption of fixed capital.

#### 2.5 Input-output model: calculating direct and supply chain value added

To obtain the sectoral direct and supply-chain value added, this study follows, this study follows Koopman et al. (2014) and Aslam et al. (2017) to obtain the sectoral direct and supply-chain value added. The calculation requires the matrix of input-output coefficients ( $\hat{\mathbf{V}}$ ), the matrix of value-added shares/coefficients ( $\hat{\mathbf{V}}$ ) and the final demand vector  $\mathbf{y}$ .

Following the literature, this subsection briefly discusses the basic relationship between gross output (gross output  $\mathbf{x}$ ), intermediate goods (input-output coefficients matrix  $\mathbf{A}$ ) and final demand (vector of goods used for final demand  $\mathbf{y}$ ) given by:

$$\mathbf{x} = \mathbf{AX} + \mathbf{y} \tag{2}$$

with  $\mathbf{A}\mathbf{X}$  being the matrix of goods for intermediate use and  $\mathbf{y}$  being the vector of final demand. Rearranging yields:

$$\mathbf{x} = \underbrace{(\mathbf{I} - \mathbf{A})^{-1}}_{\mathbf{R}} \mathbf{y} \tag{3}$$

with **B** being termed the Leontief inverse. The matrix of value added shares can be obtained by summing across the rows of the **A** matrix, putting the obtained values on the diagonal and subtracting it from an identity matrix of size industries  $\times$  countries. We follow the notation of Aslam et al. (2017) with i=1...N (163) industries and c=1...C (49) countries,

where all industries are listed for each country in turn:

Koopman et al. (2014) and Aslam et al. (2017) point out that the matrix  $\hat{\mathbf{V}}\mathbf{B}$  reflects the underlying production structure and contains all needed information on value-added production by source. Hence, we multiply with  $\mathbf{B}$  and diag( $\mathbf{y}$ ) to obtain the matrix  $\mathbf{T}_{\nu}$

The size of each of the matrices is NCxNC. The matrix  $\mathbf{T}_{\nu}$  contains elements  $T_{\nu_{icjg}}$  where the first two indices describe the value added from sector i in country c to sector j in country g:

The diagonal elements of this matrix represent the direct value added for each country/sector pair without considering supply chain contributions by other sector/country pairs. The upstream value added is obtained by summing along the columns (and sub-

tracting the diagonal elements). Finally, the downstream value-added can be obtained by summing along the rows (and subtracting the diagonal component). Having obtained three value-added components for each sector in each country allows us to evaluate each contribution with the overall score and combine sectors into industry groups.

#### 2.6 The EU aggregation

To evaluate the EU, we have to aggregate 27 countries. Let's assume an interregional IO table with three countries and three sectors as illustrated in matrix 7. Countries 1 and 3 are part of the EU. To obtain the direct effect for the first, second and third sectors, we need to aggregate all relevant elements highlighted in green. To obtain the upstream effect for sector 1 for the EU, we aggregate all elements in red taking into account the extra and intra-EU supply chain. To obtain the downstream effect for sector 1 for the EU, we aggregate all elements in blue, considering extra and intra-EU customer sectors.

This information allows for calculating the direct nature dependency of each sector as well as its indirect dependencies through its upstream value chain (suppliers) and downstream value chain (customers). This example also highlights that the value chain combines intra- and extra-EU components. To calculate the direct dependency, the consolidated dependency score of each sector is applied to the value-added generated by its own operations. Each sector's upstream dependency is calculated as a weighted average of the direct nature

dependencies of the sectors in its supply chain. Each sector's downstream dependency is calculated as a weighted average of the direct nature dependencies of the sectors that are its primary customers.

Finally, when aggregating supply chain dependencies, two alternative options have been applied: either excluding or including the contributions of a sector to itself, i.e. the goods or services produced by a sector as intermediate inputs in its own final production (e.g. motors and frames produced by the automotive sector for use in car assembly). This ensures comparability of the results with the original studies that apply the latter option. Grouping the shares of value-added contributions of sectors to each other according to the dependency score of each sector, the approach finally allows obtaining the share of GVA that is generated under "High", "Medium" and "Low" dependency within each industry group and each upstream or downstream chain, as shown in the next section.

# 3 Results

This section presents the results for nature dependencies of the EU economy, both direct and through value chains, and sensitivity analysis when varying overall dependency thresholds. Moreover, the analysis was replicated to compare the EU with other economies (US, China, and the world economy).

#### 3.1 European Union

For the EU economy, Figure 4 shows the dependency of the various industry groups on nature in terms of GVA shares, considering the direct upstream (suppliers) and downstream (customers) nature dependencies, mirroring the analysis of Evison et al. (2023). The primary industry groups "agriculture", "forestry", "fisheries and aquaculture", as well as "construction", "mining and metals", "water utilities", "healthcare", "aviation travel and tourism", "food, beverages and tobacco", and, to a lesser extent "supply chains and transport", all have a high direct dependency on nature, based on the above-mentioned consolidated dependency score. Although the level of dependency varies between sectors, in total 19 out of 23 sectors display high or medium direct dependencies on nature for a

substantial part (40% or more) of their GVA. It should be noted that, especially for service sectors exhibiting very low levels of direct and upstream dependencies, indirect dependency via the exposure of customers can be non-negligible.

A distinctive characteristic of the Evison et al. (2023) analysis is the inclusion of a sector's self-contributions in visualising upstream and downstream supply chain diagrams. This approach results in the direct dependency pattern being prominently reflected across the other panels due to its substantial influence.

Figure 4 presents the results of an alternative calculation that does not include the contributions of a sector to itself in upstream and downstream value-chain considerations. Notably, highly nature-dependent upstream supply-chain contributions are entering every sector, highlighting the significance of nature's contributions to the economy. Concerning downstream relations, the chart shows a relatively high nature dependency of the primary sectors, which is likely because other nature-dependent sectors request these sectors' output.

For the EU economy as a whole, the study finds that 44% of the GVA from all sectors' direct operations (i.e. excluding suppliers) has a high dependency on nature and 27% has a medium dependency (see Table 6). If considering only upstream supply chains (i.e., ignoring the contributions of a sector to itself), 22% of the GVA generated by suppliers is highly

dependent on nature and 33% has a medium dependency. The overall estimate, considering both direct operations and their supply chains, indicates that two thirds of the EU's GVA has a significant dependency on nature: a 36% share of GVA has a high dependency and 29% a medium dependency.

#### 3.2 Sensitivity analysis

A sensitivity analysis has been conducted to assess the impacts on the results of the differences between ENCORE versions and the level of the dependency scores thresholds, which introduce strong assumptions. Table 7 shows how the nature dependency figures would

shift when adjusting the thresholds for the two latest versions of ENCORE, as sectors considered as having "high" and "medium" dependency would change. The 2024 version of ENCORE generally indicates an increased "high dependency" share of GVA compared to the 2022 version - for instance, 35% instead of 21% globally, if considering a threshold of 3. However, adjusting the upper threshold from 3 to 3.5 would significantly reduce the share of the global economy considered highly dependent on nature (from 35% to 20%), using the latest ENCORE version. Nonetheless, recognizing that between 19% and 36% of the EU GVA is highly susceptible to the health of natural ecosystems offers a crucial insight into the degree of urgency with which ecosystem services should be considered in Europe.

Additionally, the results for US, China and the world economy show significant differences between countries in the dependencies of various sectors, particularly in supply chains. However, using ENCORE 2024, the overall dependency on nature is found to be of the same order of magnitude for China as for the EU, but lower for the US, indicating that large parts of the US economy's GVA are generated in sectors that are not considered highly dependent on nature.

The analysis aimed to trace the importance of nature for different sectors and the entire economy. The results confirm the widespread nature dependencies across most sectors of the EU economy, both directly and through supply chains, in line with the findings of the original study (see Evison et al., 2023). The estimated exposures of the world economy and the EU economy are somewhat higher than in the original studies, possibly due to the increase in the number of ecosystem services considered and the higher materiality ratings introduced in ENCORE 2024.

It should be remembered that there are high uncertainties in assessing exposure to nature-related risks, notably because of the complexity of both ecosystems and transmission channels to the economy. The ENCORE layer, the aggregation processes for economic sectors and their dependencies on individual ecosystem services, the aggregation of ecosystem services, and the level of the thresholds require strong assumptions that impact the results.

# 4 Conclusions

Even though the integrated assessment of economic, social and environmental impacts of projects or policies is becoming standard practice (see e.g. the European Commission's better regulation guidelines), incorporating ecosystem and biodiversity considerations into macroeconomic and financial risk analyses raises significant challenges. This study offers insights into assessing the dependency of the EU economy on ecosystem services. The findings indicate that, depending on the version of ENCORE used (thus on the classification frameworks as well as data updates), between 19% and 36% of the EU's GVA is highly dependent on ecosystem services and is generated by sectors that are at particular risk of being adversely affected by nature degradation. Overall, based on the recent data from ENCORE 2024, two thirds (65%) of the EU's GVA is estimated to have a high or medium dependency on nature when including both direct and indirect links. The nature dependency figures for the EU are somewhat higher than those obtained for the US (between 17% and 22% of GVA highly dependent on ecosystem services), and are broadly similar to those obtained for China (between 24% and 35%).

As illustrated by the sensitivity analysis, these results should be interpreted as orders of magnitude rather than precise estimates. More importantly, the analysis shows that the entire economy is to some extent susceptible to nature degradation, since all sectors are interconnected through their supply and value chains, although the different sectors' dependencies on nature vary. The methodology used in this study could be a foundation for more in-depth nature-economy modelling, notably to integrate information on the state of ecosystems and geospatial data on ecosystem services, since the unmet demand of ecosystem services can vary substantially with geographical location. This could be done by using, for instance, data from the INCA (Integrated System of Natural Capital Accounts) Platform (see La Notte et al., 2022). Geographical location could be easily introduced by considering smaller economic regions, e.g. at NUTS (Nomenclature of territorial units for statistics) 2 level, and making use of actual ecosystem service measurements, e.g. as described in Fatica et al. (2024). Of course, this higher granularity would have to be complemented with NUTS 2 input-output tables. More advanced analysis could then investigate how stress on local ecosystems may affect the delivery of their services, creating potential vulnerabilities on the production side of the EU economy.


