### Section A: Information on clustering method and solution

The K-prototypes algorithm uses a combined objective function that includes distance metrics for both numeric and categorical variables. The parameter  $\gamma$  determines how far either type of variable is favored. When  $\gamma$ =0, then the clustering depends only on the numeric variables, which then results in the regular K-means algorithm.

We experimented with different values of  $\gamma$  to determine a good clustering solution. Figure A1 shows the average silhouette score by number of clusters and for varying values of  $\gamma$ . The silhouette score measures the distance to the other clusters for each observation. When the silhouette score approaches its maximum value of 1, it indicates that the observation is distanced from other clusters, indicating a well-separated observation. When the silhouette score is approaching its minimum of -1, then the observation is close to observations from other clusters, indicating that the cluster is not well separated. Good clustering solutions should have large average silhouette scores.

Figure A1 shows that, expect for a spike around two to three clusters, the average silhouette score ranges roughly from 0 to 0.1 for different clustering solutions. These numbers indicate that we find a clustering solution with meaningful clusters, although these clusters still contain substantial heterogeneity and may overlap each other at the cluster boundaries. However, the silhouette score must be interpreted with caution for mixed data because its computation (as for many other evaluations of cluster fit) requires the definition of a distance metric. Silhouette scores use Euclidian distance as a metric, which is not appropriate for categorical variables. Evaluations of cluster fit must thus be interpreted with caution. We therefore did not base our choice of clustering solution entirely on the silhouette score but also qualitatively evaluated whether the clustering solution generated interpretable results. Ultimately, we settled on a clustering model with six clusters and  $\gamma$ =3.4.

Another possible way to evaluate the clustering fit is to assess whether cluster membership can be predicted using the clustering variables. This turns the problem into a "supervised learning" problem where the outcome values are known. To assess how successful such a model is, we split the data into a training and test data set and trained a gradient-boosted tree on the training data. We then evaluated how well the model predicted cluster membership on the test set (which was not used in the training step). The result of this analysis indicates that this model is very successful at predicting cluster membership on unseen data, as the F1-score is 0.99, just short of its maximum at 1, indicating perfect sensitivity and perfect positive predictive value.
