Measuring vulnerability index for managing COVID-19 behaviour in Ghana

ABSTRACT

This paper investigates the implications of human behaviour and government support for the quality of life of vulnerable populations during the Covid-19 pandemic. We sample 2.697 households and employ the COM-B model, theory of economic contagion, and information asymmetry to empirically respond to the following research questions: What is the level of vulnerability among informal settlements in Ghana? Did the support vulnerable populations receive during the peak of the Covid-19 outbreak in Ghana improve their state of being? What were the lifestyle changes during the pandemic? Our core finding is that the plight of the vulnerable population is ameliorated when government support brings about positive change in Covid-19 behaviour. Our analysis suggests that cash transfers, free utilities and credit schemes reduce income vulnerability. Moreover, government support for small businesses and tax exemption have the potential of reducing employment vulnerability. It is therefore recommended that policymakers should institutionalize emergency cash transfers, subsidize essential utilities, and establish accessible credit schemes to support vulnerable populations after the Covid-19 crisis.

1. Introduction

The novel COVID-19 virus was declared a global pandemic by the World Health Organisation (WHO) on March 11, 2020. The pandemic has ravaged human lives and significantly disrupted the world's public health, social and economic systems. As of 26th September 2020, the world reported more than one million covid-19 related deaths. Despite the high levels of disease transmission, Africa shows remarkably low cases of Covid-19 deaths. To control the spread of the virus, the WHO instituted guidelines such as social distancing, regular handwashing with soap under running water, using alcohol-based hand rubs and wearing nose masks. Governments worldwide also put in place lockdowns to restrict human movements and contain the virus in affected communities. In Ghana, a three-week partial lockdown was instituted in the Greater Accra Metropolitan area, including Kasoa and Greater Kumasi. These areas were considered the epicentre of the disease outbreak in Ghana. The lockdown was deemed to have worsened the economic situation of people whose livelihood depended on activities that guaranteed a daily wage. The crippling effect the lockdown was having on the Ghanaian economy prompted the subsequent easing of the lockdown. Vieira et al. (2020) assert that the protective measures put in place to protect physical health and healthcare systems may have an enormous effect on the wellbeing of individuals and therefore suggest collective action on a global scale rather than just resolute government action in fighting the pandemic.

Pandemic outbreaks put vulnerable populations at higher risk, necessitating special attention for the elderly, homeless, migrants, and persons with disabilities. Having the right kind of support and changing human behaviour has proven effective in mitigating related hazards and risks of the pandemic. Flanagan et al. (2011) argue that the most vulnerable people are likely those whose needs are not sufficiently

considered in the planning of local response and relief organisations. Support plays a pivotal role in ameliorating the plight of vulnerable populations when the needs of such groups are taken into consideration. Despite the major economic downturns following the outbreak of the covid-19 pandemic, countries saw support from international donor communities, and civic and humanitarian organisations. The support included economic recovery schemes for developing and developed countries alike.¹

The pandemic literature suggests a bidirectional relationship between human behaviour and pandemics. Pandemics have the potential of changing human behaviour, and human behaviour, on the other hand, can influence the spread of infectious diseases (Acuña-Zegarra et al., 2020; Clark et al., 2020; Hussain et al., 2020; Michie & West, 2021; Bavel et al., 2020). It is asserted that human behaviour played a crucial role in causing COVID-19 (Michie & West, 2021). The success stories of many countries in mitigating the harm of the pandemic to their economies and health have been attributed to the enactment of interventions directed at behavioural change. However, effective behavioural change interventions require an understanding of either or both the changes in capability and motivation or opportunity (Michie & West, 2021). Duan et al. (2020) opine that governments can ride on the public risk perception to encourage citizens to adopt recommended protective actions, which include government communication, government prevention and control and government rescue. In Ghana pandemic related studies have taken diverse forms and perspectives, including but not limited to health financing (Abor & Abor, 2020), the impact of the pandemic on poverty and living standards (Bukari et al.,2021), short term changes in behaviour (Asiamah et al., 2021), and limiting the spread of COVID-19 in Ghana (Bonful et al., 2020).

Although various studies have analysed the variables of interest and established relationships between them and economic, social and health variables, these relationships have been examined independently. These prior studies have failed to explore the relationship between pandemic support and responsible human behaviour and how such a relationship contributes to reducing the risks of vulnerable populations. This paper, therefore, seeks to answer these empirical questions. Did the support vulnerable populations receive during the peak of the Covid-19 outbreak in Ghana go a long way in improving their state of being? What were the lifestyle changes that occurred due to keeping with recommended responsible human behaviour during the pandemic? The current paper fills the gap by empirically analysing the joint effect of support and behaviour on vulnerability by sampling 2,697 households in Ghana to answer these research questions. Mainly, we test for two main hypotheses: First, support and human behaviour independently reduces vulnerability. Second, the interaction between human behaviour and support participation has an overall impact on improving the lives of vulnerable populations.

The paper aims to establish the link between human behaviour and support during the covid-19 pandemic in improving the quality of life of vulnerable populations. Apart from extending the scope of the current literature, this paper makes important contributions regarding developing economies using Ghana as a case model. First, it documents the independent contribution of support and human behaviour in improving the pandemic situation in Ghana among vulnerable populations. Secondly, it evaluates the combined effect of covid-19 support and human behaviour on reducing the risk faced by vulnerable populations in Ghana. Finally, the study attempts to add to the welfare literature by demonstrating the potential mediating role of support and behaviour in improving the welfare of vulnerable populations.

The remainder of this paper is organized into four additional sections. Section (2) reviews relevant literature on human behaviour and support. Section (3) discusses the research methodology, the measurement of key variables used in the study, and data sources. Section (4) discusses the empirical results and sensitivity tests, and finally, section (5) provides the conclusions and policy implications.

2. Literature review

This session reviews relevant theoretical and empirical literature underpinning pandemics, vulnerable populations and strategies to insulate highly vulnerable populations from global pandemics, including COVID-19. We begin with the health belief model, capability-opportunity-motivation-behaviour (COM-B) model, theories of economic contagion and information asymmetry, then discuss the empirical literature on the impact of support and behaviour on Covid-19.

2.1. Theories related to pandemic and vulnerable populations

This section reviews the theoretical underpinnings related to pandemics and vulnerable populations that can be used as the basis for this study. The purpose of reviewing these theories is to argue that the impact of Covid-19 might be very uneven for various populations, depending on various epidemiological factors and national mitigation strategies. Theories discussed here include the health belief model, COM-B model, theory of economic contagion, and information asymmetry.

Responsible human behaviour is essential to the control of the spread of an epidemic. The health belief model has been used to explain various health behaviours, such as weight

reduction, vaccination, helmet use, and nutritional consumption, and identifying fundamental health beliefs. The health belief model emphasizes the psychological decision-making process behind individual protective behaviour, with the formation of health beliefs regarded as the key to adopting protective behaviour. The health belief model explains factors in the public's adjustments to their health behaviour during an epidemic outbreak. The model mainly considers susceptibility to the disease, the severity of the epidemic, the effectiveness of the protective actions, and the cost of taking the protective actions. Individuals who highly perceive susceptibility to an epidemic and are convinced of its severity are more likely to voluntarily adopt forms of protective behaviour. Persons who are also sure that protective behaviour was very effective and perceive a lower cost of adopting protective behaviour are more likely to voluntarily adopt forms of protective behaviour.

The COM-B model is another comprehensive and straightforward way of understanding human behaviour. The model stands for capability-opportunity- motivation- behaviour. It takes its foundation from the fact that for behaviour to occur, individuals must have the appropriate physical and psychological capabilities and the opportunity and greater motivation to perform that behaviour than anything else they could be doing at the time. This model highlights that capability and opportunity feed into motivation, such that having greater capability and opportunity can enhance motivation. Therefore, to create sustained behaviour change, there is the need to make modifications to capability, opportunity and motivation that are mutually reinforcing. In the COM-B model, behaviour is part of an evolving and interacting system. The World Health Organisation has used the COM-B model to make recommendations for improving adherence to the rules and guidance on behaviours that may protect individuals against the COVID-19 pandemic.

Contagion in the economy happens when shocks in a particular economy spread and affect other regions or other aspects of the economy. The term contagion was rarely applied to the international financial markets before the global crisis was influenced by currency devaluation in Asia (Peckham, 2013). Financial contagion addresses two critical questions: what factors determine the course of a crisis and its potential to spread? Is shock propagated through existing channels or along new pathways created by crises? (Favero & Giavazzi, 2002). According to Claessens and Forbes (2004), contagion can occur due to many different fundamental causes. One type of fundamental cause is a common or global shock where an economic shift, such as a change in interest rates, commodity prices, and a fall in global growth in a country, can influence a crisis. Another type is a linkage in trade in the form of direct and competitive devaluations. Thus, a crisis in one country may trigger a decrease in income and a proportionate fall in import demand, affecting trade balance, exports, and related economic fundamentals in other economies via direct trade connection. The economic contagion could lead to competitive devaluation. This effect of 'competitive devaluations' can pressure the other countries' currencies to depreciate or devalue. This theory is employed to explain the possibility of the spread of economic crisis or boom across countries or regions. According to Baker et al. (2020), the Covid-19 pandemic has already created an economic shock beyond the financial crisis that stormed the globe in 2008-2009 and similar to the 1929-1933 great depression. The study adopts the theory of economic contagion and empirically examines pandemics and how it has affected vulnerable populations in Ghana, adopting the theory of economic contagion.

When parties in a market have more information than others, there is an imbalance of information information asymmetry. Imbalanced information in a market can lead to market failure. Stiglitz (1975) and Spence (1974) have identified two types of information asymmetry: moral hazard and adverse selection. Uncertainties among organizations may affect the flow of information and trade among external parties. The moral hazard type of information asymmetry deals with risk, which happens when a party trades based on limited information, hence, pays for the consequence of the risk. From the perspective of Jensen and Meckling (1976), moral hazard occurs due to the agency dilemma between principals and agents. In the political context, the moral hazard type of information asymmetry occurs when the principals who are the population elect an agent (government) to act on their behalf in the equitable distribution of resources. Here, the population is unable to detect the action choice of the government due to secrecy, national security concerns, and opacity; hence the government is induced to act in a way that may not meet the expectations of the population. An adverse selection which is classified as the hidden type of information asymmetry is when parties to a transaction are unable to detect the action choices of the other and hence trade based on limited information (Brown & Hillegeist, 2007). The compensation available for information imbalance is a charge of risk premium. Pandemics pose threats and damages to some individuals, groups, organizations, localities, etc. This category of people will need to be compensated for the damages suffered. Information asymmetry occurs when the right policy development cannot identify these groups and their level of required compensation. The challenges of adverse selection and moral hazards becomes the order of the day (Boot et al., 2020; Richter & Wilson, 2020), Covid-19 has created various uncertainty shocks in social and economic contexts (Baker et al., 2020). We, therefore, seek to examine the impact of pandemics within a complex network of asymmetric information among haves and haves not, place-specific interactions among people, the physical and built environments, social institutions, and infectious agents that cause disease.

2.2. Empirical review

The far-reaching impact of the COVID-19 pandemic on human behaviour and the significant role of intervention in all manner and forms have been documented in the literature. Given the importance of these variables towards pandemic mitigation, Dwomoh et al. (2021), sought to evaluate the impact of integrated government and individual-level interventions. Findings from their study suggest that enhanced government and individual level interventions and the intensity of media coverage could substantially suppress transmission of new COVID-19 cases and reduce death rates in Ghana until such a time that a potent vaccine or drug is discovered. Given that the public can oppose government interventions during pandemic outbreaks due to lack of trust, awareness, knowledge and perception about pandemics, Paek et al. (2008) explored public support for government actions during a flu pandemic. In their study, more than half of respondents trusted the government to handle a flu pandemic and showed strong support for many proposed government actions. The only proposed action that respondents objected was the offering of non-fully approved drugs. From the perspective of the transportation sector, Abate et al. (2020) assessed government support measures to the air transport sector following the covid-19 pandemic. Their assessment was viewed through the lenses of factors that shape governments to support airlines and the various types of support that may be provided, considering country-level factors. The study highlights that government support for the airline industry is backed by its intention to maintain jobs, protect economic activity and maintain air transport connectivity. Ashraf (2020), on the other hand, analysed the economic impact of government interventions during the covid-19 pandemic on financial markets. They observe that income support packages, among others, largely resulted in positive stock market returns. Social distancing, however, showed both positive and negative economic impacts.

Similarly, Haldar and Sethi (2020) also investigated the effect of country-level factors and government intervention on the incidence of COVID-19. They employ multivariate negative binomial regression models to explore the association between the country-level factors and recorded new COVID-19 cases. Their investigations conclude that periodic lockdowns are the best prerogative for countries with high COVID-19 cases. In Nigeria, Doherty et al. (2020) studied government intervention strategies among variables such as knowledge during the covid-19 pandemic in Nigeria. The findings suggest that about 70% of sampled respondents express that government intervention strategies during the pandemic were inadequate, although a significant number of them show adequate knowledge about the transmission, symptoms, and preventive measures of COVID-19. They arrived at these results by analysing responses from 387 respondents using descriptive statistics and analysis of variance.

Liu et al. (2020) research work contributes to the relationship between human behaviour and disease epidemics. Their paper proposes the coupling model of human behaviour and epidemics whilst advancing game theory as an essential tool for studying human behaviour. Their study results confirm the disease outbreak suppressing attribute of human behaviour. They also draw attention to the need for state intervention in influencing people's behaviour to achieve the best effect on curbing disease epidemics. On the other hand, Hussain et al. (2020) analysed the impact of the covid-19 pandemic on human behaviour based on data collected through questionnaires designed to assess human behaviour during the COVID-19 pandemic. They find a detrimental effect of COVID-19 on the physical and mental health of individuals and suggest that future studies should focus on more detailed aspects of the impact of COVID-19. The pandemic is significantly impacting societies around the world in an unprecedented manner. Due to their nature, vulnerable populations are much affected by the negative consequences of COVID-19. First, it is important to note that vulnerable populations have low capacities to cope with the COVID-19 pandemic. Most vulnerable people do not have savings and safety nets and have less access to support mechanisms. As a result, they need more attention to cope with the negative consequences of the COVID-19 pandemic.

Broadly, there have been two main coping strategies: those from government and civil society organisations. Realising that the COVID-19 pandemic has an economic, social and political impact, governments worldwide have adopted various measures to protect people's livelihoods, facilitate business continuity and sustain their economies. In most countries across the globe, central governments have extended social protection support to vulnerable populations. For instance, in Ghana, the central government extend food supply (both cooked and uncooked), free water and free electricity to vulnerable populations. Most governments worldwide have provided financial support to their citizens, especially the vulnerable, to ensure their survival and minimising their suffering. Non-Governmental Organisations (NGOs) and civil society organisations have played and continue to play a significant role in society. In this pandemic era, NGOs that were already working closely with communities have found new ways of continuing to provide humanitarian aid. Indeed, around the globe, NGOs have been responding to the COVID-19 pandemic through supporting health centres, raising awareness about how to prevent the spread of the pandemic, and providing essential supplies ranging from medicine and hygiene kits to Personal Protective Equipment (PPE) to, especially vulnerable and disadvantaged people.

3. Methodology

3.1. Sampling and data collection methods

Data for this study was collected from one hundred (100) informal settlements across eleven administrative regions (Greater Accra, Central, Volta, Ashanti, Western, Northern, Savanna, North East, Bono East, Bono and Ahafo) in Ghana where information on slum is available. The information on the number of informal settlements was obtained from Peoples Dialogue, Ghana, a Non-Governmental Organisational that focuses on informal settlements in Ghana. Peoples Dialogue, Ghana, has conducted enumerations of informal settlements in specific areas in Accra (Farouk & Owusu, 2012), and later conducted a national survey of informal settlements in Ghana. Peoples Dialogue has therefore become one of the reliable organisations to obtain data on informal settlements in Ghana. From this and for accessible data collection, the informal settlements were zoned into thirteen (13). The sample size for this study consists of 2,697 households. The sample size was obtained using Stratified random sampling. Stratified random sampling is appropriate for this study because it assures regional representation, accounts for variability within informal settlements, and improves the precision and dependability of the results. A total of twenty (23) enumerators were engaged to collect the data for three weeks. The enumerators visited the residents and administered the questionnaires to them.

3.2. Quality and validity of the data

To ensure the data quality, we acquire tablets for each of the enumerators and engage the services of a Data Manager to coordinate the process of the transmission of the response of the interviewee on the field to a station at Accra, the national capital. The use of tablets to collect the data enhanced the quality of data collected by prompting and disallowing some responses that were not consistent per checks in the survey instrument. The instant synchronization of the data right at the end of the interview helped the survey management team to follow what was happening at all survey sites with ease. However, interviews conducted in areas where internet connection was poor could only be synchronized in the evening when the team returned to the district capitals where they lodged.²

3.3. Variable measurements

3.3.1. Measurement of vulnerable index

We begin with the construction of the vulnerability index. The questionnaire adopts the vulnerability index questionnaire by Flanagan et al. (2011) and Acharya and Porwal (2020). Flanagan et al. (2011) social vulnerability index includes four domains: (1) socioeconomic status; comprising income, poverty, employment, and education variables; (2) household composition and disability, comprising age, single parenting, and disability variables; (3) minority status and language, comprising race, ethnicity, and English language proficiency variables, and (4) housing and transportation, comprising housing structure, crowding, and vehicle access variables. Acharya and Porwal (2020) expanded the Flanagan et al. (2011) social vulnerability index under different thematic domains, extending beyond social vulnerability to accommodate vulnerability related to the COVID-19 pandemic. Therefore, Acharya and Porwal (2020) considered the following five domains, which are important in the context of the COVID-19 epidemic. These are (1) socioeconomic condition; (2) demographic composition; (3) housing and hygiene condition; (4) availability of health-care facilities; and (5) COVID-19-related epidemiological factors. This study, therefore, adopted Acharya and Porwal (2020) vulnerability index and measured the variables as follows:

Socioeconomic vulnerability: This variable encapsulates the various socioeconomic factors that affect the ability of a community to recover quickly when hit by a wide range of disasters, including pandemics. Given that in disasters, the socially vulnerable are more likely to be severely affected, in the sense that they are less likely to recover and more likely to die, attention must be paid to these variables to decrease economic loss and reduce human suffering to the barest minimum. The socioeconomic status of individuals is influenced by income, poverty, employment and education. The income of individuals is considered because household income can influence how well individuals can prepare for unforeseen events and their recovery possibilities. Even among economically disadvantaged populations, variations exist in the proportions and magnitude they are affected by disasters. This is made possible by insurance policies, financial investments and a stable source of employment. Individuals with some level of education can read and understand information regarding pandemics and measures they can take to prevent wide transmission and reduce their infection rate. On the other hand, education influences household income as it provides employable skills for entrepreneurship and well-paid jobs. In defining the socioeconomic vulnerability of populations, this study adopts four indicator variables: attaining some level of education with the primary level being the least, employment status of respondents, monthly household income and as a proxy for poverty is the proportion of the population who did not have any of certain household assets. These assets include but are not limited to television, radio, bicycle, phone, and refrigerator.

Demographic vulnerability: The demographic condition of a population may reduce its resilience to pandemics. The nature of the COVID-19 pandemic is such that the demographic composition of a population influences the pace of transmission and mortality. This attribute makes demography an important variable in the construction of a vulnerability index. This study measures demographic vulnerability using the proportion of the elderly population (this includes persons aged 60 years and above), place of residence (whether urban or rural), location density and how well homes are suited.

Housing and hygiene conditions: Housing and hygiene conditions have a bearing on the transmission of infectious diseases. Housing conditions especially crowding within homes, poor sanitation and poor hand hygiene practices, make individuals susceptible to infectious diseases transmitted through close human contact and contact with infected surfaces due to unsanitary conditions. The COVID-19 transmission is reduced by spacing out individuals (social distancing), regular hand washing with soap under safe running water, and applying alcohol-based hand sanitisers. These measures highlight the importance of

living in a spacious and hygienic environment. Thus, making housing and hygiene conditions a variable worth considering in constructing a vulnerability index. Therefore, in this study, we employ four variables to assess respondents' housing and hygiene conditions. They are the number of people per room, availability of toilet facility within a household, availability of hand hygiene facility and household access to water.

Availability of health care: The availability of health care is crucial in an outbreak of diseases. Health facilities serve as primary care giving units that expedite recovery and restoration of health. Thus, if persons recover from pandemics like COVID-19, it greatly depends on the ease of access and affordability of a well-resourced and functioning health care system. In accessing the availability of health care, we employ variables, including possessing of health insurance, access to health care, willingness to visit and access health facilities and the number of health care facilities in a community.

Epidemiological factors: Epidemiological factors cannot be overlooked in the construction of a vulnerability index in the context of a pandemic like the novel coronavirus. Epidemiological factors increase the chances of morbidity and mortality in the event of an infection outbreak. They may be underlying health conditions that increase one's chances of being infected and reduce the probability of recovery when one contracts the virus. In Ghana, most reported COVID-19 deaths resulted from previous underlying health conditions of infected persons rather than the virus. In constructing the index, this study considers three main indicators as the proxy for epidemiological factors. They include persons current health condition, persons with any current chronic morbidity, persons undergoing any long term medical treatment.

The variables chosen for each component of vulnerability (income, education, employment for socioeconomic situation; age, type of residence for demographic composition) are justified in terms of their relevance to the COVID-19 pandemic and their influence on vulnerability. Data is gathered from reputable groups such as Peoples Dialogue in Ghana, which has performed comprehensive studies on informal settlements.

3.3.2. Responsible COVID-19 behaviour

Even before the introduction of vaccines, the control of pandemics has been linked to the responsible behavioural response of individuals. Behaviour, as it is, can be learned and unlearned, whereas the learning process can be voluntary or involuntary. In the wake of the COVID-19 pandemic, the WHO issued quidelines that constituted responsible behaviour to reduce the transmission and spread of COVID-19. Measures implemented at individual and organisational levels included the 'no mask no entry' signs at the entrances of homes, shops and organisations, maintaining skeletal staff through running of shifts, and lockdowns to restrict human movement. Also, an effort was made to provide running water and soap at vantage points to ensure regular handwashing before entering public spaces. All these measures were to solicit the right response from individuals. This responsible COVID-19 behaviour constitutes handwashing, maintaining good personal hygiene, staying home, working from home, cleaning surfaces, wearing a nose mask and stocking up home supplies and medicines. The score is based on a Likert scale ranging from '1 being never to 5 as always'. A total score of 28 shows good behaviour.

3.3.3. Government support of COVID-19

The vulnerability of a population can be linked to the support they receive from individuals, businesses, civic and community-based organisations, families and government. This is true because the sufficient support a population receives, the less vulnerable they are. Loss of support places populations at greater risk. Providing support is a way of protecting the health of vulnerable populations. To effectively provide support to vulnerable populations, there is the need to carry out a critical need assessment not to waste resources on interventions that such populations may deem unbeneficial. To effectively provide support, specific, unique needs and concerns must be considered. Further strategies and specific approaches needed to make support relevant must be considered. To address support of COVID-19, this study asks respondents relevant questions on the kind of support they expect or received from the government that will improve or improved their conditions. The questions bother on food support, public education, cash transfer and wage support, free utilities, credit schemes, business support, tax exemptions, liquidity

support and hand sanitisers' supply. We constructed an index, 1-8, with 8 being a person with more support.

3.4. Estimation strategy

We explore how government support influences vulnerable populations and responsible behaviour during the COVID-19 pandemic. We assume individuals are rational and would therefore alter their behaviours in order to reduce their risk. Also, the presence of support will be a motivating factor that will elicit the right kind of behaviour. Therefore, we hypothesize a reverse relation between COVID-19 support and vulnerability in that support can ameliorate the vulnerable populations' plight and bring about a behaviour change. We use the following model to explore the interconnections between support and vulnerability.

Where, $Y_{1i'}^*$ is the dependent variable, vulnerability. The subscript j refers to the individual. $X_i^{'}$ is a vector of individual household level characteristics such as gender, marital status, geographical location etc. $R_i \beta$ is an index score of COVID-19 support respondents received or expected to receive during the pandemic. Support comprises eight (8) indicative variables. An individual's support score indicates the level of support received. Vulnerability in this study is constructed as an index comprising five main constructs: socioeconomic, demographic, housing and hygiene condition, availability of health care and epidemiological factors. A respondent scores 1 when he demonstrates or finds him/herself in a vulnerable situation and scores 0 when otherwise is observed. A total score of 18 denotes high vulnerability. ε_{1j} is a normally distributed random error term with zero mean and constant variance.

Having estimated the mitigating effect of support on vulnerability, we go ahead to evaluate the impact of COVID-19 behaviour on vulnerable populations. The rationale is that even in the face of expected support, support may not achieve the intended outcomes when the proper behaviour is not exhibited.

Where, $Y_{2i'}^*$ is the dependent variable, vulnerability. The subscript j refers to the individual. $X_{2i}^{'}$ is a vector of individual household level characteristics such as gender, marital status, geographical location etc. P_{2i} represents the COVID-19 behaviour score of respondents. Responsible behaviour constitutes handwashing, maintaining good personal hygiene, staying home, working from home, cleaning surfaces, wearing a nose mask and stocking up home supplies and medicines. The score is based on a Likert scale ranging from 1-5. A total score of 28 shows good behaviour. ε_{2i} is a normally distributed random error term with zero mean and constant variance. The econometric models employed in our study are appropriate for analyzing the impact of government support and individual behaviour on the vulnerability of the population during the COVID-19 pandemic.

Furthermore, we estimate the joint effect COVID-19 support and responsible behaviour has on vulnerable populations. We use the model below:

Here, $Y_{3j'}^*$ is the dependent variable, vulnerability. The subscript j refers to the individual. $X_{3j}^{'}$ is a vector of individual household level characteristics such as gender, marital status, geographical location etc. $R_i \beta$ is an index score of COVID-19 support respondents received or expected to receive during the pandemic. $P_{2i}^{'}\beta$ represents the COVID-19 behaviour score of respondents. In equation (3) above, $(R_{3i}^{'}\beta * P_{3i}^{'}\beta)$ represents the interaction between support and behaviour. ε_{3j} is a normally distributed random error term with zero mean and constant variance.

Alternatively, and for the robustness test for improvement of vulnerability, we use welfare methodology to evaluate how COVID-19 support ameliorates the plight of vulnerable populations. The indicators of welfare at the household level will include changes in income level (continuous) and having access to employment (dummy). The assumptions underlying these measures are that (1) we assume that if a vulnerable person receives support in credit schemes, it will enhance the income earning capacity. A higher income is expected to enable households to satisfy their welfare needs; (2) we assume that if COVID-19 support is efficient and useful, it would help reduce labour turnout and job losses; (3) we also assume that providing vulnerable households with free utilities in the form of provision of portable water and electricity will enable households to be in a better position to meet their welfare needs. We use the following model to explore the interconnections between support and vulnerability.

Where W_{ik} is our welfare measure, subscript i represents household, subscript k (k=1, 2) represents the two proxies of welfare and V, G, U, Q, and R, respectively, are vectors of vulnerability hypothesized to influence household welfare. As earlier defined, vulnerability in this study is constructed as an index comprising five main constructs; socioeconomic, demographic, housing and hygiene conditions, availability of health care and epidemiological factors. A respondent scores 1 when he demonstrates or finds himself in a vulnerable situation and scores 0 when otherwise is observed. A total score of 18 denotes high vulnerability. S is an index score of COVID-19 support respondents received or expected to receive during the pandemic. Support comprises eight (8) indicative variables. An individual's support score indicates the level of support received. All variables used in the models, their definitions and measurements are shown in Appendix A.

4. Empirical results

4.1. Summary and descriptive statistics

This section provides the summary and descriptive statistics of variables employed in this study. Appendix B.1 shows the demographic profile of respondents sampled across the eleven regions in Ghana. From the table, females constitute 60.33% of respondents, with the remaining 39.67% being male. Concerning the marital status of respondents, the appendix in reference once again reveals that a large number of respondents are married. They constitute about 50% of the sampled population. Single or persons who have never been married make up 33% of the total sample. Separated or divorced respondents represent 6.82%, whereas widowed and co-habiting make up 5.78% and 4.67 respectively. The religious background and the regional distribution of respondents are also highlighted in Appendix B.2. The Greater Accra Region had the highest representation in the study, followed by the Ashanti Region with 38.78% and 18.98%, respectively. The region with the least representation is the North East Region with 1.08%. The religious distribution indicates that the majority of persons are Christians, with 63.18%. Muslims constitute 36.41%, whereas those who ascribe to the traditional religion and other religions make up 0.15% and 0.26%, respectively.

Appendix B.2 presents the results of the Covid-19 responsible behaviour index. It scores the behavioural responses of sampled respondents. From the table, the least index score recorded was 5, whereas the highest score reported was 28. An examination of the table reveals that about 233, constituting the majority of the sampled respondents, scored 19. This table also demonstrates good behaviour because as the index score increases, the frequency of respondents also increases at an increasing level until we notice a fluctuation in the frequencies from the index score of 14. Forty respondents attained the highest score of 28, indicating good behaviour, whereas 4 exhibited the least good behaviour, scoring 5.

We employ eight indicators to measure government support, and the results are presented in Appendix B.3. The Yes or No responses of respondents on various support measures they received or expected to receive are highlighted. In terms of food support, 12.01% of respondents answered in the affirmative, 17.09% for public education, 34.59% for cash transfers and 23.95% were in favour of free utilities. Similarly, credit schemes, support for SMEs, tax exemptions and hand sanitizers affirmative responses reported are 38.04%, 71.04%, 22.32% and 15.42%, respectively. We could observe from the frequencies that respondents were more interested in receiving or received support for their small businesses. The

support indicators were further indexed from 1 to 7. The majority of respondents ranked the support received at the second least index, which is 2.

4.2. Measurement of the level of vulnerability of the population in Ghana

In Table 1, we present results from computing vulnerability indices of 100 slums located in various regions in Ghana. Similar to Acharya and Porwal (2020), vulnerability indices were constructed along five domains: socioeconomic condition, demographic composition, housing and hygiene conditions, availability of health-care facilities, and COVID-19-related epidemiological factors. Individual domain vulnerability scores range from 0, which denotes the lowest level of vulnerability, to 2.536, which is the highest. Regarding the total vulnerability scores across the sampled slums, the lowest score is 3.781, with the highest being 6.649. Analysis of vulnerability scores below 0.5 along individual indicators reveals 16 slum areas for socio-economic vulnerability, 28 for demographic vulnerability, 8 for housing and hygiene, 0 for health care vulnerability and 90 for epidemiological vulnerability, respectively.

Regarding total vulnerability, 38 slum areas scored at least 5, with 21 in the Greater Accra Region. Intra-slum domain vulnerability reveals each area's uniqueness even though these areas have been broadly classified as slums and are expected to exhibit some similarities. The following slum areas scored the highest along the individual domain vulnerability indicators: Atuwei (2) in terms of socio-economic vulnerability, Adabraka (1.348) for demographic, Dagbandabi (2.536) for housing and hygiene, Fisheries (2.5) for health and hygiene and Ho (1.281) for epidemiological vulnerability. Atuwei, Adabraka and Fisheries are located in the Greater Accra region, whereas Dagbandabi and Ho are located in the Northern and Volta regions of Ghana, respectively. Despite not recording the highest vulnerability score along any individual domain, Ketan in the Western Region cumulatively scored the highest total vulnerability. Intra-slum domain vulnerability comparison may be misleading when their total vulnerability is not considered. However, focusing attention on domain vulnerabilities will help target the correct responses leading to a reduction in total vulnerability. Also, investigating slum specific vulnerability will improve understanding of the factors that make one slum more vulnerable than the other.

The slum areas-level vulnerability index is designed to assist government efforts to effectively respond to the fast-developing Covid-19 epidemic in Ghana. These vulnerability scores are meant to be used by the health authorities to specifically target the vulnerable population of slum areas and propose the needed government support to mitigate and reduce the health and socioeconomic consequences of Covid-19.

4.3. The effect of government support on vulnerability

In Tables 2 and 3, we present the effect of government support on COVID-19 vulnerability in Ghana. In Table 2, we regress all five vulnerability domains against support individuals received or expected to receive from the government, whereas in Table 3, we regress all 8 individual support indicators against the total vulnerability index of respondents sampled across 100 slums in Ghana. In both cases, we control for gender, marital status, religion and geographical location.

The results in Table 2 confirm the study's hypothesis that government support reduces vulnerability considerably. We observe a negative relationship between government support and three domain vulnerability indicators, of which two are highly significant. These are demographic, housing and hygiene and epidemiological vulnerability. The composite score of the individual vulnerabilities (total vulnerability) also shows a negative and highly significant relationship with government support. Although health care and socio-economic vulnerability show a positive relationship with government support, which seems unexpected by the study, this association is insignificant. From this, we can confidently conclude without any reservations that government support during crisis times like the COVID-19 pandemic goes a long way to reduce vulnerability.

The study also reveals that males are less vulnerable than their female counterparts during pandemics with the government support. This can be attributed to the fact that they are often the head of households. Thus, they serve as the first point of contact or recipients of government support and further decide the allocation and distribution of support received. Also, given the gendered role females play,

they cannot benefit so much from support because they have to ensure the needs of their families are first met at their very own expense, making them more vulnerable than their male counterparts.

The married also stand a high probability of being less vulnerable than the unmarried when provided with government support during pandemics. The negative co-efficient of two domain vulnerability variables confirms this. We observe a negative relationship between the status of married and socio-economic vulnerability, demographic vulnerability and epidemiological vulnerability. We also observe that this relationship is highly significant for socio-economic and epidemiological vulnerability. The total vulnerability of the married, on the other hand, also shows a significant negative relationship. Thus, when couples join forces, they will be able to overcome or reduce their vulnerability. Despite not having a significant relationship with total vulnerability, religion shows a negative relationship. This result suggests that Christians are less likely to suffer vulnerability in the presence of support. Regarding the specific vulnerabilities, they are less likely to be disadvantaged in terms of socio-economic, demographic, housing and hygiene vulnerability. However, it is surprising to observe that support will not inure any benefit to Christians when we observe the co-efficient of healthcare and epidemiological vulnerability. They show a positive relationship with government support, with the epidemiological vulnerability being highly significant. This observation calls for a probe into the role religiosity plays in reducing vulnerability through government support.

The regional analysis reveals variations in terms of the relationship between government support and domain vulnerabilities. Across all the regions, we observe that government support reduces total vulnerability. This is shown by the negative and highly significant co-efficient of the regions. However, some domain vulnerabilities of the Central, Ashanti, Bono East, Northern and Savannah Regions show a positive relationship.

Next is the analysis of the individual support variables on total vulnerability, as shown in Table 3. It highlights that not all kinds of support yield the intended outcome of reducing vulnerability and underscores the importance of need assessment and targeting bespoke responses to populations. The table shows that public education, free utilities, and tax exemptions significantly reduce total vulnerability.

These results have policy implications as some support have more impact than others. For example, the tax exemption (TE) is 1.77 times the effects of free utilities (FU), 1.65 times the effects of public education (PE) in reducing vulnerability in Ghana. These support variables all show a negative and significant relationship with total vulnerability. Food support and cash transfer, however, show a positive and highly significant relationship with total vulnerability. The coefficient and the sign on food and cash transfer support suggest that the vulnerable population did not like the type of food offered (hot meal) or how the cash transfer was being executed. The directions of the control variables, as shown in Table 2, did not change even when individual support variables were regressed against total vulnerability in Table 3.

4.4. The effect of responsible covid-19 behaviour on vulnerability

Having analysed the mitigating effect of government support on vulnerable populations, we evaluated how responsible Covid-19 behaviour affects vulnerability. The results are presented in Table 4 and in columns: 1 for socio-economic vulnerability, 2 for demographic vulnerability; 3 for housing and hygiene vulnerability; 4 for health-care vulnerability; and 5 for epidemiological vulnerability. Here, the covid-19 behaviour index is regressed against all five vulnerability domains and total vulnerability. Similar to Table 2, in analysing the relationship of interest, we control for gender, marital status, religion and geographical location (region). The results confirm that total vulnerability is reduced by responsible behaviour

adopted during pandemic situations. The relationship between responsible covid-19 behaviour and total vulnerability is negative and highly significant.

Considering domain vulnerabilities, we observe a negative and highly significant relationship between Covid-19 behaviour, housing and hygiene vulnerability, and epidemiological vulnerability. Although socio-economic vulnerability also shows a negative relationship, this association is not significant. However, our results suggest that the population over 60 years, residing in the urban area, and living in poorly suited rooms increases. Gender wise, males who practice responsible covid behaviour are less likely to be vulnerable than females. For males, we notice a negative and highly significant relationship across all the vulnerability measures used by the study except for epidemiological vulnerability, which is positive and highly significant. Despite that demographic vulnerability is negative, it is insignificant. Again, the married are less vulnerable when they practice responsible behaviours during pandemics, unlike the unmarried. We notice a negative and highly significant relationship with the married for

socio-economic, epidemiological vulnerability and overall vulnerability. Religion, to some extent, contributes to reducing vulnerability when covid-19 responsible behaviour is exhibited. The results suggest Christians can reduce their socio-economic, demographic, housing and hygiene and total vulnerability through responsible behaviour than others who belong to other religious faiths under consideration in this study. On the geographical location, the results suggest that total vulnerability is reduced across all regions through practising behaviours deemed to be good during pandemics like covid-19 despite observing a few positive domain vulnerability co-efficient among some regions.

4.5. The sensitivity of vulnerability to support and covid-19 behaviour

This section analyses the sensitivity of vulnerability to the interactions between government support and responsible Covid-19 behaviour. The findings are presented in Table 5. We can infer from the table that not all kinds of support coupled with responsible behaviour will reduce certain populations' vulnerability. We observe that combining government support in public education, free utilities, credit schemes, business support for SMEs and tax exemptions can reduce overall vulnerability, unlike responsible behaviour combinations with food supply, cash transfer, and provision of hand sanitizers. The results suggest that the vulnerability of populations may transcend basic needs, although basic needs are vital for survival during pandemics. Analysis of control variables also provides some evidence worth considering.

The gender and marital status of respondents both show a negative and highly significant relationship with total vulnerability when support variables and responsible behaviour interact. Religion, however, does not show any significant relationship with total vulnerability despite being negative.

4.6. Robustness tests: Evaluating vulnerability and government support

In order to provide precise inference on the relationship between government support and vulnerability, the welfare situation needs to be considered thoroughly. There are three assumptions underlying the use of employment and income measures of the welfare methodology: (1) we assume that if a vulnerable person receives support in the form of credit schemes, it will enhance the income earning capacity. A higher income is expected to enable households to satisfy their welfare needs; (2) we assume that if COVID-19 support is efficient and useful it would help reduce labour turnout and job losses; (3); we also

assume that providing vulnerable households with free utilities in the form of provision of portable water and electricity will enable households to be in a better position to meet their welfare needs. The results are presented in Tables 6 and 7.

In Table 6, we regress government support on the employment vulnerability of respondents. To be vulnerable in terms of employment, this study categorised the employment vulnerability status of respondents into two. The employed were deemed not vulnerable, whereas the unemployed were classified as vulnerable. We observe that food support, public education, cash transfers and provision of hand sanitizers did not reduce the employment vulnerability of respondents, which is expected in the sense that these support measures have no bearing on the employment status of people and would not also be a motivating factor to find jobs, unlike support to SMEs and tax exemptions. Support to SMEs and tax exemptions have the potential of reducing employment vulnerability by motivating the unemployed to be engaged in some activity to enjoy the benefit that accrues to the self-employed and businesses. SME business support and

tax exemptions will also reduce the number of people who may become unemployed due to worsening conditions associated with the pandemic leading to them being laid off by their employers.

The marital status of respondents is likely to reduce their employment vulnerability, as shown by the negative and significant relationship when support is extended. This phenomenon can be explained by the fact that the married are seen as people with responsibilities; thus, in many cases, they are offered employment opportunities to fend for their dependants. Thus in pandemic situations, they are less likely to be unemployed and more likely to find jobs than the unmarried. The results also suggest that employment vulnerability is only reduced in the Ashanti region, as shown by the negative and highly significant relationship. In contrast to this observation, employment vulnerability seems to worsen in the Greater Accra region, like many other regions. However, in the case of the Greater Accra region, the relationship is highly significant.

We present results on the effect of support on income vulnerability in Table 7. Cash transfers, free utilities, credit schemes and tax exemptions will reduce the income vulnerability of people during

pandemics. These support measures, to some extent, serve as cost-saving. Cash transfers increase the disposable income of the income vulnerable, whereas the others reduce the out-of-pocket cost of the income vulnerable. Persons deemed to be vulnerable income-wise by this study are those with monthly incomes below GHS313. Furthermore, income vulnerability is reduced across all regions, among males and persons who are Christians. We observe a negative and highly significant relationship between the aforementioned and income vulnerability in the presence of government support.

5. Concluding remarks and policy implications

This study contributes to the vulnerability literature by reporting on the vulnerability indices of 100 slum areas located in a developing economy (Ghana), which among many other countries, is experiencing a surge in the number of reported cases and deaths due to the Covid-19 pandemic. Also, among the studies carried out across the sub-region, this study provides empirical evidence on the relationship between government support and vulnerability, the effect of responsible Covid-19 behaviour and the interconnections between responsible behaviour and government support on the general vulnerability of the slum population. To arrive at these findings, we estimate the relationships using a robust regression estimation technique and check for the robustness of the relationship between vulnerability and support using welfare methodology.

We arrive at the following results, which establish the relationship between our key variables, namely, vulnerability, government support and responsible covid-19 behaviour, which also informs the conclusion and policy implications of this study. Our results first demonstrate unique domain vulnerabilities across sampled slums in Ghana, which requires that tailored or slum specific responses are provided to reduce overall vulnerability within slums. Thereby reducing the risk of spillage across the general population. Secondly, government support is important in ameliorating the plight of vulnerable populations, as exhibited by the negative and highly significant relationship between these variables. Thirdly we also find responsible behaviour playing a crucial role in reducing the overall vulnerability. There is, therefore, the need to promote the need for practising and maintaining recommended pandemic protocols to ensure that vulnerabilities are reduced to the barest minimum to safequard human lives. Finally, vulnerability is sensitive to both responsible behaviour and government support during pandemics. The study highlights that support should transcend basic human needs for the intended outcomes of government support to be achieved. This, therefore, calls for proper need assessment and not just dumping foreign policies, which may have been effective in reducing vulnerability in other jurisdictions. The proper assessment of needs will prevent wastage of resources, which are often scarce during pandemics. The study also highlights the need to focus on females, the unmarried and certain marginalised religious groups.

The following are the limitations of our study: First, our study focuses primarily on Ghana's slums. Therefore, the findings may not be relevant to slums in other nations or locations with varying socioeconomic situations and administrative institutions. Also, the study focuses on vulnerabilities associated with Covid-19. Other sorts of vulnerabilities (such as environmental factors) may interact differently with government support which has not been investigated in this study.

Notes

- The World Bank, on April 2, 2020, provided \$100 million to Ghana. On April 13, 2020, the Executive Board of the International Monetary Fund (IMF) approved the disbursement of a rapid credit facility of US\$1billion to Ghana to address the COVID-19 pandemic. At the national level, the Government of Ghana rolled out interventions like absorbing the utility bills of Ghanaians, providing hot meals, and free transportation for healthcare workers.
- The data manager run the field check tables to assess the quality of data received through the Dropbox on daily basis, whilst the fieldwork was ongoing. Observations from the field check tables were then shared with the enumerators and the team members through a WhatsApp page. Meetings were then held regularly with the field enumerators to ensure that all queries raised were addressed and if there were clarification required, the project team responded to them before the teams proceeded to the next survey areas. These protocols were put in place to provide assurance for quality data.
