Appendix no. 1. The legislation and the migration phenomenon in EU Appendix no. 1.a. The legislation regarding migration in EU

The common policy in the asylum and immigration field that is taken into account after 1999 is based on the hereunder elements:

- partnerships with the countries of origin
- a common European system in the asylum field (the common standards for a correct and efficient asylum procedure, the minimum conditions of receiving the asylum applicants, the coordination of the rules of recognition and the contents of the refugee's statute)
- the correct treatment for third party states' citizens (the citizens that live on the EU territory: rights and obligations comparable with those of the community citizens; economical, social and cultural non-discrimination; measures to prevent racism)
- the migrant flows' management (cooperation between the countries of origin and the destination countries; information campaigns regarding the legal possibilities of migration; human beings' traffic prevention; common policies regarding visas and fake documents)

The following are some of the measures taken for the administration of migrant flows within the EU: the gradual introduction of the integrated coordinated management at frontiers and illegal immigration prevention measures

1. The gradual introduction of the borders' integrated coordinated management

The Schengen agreements (1985, 1990 coming into force starting with 1995) represent the most important measures regarding the application of the principles regarding borders' crossing. Thus, by the Convention of Application of Schengen<sup>1</sup> agreements, the control at domestic frontiers was obliterated for all persons, regardless of nationality, but measures were taken in order to strengthen the control at external frontiers: common policies regarding visas, cooperation and information exchange between police departments and courts in member countries, at the external frontiers the citizens of the Union must simply identify themselves in order to be admitted in, while the citizens of third party countries need an admission visa for the Schengen area (if they decide so, governments can require in all these countries special admission visas) the EU candidate countries in Central Europe and Eastern Europe have also benefited by the annulment of visas, Romania having got this advantage in 2002. As a technical instrument the Schengen Information System was created (SIS), that includes and provides information regarding visa granting and the admission in the EU of certain citizens from third party countries. Only the police and the authorities that perform the control at the frontier have access to this system, thus assuring the cooperation between the borders police departments of the EU countries.

### 2. Illegal immigration prevention measures

The fight against illegal immigration is also part of the common politics regarding immigration and asylum. For this purpose, on the basis of the plans presented in February 2002 regarding illegal immigration prevention, in November 2002 a Programme of Action for Repatriation was settled. In principle the citizens of third party countries that have not got legal statute to allow them to temporarily or permanently live on the EU territory and to whom none of the Member States is obliged to offer residence, must leave EU and return to their native countries. This can be accomplished by voluntary returns or forced returns. Both because of humanitarian reasons and financial reasons voluntary returns have priority, but when they fail, the forced returns of the illegal immigrants are used.

## Appendix no. 1.b. Legislation regarding EU labour force market

Work force recruitment by UE from CEE countries for jobs that requires highly qualified work force or for jobs that are rejected by the local population, takes place based on bilateral agreements between countries. Each west European country that wishes to recruit labour force from Central and Eastern Europe establishes bilateral agreements with those countries in the region where they want to recruit from. For example, in 2000 Germany initiated "the Green Card" programme, by which it grants the residence right and the employment right in Germany for a period of up to five years for the highly qualified personnel in the IT domain. By this programme, by means of the Recruitment Central Office in Germany, the German employers choose yearly a number of 40,000 temporary employees and 3,000 employees on the basis of annual contract, from abroad (OECD, 2001). While India is the country with the most numerous beneficiaries in this programme, Central and Eastern Europe citizens form the group with the highest percenatge of 29%, in 2000-2001<sup>2</sup>. By this selective migration policy, Germany encourages temporary migration for its critical domains.

France and United Kingdom have got similar programmes for IT specialists' recruitment, while the Netherlands has got recruitment programmes including a larger variety of professions.

In a similar way, Spain and Portugal conclude bilateral agreements with Central and Eastern European countries, for nonqualified or poorly qualified labour force.

In recent years a certain number of European countries have chosen to regulate the illegal immigrants' flows by regularization processes, by means of which foreign immigrants working on the territory of a country became legal. The regulation campaign included a total number of 1.5 million immigrants at the EU level during the last 5 years.

By these methods that facilitate temporary legal migration, a few important advantages result: labour force is assured where it is deficient; illegal migration is intimidated by offering legal alternatives and are lowered the pressures concerning the systems of asylum granting, as a part of those who are qualified as asylum applicants can temporarily emigrate based on labour contracts.

# Appendix no. 1.c. Legislation regarding the mutual recognition of degrees and qualifications

The main four directives that regulate the mutual recognition of degrees and qualifications are:

- Directive no. 89/48/CEE was the first one that laid the basis of the General System for the Recognition of Diplomas and Qualifications. It had in view the ensurance of higher education degrees' recognition that demonstrate the professional training of a person for at least a three year period. Starting from it the first measures were taken. It was the case of establishing a period of adaptation for those jobs for which the qualifications necessary in the country of origin differ from those in the recipient country, the introduction of skill tests in order to replace the adaptation period, the possibility to recognize the qualification on the basis of an attestation of the previous experience in the field, etc.
- Directive no. 92/51/CEE completes the General System for the Recognition Diplomas and Qualifications by taking into consideration postsecondary education and training. Through this directive there were appointed the sector directives that envisage specific professions.
- Directive 1999/42/CE regulates the qualifications' recognition for professional activities for which it is recommended to take into consideration both formal qualifications and the qualifications based on professional experience.
- Directive 2001/19/CE completes the General System through specific professional qualifications' recognition<sup>3</sup>, on the basis of acknowledging degrees that have been obtained in third party countries (countries outside of EU) and by validating the experience resulted after the degree issuance. It is also called the SLIM directive (a simplified legislation for the Domestic Market) and as a new element it brings the mandatory recognition of degrees and qualifications, compensatory measures (skill tests and adapting periods) being necessary only in exceptional cases.

## Appendix no. 3. Legislative summary of the Romanian legislation with influence on the migration phenomenon

### Appendix no. 3.a. Legislation regarding migration in Romania

The Romanian Constitution guaranties the right of freemovement, each Romanian citizen benefiting by the right to emigrate and to return to the country.

The main normative acts that regulate migration in Romania are the following:

- Government Ordinance no. 65/1997 regarding the passports' regime in Romania approved by law no. 216/1998 completed and amended by Government Ordinance no. 84/2003.
- Law regarding the aliens' regime in Romania (Government Emergency Ordinance 194/2002 regarding the foreigners' regime in Romania, approved with amendments by Law 357/2003).
- The Emergency Ordinance regarding the statute and the regime of refugees in Romania (O.U. 102/2000).
- The Government Ordinance no. 44/2004 regarding the social integration of the foreigners that acquired a protection form in Romania.
- The Law on combating the trafficking in human beings (L. 678/2001)
- The Law for the ratification of the agreement Memorandum between the Romanian Government and the International Organization for Migration regarding the cooperation in the assisted volunteer humanitarian repatriation domain (L 374/2003).

The Government Ordinance no. 65/1997 regarding the **passports' regime in Romania** approved by Law no. 216/1998 completed and amended by the Government Decision No. 84/2003. These normative acts regulate the means of issuing and possessing passports in order to exercise the Romanian citizens' right to free circulation, as well as the measures for preventing illegal migration.

The law regarding the aliens' regime in Romania (L. 357/2003) is a basic law that regulates circulation of foreign persons in Romania. This law regulates the entering, the stay and the leaving of foreigners from Romania.

According to this law, the *entering of foreigners* on the territory of Romania is permitted once certain conditions are met<sup>4</sup> and on the basis of a visa<sup>5</sup>. In the year 2000 Romania unilaterally gave

up the entry visas for the EU citizens and they no longer have to justify the purpose and the conditions of their stay and they no longer have to prove the existence of certain means of living during their stay in Romania, as well as the means of returning to the country of origin.

Regarding the *stay of foreigners* who temporarily and legally are in Romania, they can stay on the territory of the Romanian state until the residence right established by visa or residence permit expire, and those for whom visas are no longer necessary (EU citizens, USA, Japan, etc) can stay 90 days within six months starting with the day of the first entrance.

The foreigners that were granted or, who, according to each case obtained a prolongation of the residence right in Romania, will be given a temporary residence permit by the Authority for Foreigners, by means of its territorial bodies. In the conditions of the law, foreigners can solicit also the establishment of their domicile in Romania, and the permanent residence permit will be issued for them.

The refugees' regime in Romania is regulated according to resolutions 90/627/CEE and 95/1110/CE, for this purpose having been adopted some series of normative acts that in time have been amended and updated.

Emergency Ordinance regarding the statute and regime of refugees in Romania (E.O. 102/2000) with the already mentioned amendments and completions is the main normative act that regulates the refugees' domain. This stipulates the main forms of protection that can be granted by the Romanian state, the granting procedures of the refugees' statute, the rights and obligations of the refugees and of the persons who have got a form of protection and the methods of ending, withdrawing or annulling a certain form of protection. This way, foreigners can be granted three forms of protection on the territory of Romania: the statute of refugee, conditioned humanitarian protection and temporary humanitarian protection. In order to avoid the further infringement of the principle of non-returning by the Government Ordinance no. 43 in January 2004 there were brought amendments and completions to the O.G. 102/2000 regarding the statute and the regime of refugees in Romania and it is particularly mentioned that measures of expulsion or forced return from the frontier or from the territory of Romania can not be taken against asylum applicants, as long as an executory decision of rejecting their application or the granting of the refugee statute have not been stated.

<sup>-</sup> refugee statute can be granted at the request of the foreigner who proves that, because of a well-grounded fear of being persecuted on the ground of race, religion, nationality, affiliation to a certain social group or political opinion, is outside the origin country and can not receive protection or, because of this fear does not want to be protected by this country.

<sup>-</sup> the conditioned humanitarian protection can be granted to the foreign person who does not meet the conditions to be considered a refugee, but who proves that in the country of origin has committed acts for which he could be punished by death penalty, he risks to be tortured or inhumanly treated or because of being part of an unfavoured category of persons who could be exposed to dangers that might damage their life, corporal integrity or freedom.

Refugees are granted rights by means of other normative acts. Thus, the recognized refugees have the right to receive financial help from the state for a period of nine months and those who are in a more difficult situation (old people, single mothers, families with many children) will also benefit of supplementary financial help. They are the beneficiaries of the same rights as Romanian citizens, including the right to work, but excluding the political rights and those related to the military service. The foreigners' children who have earned the refugee quality in Romania can attend the preschool and the compulsory educational system without paying tuition fees, the refugees who earn incomes benefit of social health insurances in the conditions established by law, with the payment of the contribution of health insurances, while the refugees that have no living means can benefit based on application by accommodation in rooms that are especially meant for this purpose.

A recent normative act is the Government Ordinance no. 44/2004 regarding the social integration of foreigners who benefit of a form of protection in Romania. This establishes the granting of rights and obligations in conditions equal to those applicable in the case of the Romanian citizens, to the foreign citizens who benefit of a form of protection in Romania and who benefit of measurements and services meant to facilitate their access to the mentioned granted rights. The ordinance comes into force in 90 days from the date of its publishing in the Official Gazette of Romania, starting with May 2004. The main new element is that the O.G. 44/2004 will be applied also in the case of the foreigners who benefit of conditioned humanitarian protection, so that at the present moment the persons who already benefits of a different form of protection have the same rights and obligations as those who obtaned a form of protection, according to the national legislation and under the same circumstances as Romanian citizens. The main improvements brought to the existing legislation by the new ordinance are: the access to the labour market, accommodation, medical assistance, to the social insurance system, to all education forms and integration programmes. O.G. 44/2004 also stipulates the legal basis for the cooperation between agencies regarding integration programmes and the National Office for Refugees is responsible with the coordination activity. Other agencies involved are: the Ministry of Education and Research, the National Agency for Labour Force Occupation, the Child Protection National Authority, the National House of Health Insurance and the nongovernmental organizations involved in the foreigners' integration programmes. The ordinance promotes the active role of local public administrations in facilitating the refugees' integration.

The Law on combating the trafficking in human beings (L. 678/2001) regulates the prevention and the fighting against the traffic in human beings as well as the protection and the assistance granted to the victims of such traffic, which is an infringement of the persons' rights and it damages their dignity and integrity. According to this law, will be labelled as crime of traffic in human beings: the recruitment, the transport, the transfer, the accommodation or the receiving of a person by threat, violence, or by other forms of constraint, by kidnapping, fraud or hoax, authority abuse or by taking advantage of those persons' impossibility to defend themselves or to express their will, or by offering, giving, accepting or receiving money or other advantages for obtaining the consent of a person who has authority over another person, for the purpose of exploiting them. According to this law, it is envisaged the prevention of traffic of persons women and children.

In order to prevent the traffic at international level the law stipulates the establishment of connection officers positions within the Ministry of Administration and Interior, as well as connection magistrate positions at the level of courts, and according to case connection magistrates who perform their activities in other states, in order to coordinate the actions during criminal investigations. For the data and information exchange regarding the criminal

investigation in case of traffic in human beings, the contract stipulates the establishment of a connection point within the Ministry of Administration and Interior with similar institutions from other countries.

The Law for the ratification of the Memorandum of Agreement between the Government of Romania and the International Organization for Migration regarding cooperation in the domain of assisted humanitarian voluntary repatriation (L/374/2003) This law has in view the establishment of a programme for the promotion of the assisted humanitarian voluntary repatriation of the asylum applicants whose applications have been rejected and of other foreign citizens who illegally enter the and/or live on the Romanian territory. By this law, the parties of the contract meaning OIM and the Romanian Government undertook to mutually provide all the necessary information for successfully implementing the programme and they formed a common consultative commission for this purpose.

### Appendix no. 3.b. Legislation regarding the labour force market

The main normative acts that regulate the ingoing and outgoing flows within the labour force market in Romania in connection with other countries are:

- the Law regarding work permits (L 203/1999 amended by L. 32/2003)
- Law regarding the protection of Romanian citizens who work abroad (L. 156/2000)

### The Law regarding work permits (L 203/1999 amended by L. 32/2003)

Foreigners can get employed on the territory of Romania on the basis of a labour permit. This is granted for six months with the possibility of prolongation at the owner's request for other intervals of six months each. There are certain foreigner categories that can get hired on the territory of Romania without labour permits<sup>7</sup>, and among them are the EU state members' citizens, those of the states who signed the Agreement regarding the European Economic Area and the members of their families.

Foreign workers can be hired on the territory of Romania only if their working positions can not be taken by Romanian personnel and if the foreign employee meets the special conditions of professional training and experience required by the employer and by the legislation in force.

The Law regarding the protection of Romanian citizens who work abroad (L. 156/2000) According to this law the Romanian state establishes agreements and conventions with public

authorities from other states on the principles of equal treatment and application of the clauses that are the most favourable in the Romanian, foreign or international legislation. By such agreements it is ensured the protection of Romanian citizens who work abroad by establishing certain aspects, like: the minimum salary level, the working time and the resting time duration, the general working conditions, the protection and security conditions, occupational accidents and diseases insurance. The coordination and the control of labour force occupation abroad are incumbent on the Ministry of Labour and Social Solidarity, who establishes bilateral agreements between countries.

# Appendix no. 3.c. The legislation regarding the mutual recognition of degrees and qualifications in Romania

The Lisbon Convention (1997) regulates the mutual recognition of degrees between the signatory states and was ratified in Romania in 1998.

There is not a clear distinction in Romania between the academic recognition and the professional or qualification recognition. However certain progresses have been recorded in recent years. Academic recognition is established by means of the National Centre for Recognition and Equivalence of Degrees.

Regarding professional or qualification recognition, the recognition procedure is *de facto* when the access to the profession is not regulated by supplementary normative acts. In other words, after the recognition of the study papers, the applicant as a citizen of a Member State can have direct access to a lucrative activity. In July 2003 was initiated the automatic recognition of qualification— either on the basis of professional training or professional experience— acquired abroad, outside the educational system by Romanian or EU citizens, and at the end of the year 2003, by Order of the Labour Minister no. 701/17 December 2003 an institution was designated to admit the documents that prove the qualification acquired abroad, outside the educational system. Practically people hand in an application and a complete file in order to be granted a certificate at the Ministry of Labour and Social Solidarity, on the basis of which they are entitled to perform a lucrative activity. Those certificates cannot be used for the continuation of studies, but for the purpose of being hired.

The legislation introduced in Romania in the domain of degrees' and qualifications' recognition has in view only the transposing of the stipulations of the two directives of the general recognition system 89/48/CEE and 92/51/CEE, while the other two directives are not taken into consideration.

Regarding the sector directives were sett up the Office for Professional Qualifications' Recognition and for the Continuous Training in Medical Professions within the Ministry of Health, the main task of which is the recognition of the qualifications of doctors, stomatologists, chemists, nurses, and midwifes. The modification of the university curricula in this domain was also taken into account, starting with the university year 2003-2004.
